Facilitator and Speakers

Paul Dugdale

Paul is Director of Chronic Disease Management for Australian Capital Territory (ACT) Health, Associate Professor of Public Health at the Australian National University (ANU), and director of the ANU Centre for Health Stewardship. The Centre undertakes work on health department administration, clinical governance and the legal basis of health stewardship. He was ACT Chief Health Officer, and prior to that worked in the Commonwealth Department of Health, in New South Wales Health, was Medical Superintendent at Liverpool Hospital in Sydney, and was private secretary to former Commonwealth Minister for Health Neal Blewett. Paul's research interests include health policy, financing, and regulation from a social and political theory perspective.



Blair Sadler

Blair is a Senior Fellow at the Institute for Healthcare Improvement. He is an Associate Clinical Professor of the UCSD School of Medicine and an Executive in Residence at the UCSD Rady School of Management. He served as President and CEO of Rady Children's Hospital in San Diego from July 1980 until July 2006. As a longstanding member of the Board of the Center for Health Design, he has been heavily involved in developing the business case for building better hospitals through evidence - based design. He is a strategic advisor to Health Care Without Harm and its Healthy Hospital Initiative, applying lessons learned from IHI's 100,000 Lives campaign and 5 Million Lives campaign to support hospital sustainability.

Richard Di Natale

Dr Richard Di Natale was elected to the federal parliament in 2010 and is the Greens' first Victorian Senator. His portfolios include health, multiculturalism, gambling and sport. Prior to entering parliament Richard was a general practitioner and public health specialist. He worked in Aboriginal health in the Northern Territory, on HIV prevention in India and in the drug and alcohol sector. His key health priorities include preventative health, public dental care and responding to the health impacts of climate change.













Madeline Dorman

Madeline has a clinical background and since 1997, has worked in both the public and private sectors of health care. As a critical care clinical nurse specialist, she has been able to observe firsthand the issues surrounding clinical waste management in healthcare facilities. After completing completed a Post Graduate Diploma in Environment, Madeline joined the Environmental Services team in October 2008. She recently took up the position as Sustainability Manager in the newly formed Sustainability Unit at Austin Heath. Her presentation will focus on the development and implementation of an environmental management strategy in a large metropolitan health service

Chris Hill

Chris is the Director of Environmental Sustainability for Mater Health Services Brisbane. He has extensive hospital management experience and was appointed to oversee the Environmental Sustainability platform in March 2010. Chris has a Masters of Environment with the education for sustainability specialisation, a graduate certificate in sustainable enterprise and diplomas in sustainability and project management. Chris has collaborated with Griffith University and University of Queensland on a number of Environmental Behaviour studies at Mater.







Maggie is Associate Professor, Public Health at the University of Canberra and has, at senior executive level, twenty years experience in the health and tertiary education fields with a major focus on population health, health system research and recently senior executive leadership and management in the UK and more recently in Australia.

Prior to returning to Australia after 5 years back in the UK, Maggie worked at the Centre for Research and Dissemination at the University of York on developing the evidence from systematic review for public health. Prior to coming to University of Canberra, Maggie was Chief Executive of Lifeline Australia.

Josh Karliner

Josh is the International Team Coordinator at Health Care Without Harm. He was the co-founder of the Green Schools Initiative, Founder of CorpWatch, and the Earth Summit Coordinator with Greenpeace. He has worked with numerous environmental and human rights organizations over the years and is author of two books on global environmental politics.











Sophi MacMillan



Sophi has worked with the PVC sector's industry association, the Vinyl Council of Australia, since its establishment in June 1998 and has been Chief Executive Officer since 2002. Sophi works with companies and stakeholders across the supply chain for vinyl products in Australia characterising and addressing life cycle issues. She has been instrumental in the establishment and management of the Australian PVC industry's Product Stewardship Program, now in its 10th year of operation. A qualified environmental scientist, Sophi has many years' experience in health and environmental issues, advocacy and stakeholder communication across a range of organisations, sectors and government bodies.

Matt Power

Matt joined St Vincent's Health Australia as Group Manager – Energy and Environment in February 2011. During the 4 years prior, Matt worked as the Energy Conservation and Sustainability Manager for Jones Lang LaSalle, providing energy efficiency and environmental management expertise to a portfolio of 7 Federal Government Departments including areas such as, development of environmental management systems, energy efficiency project implementation, legislative reporting and compliance, and energy procurement.
