SitRep #1 - Self Harm Attempted at North West Point - Christmas Island - 26 May 2011

As at 1920hrs AEST Thursday 26 May 2011

- On 26 May 2011 at approximately 1123hrs local time, s. 47F(1) attempted to hang himself within the Education compound using a bedsheet.
- IHMS attended on-site after s. 47F(1) refused medical treatment. IHMS has advised his injuries are not serious.
- The Mental Health Team will attempt to engage with s. 47F(1) later today.
- s. 47F(1) is currently under Serco observations.
- Serco and IHMS will continue to monitor s. 47F(1).

Background
