She informed Operations Manager Wilson that she had spoken to the Mental Health Registrar at the Royal Darwin Hospital and he had passed on the information that had been relayed through an interpreter that the child had stated that he was going crazy in detention and obtained the medication from his mothers possession and consumed them aware of what they were and what they could do. The Registrar informed Serco to make sure all stakeholders were aware of the situation. DIAC Duty Manager Meredith Gawler was informed of the updated information at 1830hrs.

Mental Health will be at the Darwin Airport Lodge on Saturday the 21st of May to review the client after hospital discharge and determine PSP status.
