to head butt a support pole on the walkway between B and C block. A Code Blue was called for officers to attend the area. Officers Hassan, Coleman and Scaife all attended to the area. The client then fell to the ground with what appeared to be blood dripping out of a wound on his forehead. Client S. [redacted] then got up and proceeded to his room S. [redacted] (B Block) continuing to head butt the window when he got there. CSM Miller and OM Elsey attended room S. [redacted] also. Upon arrival the client was sitting on the ground outside his room surrounded by the above mentioned officers along with 2 LWB staff and the clients psychologist. OM Elsey then left the site to inform DIAC while CSM Miller alerted onsite IHMS staff. The client was tended to by IHMS onsite and it was advised that we call an Ambulance. An ambulance was called and the client was taken to RDH A+.
