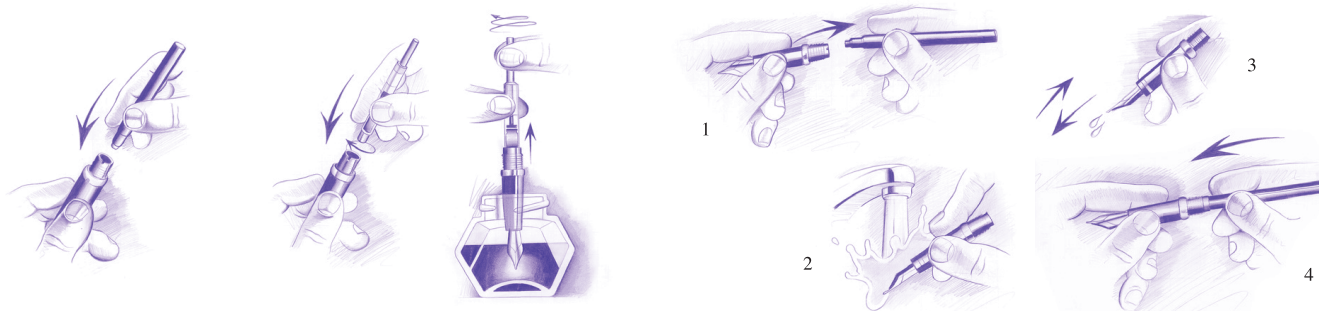

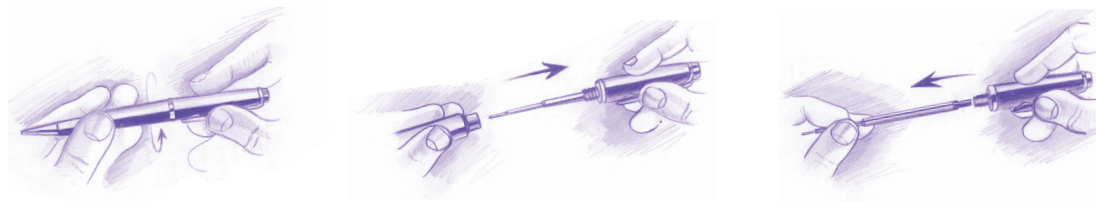

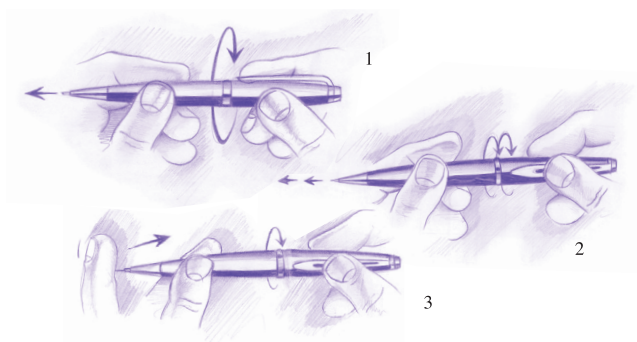


BALLPOINT

Twist mechanism

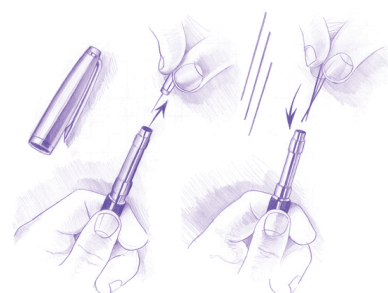


1, 2 : To advance the lead
