BY CAR –

The workshop will be held at the studios of Ballet Academy Northside (2/22 Narabang Way, Belrose).

- Approaching from Forest Way, turn into Garigal Rd and then left into Narabang Way.
- Approaching from Mona Vale Rd (St Ives), turn right into Narabang Way (towards Super Centre). Turn right at the final roundabout before Forest Way.

PLEASE NOTE there is limited parking underneath the studios due to the number of offices in the building – we suggest that you park on the street and students walk up the driveway.

BY BUS –

Forest Coachlines routes 141, 193, 196, 197 & 271 stop in Narabang Way.
