AUSTRALIAN CONTINGENT APPLICATION FORM

ELIGIBILITY

Rover Participants

- Born between 3 August 1995 and 23 July 2000 inclusive (i.e. minimum age 18 years, maximum age 23 years)
- An invested Rover Scout who is a financial member of their Crew
- Must be recommended as suitable to attend by your Crew Leader or Region Rover Council Chair / Region Commissioner (Rovers), and be approved by the Contingent Leader and your Branch Rover Council Chair/Commissioner.

International Service Team (IST)

- Registered members of your Branch as a Rover, Adult Leader or Fellowship Member born on or before 3 August 1995 (Minimum age 23 years)
- Must be recommended as suitable to attend by your Group Leader or next appropriate level of Commissioner (depending on your current role), and be approved by the Contingent Leader and your Branch Headquarters.
- Adult members will be selected to meet required quotas as prescribed by the Moot Organising Committee.

CONTINGENT INCLUSIONS

The Australian Contingent Fee includes all expenses after joining the official Contingent itinerary in The Netherlands until the advertised departure day. An optional post-tour to Drave Scout centre in Portugal is available including flights between The Netherlands and Portugal only. Flights between Australia and Europe are an additional individual expense.
