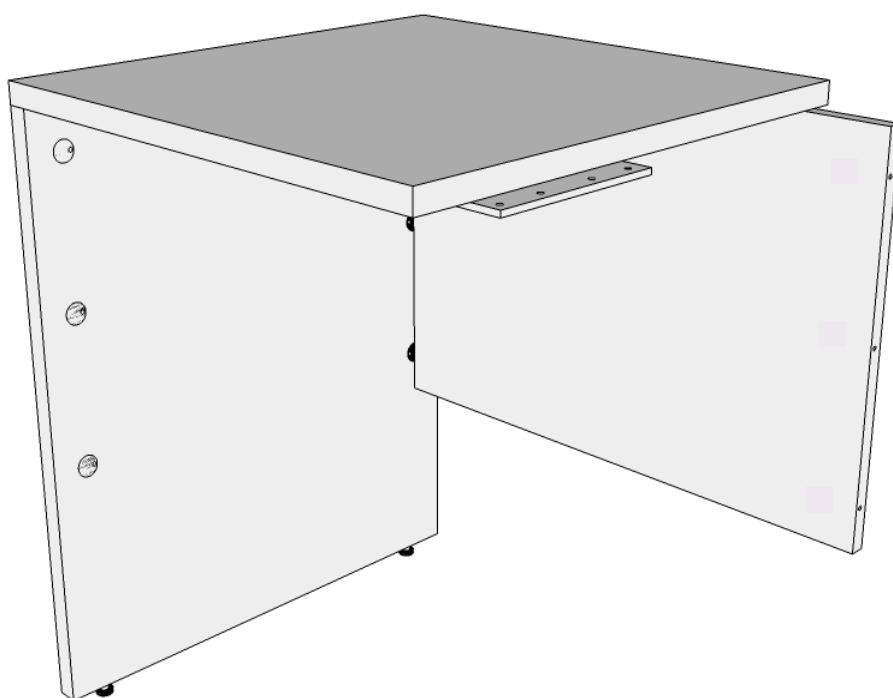
ALIGN SIDE (A) WITH MODESTY (B), PUSH TOGETHER AND TIGHTEN TIGHTENING SCREW IN CAMS

ENSURING THAT THE HOLES ON THE SIDE (A) OF THE MODESTY (B) ARE FACING INWARDS

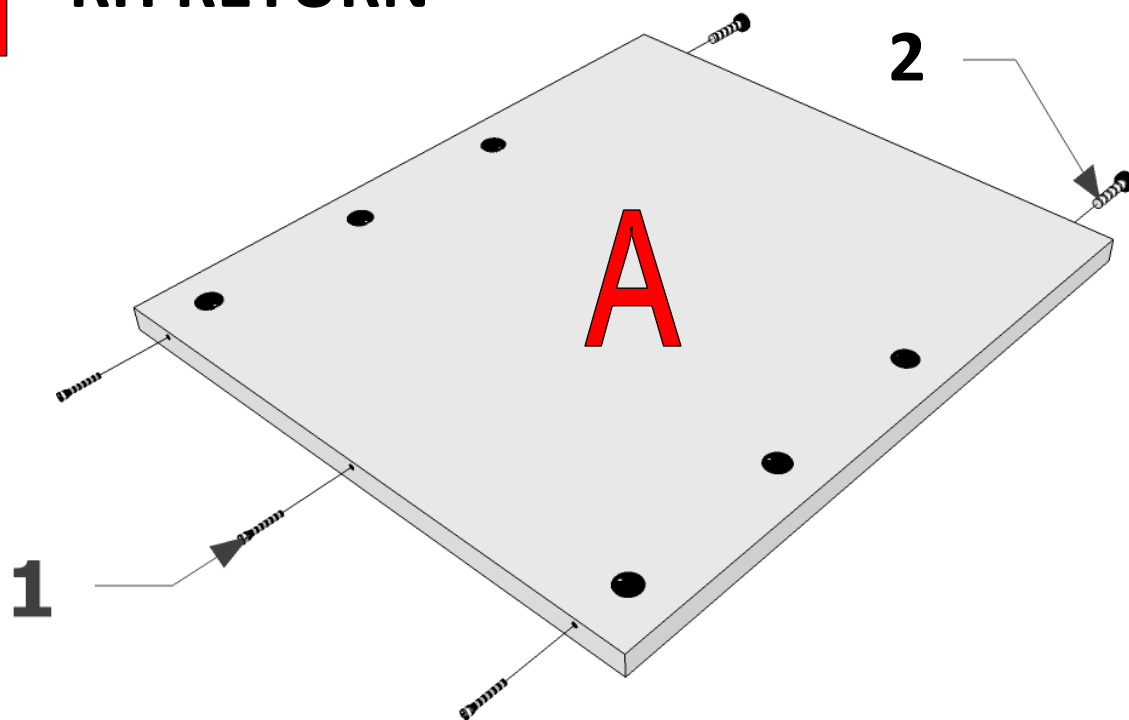

PLACE ITEM (3) OVER TOP AND USE 4 X ITEM (4) TO SECURE TO TOP (C)

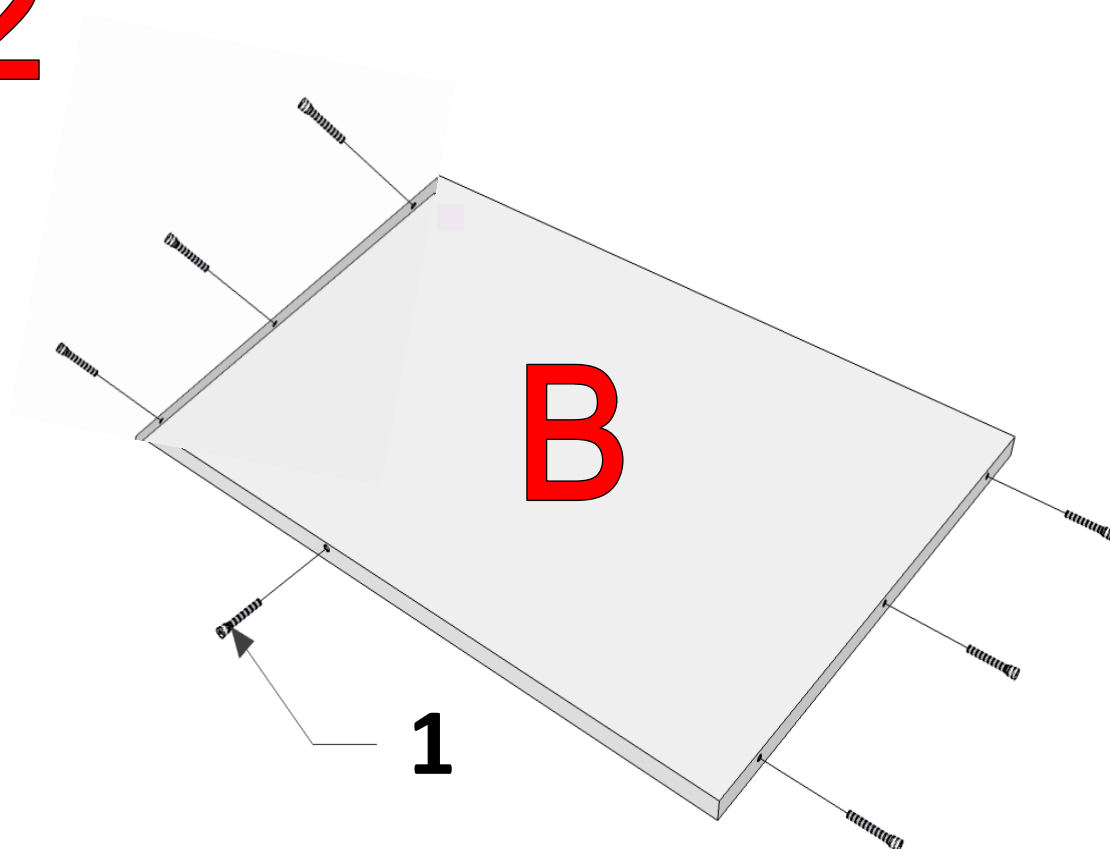

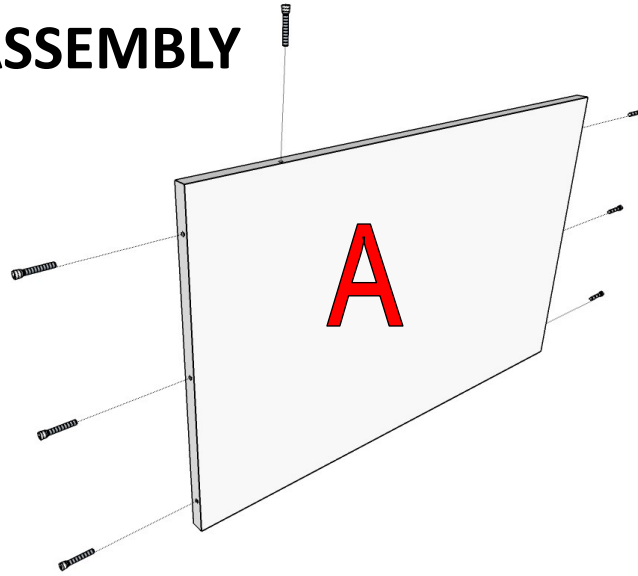

ENSURING THAT THE HOLES ON THE SIDE OF THE MODESTIES (A&B) ARE FACING INWARDS

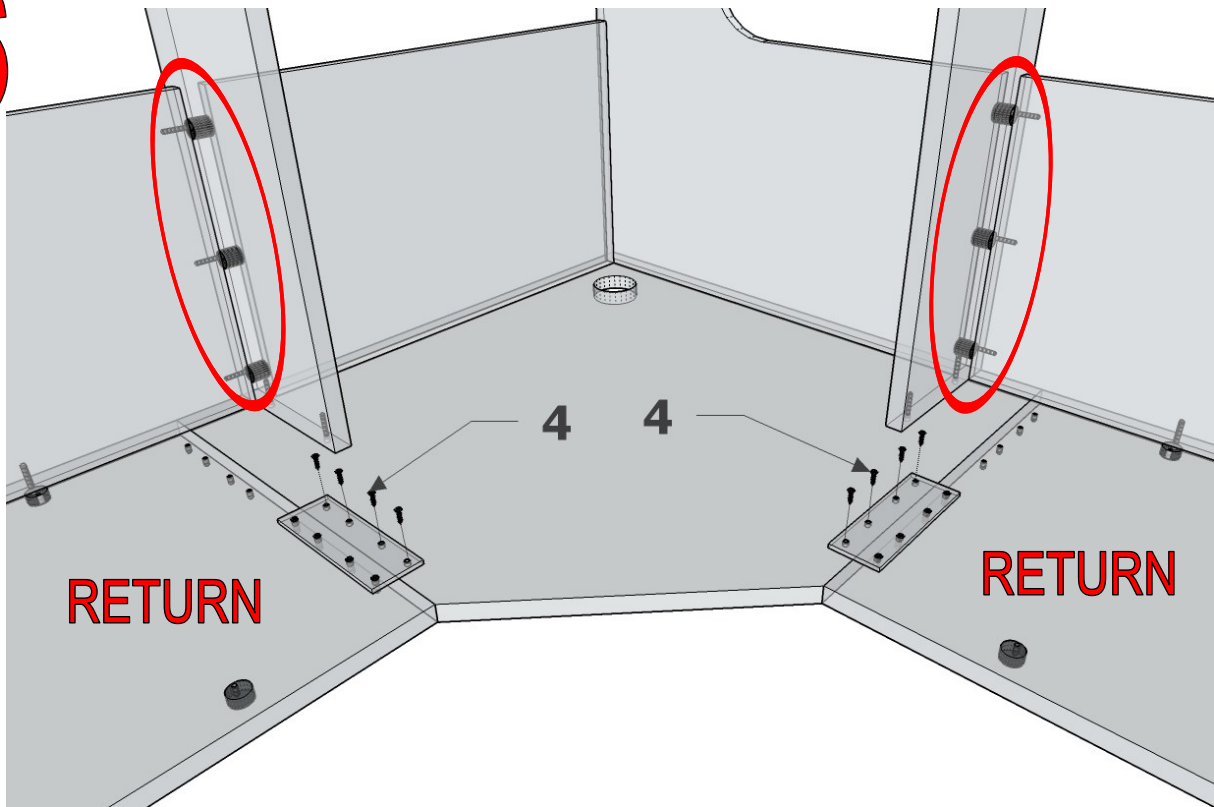


ALIGN ASSEMBLED ABOVE COMPONENTS OVER THE TOP (D) ENSURING PINS LINE UP WITH CAMS  
PUSH IN PLACE AND TIGHTEN TIGHTENING SCREW UNTIL SECURE  
SCREW ITEM 2 INTO PRE-BORED ENDS FOR HEIGHT ADJUSTMENT ONCE ENTIRE WORKSTATION IS ASSEMBLED FINE  
ADJUST LEVELLING FEET TO SUIT YOUR REQUIREMENTS

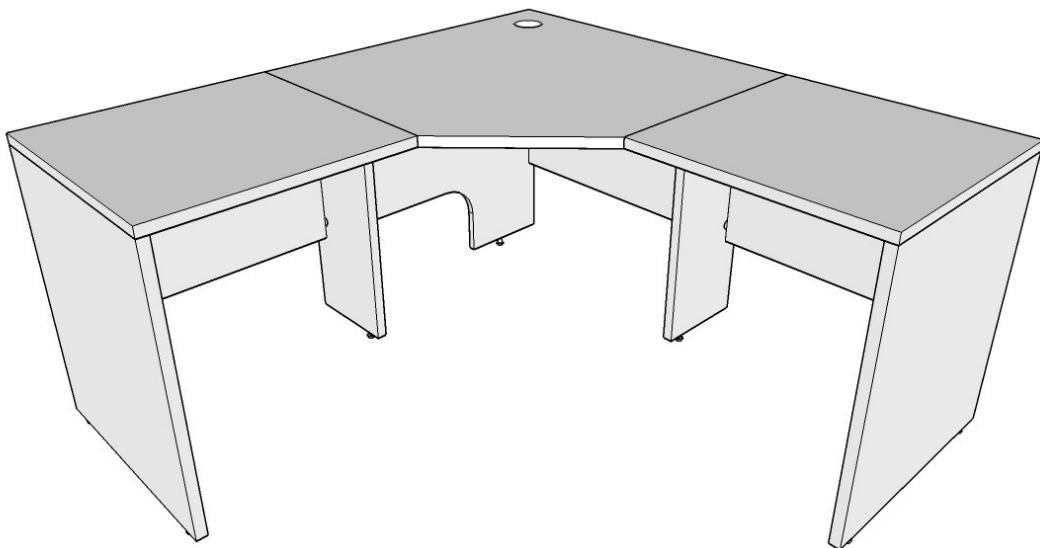

3. All items must be used for the purpose for which they were designed and built. Damage caused by misuse, abuse or neglect, will not be repaired under warranty.
4. Damage caused by incorrect cleaning methods or materials is not covered by warranty.
5. Any modifications or alterations to the furniture will void the warranty.
6. Designtec furniture is manufactured to suit internal use and any exposure to direct UV light will void this warranty.
7. Warranty only applies to the original purchaser. Goods that are let out for hire or loan are not covered by warranty, nor are factory seconds or prototypes.
8. Original suppliers invoice must be produced prior to any repair taking place and emailed to [sales@designtec.com.au](mailto:sales@designtec.com.au) together with any relevant images or information to the claim for warranty verification.
9. Defective goods must be returned at the consumers cost to the address of the warranty provider.
10. Designtec's liability is limited to the repair and / or replacement of the parts or part found to be defective.
11. Any additional items supplied with the furniture and not manufactured by Designtec Commercial Furniture are covered only by the original manufacturer's warranty.
12. The decision as to whether the damage is covered under warranty is at the sole discretion of Designtec Commercial Furniture.
13. This warranty gives you specific legal-rights. You may have other rights or remedies pursuant to other applicable laws. Nothing in this limited warranty should be construed as limiting or restricting any other statutory right or remedy available to you, except as permitted by applicable law.
14. Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced, if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
