



#### **QUALIFYING / ELIGIBILITY REQUIREMENTS, RULES and CONDITIONS OF ENTRY**

SADDLES PLUS DEBUTANTE (NEWCOMER) CLASSES - Qualifying & Eligibility Requirements

**Qualifying Requirements:** Horse/pony is required to have attended two SHC WA official Show Horse events within the qualifying period.

Qualifying period: 17th April 2015 to 25th May 2016

#### **Eligibility Requirements:**

1. The horse/pony must not have competed under saddle in any discipline (racing excepted), either official or unofficial prior to the commencement of the qualifying period, that is, 17<sup>th</sup> April 2015. "Competing under saddle "includes participation at Dressage Training Days and Dressage competition and any other competition (including closed gymkhanas). Participation at Adult Riders and Pony Club Rally Days is not considered as having competed under saddle. 2. The horse / pony may only be ridden in a snaffle.

#### **FOUNDATION CLASSES - Qualifying & Eligibility Requirements**

3. A Foundation Hack/Hunter is one that has not been placed 1<sup>st</sup>, Champion or Reserve in an Open Ridden Hack / Hunter class at any Royal Show or has never been the winner or runner-up at the Grand Nationals, or the winner or runner-up at any State HOY title (including EA HOY) or has never been the winner or runner-up of any Grand National Qualifier (including Gosnells Masters and SHC Classic) or winner or runner up of a SHC WA Foundation class, as at the date of competition.

**NOTE:** Any horse or pony entered in the Foundation Class that becomes ineligible after the close of entries will be refunded the entry fee for the class. It is up to the competitor to request a refund and all requests must be submitted by 31<sup>st</sup> July 2016. Requests for refunds received after this date will not be accepted.

#### RULES OF COMPETITION & CONDITIONS OF ENTRY:

In addition to the rules outlined above all competitors must take note of the SHC Australasia Inc. Competition Rules,

which will apply, and the rules or conditions of entry specific to this show, The Saddles Plus Debutante & the SHC WA Foundation Horse of the Year.

#### **CONDTIONS OF ENTRY — ELIGIBILITY**

- 4. The onus is on the owner/exhibitor/representative to make sure that their horse / pony is eligible to compete in this event.
- 5. The horse must be registered with the Show Horse Council of Australasia Inc. National Saddle Horse Register prior to competing under saddle for qualifying event.
- 6. The rider and owner/lessee must be a financial member of Show Horse Council WA Inc. prior to the close of entries and on the day of competition.
- 7. All riders regardless of age are required to wear an approved safety helmet.
- 8. Attention is drawn to Rule 16.1 (gadgets and bits), 16.2 (spurs) and SHC 16.3 (whips) of the SHC Competition Rules.
- 9. Horses/Ponies can only compete in either Show Hunter or Show Horse Classes. Exhibits must be entered as a Show Hack (Saddle Horse) or Show Hunter in accordance with the SHC Australasia Rule "Once a horse has competed as either a saddle horse or as show hunter at its first SHC competition in a calendar year it must remain as a saddle horse or show hunter at SHC competitions for that calendar year".
- 10. Horses/Ponies current SHC Measurement Certificate must be attached to the entry form (copy only). It is the competitor's responsibility to ensure that their horse has been measured prior to competing.
- 11. Horse registration papers with the Show Horse Council of Australasia Inc. National Saddle Horse Register must be attached to the entry form (copy only).
- 132. Show Horse Council of WA Inc. membership number for owner/exhibitor/representative and rider must be included on entry form entry is for WA members only.
- 13. Where a horse is registered in the name of a minor (under 18 years), the Entry Form shall be signed by the parent/legal guardian; AND that parent/legal guardian MUST be a financial member of the SHC of WA. Inc.
- 14. Drug Testing (Swabbing) may be carried out on both days of the Show in accordance with SHC Australasia Inc. Competition Rules on DRUGS and DRUG TESTING (Rules 7.1 to 7.12) and Rule 1.0-1.9
- www.showhorsecouncilaust.com.au. Original registration papers must be produced if a horse is called up for Drug Testing. The Responsible person present during the swabbing procedure must be 18 years or old.
- 15. Alcohol is prohibited the consumption or possession of alcohol may result in disciplinary action and/or disqualification. Riders are not to be under the influence of alcohol during the competition.
- 16. No Dogs are allowed on Grounds.
- 17. Entry and Competition in the Show are voluntary. The Exhibitors, Competitors, and Riders enter and compete entirely at their own risk. By Entry it is the Absolute Liability of all participants to agree to be bound by the decisions of the Ground Jury and/or SHC of WA Committee and compete in accordance with all Rules applicable to the Competition.
- 18. The SHC WA Inc. reserves the right to interpret all rules where any dispute arises.

#### **ENTRIES**

Entries can be lodged by mail, email or in person. No faxed entries accepted.

- 19. CLOSE OF ENTRIES IS 9:00PM 25th MAY 2016. NO LATE ENTRIES WILL BE ACCEPTED.
- 20. The acceptance or otherwise of an Entry will be at the discretion of the Show Horse Council of WA Inc.
- 21. Withdrawal of Entry: no refunds whatsoever will be provided.
- 22. All protests shall be in writing to the Ground Jury accompanied by a non-refundable fee of \$50.00 and are to be received no later than 30 minutes after the event/class, after which time no protest shall be accepted.
- 23. **Incomplete/Incorrect Entries** Should any information and/or fees be omitted from the entry, the entry will be deemed incomplete and as such may not be accepted. A handling fee of \$20 will apply to any entry that is incomplete/incorrect and must be paid prior to competition at the show or you will be ineligible to start until all fees have been paid.
- 24. If your entry has to be returned or is incomplete or incorrect or has insufficient paperwork or money a handling fee of \$20.00 will be charged.
