PIC Number – Property Identification Code

The Western Australian brand and PIC register (Department of Agriculture and Food)

People with any livestock in WA must be registered as owners of livestock with the Department of Agriculture and Food, Western Australia (DAFWA) Brands Register. On registration, a property identification code (PIC) will be allocated to the owner to indicate who owns the animals and where they are kept. A PIC card is issued that lists the properties that the owner has nominated to run stock on and the registered identifiers for use with stock, namely their stock brand, earmark and pig tattoo.
