# American Express Membership Rewards Webjet Travel Competition

### **CONDITIONS OF ENTRY**

- 1. Information on how to enter and prizes form part of these Conditions of Entry. Registration and entry in this promotion is deemed acceptance of these Conditions of Entry.
- 2. The Promoter (the "Promoter" or "American Express") is American Express Australia Limited (ABN 92 108 952 085) of 12 Shelley Street, Sydney NSW 2000.
- 3. The Promotion starts at 09:00am on 15th March 2019 AEST and closes at 11:59pm AEST on 12th April 2019. ("Promotion Period") No entries will be accepted after this time.

#### **ELIGIBILITY**

- 4. Entry is open to all Australian American Express Primary Card Members, aged eighteen (18) years or older who are enrolled in the Membership Rewards program ("Eligible Entrants").
- 5. Additional Card Members are not eligible to enter.
- 6. Employees of American Express and any related bodies corporate, any other agencies associated with this promotion, and their immediate families, are ineligible to enter.
- 7. By entering the competition Eligible Entrants agree that American Express may provide their personal information including name, phone number and address details to related companies and affiliates, for the purpose of awarding the prizes.

### **THE PRIZE**

8. The total prize pool is valued at \$5,000 (RRP incl. GST).

#### **Details of the Prize:**

- 9. There is (1) Major Prize to be won during the Promotional Period. The Major Prize is:
  - a. Webjet Travel e-gift cards, valued at \$5,000 (incl. GST)

#### **How to Enter**

- 11. To enter, American Express Card Members must, during the Promotional Period, redeem a minimum of 7,500 Membership Rewards points for "Travel" at :
  - a. Webjet Travel online at https://www.webjet.com.au/

- "Travel" includes flights, hotels or holiday packages. Points that are redeemed for car hire are excluded from entry into this competition.
- 13. Once points are redeemed as mentioned above, Card Members will automatically go into the draw to win the Major Prize with the respective travel partner where the points were redeemed;
  - a) American Express Card Members that have redeemed their Membership Rewards points at Webjet Travel for flights, hotels or holiday packages during the Promotion Period will go in the draw to win a \$5,000 Webjet Travel Voucher.
- 14. A minimum of 7,500 Membership Reward Points must be redeemed at any one time, to go into the draw to win.
- 15. Each eligible redemption of 7,500 or more Membership Rewards points is deemed one entry.
- 16. There is no maximum number of entries over the Promotional Period.

### **Draw & Winner Notification**

- 17. The prize draw will take place as follows:

- 27. The Promoter, Engage Australia Pty Limited, and any agencies or companies associated with this Promotion, make no representation as to the safety conditions, political conditions, or other issues that may exist at any destination.
- 28. The Promoter reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of Promoter, includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements, disqualify any Eligible Entrant who tampers with the entry process, who submits an entry that is not in accordance with these Conditions of Entry or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. - 29. The Promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, technical problems or traffic congestion on the Internet or at any web site, or any combination thereof, including but not limited to any injury or damage to participants or any other person's computer related to or resulting from participation in or downloading any materials in this competition.
- 30. It is a condition of acceptance of the prize that the winning Eligible Entrant's American Express
  Card account must be current, not in default and in good standing during the Promotion Period
  and at the time of notification that they have won.
- 31. Unless expressly stated in these Conditions of Entry all other expenses that extend beyond the prize terms are the responsibility of the winner.
- 32. If the prize is unavailable, for whatever reason, the Promoter reserves the right to substitute the prize for a prize of equal or greater value, subject to any written regulatory direction or as required by law.
- 33. It is a condition of accepting the prize that the winner may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.

The Promoter is not responsible for any incorrect or inaccurate information, either caused by the website user or for any of the equipment or programming associated with or utilised in this competition, or for any technical error, or any combination thereof that may occur in the course of the administration of this competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.
- 40. The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 41. If for any reason this competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the competition, subject to any written regulatory direction or as required by law.
- 42. No responsibility is accepted for late, lost or misdirected entries.
- 43. Incomplete or indecipherable entries will be deemed invalid
- 44. All entries become the property of American Express. The winner agrees to allow American Express to use his/her particulars for the purposes of marketing, publicity, promotional or direct mailing (unless they have already notified American Express not to do so).

### **Privacy Consent**
