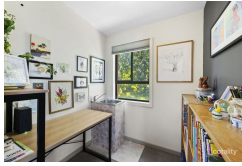

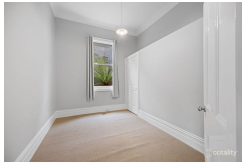


1A VICTORY LANE BLACK HILL VIC 3350 Sold Price
