No.12 of 1917.

WAR OFFICE,

2nd January 1917.

12. Hospital Stoppages etc. Officers and Warrant Officers suffering from Venereal Diseases or from injury or sickness due to causes within their own control.

1. With reference to para. 73 Allowance Regulations, it has been decided that Officers admitted to Military Hospitals with Venereal disease, or on account of injury or sickness due to causes within their own control, will in all cases be required to pay the full hospital stoppage, viz. 2/6 a day. It has further been decided that the issue of the following money allowances, viz. field allowance (when issuable), and the special allowance authorised by A.O.501 of 1914, shall cease for the period during which an officer remains under treatment in hospital as a result of venereal disease, or on account of injury or sickness due to causes within his own control.

Field Allowance will also cease for the period a Warrant Officer is in hospital under treatment for venereal disease, or on account of injury or sickness due to causes within his own control. The hospital stoppages of Warrant Officers are dealt with under the regulations applicable to N.C.Os. and men.

2. The necessary steps will be taken locally to furnish the Command Paymaster with the requisite information to enable him to carry out the foregoing instruction. The new provisions not embodied in A.C.I. 1288 of 1916, which is hereby cancelled, will apply on and after 1st January 1917.

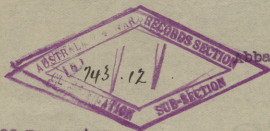

(1). I note that all communications should now be addressed in the first instance to your Office.

I would point out, however, that the Staff-Paymaster has misread my letter to him of the 15th instant, as you will see from copy of same which I attach hereto.

The question which I asked referred to pay due to soldiers before admission to this Hospital and not while they were under the Command of a Medical Officer. I was under the impression that in accordance with King's Regulations 1843, para.2, this question should have been transmitted "direct to the authority who had power to dispose of the case", who in this instance is the Staff-Paymaster.

The Staff-Paymaster's reply to me of 18th instant, was not shewn to me, and the minute II was endorsed thereon by my Staff Sergeant Clerk without my authority or approval. If Staff-Paymaster's reply had been shewn to me I should have seen at once that it did not deal with the question I asked him. I was perfectly well aware that Venereal ~~Manxixixix~~ Patients received no pay whilst in hospital; therefore would not have asked this question of the Staff-Paymaster.

The Staff Sergeant concerned has been instructed that in no case must he sign correspondence on my behalf.

(2). Noted.

I beg to bring the following facts under your notice:-

(a). When the proposal to form this Unit was first moved, the Minister of Defence asked me to put in writing my suggestions as to its scope and utility. I did so, and as the result of my report and personal interviews with the Minister of Defence and the D.G.M.S., it was decided that the Unit should be one

for the treatment of both Venereal and Skin Diseases.

This decision was come to, firstly, because Syphilis and Skin Diseases nowadays, are so bound up together, owing to the ~~xxx~~ difficulty of differentiation between the former and many of the latter without special pathological examination and observation for some days and secondly, because such a Unit as this was considered to be eminently suitable for treatment of infectious skin diseases.

It has often happened that cases have been sent in as venereal which have turned out to be skin cases.

(b). The establishment of this Unit as published in Military Order 696, of November 14th 1915, provides for "One Major, Syphilologist and Dermatologist" (See remarks column, page 8, of Military Orders, Australian Military Forces, November 16th 1915).

This would appear to indicate that this Unit was intended to treat Dermatological cases

Major Raffan, was offered the position of Syphilologist and Dermatologist, and only accepted it on the understanding that both these branches were included in his sphere of work.

(c). In the Military Order referred to, the Hospital is described as Australian V.D. Hospital. This was noticed as soon as the orders were received by the Acting O.C., in Sydney, and on November 29th a telegram was despatched by Major Raffan, Acting O.C., to Melbourne asking that the name should be changed to Dermatological for reasons mentioned in telegram, copy of which is attached hereto, in which the treatment of non-venereal skin diseases is expressly stated.

The matter was subsequently submitted to the Minister for Defence, who gave instructions that the name should be changed accordingly.

(d). No. 9 Stationary Hospital, Havre, which I was sent to inspect in order that this Hospital might be modelled upon it, treats both venereal and skin diseases.

(e). Often Patients are sent for admission here, who may or may not be Venereal Cases. How am I to dispose of them?

(3)(a). Would you inform me to what Hospital, I am to transfer

MEMO:-

Entry of Venereal Forfeitures in Paybooks.

Owing to the introduction of the new Paybook it has been found necessary to amend the system of entry of Venereal Forfeitures in soldiers' Paybooks.

It has been arranged that, as nearly all venereal patients pass through the Venereal Block, No 14 A.G.H., information as to the commencing date of the disease will be supplied to the Registrar, No 14 A.G.H., from Australian Records Section, 3rd Echelon, and that on discharge to Unit the whole period of forfeiture will be entered in the Paybook by the Registrar, No 14 A.G.H., in one entry. This will ensure that all men on returning to their Units have the amount of forfeiture clearly shown in the soldiers' Paybooks. Particulars of the entries made will be forwarded to Australian Records Section for comparison before entry in Part II Orders, from which the entry will be made in Pay Ledger Accounts.

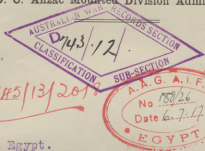
I shall be glad, therefore, if the following Order could be promulgated in next A.I.F. in Egypt Orders:-

VENEREAL FORFEITURE.

Para 11 Routine Order No 5 of 14th March 1917 is cancelled and the following is substituted:-

" All Units must take particular care that men suffering from Venereal Disease are clearly shown on B 213 with the date of evacuation sick to Hospital, especially stating if suffering from Venereal Disease."

1. Your attention is particularly directed to Circular Memo.No.263 of 26-7-18, a number of copies of which are sent herewith. Will you please circulate these to all Officers commanding Battalions, Companies, Detachments or other formations within your Command.

2. Please note that the provisions of paragraph 2 of such Memorandum, which incorporates A.I.F.Order No.1295 of 12-7-18, do not come into force until the 31st.July 1918. All awards made on and after that date will be affected thereby.

3. With regard to Circular Memorandum No.254 (as now amended by paragraph 1 of Circular Memorandum No.263) the following rulings have been made.

(a) Where a member of the A.I.F. has been charged before a Court of Summary Jurisdiction as a deserter under Section 154 of the Army Act and remanded to Military custody, the date of first investigation by such Court, is the date of first investigation within the meaning of A.M.Regulation, No. 563.

(b) Where a Company Commander investigates a charge against a soldier under his command, and himself makes an award, the date upon which he first investigates such charge is the date of first investigation.

(c) Where, however, a Company Commander does not go into the charge himself but sends it to the Commanding Officer, the date on which the charge is investigated by the Commanding Officer, is the date of first investigation.

(d) In the case of men on the strength of A.I.F. Depots in United Kingdom, remanded by the O.C., Troops, London, to be dealt with by their own C.O's., the date on which the charge is first investigated by the man's C.O., is the date of first investigation.

4. Please note that you should be careful to see that the date of first investigation set out by you in "Remarks Column" of Army Form, B.2069, is that of an investigation of the same charge as that of which the soldier is convicted.

CIRCULAR MEMORANDUM NO. 263
FORFEITURES OF PAY AND ALLOWANCES.

1. Circular Memorandum No. 263 is amended as follows:--

In paragraph 5(a) for the words "The Commanding Officer"
substitute the words " a Commanding Officer"

Insert new paragraph:---

(6A).The expression "Commanding Officer" as used in this Order,
in relation to a member of the Australian Imperial Force,
means the Officer or soldier's Commanding Officer for the
time being.

(Authority:-- A.I.F. Order No. 1275 of 28-6-18.)

2. With reference to Circular Memorandum No. 263 as amended by the
preceding paragraph hereof, the following system of calculating--
forfeitures of pay during absence, imprisonment and detention,
which is in accordance with an amendment to the Army Act which
will come into force on the 31st instant, will be adopted in
the A.I.F., Depots in United Kingdom, on and from that date:--

(1) The period of absence, imprisonment or detention
must be reckoned as from the time when the absence,
imprisonment or detention commences.

(2). If the period does not amount to six hours or
upwards no pay is forfeited.

(3). If the period amounts to six hours but not to twenty-
four one day's pay is forfeited whether the period falls
wholly on one natural day or partly on one natural day
and part on another.

(4) If the period exceeds twenty-four hours the number
of days' pay forfeited will be the period in hours divided
by twenty-four, any fraction over being counted as an
additional day.

With reference to Divisional Order No. 47 of 1st. February, para. 398, stating that "No Pay will be issued while abroad for any period of absence from duty on account of Venereal Disease", I shall be glad to have a ruling as to whether this is to be treated as an absolute forfeiture of the whole amount of pay inclusive of deferred pay during the period of absence from duty. Pay for the period is being treated by O.C's. of some Units as being withheld only, and not finally forfeited, and no entry is being made in Soldier's Pay Book: in other cases an entry is being made.

If the Order is intended to convey a final forfeiture, I shall also be glad of a ruling as to whether it is to act retrospectively or from the date of promulgation only.

ABSENCE FROM DUTY ON ACCOUNT OF VENEREAL DISEASE.

With reference to Divisional Order 452, of 11th inst., which reads as follows:-

"With reference to Divisional Order 398 of 1st inst., all periods of absence from duty on account of venereal disease, whether the man is admitted to hospital or not, are to be recorded in Part II Unit Orders.

Two entries will be made, the first the date of beginning of absence, the second the date of return".

I am to suggest the desirability of similar instructions being issued by you to other units of the A.I.F., and that in addition officers commanding hospital units be instructed that the names of men of the A.I.F. in hospital suffering from venereal diseases are to be recorded on Army Form A36 (in addition to being included on the copy of this form rendered to Army Head Quarters) which is to be rendered weekly by officers commanding hospitals to-

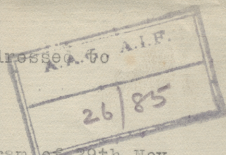

413. CANDIDATES FOR COMMISSIONS.

The nominees for training at Infantry Cadet Battalions in England (vide A.I.F. Orders 328 and 349 of October 1916) will be carefully selected in good time beforehand by Divisions, and for the period of one month prior to the date upon which they will be required to leave France for England, the nominees will be sent for preparatory training to Divisional Schools.

Candidates from Corps Troops may be sent for similar training to a Divisional School under arrangements to be made by the A.A.G., A.I.F.

2. In order to meet the still existing demands for direct commissions the number of above nominees sent to Divisional Schools by Divisions will be 25% in excess of the number sent to England monthly. Whilst the present allotment for divisions remains in force the number selected to attend Divisional Schools will therefore be 15 for each of 1st, 2nd, 4th, and 5th Divisions, and 8 for 3rd Division.

Approval of the B.O.G., A.I.F. must be obtained for any of the above nominees to be commissioned direct, but applications will only be made when Battalions are much below strength and Base demands are not fulfilled. In the event of any nominee being selected for direct commission his place in the Divisional School must be immediately filled.

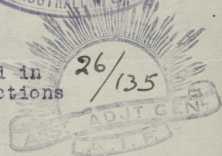

Hospital Stoppages.

With reference to A.I.F. Order No. 409 governing the above question, a ruling is requested as to the exact interpretation which is to be placed thereon.

In all cases where Hospital Stoppages, and other deductions from pay for disciplinary reasons are due, such are computed here and are published in the Part II Orders, issued from this Office, of the Unit to which the individual belongs.

In the case of self inflicted wounds, the practice prior to the issue of A.I.F. Order No. 409 has been that, where a man has been admitted to a special hospital and has subsequently been brought to trial, in the event of a conviction, stoppage of pay has been reckoned as from the date on which the man was placed under arrest until date of trial, on the ground that ^{was} he under arrest awaiting trial for an offence for which he was subsequently convicted, plus any forfeiture that may be due by reason of the sentence imposed.

This in most cases covers the period in hospital.

There are cases however where the whole period in hospital would not be covered, e.g. Cases have occurred where a S.I.W. case has been tried in hospital as soon as a man was fit to stand his trial and the Court has inflicted a minor punishment, say 14 days F.P. No.2, and the man has not been discharged until a date subsequent to the expiration of the sentence of the court.

In such a case stoppages have been reckoned in the past as from the date of arrest until the date of the expiration of the sentence imposed. This on the ground that the soldier having been tried, and having served the sentence imposed has expiated his offence and should not be liable to any further penalties in consequence thereof.

Under A.I.F. Order No. 409 Stoppages will now continue, in such a case until the man is discharged from hospital "Fit for duty". Is this interpretation of the Order correct?

A further case which at the present time is awaiting final action is submitted:-

A man was reported S.I.W.	28.8.16.
Admitted Boeschepe	31.8.16.
Tried by F.C.C.M. and awarded	
14 days F.P.	10.9.16.
Discharged to duty	24.10.16.
Joined Base	25.10.16.
Admitted to hospital (old wound)	1.11.16.
Evacuated to England	5.1.17.

In accordance with A.I.F. Order No. 409 this man is liable to stoppage of pay from 28.8.16 with the exception of the period from 24.10.16 to 1.11.16 and would appear still to be still so liable until he is either fit for service or finally discharged from the Force.

It is submitted that in the case of a S.I.W. 26/35
date of discharge from hospital to duty should be considered
as the termination of the period for which stoppages are
imposed under A.I.F. Order No. 409.

This suggestion is made for the following reasons :-

1. Responsibility for discharge from hospital rests solely with the medical officer.
2. It is possible, in some cases, that such discharge may be premature and that thereby a return to hospital may be necessitated for a very much longer period than would have been necessary had the discharge not been effected at the time it was.
3. Where a man has been returned to duty for a short period prior to re-admission to hospital due to the old self-inflicted wound, it may be argued that the nature of the duty imposed in the interval has been a contributory cause of the second admission to hospital.

These suggestions are put forward as points which are likely to be developed at a future date by the individuals concerned.

I desire to bring under your notice the question of men suffering from Venereal Disease who are practically out door patients. A large number of men in these Depots who are suffering from such complaints, attend 51st. General Hospital twice weekly for injections, they lose the afternoon of the day they visit Hospital, and are then off duty for 24 hours, - a day and a half twice a week - three days per week.

As the regulation forbids their being put on duty of any description during that period, the matter is submitted to you please for a ruling as to whether their pay is to be stopped on the days in question. These men are held up at the Depots for periods of two and three months, and are of little use for anything owing to their broken time.



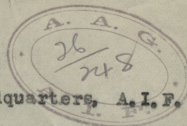

Forfeiture of Pay - Venereal Disease.

Referring to your 26/158 of 1.6.17., and A.I.F. Order No. 685 published on 8.6.17., it is desired to intimate that the provisions of this Order are not considered to be quite adequate, inasmuch as no provision is made for forfeiture in the case of members, who may be absent from duty on account of venereal disease, although not actually in Hospital for the whole period of such absence, and further, inasmuch as no provision is made for the forfeiture of field allowance in the case of officers.

2. It is therefore suggested that the A.I.F. Order referred to be cancelled and the following substituted therefor:-

"Forfeiture of Pay - Venereal Disease.

All members of the Australian Imperial Force will forfeit all pay and allowances, including field allowance, extra-duty pay and "deferred pay", for every day during which they are absent from duty on account of Venereal Disease or illness resulting therefrom".

3. As nowhere in Orders for A.I.F. is there any definite provision as to the circumstances in which an officer or a soldier forfeits his pay, either on account of venereal disease, self-inflicted wounds or otherwise, a paragraph providing for such forfeiture was included in suggested amendments and additions to Orders for A.I.F., recently drafted by the Chief Paymaster and forwarded to Defence on the 17th April last.

A copy of this paragraph, which deals with forfeiture of pay for venereal disease and self-inflicted wounds, as well as other offences under the Army Act and Commonwealth Defence Act, is enclosed herewith for your information.

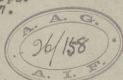

With reference to your P.1429/2/19. of 16/6/17., I am to inform you that it is not proposed to make any amendments to A.I.F. Order 685 re forfeiture of pay for Venereal Disease, except that the words "and field allowance" should be inserted after word "pay" therein.

It is published in the same terms, except that it now includes Officers, as the previous Order (409) on the subject, and with the above addition, it is considered meets the purpose in view.

It is not considered advisable to make any provision for forfeiture of pay for venereal disease when the patient is not in hospital: firstly, because in the ordinary course all V.D. patients should remain in Hospital until cured, and secondly, because of the administrative and record difficulties involved.

The word "pay" as used in A.I.F. Order 685 will, as a matter of ordinary interpretation include deferred and extra duty pay, to which it is not considered necessary to make special reference.

With regard to the question of forfeiture of pay for self-inflicted wounds, it is pointed out that the terms of A.I.F. Order 686 were adopted deliberately after full consideration. There is a general order in France which provides for trial by Court Martial of all cases of self-inflicted wounds when such are regarded by the competent authorities specified as being either due to wilful maiming or to negligence. In view of this and also on general grounds it was decided that a soldier should not suffer the stigma of being recorded as a self-inflicted case and suffer forfeiture of pay therefor unless he had been convicted by Court Martial for the offence. It was specially desired that the award of a C.O. should not be regarded as sufficient for this purpose.

For the above named reasons the terms of the suggested addition to Orders for the A.I.F. sent by the Chief Paymaster to Department of Defence are not concurred with, and I am to ASK that you inform the Chief Paymaster that matters of this kind involving policy are not in future to be sent to Melbourne without first being submitted to this Office for the approval of the G.O.C., A.I.F.

It is requested that the following amendment be made to War Financial Regulations.

Regulation 37 of the War Financial Regulations dated 28th February, 1917, (Statutory Rules 1917, No. 49) is repealed and the following regulation made in lieu thereof. To take effect from 1st September, 1917.

- 37 (i) Notwithstanding the provisions of Regulations 13 and 13A in regard to the forfeiture of pay in certain circumstances, any allotment made by a member of the A.I.F., to his bona fide dependants will, except in the case of discharge or dismissal as hereinafter mentioned, be continued to be paid during the period of such forfeiture, provided that the amount of such allotment does not exceed the prescribed rate for private (e.g. for wife only, 2/- per diem, and for wife and children 3/- per diem). An allotment payable to a bona fide dependant and exceeding the prescribed rate will be reduced to such rate and be continued accordingly for the period of the forfeiture.
- (ii) In addition, Separation Allowance will continue to be paid to the allottee of a private who is already in receipt of same, and will also be paid to the allottee of any other member who is undergoing stoppage of pay, on the same conditions and at the same rate as if the member were a private, but where the forfeiture has been incurred in Australia the amount of separation allowance will be limited to 2/- per diem.
- (iii) No payment under this regulation will exceed the amount originally payable to the allottee.
- (iv) Where the forfeiture has been incurred abroad, any sums paid to dependants under the provisions of paragraph (i) and where the forfeiture has been incurred in Australia, any sums paid to dependants under the provisions of paragraphs (i) and (ii), will be deducted from any amount standing to the credit of or becoming due to the member concerned, and should there be a debit balance against his account on the expiry of the period of forfeiture, the reduction in the allotment shall continue until the debit is liquidated, the member's drawings being restricted to an amount not exceeding 6^d per day for a soldier and 3/6 per day for an Officer.
- (v) In the case of a member who is sentenced by Court Martial to dismissal or discharge from the Australian Imperial Force, all payments to or on account of such member, whether to dependants, or otherwise, will cease on and from the date of the award of the Court.

FORFEITURE OF PAY.

I enclose herewith copies of amendments of War Financial Regulations, Nos. 37, 13, 13A and 13B., which have now been approved by the Governor-in-Council.

2. Regulation 37 is amended in accordance with the new provisions regarding Separation Allowance and is extended to include all ranks.

3. The particulars as to the "prescribed rate" mentioned in paragraph (i) are set out in War Financial Instruction 108.

4. Regulation 13 is merely intended to set out definitely the interpretation of the term "forfeiture" as applied to the A.I.F. and it is not thought desirable that the Regulation should state the conditions under which pay is forfeited as these are prescribed in the Defence Act and the Army Act and the publication of the paragraph as suggested in "Amendments and additions to Orders for the A.I.F." might give rise to conflicting ideas and rulings.

5. Regulation 13A is in accordance with your letter (F.1429/2/19) of 9th July, 1917, and A.I.F. Order 685 of 8th June, 1917.

6. Regulation 13B promulgates a decision by the Minister, and takes effect from 3rd July 1917 as that was the date on which paragraph (4) of Regulation 37 was cancelled. This decision (which was notified you by cable, WX646 on 5th October 1917) was made on the grounds of "consideration for the feelings of relatives" and it is therefore essential that all reference to such forfeitures should be kept out of the final statement prepared for the next-of-kin. In order to effect this the amount shown therein as Pay Debits must exclude V.D. forfeitures, for if the remission of such forfeitures were to be shown as a credit, an explanation would be necessary. To facilitate the preparation of the final statements on these lines you were asked, in the above-mentioned cable, to make the necessary adjustments by deduction from ledger debits before the despatch of non-effective statements in the future. With regard to the past, it is noticed that in most cases the non-effective statements distinguish between V.D. forfeitures and other forfeitures, but in the instances where non-effective statements have been despatched during the last six months containing no reference to the nature of the forfeiture it will be necessary for you to furnish particulars, to enable District Paymasters to

The approval for remission under this Regulation applies to all forfeitures incurred on account of V.D. during the whole service abroad of any member whose death has occurred on active service, except those whose accounts have been finally settled prior to 13th October, 1917.

7. With reference to your letter of 28th May, 1917, and other correspondence, in which you point out that nowhere in the Army Act, King's Regulations, or Orders for the A.I.F. is there any definite authority to forfeit pay of soldiers suffering from V.D.. I may state that in F. & A. Regulations (which are issued under the Defence Act) Regulation No. 265 contains the following provision:-

"the full pay of any soldier admitted to hospital
"or treated in quarters for V.D., or on account
"of sickness the result of offences committed
"by him, shall be stopped."

This is considered sufficient authority to cover all such forfeitures in the past.

PAY - CHRONIC VENEREAL PATIENTS ATTACHED
FOR DUTY.

With reference to the question of pay of the Australian Soldiers chronic V.D. cases who have reported at your Station for duty and treatment, please note that the pay of these men will not be forfeited for the days they are performing duty, but that pay will be forfeited for any day or days that these soldiers do not perform duty on account of the disease.

The forfeiture of pay for the days these soldiers are absent from duty on account of the disease will be shown on a supplementary return (as per sample herewith) and attached to your weekly A.F.S. 213. The forfeiture will be entered in Paybook and will be at the full daily rate less Deferred Pay, i.e. for a Private who forfeits pay the daily rate will be 5/- (6/- less 1/- deferred = 5/-), for a Corporal 8/6 (10/- less 1/6d = 8/6d) and so on. No mention is to be made of Venereal Disease; the entry in Paybook will be endorsed "Hospital Stoppages" under heading "Place" and the entry in Paybook for a Private will be as follows:-

The above example, of course, as you will observe allows for 16 previous entries having been made in a Paybook the progressive total of which amounts to £13.

These soldiers will in all probability be considerably overdrawn. It is therefore to be clearly understood that payment at the rate of 5 francs per fortnight only can be made until the overdraft is liquidated.

(1) An Officer or a soldier who is convicted by a court-martial, or a soldier who is awarded punishment by his Commanding Officer, of or for an offence which, under the provisions of the Army Act, or the Commonwealth Defence Act, entails forfeiture of pay, will forfeit for each day during which pay is forfeitable the whole of his daily pay including deferred pay, field allowance, and any amount which may have been earned as extra duty pay.

(11) An Officer or a soldier will also forfeit all pay as in the preceding sub-para. hereof for every day during which he is absent from duty without leave or while in hospital as the result of disease or injury caused by his own misconduct, including venereal disease, alcoholism, self-inflicted wounds etc.

3. A copy of this office memorandum of the 9th July last, referred to in the above quoted communication from Department of Defence, is attached hereto for your information.

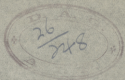

685) in respect thereto, the G.O.C., A.I.F., did not consider it advisable
to provide for forfeiture of pay except where, and for the period
during which the member concerned is actually "in Hospital".

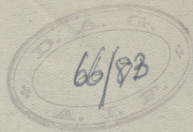
Prior to the issue by the G.O.C. of the Order referred to, on
8th June, 1917, it was our practice to forfeit the pay and allowances
of members suffering from venereal disease during the period of absence
from duty, and irrespective of whether they were actually in Hospital,
in accordance with your cablegrams W.10174 of 29/1/1915, WY 234 of
15/12/1915; Orders by the late Major General Bridges No. 396 of 1/2/1915,
452 of 11/2/1915; and A.I.F. Order No. 409 of 20/12/1916 by the G.O.C.,
A.I.F.

FORFEITURE OF PAY - VENEREAL DISEASE.

With reference to your memorandum 26/248 of the 7th instant, addressed to the O.C. 1st, 2nd and 3rd A.C.C.S., of which a copy was forwarded for information to the Chief Paymaster, it is desired to know whether that portion of the first paragraph which reads -

"that the pay of these men will not be forfeited for the days they are performing duty, but that pay will be forfeited for any day or days that these soldiers do not perform duty on account of the disease." -

is intended to mean that pay will be forfeited for any period during which the soldiers are absent from duty although they may not actually be in hospital. If so, such a ruling would apparently conflict with A.I.F. Order No. 685 which provides only that pay will be forfeited while in hospital.

2. In this connection I would refer you to your 26/158 of 25/6/1917, replying to my 1429/2/19 of 16th idem, which reads inter alia -

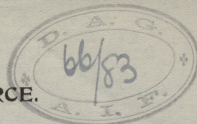
"It is not considered advisable to make any provision for forfeiture of pay for venereal disease when the patient is not in hospital; firstly, because in the ordinary course all V.D. patients should remain in hospital until cured, etc....."

Upon the receipt of your communication above quoted, a cablegram was despatched to Defence amending, in accordance with your decision, a suggested amendment to Orders for the A.I.F. which had previously been forwarded to Melbourne. This matter was referred to in my 1429/2/19 of the 10th instant in which I forwarded you copies of the correspondence between this office and the Department of Defence.

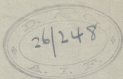

With reference to your F.1429/2/41 of 17.11.17 I am to inform you that the instructions contained in this office 26/248 of 7.11.17 are designed to cover the special circumstances which arose owing to the despatch by the D.G.M.S., G.H.Q., without the concurrence of this office, of a number of convalescent venereal patients for employment at Casualty Clearing Stations and for supervision and treatment (when necessary) until final discharge as cured.

These special instructions are not to modify in any way the ordinary procedure laid down in A.I.F. Orders regarding forfeitures for venereal disease.

The necessity for the query contained in the first para. of your memo. is however not very clear since the instructions, being addressed to the three Casualty Clearing Stations only, apply merely while the men are at these hospitals, and if off duty through suffering from venereal disease there can be no question of their not being in hospital at the time. In its essentials the matter is not one, as you appear to assume, concerning the deduction of pay from men suffering from V.D. when not in hospital, but is one which relates to the allowing of pay in the special circumstances of the case, to V.D. patients who are in hospital.

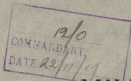

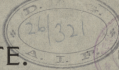

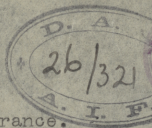

It has been brought to notice that one of the causes of unrest and dissatisfaction among the Australian troops in Venereal Hospitals in France is connected with their voluntary allotments of pay.

Apparently in the case of an Australian soldier who has made an allotment of pay, such allotment continues during the time he is in a venereal hospital, and the total sum thus paid to his family is subsequently deducted from the pay earned by him after discharge from the hospital.

It is understood that any member of the Australian Imperial Force forfeits the whole of his pay for every day in a Venereal Hospital. Consequently an Australian on leaving the hospital starts with a big debt, and is only allowed to draw a modified rate of pay until such debt has been cleared. (In a few exceptional cases, the allotment has been stopped when men have been in hospital for a long period).

The result is that the men on discharge from hospital are often low spirited, and while in hospital labour under a grievance in comparing their treatment, as regards allotment and loss of pay, with that of British troops in the same hospital.

I am of opinion that some modification of the rule as regards total loss of pay while in Venereal Hospitals, or some alteration of the system as regards the piling up of debt due to allotments, would have a good effect on the moral of the Australian troops concerned.
