

Cairo.	1st.March,	Correspondence, which has passed between the Residency and the Foreign Office during the months of January and February relating to the jurisdiction to be set up for Venizelists in Egypt, is received from the Residency, and submitted to the Commander-in-Chief. A Proclamation is attached calling on Venizelists who wish to come under the Commander-in-Chief's protection for judicial matters to declare themselves.	
		Interview with Venizelists representatives, Mr. BOUBOULIS and Mr. SACTOURIS, and Dr. ROUSSOS of Alexandria. They explained that they were disappointed that it had not been possible to issue a Proclamation calling on Royalists to declare themselves as such rather than one calling on Venizelists to declare themselves. They were somewhat apprehensive as to the results of the election as they fear that Venizelists will see in the declaration that they were called on to make, the "thin end of the wedge" compulsory service.	
		Lieutenant St. Quentin brought Lieutenant Cambon, who has been sent by the French Government to organize recruiting of Syrians in EGYPT to introduce him. He was informed that this question was still under consideration by the Commander-in-Chief.	
		It has now been ascertained that the capture of the three Officers who escaped from Sidi Bishr was mainly due to the fact that they were not in possession of "Seaman's Passes" which have been recently instituted.	
		An Officer was sent to El Arish with our Agent, who is proceeding to KERAK (referred to on 24th. February) in order to make arrangements for him to pass through our lines, and to facilitate the entry of his sub-Agents hereafter.	
		Proclamation has been signed by the Commander-in-Chief regarding residents in the Canal Zone travelling to BALLAH, KANTARA and SUEZ.	
		Foreign Officer telegram (forwarded from Residency) said that Colonel TALBOT had been informed by Italian Delegate of arrangements for exchange of prisoners of war captured on western frontier who are now on their way to the vicinity of GHEMINES.

A refugee who left SIWA on the 25th. February, reports that the Oasis is now clear of Senussi, the last band of marauders having left for the west on the 19th. February. There has been very heavy rain and the roads are all flooded in parts and impossible for cars. There are rumours of Turkish Officers coming Eastwards with guns to join SAYED AHMED at JAGHBUB. This does not meet with MOHAMED IDRIS' approval, and the latter talks of sending troops to JAGHBUB to control the situation. The exchange of Italian prisoners is on the point of being settled with IDRIS, and it is hoped that AHMED may remain dormant at JAGHBUB until they are actually handed over.
