



Stores undamaged have been shipped on board "S.S.BOORAL" which is due to sail to-day (5.1.1920).

With reference to the 3rd.Military District Demand forwarded to D.D.O.S., Royal Arsenal, Woolwich under your 4D/6509/7/18/1 dated 19th December 1919, I am directed to observe that seven of the latest design 18-pdr. equipments Mk.IV guns and Mk.III or III carriages, are asked for.

It appears that these are not required for training purposes, vide last paragraph of our letter, number as above, dated 13th March 1919 (copy attached for reference), seeing that no breech mechanisms or limbers are included in the demands; no reply to this letter can be traced.

The position regarding this equipment is that at present several essential modifications have not been embodied and it is not proposed to issue any equipments until these modifications are embodied which must necessitate many months delay.

Will you now say whether you wish completely to equip the Unit referred to in your letter with 15 Mk.II 18-pdr. equipments and await a notification of the possibility of obtaining new design 18-pdrs. before submitting any demand for them.

The demand is returned for amendment in accordance with your wishes.

Sir,

With reference to your 57/20/1200 (A.2.) of the 3rd inst., returning my Demand 3.M.D./b/5 dated 1.12.19 for 18-pr. and 4.5-inch Guns and Carriages (without fittings) intended as "Reserve Spares" for the Field Artillery Equipment of the Post Bellum Army of Australia, I am directed to state that a slight misunderstanding appears to exist in regard to the pattern of 18-pr. material with which it is the intention to equip the Australian Forces. In my 6509/5/13 dated 7.2.19 (copy attached) you were requested to state whether it would be ·possible to procure at a later date 18-pr. equipment of the latest pattern to the extent of half our total requirements. Following this, your 092/1596(Q.M.G.10.A) dated 28.2.19 was received in this office, the concluding paragraph reading as follows :-

"The supply of 18-pr. Equipments of the new pattern, Mark IV, is only sufficient to cover the requirements of the forces in Great Britain. It is not therefore feasible to issue equipments of this pattern to Dominion Governments at present. The current demand on the manufacturers is not likely to be completed before the end of 1919 at the earliest, there would therefore be no possibility of supplying the Dominions before 1920 when fresh contracts would have to be entered into. The financial aspect of the issue of a new pattern equipment would require consideration with reference to the existing financial agreements between the Imperial and Dominion Governments."

that we should equip half the Force with the then latest pattern, Mark II, and, at a later date demand Mark IV Equipment for the remainder, was placed before the Minister for Defence. In this connection I am to invite your attention to para. 6 of my 6509/7/18/1 of the 28th March last, which read as follows:-

" As stated in letter above (4309/9/1 dated 14.3.19) the Artillery Equipment at present to be demanded (Q.F.Mark II carriage) will be about one-half of the total establishment of 5 Infantry and 2 Mounted Divisions, the remainder may be demanded later as above, or Q.F.18-pr Mark III Carriages and Mark IV Guns may be demanded in lieu."

- 4. The proposal mentioned in the commencement of the preceding paragraph was subsequently approved by the Minister for Defence but, unfortunately, the decision does not appear to have been officially communicated to you. This omission is regretted.
- 5. The position may now be summarised as follows:
 - (a) Total number of 6-gun 18-pr. Batteries to be equipped 48
 - (b) No. of 6-gun 18-pr. Batteries to be equipped with Mark II Guns ... 24
 - (c) No. of 6-gun 18-pr. Batteries to be equipped (later) with Mark IV Guns ... 24

In regard to (b) the submission of demands for this Equipment is now practically complete.

Preparation of demands for the equipment under (c) is being left over until all other demands have been submitted.

6. The demand returned with your letter of the 3rd. inst. is for a percentage of "Spare" Guns and Carriages (without fittings) as a "Reserve" for the equipment under both (b) and (c). For the sake of convenience they were included in one demand, although it is realised that the Mark III Carriages and Mark IV Guns may not at present be available. The demand is returned herewith.

Adverting to your letter of the 12th ultimo, No. 57/20/1758 (F.5.R.V.), on above subject, I am anxious to submit, for your information, the following points in connection with the question of liability for the "initial" supplies (of our various Divisions) of ammunition to our Divisions serving in Egypt and France.

- organisation of our Divisions took place in Egypt during the first six months of 1916, resulting in equipment, arms, etc. etc. being issued both by Imperial and Australian Depots to bring the equipment, etc. of those Divisional Units up to the then current Mobilisation Store Tables, the part-worn material replaced by the new issues from both sources being handed over to Imperial Ordnance. In this connection, the financial arrangements with your office were -
 - "per capita" charge (i.e. 6d. per man per day for period 1st January to the 31st July 1916, that sum being comprised in the 5/- capitation rate charged for the maintenance of our troops then serving in Egypt), as well as forego any credit due for the material, etc. handed over to the Imperial authorities during the period stated, in full settlement of the whole of the issues from Imperial stocks.
 - (b) that all new issues from Australian stocks would remain as a final charge against our funds.
- a reasonably established fact that we initially equipped the whole of the Units comprised in those Divisions (i.e. 1st. 2nd. 4th and 5th Divisions and two Mounted Divisions) during that period with ammunition in accordance with Mobilisation Store Tables, though it is regretted that no detailed data are at present available to permit of this specific point being absolutely substantiated.
- 4. I might say that the four Infantry Divisions . referred to, immediately after this re-organisation, proceeded to France, the two Mounted Divisions remaining in Egypt.
- 5. With regard to our 3rd. Division (the equipment of which was practically completed in this country about the end of 1916 when that Division proceeded to France), I am to

(Cont'd)

state that investigation is now proceeding with a view to determining whether the "initial" supplies of ammunition to that Division were provided at A.I.F. expense, and as soon as definiteness in this connection is reached, you will be duly advised.

6. It is, however, pointed out that no "initial" supplies (under M.S.T.) of ammunition for 8-inch or 9.2-inch howitzers used by the Australian Forces in France, were provided at Australian expense. In all cases, however, as you know, we have discharged our liability for all ammunition consumed by our Forces in France and Egypt by inclusion of those charges in your capitation claims.

Report called for in connection with Post Bellum Equipment damaged or destroyed on S.S. "BOOHAH".

at the outset I would invite your attention to the attached copies of correspondence which clearly set forth the arrangements made between this Branch and 2.D. in regard to the procedure to be followed in the shipment of Medilisation Stores to Australia and the responsibility for the safe custedy of the Stores during transit and in course of shipment.

Following these arrangements, particulars of some two thousand tons of equipment available for shipment were furnished to 2. D., it being understood that accommodation had been urranged per S.S. "BOONAH" sailing in December.

On Monday the 15th. of December, advice was received that the "BOOMAH", into which a portion of the above equipment had been placed, was on fire at the Albert Docks. A representative of this Branch was immediately sent to ascertain some idea of the extent of the damage and to safe-guard the interests of 4.D. by ensuring that every possible step was taken in the matter of salvage.

After the whole of the material had been removed from the "BOOBAH" the Port of London Authorities intimated that it was impossible to allow the damaged equipment to remain upon their premises. Endeavours having been made without success to secure suitable accommodation in the neighbourhood, the stores were eventually brought by lorry to these Headquarters.

The chief concern of this Department now being to establish the extent of the losses and damages, it was suggested that a complete tally be taken of the equipment remaining at the Docks. This task would have entailed a great deal of labour, but in the opinion of 4.D. it was the most satisfactory method of arriving at our losses. The project, however, was abandoned, as a definite assurance was furnished by both 2.D. and the representative of the Shipping Company that detailed particulars could be arrived at from documents in their possession.

had been made upon the re-shipment of the undamaged pertion of the consignment into the "S.S. BOORAL". It was then pointed out to 2.D. that an absolutely reliable tally of the equipment shipped per "BOORAL" was indispensable to this Branch, as only by deducting

such quantities from the total consignment could the actual losses and damages (to be accounted for at this end) be accordance. An assurance was again given by 2.D. that this information would be forthcoming in due course.

This occurence has thrown a considerable amount of extra work on this Branch. Vouchers covering the whole of the original consignment were ready for despatch to Australia, and the volume and intricate hature of the task of extracting from those voushers the articles which were, according to information supplied by 2.D., not actually shipped, and bringing them to account at this end, will be realised. Notwithstanding that the utmost care has been exercised, it is feared that certain minor dicerepancies between the stores shipped and those charged by Voucher to Australia may be subsequently revealed, inasmuch as considerable difficulty has been experienced by 2.D. in establishing the identity of certain articles, such as Oil Drums etc., which are of course not enclosed in packing cases. Further, it is felt that in the case of certain articles which are "bundled" for shipment, the bundles may have become disintegrated during the course of loading, unloading and reloading, and so may not now coincide as to contents with the bundles originally described on the vouchers.

Full particulars of the stores shipped per "S.S.BOORAL" have not yet been received from 2.D., but it is anticipated that the last batch will be available to-day.

In the meantime the identifiable equipment salved from the "BOONAH" has been brought to account and is being prepared for Board of Survey. It will be understood that the quantities totally destroyed cannot be set down until full particulars of the "BOORAL" shipment are received from 2.D., and a thorough reconciliation is effected.

A complete list of the losses due to the fire will be drawn up as early as possible for depented to Australia, in order that the matter of replacement may be taken up.

Acquittance. It is noted that no acquittance is to be given by this Branch for any goods issued. The only papers signed will be Carrier's notes and Railway Vouchers.

Losses in Transit. With reference to this question, the experience of this Branch is that with such quantities, losses are bound to occur both by mil and ses.

as this Branch will be arranging shipment, it is suggested that we should initiate claims for losses in Francit. Any shortpacking, will of course, only be noted in the examination of undamaged cases, bales etc., when taken into Sepot in Australia. Ordnance Service there would then claim on the Imperial Authorities for these shortages.

Longes by rail will be noted by our loading representative at Fort in England. Damaged bales will be checked and re-packed. Report on lesses giving bale numbers etc., will be forwarded to 4.0., with a view to pricing for claim, and to making fresh indent to replace.

a report on allaged bales will also be forwarded to australia, to enable the check as to lesses on shipboard to be made.

Louges by Sea should be noted at off-loading port in Australia and claim made direct on Shipping Company at that Fort.

SHIPMENT OF EQUIPMENT FOR POST BELLUM ARMY OF AUSTRALIA.

The arrangements in connection with the above matter, which were made at a personal visit to your Branch, are now set out hereunder for confirmation, please.

- (1) The Issuing Depots have been requested to forward to 4.D. two "advance" copies of Issue Vouchers for stores reported ready for shipment.
- (2) The documents mentioned in (1) will, after registration here be passed to your Branch. The matter of shipping space will then be taken up by you and, when same has been secured, "forwarding instructions" will be sent from your Branch direct to the Issuing Depot. When the stores have actually been shipped one copy of the Issue Voucher bearing the name of vessel and date of sailing will be returned by you to 4.D; the remaining copy being retained in support of shipping documents.

It should be clearly understood that in no circumstances should a copy of the Issue Vouchers mentioned above be signed, as receiving the goods, and returned to the Issuing Depot. Acquittance will not be given until stores have been landed in Australia and checked in detail. Further copies of Issue Vouchers will be obtained for this purpose. These, however, will not concern your Branch.

I shall be glad to have your views in connection with the possibility of, and responsibility for, losses between the time goods are placed on rail, etc. by the British Authorities, and the time delivery is taken by the Ordnance Department in Australia. To eliminate the possibility of losses in transit is of course, impracticable. At the same time, owing to the technical nature of much of this Equipment and the length of time that would be occupied in securing replacement, it is particularly desirable that every precaution be taken to avoid losses. The necessity for clear responsibility in regard to the recovery of value of losses will also be obvious to you.

POST BELLUM ROUIPMENT DAMAGED OR DESTROYED ON S.S. "BOONAH".

The first consignment of post bellum army Equipment was to have been shipped by the s.s. "BOONAH", and loading commenced in early December.

The ship was on fire on the night of 15.12.19 slongside No.1 Shed, Royal Albert Dooks. Captain Scouler of 2.D. and Captain Hammond of 4.D. visited the ship on the morning of the 15th. The fire was not then under control but was in hand in the afternoon. It was noted that considerable damage, mainly by fire, had been done to some of the Fost Bellum equipment - this was in No.4 Hold. A small quantity of storeeth No.6 Hold was damaged by water.

was offloaded. Undamaged equipment was placed in No.1 Shed alongside the steamer. Damaged Stores were offloaded into lorries and brought to 4.D. store at Norseferry Road. The balance of the consignment totalled over eleven-thousand packages. As alarge number of these, consisting of practically all the Didcot stores, were not marked in a manner which would permit the checkers on the ship to note information which would definitely assign them to their Issue Vouchers, the final check of stores loaded had to be made very carefully, but in spite of this considerable difficulty has been experienced, in finalising papers. Difficulty has also arison owing to the manner in which packages have been numbered in some sections. It has been noted that in one section there were as many as 5 sets of repeated numbers for sack-markings, and several sets with cases.

Bundles of pickheads, crowbars, ets. have also come forward unnumbered, and where these packages have broken they have, of course, been recoopered and loaded.

Had one set of numbers only been used in each section, and had all packages been numbered, and almost definite check should have been obtained although there are always discrepancies in large and varied-chipments such as this one.

The Issue Vouchers for this consignment have now been noted and passed to 4.D. showing shipment. It is considered probable that discrepancies will be noted on the check being made in Australia, but it should be understood that these discrepancies if more that normal have been caused owing to the circumstances above mentioned and are unavoidable.

The shipment of undemeged goods has finally been made by s.s. "BOORAL", sailed 10.1.20.

with reference to shipment of Stores by S.S."BOORAL", the following points were noted:-

Heavy goods such as axes and Wedges, were packed in cases which could not stand the handling entailed under ordinary shipping conditions. In some cases the boxes were not new.

Some of the crates used for packing were also not sufficiently strong.

Some goods, notably from Didcot, came forward with no distinguishing mark which the checkers could note to enable the Issue Voucher concerns to be located. A consecutive numbering of cases and bundles in each Section would considerably simplify checking. In Section I several sets of serial numbers commencing from No.1 have been used, both for sacks andcases. In the lower numbers on sacks markings have been repeated as many as five times, and with cases several times.

In offloading trucks from Didcot the numbers of packages from various trucks differed from those shown on the consignment note although the total offloaded was correct.

In the matter of numbering it might be suggested that difficulty is experienced with articles such as bundles of Crowbars. Anvils, etc., but perhaps it may be possible to arrange that a tag. either metal or cloth, be attached by wire, marked to identify the package.

In regard to your 121/Overseas/7370 (A.3.) of the 15th ultimo, relative to the issue of Steel Helmets in connection with the re-equipment of the Australian Imperial Force, I am directed to inform you that fresh consolidated demands for these helmets have now been submitted to the D.D.O.S..

Further, I am to ask when particulars regarding the financial aspect of this case may be expected from your Department. This matter was dealt with in my 6509/7/18/1 of the
13th November last. The closing of A.I.F. Camps in the United
Kingdom has revealed further quantities of steel helmets, bringing the number held at our Salvage Store from 3,075 to approximately 10,000 and thereby strengthening our request that the
general principle of a "free issue" be extended to this item.

The helmets in our possession are, in common with other war equipment handed in Overseas, the property of the Imperial Government. I am therefore to request that particulars be furnished as to when and where the number mentioned above may be handed over.

With reference to the issue of Mobilisation Stores for the re-equipment of the A.I.F., I desire to bring to your notice that considerable inconvenience has been caused in connection with shipment and the recognition of ullaged packages by the fact that serial numbers were not in all cases marked upon the packages issued from Didcot.

I might mention that in reply to a letter from the War Office regarding the marking of this equipment, the D.E.O.S. was notified that all packages should be marked. "in the manner customary to the Ordnance Department", meaning of course that each package would bear, inter alia, a serial number. It is presumed that the terms of my reply were transmitted to your Department.

This matter has been taken up with the Authorities at Didcot by my representative in person, but it is deemed advisable to officially place the matter on record.

Further inconvenience has been caused in this office by the fact that vouchers from Didcot do not in all cases shew the designation of the consignee, e.g. "S.O.O., Sydney" or "S.O.O., Melbourne".
