

#### 29th July, 1914.

Cablegram from Secretary of State for the Colonies -

"See preface Defence Scheme. Adopt precautionary stage. Names of Powers will be communicated later if necessary. (1877/9/1)".

#### 30th July, 1914.

Cablegram from Secretary of State for the Colonies - Received 3.35 p.m.

"With reference to warning telegram sent you, it is not intended that examination service should be enforced against ships although all necessary steps may be taken for its institution".

This communication was forwarded by the Official Secretary to the Minister of Defence. - dated, Sydney 31:7:1914.

#### 31st July, 1914.

Major C.B. White (Director of Military Operations) left Melbourne by express (5.0 p.m.) to interview Minister of Defence in Sydney.

#### 1st August, 1914.

Cablegram dated 1st August sent to Minister of Defence on 2nd August -

"See Defence Scheme. Enforce examination service at all Defended Ports".

Minister for Defence approves.

Naval Board to issue accordingly and first to notify Chief of the General Staff.

## 2nd AUGUST 1914. Lunday.

Message received from Prime Minister at 10.30 a.m. for responsible military officers to meet him at his office (Treasury Buildings)

The Brime Minister discussed with officers the arrangements for putting the precautionary stage into force.

Prime Minister directed all officers to stand by until communications from Minister of Defence were decoded.

"Please issue instructions for adoption of precautionary stage at Defended Ports. Thursday Island Garrison not to leave Townsville without orders"

At 3.30 p.m. Prime Minister sent for Secretary, Major Reynolds and Captain Griffiths.

"Adopt precautionary stage Defence Scheme"

Telegram to Commandant, 1st Military District - 4.30 p.m. -

"In connexion with message regarding precautionary stage troops detailed from mainland for garrison Thursday Island will be mobilized but not embarked until further instruction".

All members of Board were ordered to come into Headquarters

showing that His Excellency the Governor-General has been requested to cable to the Secretary of State for the Colonies that censorship of all cable and wireless communications has been adopted from 5 p.m. on 3rd August, and that Colonel J.W.McCay has been appointed Deputy Chief Censor in Australia.

"With reference to warning telegram in view of the strained relations with Germany be on your guard against the possibility of attack in advance of any formal declaration of war. Understand clearly that this is not war telegram"

"Can supply number highly suitable staff cadets as junior officers to assist central administration or District Commandants. Reply at once if I shall visit Melbourne with proposals"

" 4284 Could Commonwealth Government nominate if required candidates for commissions in British Regular Army as follows from Royal Military College Augusalia. 20 to be shared by Australian and New Zealand Cadets not less than 18 years of age who have completed at least three years period of course. On nomination of Governor-General 20 who are qualified or would be likely to qualify under existing regulations for obtaining commissions from Dominion Forces. If so will you secure names satisfy yourself as to the suitability of etcetera and arrange medical examination of. If mobilization is ordered names should be telegraphed and branch of service for which recommended. Forwarding of names would guarantes be guarantee of commission. New Zealand informed of offer to R.M.C. Cadets. Colonial Office approves".

"Cypher R to be used on all operation messages"

Letter from Naval Secretary -

"Code messages on Government Service for transmission by wireless telegraphy from Thursday Island will be prefixed by code word "Glynhunt". You are to certify accordingly to censor for each message".

Naval Secretary informs Secretary for Defence that censorship of wireless communications was put into force on 5.5 p.m. 3/8/1914.

"Referring to your telegram 3rd August His Majesty's Government greatly appreciate prompt readiness of your Government place Naval Forces of the Commonwealth at disposal of Admiralty and generous offer to equip and maintain expeditionary force. Will telegraph later on the latter point".

Telegram from Secretary of State for the Colonies, dated 4th August, 3.5 p.m. transmitted through Official Secretary to His Excellency the Governor-General.

"Though there seems to be no necessity for any request on our part for expeditionary force from Australia I think that your Ministers would be wise in view of their generous offer to take all necessary administrative steps by which they would be enabled without delay to provide such a force in case it should hereafter be be any contagion."

N.B. This message is endorsed by Cable Company "Correction is to follow".


