Feb.	10		I visited 1st and 2nd Divisional Signal Corps and found that everyone appears to be well satisfied re their demobilisation; A large percentage are desirous of Non-Military Employment before demobilisation. This, I think shows good sense as it will in most cases benefit these men considerably.	
	2.		1st. Embarkation quota " from Corps Signal Company left here today. Consisted of one officer (2/Lieut. Sladen) and 50 O.R's. All these men were very jubilant as the lorries departed with them for Charleroi from whence they leave by train for Havre.	
	3.		Communication received from Army asking whether it could be arranged that Divisional Signal Companies do with less Motor Cycles or any vehicles. Sent to O.C's Div. Sig. Coys. for early report. Notification received re the opening of an Aust. Officers club in Brussels.	
	4.			
	5.		Notification received from D.A.G. that approval given for promotion to Major of Capts. (T/Majors) C.H. Joseph, M.C. and J.M. Grant, M.C. also that Capt. Tinkler's (2nd. Div. Sig. Coy.) suggested promotion to T/Major and to command 5th. Div. Sig. Coy. was not approved but that Capt. Tinkler could proceed to take command of 5th. Div. Sig. Coy. with his present rank. This I consider most unfair and a bad attitude to adopt at this stage of the Campaign. It means that for an officer 4 years of commissioned rank in the field his work is thought that much of. 2nd. Draft of Corps Sig. Coy. personnel left today for return to Australia. 2/Lieut. Purdue in charge of 23 other ranks. This makes a fair clearing out of 1915 men of the Company. More satisfaction than heretofore now prevails.	
	6.		I made arrangements for Corps Wireless Officer to visit 1st. M.G. Btn. for purposes of lecturing on wireless.	
	7.		Lecture to Bn. a success and another visit asked for when it is convenient. All roads in a pretty bad condition with snow which is now freezing. Asked that, D.R.L.S. run to 2th. Aust. Division be cancelled today. "G" Staff refused. Don't know how the D.R's will reach this or any other place.

	18.		Received an allotment of Imperial Personnel for Demobilisation. This will affect the Corps Heavy Artillery as all their Brigades are composed of Imperial Personnel. The allotment is two per day but it will not always be possible to send two per day from these Brigades as they are somewhat depleted just at present.

NEW PROCEEDURE. All Companies except 3rd Divisional Signal Company advised that Operators trained in new proceedure.

NEW PROCEEDURE MODIFICATION OF. Modifications as per suggestion by 1st Div. Signal Company adopted.

"IN" REGISTER. Resolved to continue to keep this.

NEW FORMS Resolved that Companies warn their respective staffs re indenting for new forms.

PROPOSALS RE NEW M.S.T. President advised that recommendations of Divisional Signal Companies would be collected for information and circulation amongst Companies.

TOURING CARS FOR COMPANIES. Resolved that substitution of a box car (tender) for present touring car would be agreeable to Company Commanders.

BAGGAGE WAGGONS FOR BRIGADE SECTION. Resolved that Brigade Sections should have their own transport provided for within the Unit.

BELGIAN COMMUNICATIONS. A Public Telephone was recommended in Offices where civilian traffic called for it.
