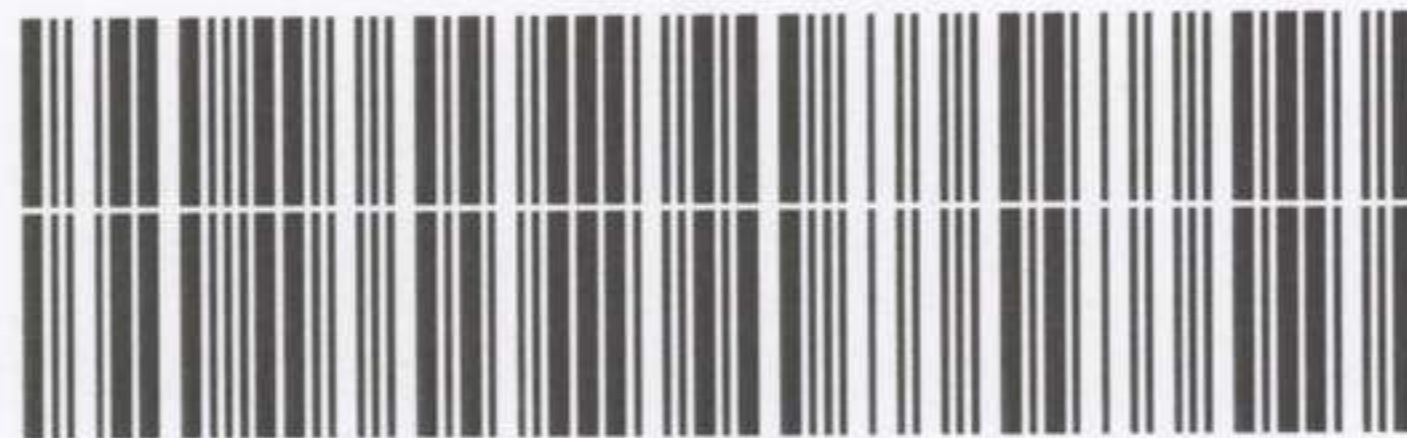

			<p>The strength of the Unit on 1/5/19 was 5 officers 57 O.R.^s " " " " 9/5/19 " 3 " 20 O.R.^s</p> <p>From the 1st of May until 13th of May the remainder of the Unit was engaged in cleaning up and in preparing for the final evacuation to the Base en route to the United Kingdom.</p> <p>On 5/5/19. Capt. Chaplain S. M. Baird was evacuated to U.K. and struck off strength.</p> <p>On 6/5/19 Capt. R. V. Langdon M.C. & 2/Lt. H. Taylor with 34 O.R.^s marched out to Le Havre & were struck off strength.</p> <p>On 13/5/19 the last Company Routine Orders were issued. Cadre B consisting of Lt. E. P. Horn, Staff Sgt. Gutterin W. F., Sapper Cicals-Moris J., Sapper Newton T. & R.Q.M.S. Loggie A. B. with a Stores Guard of 5 O.R.^s marched out to Calais, where the Stores were handed over to A.O.D. Beaumarais.</p> <p>On 14/5/19 R.Q.M.S. Loggie A. B. embarked for England & for demobilization & discharge in U.K.</p> <p>On 15/5/19 The personnel of the Unit consisting of Lt. E. P. Horn & 8 O.R.^s left for Havre.</p> <p>On 17/5/19 5015 Spt. Smith S. S. was admitted to hospital.</p> <p>On 20/5/19 Lt. Horn with 7 O.R.^s arrived at Hurdcott Camp, England.</p>
