



CIRCULAR MEMORANDUM NO "Q" 25S A L V A G E.

1. While in this area Units must go into the question of Salvage thoroughly. Units are responsible for salvage :-


- {a} In and around their Battalion Camps and Billets,
- {b} Immediate vicinity of works carried out by units,
- {c} Any line or posts held by men of the unit
- {d} The area allotted on attached map.

2. Units will allot for salvage work a party of men who will be placed in charge of an N.C.O. of sufficient initiative and energy to carry out the work, in such a way as to ensure that measure of success, which is demanded by the importance of the work.

3. All units will establish at least one salvage dump, which will be cleared periodically and delivered to Brigade Salvage Dump by regimental transport. Brigade Salvage Dump is situated at Brigade Transport Lines, near BULFORD CAMP. Units will be supplied with "SALVAGE DUMP" notice boards on demand.

4. When handing in salved stores to Brigade Dump units will insist that a receipt is obtained from Brigade Salvage N.C.O., in order that Units may obtain full credit for their work. Clothing will not be received at Brigade Salvage Dump.

5. Steps should be taken to impress on all ranks the absolute and urgent necessity of salvaging all waste and apparently useless articles and material. The immense importance of this work does not appear to be realised as it should be. If the men were made to realise that all these arduous and unpleasant tasks were just small aids to the "Big Push" and that every article salved is just one step nearer to the successful termination of the war, there would probably be a greater amount of energy and impetus put into the work, which up to the present has been most conspicuous by its almost entire absence.









SMALL BOX RESPIRATORS.

1. The following paragraph is taken from S.S. 193 STANDING ORDERS for GAS DEFENCE.

"In the READY and PRECAUTIONARY ZONES the following rules will be observed:

(i) Anti-gas appliances will be inspected at least once a week, and immediately before men proceed to any point within the ALERT ZONE".

2. It is evident, from the returns sent in during the last three weeks, that there are large numbers of respirators which are not inspected ~~which are not inspected~~ in accordance with the Order quoted above.

3. Each unit now has personnel, specially trained in anti-gas measures, who will not be employed on other duties to the detriment of the work of inspection.

4. Recent inspections have shown that in many cases the Anti-Dimming Composition is not present. The proper and regular application of this paste facilitates very much the prolonged wearing of the respirator.

5. Instances occur where the Record Card is not present, and many more, where the Card is neither dated nor filled in. These Cards should have the date of issue stamped upon them - not written - and it would be preferable to have the cards tied round the neck of the canister. The periods of drill are not now entered upon the Cards.

#### S A L V A G E.

AUSTRALIAN CORPS Scheme for salvage is repeated for information and action of all concerned :-

"The following scheme has been adopted for Salvage work in the AUSTRALIAN CORPS Area :-

#### SALVAGE SCHEME FOR AUSTRALIAN CORPS AREA.

1. PERSONNEL: Each Brigade will detail one Officer and 30 men to be engaged solely on salvage. These parties will work under instructions from the Divisional Salvage Officer. Divisional Salvage Officer will detail one N.C.O. to be attached to each Brigade, and one other rank to each Battalion, this N.C.O. will be responsible for Brigade Salvage returns and the other ranks for the battalion returns.
2. AREAS: The Staff Captains of each Brigade, in conjunction with the Divisional Salvage Officer, will subdivide each Brigade area into Salvage Areas, and the unit occupying the Salvage area will be responsible that the salvaged is collected into dumps and disposed of by 1st Line Transport to the Brigade Salvage Dump.
3. DUTIES: A dump will be established for each Brigade in the line beside a loop in the light railways or on the main road that ration wagons use. Those dumps will be as far forward as circumstances will permit. The Brigade in the Reserve or Support Area will establish a dump at the most convenient place for all units in the Brigade. This dump will also be on a loop in the light railways or the main road. Each Battalion in the line will establish a dump at the head of the communication trench that carrying parties must use when returning from the line. The battalion will also establish a dump at a point where ration wagons or ration trains off-load. The Divisional Main Dump will be established at CONNAUGHT Railhead.
4. SCHEME: Battalions in the line will be responsible that the line is cleared, and also any salvage that may be in the vicinity of the line. Salvage collected will be placed either at the Communication trench dump, or at the ration transport dump. Every Officer in charge of carrying and working parties returning from the line will be personally responsible that each man of his party carries some salvage to the ration transport dump. The Brigade Salvage Officer will have this transport dump cleared by returning transport to the Brigade Salvage Dump. The Divisional Salvage Officer will have the stores salvaged, evacuated from this dump. The Brigade in reserve or support will clear their own Salvage under instructions from the Divisional Salvage Officer. The Brigade Salvage details will also be engaged on clearing "Pockets" in the area and will co-operate with the Divisional Salvage Company. Units will be responsible that their own Area is clear of Salvage.
5. AMMUNITION: Abandoned gun positions will be cleared by Salvage parties working in the Area. Care will be taken that reserve gun positions are not interfered with.
6. R.E. STORES: R.E. Stores will be collected in Dumps, and the Staff Captain of the Brigade notified of the location and contents of the dumps.



Will you please forthwith reconnoitre the area North of the PLOEGSTEERT-LE CHEER Road with a view to submitting to the consideration of Divisional Headquarters a comprehensive scheme for the Machine Gun defence of the Second Zone in this area.

The role of our Machine Guns in the Second Zone may be considered as being fourfold, and they must be prepared to act in any of the capacities enumerated hereunder:

- (1). Barrage M.Gs. in defence of the successive defensive lines of the Second Zone;
- (2). Sniping guns for the purpose of engaging enemy targets which may present themselves;
- (3). Counter-attack M.Gs. for the purpose of following up our infantry in counter-attack and subsequently consolidating on or in the vicinity of the objective gained.
- (4). Machine Guns for the pursuing by fire of an unsuccessful attack by the enemy.


It is proposed, however, to devote the major portion of our energy to the consideration of barrage guns.

In making your reconnaissance will you please site your guns in such a manner as to ensure that the maximum fire effect may be obtained from them if called upon. To this end it will obviously be unnecessary for you to provide for a continuous beaten zone along the whole front of the Second Zone for two reasons which are as follows:

- (1). There are certain areas on the ground in question over which it would be impossible for any troops to operate;
- (2). The number of Machine Guns at our disposal are very few for the extent of front which it is required to defend.

In submitting a scheme to Brigade Headquarters resulting from your reconnaissance will you please consider your Company as having 20 Machine Guns on establishment.

The necessary maps and every facility will be given to you in order to portray the principles of the scheme as clearly as possible.

It has now been decided to move more to the North the centre of activity as far as the work of the Brigade in the Second Zone is concerned. In other words, more attention will in future be directed to the construction of defences in Nos. 3 and 4 Sections of the Second Zone.

While it is not intended that the defences undergoing construction in Nos. 1 and 2 Sections should be abandoned, it will be necessary to relieve troops in those two areas in order that sufficient men may be available for work on Nos. 3 and 4 Sections. All units will be notified in due course of the consequent readjustment of working parties which will not take place for a few days.

It is considered that the more probable course of action which may be adopted by the enemy is an attack in the direction of HILL 63 from the MESSINES RIDGE rather than an attack launched from a South-easterly direction, hence the change in works policy which it is proposed to carry out. Units will therefore devote as much time and energy as possible to doing everything that knowledge, care and judgment can effect in making the defences of the Second Zone very highly efficient.

All ranks should be infused with a spirit of energy and enthusiasm in the prosecution of the works in hand as well as those projected, in spite of adverse weather conditions and arduous hours of work.

All works and working parties are to be very carefully organised in order to obviate waste of effort. This calls for the personal consideration by all Officers of the minutest details in connection with the construction of defences and the action of our troops in the event of a hostile attack.



Patrols. A patrol reports that six of the enemy came through a gap apparently to examine the wire at U.18.a.07.94. They crawled down which fired on by a machine gun and were not seen again. The wire seems to be in a good condition on both sides of the above gap.

One of the enemy was soon to run through a gap in the wire near U.18.a.23.45; he appeared to be repairing the wire. An enemy patrol was observed to be moving S.W. along the river bank near the COULON. Our patrol withdrew slightly but the enemy patrol did not come further. Patrols working in U.23.b. and U.17.d. report all quiet. The patrol working up the BASSE VILLE-WARNETON road was unable to go further than about 50 yards owing to activity of machine gun in SPINNEY. The road is badly knocked about and almost unrecognisable in parts. The enemy use more white Very lights than usual but there was no apparent resultant set on.

ENEMY ACTIVITY.

Artillery. More active than on the previous day. The enemy appeared to be registering DOJVE WALK, WALLY SUPPORT and USEFUL LAND. U.11. was shelled from COKINES and BLANC COULON. areas. U.10.a. " " " BLANC COULON area.
