





		2		Wire received from Fourth Army, hastening report on ceded Guns, etc. Previous instructions were not received here, hence the delay.

appendere 62 A. AUSTRALIAN CORPS. 77/010 Headquarters, 2nd January 1918. ADMINISTRATIVE INSTRUCTIONS No. 13. MOBILIZATION EQUIPMENT. It is realised that Units are deficient of stores which were not used, or it was impossible to carry, but, with a view to correct adjustment on Demobilization, all Units will immediately hold thorough equipment inspections and submit indents under the following headings for all deficiencies :-I. Lost or rendered unserviceable prior to 11-11-1918, which are required. II. Lost or rendered underviceable prior to 11-11-1918, which are not required. III. Lost or rendered unserviceable since 11-11-1918, which are required. IV. Lost or rendered unserviceable since 11-11-1918, which are not required. Indents under I and III will be rendered in duplicate; under II and IV in triplicate, and endorsed with the statement of the category under which they come. Officers Commanding Units will render certificates through the usual channels to reach AUSTRALIAN CORPS by 14-1-1919, on the following pro-forma :-"I certify that I have held a thorough inspection of the equipment of this Unit and submitted Indents to complete to scale laid down in latest Mobilization Store Table amended by G.R.Ob. and Q.M.G. Authorities. This is the last opportunity of completing equipment, and it is essential that great care be taken in the preparation of these indents, as deficiencies on Demobilization will be the responsibility of the Officer Commanding the Unit.
