

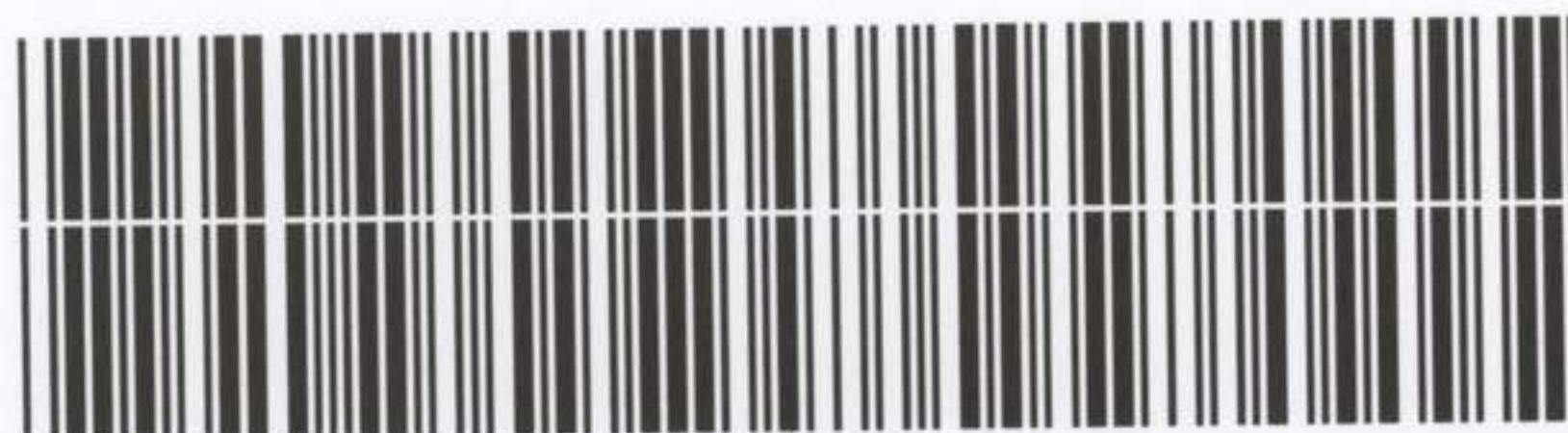

<u>GENERAL REMARKS.</u>				
During the month the process of Demobilization of both personnel and stores proceeded smoothly. Considerable difficulty, however, was experienced in disposing of the remaining horses. It was not until the 29th April that the majority of them left for BOULOGNE, with the result that many men for No. 45 Quota were instructed to join the Quota at HAVRE direct from BOULOGNE. <u>TRAINS FOR ORDNANCE EQUIPMENT:</u> These were slow in arriving, with the result that a very large number of vehicles and a large quantity of stores had accumulated with D.A.D.O.S. at OISEMONT. <u>EDUCATION:</u> Education within units was continued up to the last. Arrangements for Educational Staffs for Quotas were in all cases made by the Divisional Education Officer. <u>HEALTH OF TROOPS:</u> In view of the inclement, wet and cold weather, the health of the troops was exceptionally good. -

8. Accommodation at GAMACHES Concentration Camp allotted to Camp Staff, Canteen, Y.M.C.A., etc. will not be altered.

9. No 1917 personnel will be included in quota (except bandsmen and "B" Cadre) without reference to this Headquarters.

10. R.M.Os Embarkation Quotas detailed by the A.D.M.S. will be responsible for the inspection of all personnel of Quotas as soon as possible after concentration and within 48 hours of arrival in Camp.

All cases of V.D. will be evacuated immediately.

All cases of Scabies or other skin disease will be isolated and subjected to vigorous treatment.

Within 24 hours of entrainment of Quota, R.M.O. will hold a final inspection, all cases of V.D. and Scabies being immediately evacuated.

DEMobilIZATION.3rd. April, 1919.CIRCULAR MEMORANDUM No. 38.REGIMENTAL FUNDS AND CANTEEN ACCOUNTS.

1. Reference 3rd. Aust. Div. ^{Demob.} Circ. Memo. No. 28 dated 14-3-19. Under the provisions of A.I.F. Order 1584, the 3rd. Aust. Divn. Embarkation Quota Trust Account established by 3rd. Aust. Div. Circular Memo. No. 28 becomes inoperative for the purpose for which formed. The balance at the credit of this account will therefore be refunded to units whose Regimental Funds Accounts are still in existence in proportion to the amount originally paid over to the account.
2. Under the provisions of A.I.F. Order 1584 dated 21-3-19 each demobilization quota will on formation receive an allotment of £20.
3. This sum will be drawn by D.H.Q. from the Divisional General Trust Account and the C.O. Quota, commencing with No. 29 Quota, will be handed a pass book with a credit of £20.
4. This sum will not be used by the C.O. Quota until after departure from the Divisional Area. Minor claims whilst at the Concentration Camp will be traced as far as possible to units concerned, and forwarded there for necessary settlement.
C.O.s of Units represented in each Embarkation Quota will make whatever provision possible for their men whilst at CAMPS awaiting entrainment, as if they were present with their unit.
Extra messing will be provided by D.H.Qtrs. in the way of tinned foodstuffs on the arrival of a truck of these goods ordered from PARIS. Payment for this truck is being made from the Reserve Fund of the Divisional Canteens.
5. The Divisional Canteens will also make a distribution of brown boot polish sufficient for the needs of each quota.
6. A Divisional Retail Canteen has been established at the Concentration Camp to supply the needs of troops.
7. The Divisional Canteens have purchased an adequate supply of mess gear for the Officers' Mess - a charge of 50 francs per quota will be made plus the cost of breakages.
8. It will be noted from A.I.F. Order 1584 that each Quota while in HAVRE and the U.K. will be provided for from the Regimental Funds of the Depots.
9. On embarkation, the Chief Paymaster will advance to the O.C. troops a sum calculated at 2/- per head for all ranks. It is understood that a further provision of foodstuffs and comforts to the value of £100 is also being provided on each transport by Aust. Comforts Fund.

Appendix No 3.DEM OB I L I Z A T I O N .CIRCULAR MEMORANDUM No. 39.5th. April, 1919.FINALISATION OF REGIMENTAL FUNDS ACCOUNTS.

The following procedure will be adopted in regard to the finalisation of Regimental Funds Accounts:-

Regimental Funds will be retained by units as long as required to provide for the comfort of troops still remaining with the unit.

When troops are attached for purposes of demobilization to another unit an amount of say 5/- per head for all ranks so attached will be handed to the unit concerned to provide for the comfort of the troops attached. This amount will be paid into and form part of the Regimental Funds of this unit.

This instruction, however, does not apply to troops transferred to an Embarkation Quota concentrated at GAMALIES (vide 3rd Aust. Divn. Demob. Circ. Memo. No. 38 dated 3-4-19)

When a unit ceases to exist and the Regimental Funds Account is no longer required, the C.O. Unit will forward to this office a final statement of the account together with a certificate that to the best of his knowledge and belief all liabilities have been met. The balance at the credit of the account will then be transferred to the 3rd. Aust. Divl. General Trust Account held by the Divisional Paymaster.

After the closing of the Regimental Funds Account by this transfer, any claims which may be rendered against the unit will be paid by Divisional Headquarters from the General Trust Account.

After all liabilities have been met, the balance of the Third Aust. Div. General Trust Account will be finally disposed of in accordance with A.I.F. Order 1575 dated 7-3-1919.

Appendix No 4DEMobilIZATION.CIRCULAR MEMORANDUM No. 40.7th. April, 1919.

1. With reference to Demob. Circ. Memo. No. 29, Embarkation Quota which is now concentrated at GAMACHES, will entrain at GAMACHES at 09.30 on 9th. April, 1919, and depart for HAVRE at 10¹⁵6.
2. C.O. No. 29 Embarkation Quota will be responsible for the entrainment and will make his report on completion to the Staff Officer from this Headquarters in attendance at the GAMACHES.
3. C.O. 3rd. Aust. M.G. Batta. will have those warned as "Emergencies" standing by to fill any vacancies which may occur at the last moment.

Appendix No. 5.DEMobilIZATION.CIRCULAR MEMORANDUM No. 41.8th. April, 1919.

1. (a). It has come to the notice of the Divisional Commander that men are arriving at the Concentration Camp GAMACHES with boots which are in such a bad state of repair as to be unfit to last the short period prior to arrival in Depots in the United Kingdom.

In the case of No. 29 Quota this was particularly noticeable in some of the Divisional Units.

(b). C.O's will in future ensure that all men marching into the Concentration Camp are properly equipped in this respect, arrangements being made within Regiments for the repair of those boots which need it. New boots should not be issued for this purpose.

2. (a). As units are concentrated, the Areas vacated must be thoroughly cleared of all salvage which will be disposed of as follows:-

1. R.E. Material will be collected into a dump and the C.R.E. notified of its location and contents. A Guard will then be placed over this material until it has been collected by the C.R.E.
2. Ordnance material will be returned to D.A.D.O.S. under Regimental arrangements.

(b). Regiments will report to these Headquarters within 72 hours of an Area being vacated that action as above has been taken, and will also report by noon 11th. inst. that all areas already vacated have been cleared of all salvage.

3. Units are responsible that all men are Medically Boarded before arrival at the Concentration Camp, and advantage must be taken of one or other of the Boards set out in D.R.O. 2154 of 30th. March.

In future no men will be sent to the Concentration Camp who have not been Medically Boarded except by special arrangement with C.O. Quota. Under no circumstances will men who have not been medically boarded be accepted at the Camp after the Monday of the week in which the quota to which they belong is due to depart.

DEMobilIZATION.April 14th. 1919.CIRCULAR MEMORANDUM No. 43.

1. The following will be brought to the notice of all ranks -

Owing to the rapid departure of Embarkation Quotas from the Division, applications for Early Repatriation (Forms 537) will not be received at Divisional Headquarters after 15/4/1919.

The following applications will not be submitted after 24/4/1919 -

Form 535. Applications for discharge outside Australia.

Form 539. Applications for Extended Leave.

Form 540. Applications for Non Military Employment.

If any member of a Unit desires to submit an application under any of the above headings, every facility must be given him in order that it may be sent to Divisional Headquarters before the dates mentioned.

2. Personnel detailed for duty at Aust. Base Depots, HAVRE, will be struck off the strength of their original units, and will be demobilized by the Depots.

Units and Aust. Base Depots will forthwith exchange nominal rolls of such personnel to ensure that the transfer is accurately carried out.

3. Personnel attending Aust. Corps Central School, RUE, Aust. Corps Technical School, and Aust. Corps Workshops, JEUMONT, have been allotted to No. 48 Quota, and will be struck off strength of Units accordingly.

4. When a Unit demobilizes personnel attached to it, but belonging to another Unit, the latter unit will be immediately informed so that it may strike them off strength.

5. Casuals discharged from hospital will not rejoin their units in future, but will be sent direct to Aust. Base Depots, HAVRE.

1. In order that all ranks may be acquainted with the position as regards demobilization of the Division, and in order to ensure that all members of the A.I.F. at present in the Divisional Area have been included in the 7th. and 8th. Quotas from the Division, the following instructions are issued.

2. According to the figures of the Census of the night 6/7th. April, 1919, the following numbers in this Division were due for repatriation:-

CIRCULAR MEMORANDUM No. 48.

The following communication issued by Demobilization Section, A.I.F. Depots in U.K., is promulgated for information of all ranks:-

"ACCOMMODATION ON TROOPSHIPS FOR WARRANT OFFICERS AND SERGEANTS.

"Complaints have recently been made by Sergeants, on their embarkation, that they have been informed by their Officers that the reason they have not been sent with their Quotas is that they are kept back for other Transports WHERE BERTH ACCOMMODATION WILL BE PROVIDED FOR THEM.

2. Any such promises that Berths will be provided for Sergeants are quite unauthorised, and the G.O.C. will be glad if the situation, as stated hereunder, is fully explained to Sergeants who at any time, have to be omitted from the rolls of the Troopship by which their Quota sails.

3. The circumstances are as follow:-

The normal berth accommodation on Troopships is quite inadequate for the large proportion of Warrant Officers and Sergeants attached to Quotas, but on representations made by this Headquarters, with a view to "speeding up" the repatriation and Demobilization of such W.Os and Sergts, the Department of R. & D. has made special provision, where facilities offer, for an increased number of Sergeants on Troopships, SOLE OF WHOM, HOWEVER, MUST TRAVEL IN HAMMOCKS. Accommodation cannot be provided on all ships, and this means, of course, that some W.Os and Sgts. cannot embark with their Quotas, but will be provided for as soon as possible after their Quotas leave".
