

	July	-	A second Officers' Mess started in No. 5 Camp to-day.

	3rd.		Lt. Gen. Sir H.C. Sclater, G.C.B, G.O.C C-in-C, Southern Command and Brigadier-General Laundaloy accompanied by Brigadier-General E.G. Sinclair Maclagan, director of Training, A.I.F Depots, arrived at the Depot this morning and went minutely into the organisation of the Depot; the kitchens and lines were inspected and the C-in-C. expressed himself as highly pleased with everything, especially with the kitchens and the splendid dietary provided for the troops. He promised to do everything in his power to expedite the erection of the new hut promised by the Y.M.C.A, but expressed the opinion that the shortage of timber might retard the completion of the project. At 8.45a.m to-day, in the presence of all Officers, the Commandant promulgated the finding and sentence of a General Court Martial dismissing Lieut. H.H.Walker, 44th. Battalion, from His Majesty's service, this Officer having been found guilty of falsifying his paybook and breaking arrest.

	14 th.	-	Colonel McWhae (A.D.M.S, A.I.F) visited the Depot to-day and went into the matter of providing additional Dental Officers.	
	15th. to 17th.	-	Nothing to record.	
	18th.	-	A 5 h.p petrol engine installed in Depot Sausage Factory; this engine was purchased from Regimental Funds and was installed at a total cost of £47;10;0. Prior to its provision, the mincing was done by a machine operated by hand labour, which necessitated the employment of a fatigue party all day of from 8 to 10 men according to the physical category of the men employed. The adoption of the power plant will permit of the	
			the whole of the mincing of meat will be carried out between 4.30 and 6 o'clock each morning, thus permitting of the meat being delivered fresh to the kitchens. Under the old method, the meat was minced during the ordinary working hours and was frequently found, on the following morning, to be tainted.	
			The Commandant conferred with the A.P.M, A.I.F at Salisbury with reference to arrangements made at the Depot to secure the arrest of men alleged to be trafficking in forged leave passes and railway warrants.

	July 22nd	-	Five prisoners escaped from No. 7 Camp guard Room detention at 6.30.p.m. Patrols, etc., were turned out and the whole of the escapees were recaptured and returned to the detention room at 7.45.p.m. All the men are scheduled as desperate characters; one of them, after having been handcuffed in a cell, slipped the handcuffs and passed them through the ventilator.	
	23rd		Yesterday's escapees remanded for trial by District Court Martial. Colonel Knox (A.A.G) visited the Depot this afternoon. A meeting of all Officers of the Depot held to arrange for a Sports Meeting.
