MEDICAL.

67

Recently a certain number of men with Scabies or Pediculi (Crawls) have been struck off Boat-rolls at the final Medical inspection before embarkation. Pediculi can be rapidly removed and Scabies can be cured in 5 days, so that if these men had reported earlier they would have been cured in time to allow them to embark.

All ranks with any skin irritation or who have any suspicion that they have any skin complaint, especially if they are likely to be placed early on Boat-rolls, should parade to their Medical Officer for examination at the usual sick parades.

It is also in any man's own interest to see that he is inoculated with Influenza Vaccine and that necessary entries are made in his Ry-Book. If Ry-books are not available he will be given a certificate of inoculation which will be signed by the Medical Officer.

Further, many cases of Gonorrhoea can be cured by early treatment if men report early enough. It is also, therefore, to the advantage of men to report for treatment immediately they notice any signs of a discharge because, by so doing they may be cured in sufficient time to allow them to embark with the remainder of their Quota.

The R.T.O. at station of entrainment will select a suitable place of assembly for the troops in close proximity to the station, and on no account must troops be allowed to enter the station building or occupy any platform used by the public until orders are received from the R.T.O. The Depot Entraining Officers should report to the R.T.O. for instructions 15 minutes before the arrival of troops at the Railway Station.
The troops must arrive at the Railway Station 30 minutes before the scheduled time of departure of the train and all entrainments must be completed at least five minutes before the time set down for the departure of the train.
The R.T.O. will superintend and give all instructions regarding entrainment, which must be carried out in a quiet and orderly manner.
Units are to be entrained in order of precedence commencing at, and filling the compartments from the front, or rear, of the train as directed by the R.T.O. Infantry will be entrained in order of sequence of Battalion numbers and, as far as possible, all men of a Battalion must travel on the same train.
