

24/3/16. No. 1608, Private R. Henshaw, 12th Battulion, A.I.F. died at Sydney Hall Mospital, at 5.45 A.M., from pneumonis.

Accidents etc.

21/3/16. No. 1454, Frivate D.F. Milnes, 2nd Battalion,

A.I.F., had a pass into Weymouth, but went into Dorchester, and boarded a train back to Weymouth at
about 11.0 P.M.

Leaning against the door of the carriage, it opened, and he foll out, and the train passed over his left foot, which had to be amputated a few inches above the ankle. Proceedings of a Court of Enquiry are being submitted on the case.

Health & Sanitation.

Auxiliary Hospital.

A hut has been converted into an Auxiliary

Hospital in which men who are indisposed for a few days

and not removed to hospitals are accommodated.

This scheme has worked admirably insomuch as hitherto such men usually lay about the huts, greatly to the inconvenience of themselves and the other occupants of the huts, but now are attended to by a medical staff and have greater comforts than those they would enjoy in their huts under the old conditions.

Hutments.

Stocktaking Boards have already been held, which form the subject of separate communications.

This has resulted in the losses and damage being greatly minimised. A system is now in vogue under which, if the officer in charge of a hut fails to report loss or breakage on completion of his daily inspection, and such loss or breakage cannot be traced to the individual responsible for same, the cost of such breakage or damage is charged against the officer responsible for the hut, with the attendant result that officer display more interest in government property than heretofore. Further, if such breakage or damage is reported by the officer in charge of the hut, but cannot be charged to any individual, the cost of such loss or breakage is either paid from Regimental Institute Funds or struck off charge.

The water supply has not been efficient of late, owing to an unserviceable meter. This matter is now in the hands of the Barrack Department.

SUBJECT: - Sanitary Report for month of March.

I have the honour to forward attached reports on the sanitation of Monte Video and Westham Camps for the month of March.

The health of both Camps has been good and there have been very f few cases of Infectious Diseases. 1800 men have attended for Medical treatment during the month, the percentage of daily sick being 1.9 % of the total strength.

The following cases of Infectious Disease have occurred during the month:-

Venereal Disease..........109

Scabies..... 37

Measles..... 3

Mumps..... 2

and one case of suspected Cerebro-spinal Meningitis. A definite diagnosis has not yet heen made of this suspected case, but all precautions such as Isolation and treatment of contacts have been taken.

Venereal Disease.

In view of the large number of venereal cases, the following routine will in future be adopted at both Camps:-

All men undergoing risk of venereal infection will be urged to attend at the dispensaries in the camps within 24 hours of running the risk to undergo preventitive treatment.

This treatment will be given under the supervision of trained orderlies.

A lecture will be given to all N.C.Os and men during the first week of each month in which it will be pointed out that in the vast majority of cases, preventative treatment will prevent venereal disease if

if carried out effectively and early enough, and men will be urged to attend for this treatment.

Also Venereal Enspection of all N.C.Os and men in the Camps will be held once a month.

Innoculation against Cerebro-spinal Menengitis.

During the month innoculation was carried out at Monte Video Camp against Cerebro-spinal Meningitis, and two injections were given with one week interval between each.

SANITARY & PIONEER REPORT

Report of Monte Video Camp, Weymouth, for the month ending March 31st 1916.

Roads & Paths. New paths have been formed from Offices to Horse shelter and from top of A.S.C. Hut to Horse Shelter.

The completion of re-building and metalling all paths from Hut No. 1. to Hut No. 25 has been executed. A new pathway has been formed from Hut No. 83 to Lower Incinerator in Upper Field.

The quagmire around Horse Shelter has been removed and good paths have been formed all round shelter with large rubble-shingle and top dressing making a very satisfactory and solid work.

The paths round M.I. Hut, Q.M. Stores, Hut 26 have been thoroughly repaired.

All paths and roads have received reparation from time to time and as necessary, this work was slightly delayed in the earlier part of month owing to shortage of shingle. This has now been remedied as about 130 tons of shingle have now been delivered.

Surface Water Drainage.

old and existing open rubble channels have been cleared and reformed to proper falls as necessary -- the system is now doing its work as satisfactorily as required.

All sewers are disinfected twice weekly, entrances to sewer from latrines etc. scrubbed out daily, no trouble of any description has occurred in any part of system during the month.

Latrines and ablutions.

The contractor for night soil removal is fullfilling his work in a proper manner.

The latrines are in a perfectly sanitary and good condition. The Ablution houses are clean and in good working order.

Water Supply.

Work has commenced with regard to improvement put forward for building tank or reservoir storage supply from point on Hill 60, and should be completed in 2 or 3 weeks.

Water Supply.

The supply otherwise is as usual and reports of shortage at Top Cookhouse and Upper Field still occur.

Huts.

The Huts, otherwise from many leaks in various roofs, as already reported, are in good habitable condition.

Glazier.

The Glazier has put in 194 panes of glass during the month majority being put into living hits.

Bath Houses.

The mens' half of the Lower Bath House is now solely used as an isolation bath house. The buildings are in a clean and proper condition. The H.& C. supplies are satisfactory.

Carpenter & Joiner.

New shelving has been fixed in Cook Houses.

Officers Mess. - Framing has been fixed over entrance and a screen made and fixed in lavatory.

Dental Surgery .- 3 partitions, with opening and 2 doors have been fixed also shelving and cupboard.

H.Q. Office.- I draft card cabinet has been made.

Six shelves have been fixed in Officers quarters, locks, boxes, bolts, window catches, step, floors etc., have been repaired or renewed as necessary throughout the camp.

Cook Houses.

4 New 100 gallon coppers have been supplied and fixed to cook houses, the cost of same being defrayed by Depot Regimental Institute Funds.

Ironmongers.

The stoves of huts are dilapilated in some cases and part missing in various cases- full list of same has been submitted to DORE.

Incinerators.

The incinerators are doing all work required and are

now being renovated with fire bricks and fire clay as deemed necessary.

Painter.

In the Surgery in Dental Hut, the walls have had distemper 1 coat The posts of fence round garden have received twice distempered.

The garden in front of Officers' mess has received much attention the beds having been well stocked with herbacious roots and annuals and seeds.

The drive has been recovered with thin top dressing.

SAMITARY & PIONEER REPORT of Westham Camp, Weymouth, for the month ending 31st March, 1916.

Roads and Paths.

The paths have been picked up and reformed where sufficient old metal was available, but paths need further attention which they can now receive owing to the delivery of shingle at the end of the month.

Surface Water Drainage.

All existing open surface channel drains have been opened up and rubble removed and channels cleaned.

New channels have been cut where found to be necessary.

Sawers.

to sewers cleaned daily.

There have been no reports of trouble during the month in connection with general sewerage.

Latrines & Ablution.

The latrines generally are in good sanitary condition and working order though in many cases the back doors, for removing pans, are off, these should have new garnets fixed to rectify same, requisitions have been put in for this work.

In the ablution houses all leaky and broken taps have been repaired and houses now are in good condition.

Night soil contractor has properly fulfilled his contract with one case of lateness only, and in which case arrived immediate:

WaterWSupply.

The water supply is undoubtedly unsatisfactory, the water has at times been "off" twice in one day. the duration for which it has been cut off is in many cases for hours.

This lack of proper supply is liable to create dissatisfaction and complaints in the work necessary regarding cleaning W/

latrines, ablution houses and cook house working.

Huts.

The huts leak in roofs very badly, this work of repair is in the hands of Contractors who to date have completed in proper fashion 9 huts.

Bath Houses.

Satisfactory as last report.

Carpenter.

The carpenters have been engaged on Q.M's work only, no constructional work executed.

Cook Houses.

There is no report of complaints from Cook Houses, with the exception of one instance in which case the drain was choked and the R.E's were called in to rectify the trouble.

Incinerator.

The incinerators are all proved to be satisfactory.

Sir,

Herewith I beg to submit a Report on the working of the Depot Post Office for the Month Ending 31st March, 1916.

During the month, we have dealt with 206 bags of mail matter. This comprises Letters, Parcels and Papers; Registered matter being separate. With Parcels, a very good clearance has been effected. On March 1st, our records showed a total of 378 names. We have delivered 2063 for the month, and now show only 286 on hand.

In Registered matter we have received 1004: 76 have been delivered through the window and 73 have been forwarded for men who have left on Draft.

Mr. Trahair of the Military Post Office, Horseferry Road, paid this Office a visit last week and gave
valuable assistance in the way of suggestions for clearance of old mails, which had accumulated here. His
suggestions were adopted and I can report a very appreciable clearance.

I have frequently visited Westham Post Office, and report that it is working satisfactorily in conjunction with Monte Video Post Office.

As regards the inner working of the Post Office, I can report that everything is satisfactory.
