





 - ii. To take the name, Reg.No., and Unit, of any cases so discovered, and give them to N.C.O., i/c bathing parade for transmission to R.M.O. concerned, of, in the case of casuals, forward them to 2nd Field Amb., who will insturn notify the R.M.O.
- Records will be kept at Baths of all cases so discovered and a return rendered weekly to this Office by noon, SATURDAY.
- 4. Arrangements have been made with the Baths Officer xxt for each of the Baths to supply clean underclothes at the commencement and end of treatment, and R.M.Os will ensure that outer clothes and blankets of such cases are disinfected.
- 5. C.O., 2nd Aust.Field Amb., will detail a M.O., to make frequent periodical visits to the Baths to supervise the treatment.
- R.M.Os will hold weekly Scabies inspections, and send all uncomplicated cases to Baths for treatment.

REPORT BY D.A.D.M.S., ON QUOTA NO.22 -FROM A.1 AUST.DIVN. PENTRAINING ON 29/3/19.

- (1) The train was in a sanitary state, the trucks having been swept out by German prisoners. The kitchen set was clean and tidy.
- (ii) The A.M.C. personnel were complete. Capt.G.A.LAWRANCE, the medical Officer in charge of the Quota, was in charge of the 14 A.A.M.C. personnel who were allotted a truck to themselves, one end of which was available for an R.A.P.
- (iii) The Medical Officer was equipped as instructed in D.D.M.S., Aust. Corps P.7/2 dated 17/1/19.
- (iv) He was in possession of D.M.S., A.I.F., M. 1507/2/3 dated 22/2/19, and D.D.M.S., Aust.Corps, P.7/94 dated 28/2/19, and was thoroughly conversant with his duties.
- (v) No faults were represented to the Entraining Authorities as everything was considered to be satisfactory.
- GENERAL. Owing to the doors of the trucks having been (vi) left open, the floors of the trucks were wetted by the heavy fall of snow during the night of 28th. However, had this not been the case, the floors of the trucks would have soon been wetted by the continual movement of men in and out of the In view of this and also the fact that the trucks. blankets rolled over packs may get wet during the march to the Reinforcement Camp (as happened in the case of No.22 Quota), I consider it very unwise that ground-sheets should be withdrawn at any time before a Quota departs from HAVRE. This is all the more necessary on account of straw not being allowed in trucks owing to the danger of fire.

Each truck was equipped with a stove, and a supply of

coal was issued to each.

The train left CHARLEROI Station at 1000 on 29/3/19

amidst a continuous fall of snow.

Maj-General Sir N.R. HOWSE, VC, KCB, D.M.S., A.I.F., and Col. G.W.BARBER, CMG DSO, D.D.M.S., Aust.Corps, were present at the entrainment, and expressed their satisfaction with the arrangements.


