

As will be observed from Appendix "A", there has been no decline in the sick rate, Malaria is the predominant cause & as a number of cases of a primary nature have been admitted, Brigade was advised to expedite the issue of Mosquito nets. This has already been done. There has also been an alarming increase in the number of venereal cases, & with a view to minimising these, small "blue light" outfits have been procured & issued to the various outposts. Evacuation of patients has been the cause of considerable confusion. Owing to the lack of accommodation on trains, different arrangements were made. On 19th inst., orders were received that ordinary patients were to be evacuated to ISMAILIA & V.D. & infectious cases to CAIRO. But it was discovered that the ISMAILIA train had been cancelled. Numerous letters telegrams, & telephone conversations resulted. It is indeed fortunate that we are all thoroughly familiar with	QMS



in connection with Defence Scheme, forwarded for your information.

With regard to 3 (b), instructions have already been issued, that reserve supplies of drugs and medical comforts &c., are to be requisitioned for. Special attention should be paid to this matter. Bleaching powder should be kept in large quantity, and some sort of water tank made available in case of emergency.

Attention is directed to recently issued circular dated 5/4/19., by MAJOR FAIRLEY on "Bilharziosis", especially the points dealing with sterilization of water.

3c. Medical officers at places mentioned will please inspect & report, as soon as possible, on building, which would be suitable for hospital purposes.

Camels will be sent upon arrival at ZAGAZIG.

MEDICAL ARRANGEMENTS.Present Disposition of Medical Personnel.

2. GENERAL PLAN IN THE EVENT OF A RISING.

- (a) All places on which regiments are based to be self-contained as regards medical arrangements in order to provide against the possibility of immediate evacuations of casualties being impracticable.
- (b) All posts (exclusive of posts along the railway), thrown out from the Regimental H.Q. posts, to be provided with some form of sick transport in order to clear casualties to the nearest medical base as soon as the situation permits. Casualties from posts along the railway to be collected from the nearest medically equipped post.

3. ACTION TO BE TAKEN AT ONCE.

- (a) 30 Cacolet Camels will be sent to ABU KEBIR.
40 " " " MANSURA.
30 " " " ZAGAZIG.

- (b) All R.M.Os will arrange for one week's reserves of medical comforts, bleaching powder, disinfectants, wool &c., to be maintained at the posts in addition to any held at places where field ambulances sections of P. of W. Hospitals are stationed.
- (c) Buildings suitable for hospitals will be selected as MANSURA, MIT GHAMR and ABU KEBIR.

4. ACTION TO BE TAKEN ON PRECAUTIONARY PERIOD BEING ORDERED.

- (a) One section of a Field Ambulance will be sent to:-
- MANSURA from 4th L.H.F. AMBULANCE, at MOASCAR.
MIT GHAMR. " " "
ABU KEBIR. 3RD L.H.F. AMBULANCE, at ZAGAZIG.

6. FURTHER EVACUATION OF CASUALTIES.

This will depend on situation but cases will eventually be sent to CAIRO or ISMAILIA, as the case may be.
