

No.3 Road Party - 88th Brigade.

Line and just behind Leith Walk to 4 men each, with 4 Stretchers at each post. Remaining personnel to be brought down to No.3 Road.

2. (a) At 1700 the Horse Ambulance Wagon should leave No.3 Road Dressing Station for Pink Farm.

If the wagon is out at that time it should not return to No. 3 Road, but proceed direct to Pink Farm.

- (b). No.3 Road Dressing Station and Relief Post will shut down at 1700 and report at Pink Farm with all personnel and as many stretchers as can be carried.
- 3. At 1645 the Bearer Post immediately behind Leith Walk moves forward and takes position in Leith Walk E. of "B" Avenue as in diagram.

4. The diminished bearers at Redoubt and 2nd Australian Lines and at Leith Walk remain at their posts except for carrying down patients, and if any bearers are still there when 88th Brigade passes down they will follow Brigade along Leith Walk.

Note. Brigade will cross Eski Line about 2030. The Bearers will leave Leith Walk close to its junction with Eastern Mule Trench (large spread out fir-tree 2 minutes from Pink Farm) and will report at Pink Farm immediately.

5. Rearguard Party, consisting of 8 rank and file all told, sturdy men will report to control officer, junction of "B" Avenue and Eski Line at 1600, with 4 stretchers.

Officer i/c Rearguard (Troops) will pass these bearers on as the Rearguard comes down.

Note. Should Stretcher Cases require carriage to Pink Farm before main body passes, bearers will not leave Pink Farm for up journey after 1900.

PINK FARM. 87th BRIGADE

1. Beginning at 1600 Bearer Posts will pass down as far as Eski Line where 36 Bearers will remain at 1700 under an officer who will report to control officer there for duty. They will carry stretcher cases to Pink Farm.

Note. These Bearer Posts should have been reduced to 4 each with 2 stretchers not later than 1500. 3 or 4 surplus stretchers should be left at each post.

- 2. At 1700 the bearers at Bearer Post at foot of Mule Trench will pass back and report at Pink Farm.
- 3. As the Brigade passes the Eski Line centrol post all remaining of the 36 Bearers will follow not necessarily in a clump but with parties of troops. These bearers report at Pink Farm after leaving the Mule Trench at Pink Farm.
- 4. 1 Officer and 11 other ranks of Rearguard party for 87th Brigade will remain at Pink Farm. They will keep a look out for rearguard 87th Brigade passing down Mule Trench and come with it to Rendezvous.

5. Wagon will convey stretcher cases towards "W" Beach by
Pink Farm Road and any wagon in vicinity of beach at 1800 will

6. Stretcher cases will be carried to "W" Beach by Pink Farm
Road.

Note. Wounded able to walk will accompany troops.

7. All ranks should wear brassard on left sleeve of greatcoat.

8. Boots should be muffled by sand-bag material, lint or wool tied with string.

Note. No lights, no smoking, no taking.

9. Every man must be instructed that his designation is "Field Ambulance" 29th Division.

11th January. Moves. Sailed from Mudros. Arrived
Alexandria 13th. Entrained. Arrived Camp Suez on 15th, where
87th F.A. 88th and 89th F.A's. not yet arrived. Evacuation of
sick to Egyptian Government Hospital.

23rd. Health of Troops much improved. Men shewed less signs of strain.

29th. 88th and 89th F.A's. expected.

The R.A.M.C. of this Division has been Summarised with that of other Divisions at Caps Helles during January, 1916, because although the Troops of the 42nd. Division proceeded to Mudros in December, the R.A.M.C. Units, with the exception of the 1/2 E.L. F.A., were working with the 13th. Division on the Peninsula.

Operation Order No.12 of the 13th Division received - Appx.25

- 2nd. On the 2nd 27 other ranks R.A.M.C. embarked at V Beach, while surplus equipment was sent to the 13th Divisional Depot at Lancashire Landing.
- On the 3rd the sea was calm and information was received that baggage etc., at Lancashire Landing had been embarked.
- 4th. On the 4th, 4 carts, mules and Indian drivers rejoined their Headquarters at Hunter Weston Hill.
- 5th. On the 5th 13th Divisional Order No.13 received (no copy), and R.A.M.C. Operations Orders No.5 (Appx.26) and No.6 (no copy) were issued, No.6 being subsequently cancelled by No.7.

Extract of Order No.5 follows: -

- 1. Final period of evacuation to take place on dates to be notified later, but now designated Y & Z.
- 2. Following to embark on Y day from W Beach.

4 Officers, the personnel of the 1st East Lancs Field Ambulance less 3 and 48 and of the 3rd East Lancs Field Ambulance less 3 and 56.

This remaining personnel to be under command of Lt.Col.E.H.Cox.

- 3. The party to march to W Beach via Sea Beach Road and up Bakery Gully Road to the forming-up place "B" 400 yards East of Headquarters and on arrival to proceed in file direct on to a light marked "B" where leading man to halt. To arrive at 7.55 p.m.
- 4. A.D.M.S. to be at Gully Beach. Divisional Headquarters 18th Division. Men to carry packs with blankets, waterproof sheets,

Strength of Field Ambulances - a.m. = 8 and 210 which included 35 other ranks of Transport Sections. At 2.30 p.m. 14 N.C.C's. of Transport Section left with 50 horses and mules for embarkation at W Beach. These were the best selected animals. 34 horses and 1 mule remained, which it would not be possible to evacuate as they would be required to work up to the last moment, in addition they were unsound.

4.20 p.m. - continuous shelling of front trenches of left section

having passed through. At 7 a.m. the Main Dressing Station on
Gully Beach was clear, 17 sick and 114 wounded having been
evacuated by motor ambulances to No.17 Stationary Hospital.
Information that this day - the 8th January 1916 - the Final Period
Weather and sea calm. At 11 a.m. orders given to N.C.O.1/c
Transport to keep 2 fully horsed ambulance wagons at East Anglia
Gully and 2 at the transport lines. Remainder of animals, of
which there were 11, to be at one end of the lines and to be shot
at 2 p.m. Wheels to be removed from all other vehicles, and
destroyed, bodies being rendered unserviceable.

At 12 noon the Officer i/c 1/3rd Field Ambulance ordered to send down all stretchers and equipment not wanted by stretcher squads in Ambulance Wagon to Main Dressing Station at Gully Beach at 3 p.m. when Advanced Dressing Station broken up. All other material to be destroyed, also buildings - sand-bags - corrugated iron, etc.

8th contd. At 5.30 p.m. 1 and 105 R.A.M.C. left for W Beach, for boat leaving at 6.55 p.m. 27 other ranks who should have joined this party did not get down from A & F controls, being delayed by having to bring in a few injured and wounded. They arrived at 6 p.m. with the cases, which were dressed and sent by motor ambulance to No.17 Stationary Hospital. The A.D.M.S. here notes that these motor ambulances could have been dispensed with and that a notification to that effect was sent on the 5th to the 8th Corps. It was found however impossible to send them off.

At 6.30 p.m. the 2 ambulance wagons had been withdrawn from East Anglia Gully to the transport lines and the horses shot. The ambulance wagons were then destroyed. This done with horses and another ambulance wagon towards midnight.

At 9 p.m. 1 and 66 K.A.M.C. left for W Beach for boat leaving at 10.25 p.m. - this party included the 27 who should have gone earlier. By now the wind was getting up and the sea was no longer smooth.

No casualties had occurred so far.

At 12 midnight any casualties occurring from now on were to be evacuated, together with troops, from Gully Beach. The 2 Motor Ambulances on loan from the 11th Casualty Clearing Station were sent to W Beach.

By 1.15 a.m. the 9th all R.A.M.C. were in from advance posts and Officers with stretcher parties with the controls reported all clear and no casualties. The last Ambulance Wagon therefore destroyed, but horses could not be shot as time short, dark etc. They were turned loose. Sea and wind getting up.

At 2.45 last party from section held by 15th Division, 390 strong, were to have embarked from Gully Beach in two K boats for transfer to H.M.S. "Talbot". I boat loaded and got away with 260. 2nd boat ran aground. The remainder of the party including 6 and 24

ontd. the R.A.M.C. having to abandon a small amount of equipment kept for emergency at the Dressing Station and intended to be put on the lighter. The General Officer Commanding and staff marched with this last party, which much delayed by darkness, and it was only with difficulty that it reached W Beach in time to embark on the last 2 K boats to leave the shore, embarkation being a difficult matter for the sea was rising. The situation had become critical, for demolition fires had been started and enemy might be expected to open fire at any moment.

At 4.45 a.m. the K boats left under their own power for Imbros, arriving at 8.15 a.m. after a rough and dangerous passage, as these boats only adapted for a smooth sea and very low-powered.

Moves. At 1 p.m. the Divisional Headquarters embarked on the "Chatham" and arrived Mudros at 6.15 p.m. where they transferred to the "Minneapolis" for the night, disembarking on the 10th, where the A.D.M.S. and his Field Ambulance details rejoined the 42nd Division, which was concentrated at Mudros West.

On the 12th, 13th, and 14th the Division embarked, further embarkation on the 15th being stopped by heavy weather, the troops going aboard the "Haverford" in the inner harbour for shelter, as the camp struck, and some were sheltered in huts ashore.

On the 20th the Division reached Alexandria, entrained and arrived Mena Camp on the 21st.

Operations R.A.M.C. - overhauling equipment of Field Ambulances.

No transport vehicles or animals, but 14 other ranks and 50 men embarked from the Southern Zone of the Peninsula on the 7th were expected.

Moves. The Division to go to Tel-el-Kebir, but destination changed later to Shalufa where the Field Ambulances were ordered to move on the 30th.

13th DIVISIONAL OPERATION ORDER No.12.

Reference 8th Corps Diagram No.M.S. 80, dated Dec. 18th. 1915.

1st January 1916

- 1. In continuation of Operation Order No.11 the preliminary orders contained therein are supplemented as follows.
- 2. In withdrawing from the trenches during the final periods the undermentioned lines of withdrawal are to be followed:Right Sub-section.
 - (a) COMMERCIAL ROAD LANCASHIRE STREET GREAT NORTH ROAD to GULLY BEACH.
 - (b) GULLY RAVINE to GULLY BEACH.

Left Sub-section.

- (c) BURNLEY ROAD (or WESTERN MULE TRENCH) head of Y RAVINE P.POINT JENNET ROAD Cut down to Beach GULLY BEACH.
- (d) BURNLEY ROAD (or WESTERN MULE TRENCH) Down Y RAVINE along sea beach to GULLY BEACH.
- 3. With reference to para.6 of Operation Order No.11, Sub-section Commanders are responsible that steps are taken at once to arrange for blocking trenches and roads which will not be used on the last night of the withdrawal, and to ensure that they are blocked by 1630 on that night, so that there may be no danger of a wrong turning being taken in the dark. Similarly, they are responsible that arrangements are made beforehand to mark the lines of withdrawal at any points where troops are likely to go astray on a dark night. This can be done by means of a strand of plain wire or rope supported by pickets or iron standards, by flour, by planks, or in many other ways.

 All these matters are very important.
- 4. An Officer and such orderlies as he may require are to be detailed by the Sub-section Commander concerned for each of these control stations. These officers are to be provided with a list of parties which will pass their posts, and the approximate times at which they will pass; the passing of each party to be reported by telephone to Divisional Headquarters. Telephone communication between

the Control Stations and Divisional Headquarters will be arranged for from Divisional Headquarters.

- est care must be taken to move noiselessly in withdrawing from trenches, and especially those in close proximity to the enemy.

 Absolute silence must be maintained, except for necessary orders, which must be given in an undertone. No smoking to be permitted, nor are lights to be shown, and care is to be taken that equipment and articles carried by the troops do not rattle. In places where the ground is hard it may even be advisable to muffle the men's boots. No firing by troops withdrawing to be permitted except by order of an officer. Fires and incinerators to be left burning as usual. The extreme importance of these instructions to be impressed to all concerned.
- As it is most important that nothing of any use should be allowed to fall into the enemy's hands, <u>Sub-section Commanders</u> are to cause a careful survey of their area to be made forthwith, so as to ensure that anything of this nature which it may not be possible owing to lack of time to evacuate, shall be buried. Suitable sites under the parapet, or parades, or elsewhere, where the earth can be replaced easily so as to look natural, are to be selected for this purpose, and arrangements made for anything that is left to be buried at short notice. Such ammunition, grenades, ordnance stores and clothing as cannot be moved are especially to be dealt with in this way.

- 4. Packs of infantry remaining till the last day with blanket and waterproof sheet folded under the flap of the pack, are to be stacked by battalions in the GULLY RAVINE at its junction with the ESKI line by 1600 to-morrow, in charge of 1 N.C.Officer or man per battalion, selected from amongst those embarking to-morrow night. Each brigade to furnish a party consisting of 1 N.C. Officer and 10 men to be at the same place at 1700 to-morrow, to load the packs on transport.
- 5. The numbers of ALL RANKS to remain on the Peninsula for the final period are as follows: -

R.A.M.C.	220

Numbers in excess of above numbers will be evacuated under instructions issued from Divisional Headquarters.

As many effective rifles as possible are required on the Peninsula during the last period. Steps are therefore to be taken to evacuate previously as many employed men as practicable.

It is to be clearly understood that the numbers above include not only all ranks, but Brigade Headquarters, Control Officers, Specialists, employed men etc.

6. By day-break on the last day, troops remaining on the Peninsula are to be disposed approximately as follows: -

Brigade Headquarters to remain where they are at present, and to be deducted from the above numbers.

- 7. A time table for the withdrawal, marked "A" is issued herewith.

 As troops are thinned out in the various lines after dark on the last night, those remaining in trenches are to be concentrated in groups to facilitate control.
- 8. The Divisional Rendezvous where troops from the trenches will be grouped together in parties of 100, 200 or 400 by the Staff of the Division will be on GULLY BEACH, just below Divisional H.Q. The forming up place prior to embarkation will be on the Sea Seach North of "W" Beach, just below Sorps Headquarters. On arrival at the forming up place, the officer in command of each party for embarkation will report to the Staff Officer of this Division his numbers for embarkation.
- 9. The following instructions as regards embarkation are to be strictly attended to:-
- (a) Troops are to march straight along the Sea Beach till told to halt by the Staff Officer of this Division.
- (b) No baggage or transport will be embarked with the troops.
- (c) In order to ensure that the lighters are correctly loaded, one officer of each party will be stationed at the foot of the lighter's gangway, below decks, to see that the lower deck is well filled up, I Officer at the top of the gangway to pass the men down rapidly, and a third officer at the point where the men board the lighter.
- (d) on board the lighters, troops are to be packed as close as possible, and are to remain standing with their equipment on, but loosened, and shoulder straps unfastened. Rifles are to be carried in the hand and not slung. The senior officer of each party is responsible for the speedy and orderly embarkation of his party.
- (e) On reaching the ship, the troops are to stand fast till the senior officer orders them to go on board. The senior officer will first board the ship, get in touch with the Maval Transport officer (or in his absence, with the Master of the Ship), and having ascertained how the men are to be stowed, will arrange for the men to be passed rapidly to their allotted decks, so that there may be no congestion at the gangway.
- 10. Troops are to carry filled water bottles and 220 rounds 5.4.4.
 in withdrawing, and machine gun detachments are to bring away 3500 rounds per gun with them. Troops are to bring away with them any

additional rounds over and above 220 per man, and 3500 per machine gun which cannot be evacuated or buried. Where ammunition is buried, the greatest care is to be taken to restore the natural appearance of the surface round the place of buriald No.11 attached.)

11. The following officers are to report at Divisional H.Q. as soon as the last troops under their orders have left the trenches (in the case of Sub-section Commanders, at 2150):-

After Sub-section Commanders have withdrawn from their present Headquarters, troops in (b) and (c) above will be under the direct orders of the Divisional Commander.

to be notified by telephone at once. Control Station Officers are to telephone to Divisional H.Q. as each body of troops passes their station, and to ask permission from Divisional H.Q. before they finally withdraw, unless the telephone line is broken, in which case, they will use their discretion in withdrawing as soon as the last party has passed, in accordance with the spirit of para.4 of Operation Order No.12.

- 14. Steps are to be taken to ensure that all telephone instruments are brought in during the withdrawal, and that telephone lines are destroyed by cutting out lengths of at least 200 yards, and carrying them away.
- 15. The C.R.E. will make preparations for the destruction by fire of any stores collected at the R.E.Stores, ESKI Line, and at the mouth of the GULLY RAVINE; also for the destruction by fire of any supplies unconsumed by the two Infantry Brigades. He will arrange for all these piles to be fired automatically at 0500 after the withdrawal is completed. He will also cause the gaps in the wire in the Keserve and ESKI lines to be closed after the last parties have withdrawn and arrange for mines to be laid on the Sea Beach in advance of Fusilier Bluff and in the GULLY RAVINE.

Troops in withdrawing are to be prepared, should circumstances necessitate it, to occupy and hold on to the PRITH WALK DOUGLAS STREET Line, or the ESKI Line, on receipt of telephonic instructions to that effect through the Control Officers. Those lines are there therefore to be carefully reconnoitred, so that they may be manned without delay or confusion.
- 20. Watches are to be checked by Divisional time at 0830 and 1630 on each day of the final period. Extreme punctuality in all move-ments is essential.

Very little information re this Unit has been obtainable from earlier diaries. The first note is dated August 24th 1915, when the Unit was at Port Said. It disembarked at Lancashire Landing ("W"Beach) on August 29th, and was still at Cape Helles at the end of 1915.

Evacuation of Cape Helles. On 1st January the Unit had relay posts in Plymouth Avenue, and was ordered to hand over to the 1/3rd Lowland Field Ambulance. At 6 p.m. 1 and 60 embarked at "V" Beach. Remainder appears to have been attached to 1/3rd Lowland Field Ambulance.

On the 2nd 1 and 25 embarked at "W" Beach. Later 1 Sergeant and 6 other ranks ditto. All rum in store destroyed by order of A.D.M.S. All ordnance stores returned to Ordnance park, except tentage, ambulance wagons and Thresh Disinfectors.

Officers' Kits shipped. Medical equipment put on "W" Beach under a guard. Later these were shipped. Enemy shelling night and day.

- 3rd. On the 3rd strength of Unit 6 and 90. All baggage, etc., now shipped. Horses, vehicles and harness still retained. 8 horses and 10 mules remained.
- 4th. On the 4th very heavy shelling. 2 (including Officer Commanding) and 8 embarked 5.50 p.m. at "V" Beach. This small party remained in a crowded barge for 12 hours under direct shell fire from Asiatic shore. They cruised about the bay seeking for a steamer and were ultimately picked up by a ship, which, however, had no orders. Horses and mules evacuated same night.
- 5th. On 5th Officer Commanding arrived Mudros.

On 10th Baggage party arrived.

On 11th strength of unit 9 and 205. Excluding men with horses and baggage 1 and 2 still to return.

R.A.M.C. strength 5 and 100. "Z" Day. Control posts manned at 6 a.m. At dusk all standing tents cut into ribbons. Rendezvous party moved to Divisional Rendezvous. Exceptionally quiet day and night. Control Post R.A.M.C. proceeded with troops to embarkation point and embarked with them. When all Control Posts cleared, rendezvous party moved to "V" Beach and embarked on T.B.D. "Bulldog" at 3 a.m. 9th. 3 Ambulance Wagons were left on the beach for destruction.

The Field Ambulance re-assembled at Sarpi Camp, Mudros 9th. On the 17th embarked 7 and 192 strong on "Hororata". Arrived Alexandria 21st. Railed to Abbassia and went to Polygon Camp. 

- Orders to send 180 all ranks off the Peninsula and the 1st. lst. Field Ambulance was instructed therefore to detail one medical officer and 89 other ranks and the 2nd. Field Ambulance a similar number. A party from the 2nd . Field Ambulance embarked on the 1st. and from the 1st. Field Ambulance on the 2nd. at V.Beach. On this date further orders were issued that Field Ambulance personnel in excess of 10 and 220 were to embark at mid-night, and one medical officer, one quartermaster with 26 other ranks from the 1st. Field Ambulance, two medical officers, one quartermaster, one chaplain and 25 other ranks from the 2nd. Field Ambulance were embarked, while all stores except those necessary for the final period were sent to Ordnance for embarkation.
- Evacuation of the Peninsula. Alteration in the general plan 3rd. had given rise to the need for a new medical scheme. There were now to be no more than 220 all ranks medical personnel, R.N.D., and on the 4th. it was further noted that 60 medical personnel, all ranks, would remain and leave the Peninsula with the final party.
 - Evacuation. The D.D.M.S. 8th.Corps instructed the A.D.M.S. 5th. R.N.D. to open a small advanced dressing station at V. Beach. Surgeon Rivers and 2 other ranks detailed.
 - Nine drivers, one horse, 10 mules, were embarked, leaving for 6th. the final party 2 motor ambulances, 4 horsed ambulance wag ons, 16 mules and 12 drivers. Field Ambulances closed and all cases evacuated from advanced dressing stations to No.11 Casualty Clearing Station, and on the 7th. all Field Ambulance personnel, detailed for the final period, went.

Their positions in the trenches and detailed instructions were issued to all medical officers in the final evacuation. Appendix 2 should be seen for a detailed table of positions occupied by medical personnel and the numbers at each post (1) Remaining on the 6th. of January 1916 and

Appendix 3 orders to Surgeon Schlesinger, R.M. 1st. Field Ambulance, and Surgeon Taylor, R.N., 2nd.Field Ambulance.

- 1. On Saturday January 8th.1916, 5 men of each Field Ambulance to be sent from Surgeon Hamilton's party at the 1st.Field Ambulance Advanced Dressing Station to the A.D.M.S. at Divisional Headquarters at 5 p.m. sharp where a party to join them for V.Beach. All camp kettles to be sent to 1st.Field Ambulance, Advanced Dressing Station by 2 p.m. and to be brought down with the party.
- 2. Officers and men at B.1., B.8., Rougnon, Source Labarsouque Point D'Eau, D'Amade, Boyau Central, Head of Ferme Vermeche Road (Armanet) and 1st. Advanced Dressing Station will, with the exception of those detached to posts to be finally held, leave with main body at 8 p.m. when a large body of troops will be leaving with whom they must get in touch. Surgeon Schlesinger and Surgeon Mayne before leaving see that proper men posted at final posts with stretchers and clear instructions. Surgeon Mayne to relieve Surgeon Taylor at the head of Ferme Vermeche Road so as to enable Surgeon Taylor to leave with the main body.
- 3. Final parties at Control Stations to leave with combatant parties bringing stretchers, and on no account to leave the recognised trench routes, so that should a party have been carrying down a patient and return empty they would be met and would accompany their comrades. Time of leaving

- (4) On moving up to trenches from Fleming Nullah on the afternoon of January 7th, Surgeon Schlesinger to take two horsed ambulance wagons and one motor ambulance with mules, equipment and personnel, finding accommodation for them at the 1st.Field Ambulance, Advanced Dressing Station. His surplus consisting of 1 Medical Unit, men to go to 2nd.Field Ambulance at Orchard Valley with a nominal roll and join the 2nd.Field Ambulance surplus there and await instructions to embark in the evening. When Main Body leaving the trenches about 8 p.m. only one horsed ambulance wagon to be subsequently used for each Brigade. The officer stationed at Point D'Eau and Armanet to see that surplus wagons and personnel leave with that party for V.Beach Dressing Station. - At 6 p.m. officers and men left bivouac for V.Beach and
 embarked at 7.30 p.m. together with 10 men of the Medical Unit,

Beach was augmented by the addition of 4 other ranks, making one medical officer and 6 other ranks in all. At 11.45 p.m. final party commenced to leave their stations in the trenches. Surgeon Walker from the 1st.Field Ambulance, with 20 other ranks, one ambulance wagon and two drivers and one ambulance wagon orderly, and Surgeon Mayne and 22 other ranks with 1 ambulance wagon, 2 drivers and one wagon orderly from the 2nd. Field Ambulance accompanying the party embarking at V. Beach at 2 a.m. 9th. and being joined by the A.D.M.S., and D.A.D.M.S. and Staff Sergt.Wilson. Surgeon Rivers and 6 other ranks remained at the dressing station on V. Beach until the demolition party and beach guard had embarked.

They arrived at Lemnos and went to south camp at West Mudros, where the personnel of both Field Ambulances arrived during the day.

Water. Wells in unsatisfactory condition. See Appendix 5 which is a report. See also Appendix 8 a further report. Perusal of these two reports shows that the supply of water was inadequate and uncovered. However there was a condenser plant close by , but the output of this was limited, and the nearest station post was a very long way from the R.N.D. Camp. Medical Arrangements. General Officer Commanding gave instructions to hasten the re-equipment of one Field Ambulance to be ready for a move at short notice, and the 2nd. Field Ambulance was instructed to make ready and to get together their equipment and stores. On the 18th. there is mention of hospital of 200 beds which was to be established for the

R.N.D. A later mention is made of No.18 Isolation Hospital

which was to be handed over to the R.N.D.

"MEDICAL ARRANGEMENTS FOR THE FINAL PERIOD OF EVACUATION".

"A" - 17th Stationary Hospital and 11th Casualty Clearing Statio

- 1. A personnel of 4 Officers and 24 other ranks will be left to carry on the duties of each of the above units. .
- 2. A. personnel of 6 Officers and 40 other ranks will be placed on a warship as reserve to the above in case they should be required on the day following the embarkation.
- 3. Sufficient medical and surgical equipment and stores, including rations, medical comforts, dressings, blankets, fuel, light, etc, have been collected to allow of sufficient and ample attention for 14 days to 1600 patients.
- 4. Water supply has been arranged by means of 4 mules and 8 Egyptian tanks with a pump and tube for each of the above to draw water from the well near W. Beach.
- 5. As no interpreters can be provided and in case the personnel of these units cannot be evacuated, they will be provided with copies of a notice in Turkish and French to the following effect.:-

I am not a fighting soldier; my only work is in connection with the wounded and sick in Hospital and in the Field under
the protection of the Geneva Convention.

6. In the event of light or no casualties being admitted and held up in the above units, instructions will be given when the final retirement has commenced for the personnel to retire with their medical and surgical panniers to W. Beach for embarkation.

- 3. The embarkation of sick and wounded will take place at V, W, X, and Gully Beaches. A Medical Officer has been detailed to supervise this at each beach in conjunction with the embarkation Staff.
- 4. During the final period, all wounded will, as far as possible be evacuated with the troops and not taken into either 17th Stationary Hospital or 11th Casualty Clearing Station.
- 5. Any sick and wounded in either of the above or in Field Ambulances will be evacuated to Hospital ships by dusk on the final night.
 - C. Maintenance of appearance of Occupation of Camps etc.
- 1. Strict orders have been issued to all concerned that no tents, dugouts, etc, are to be altered or removed in any way, and that Red Cross Flags where previously flying shall be kept flying.
- 2. Sufficient personnel will be left in each camp etc, to keep fires and incinerators going and to move about to give a semblance of occupation to all camp and areas vacated by medical units.
- 3. Particular care will be taken that all packing of surplus stores for removal is done inside tents and that no dumps of those ready for removal are made outside tents by any medical unit.
- 4. If the personnel of 17th Stationary Hospital and 11th Casualty Clearing Station are evacuated arrangements will be made to have all lamps and lights burning when they march out.



"January 1916" Helles-Egypt



January 1916

The units divided on December 31st into 3 sections.

- "A" to remain till the end.
- "B" to remain till the last day, embark on a Man of War and stand by, in case required to disembark to care for casualties to be left.
- "C" Remainder embarked for Mudros 31st.
- "C" party arrived Mudros 1st, remained in R.A.M.C. Detail Camp Mudros E.
- loth on loth "B" party arrived.
- 11th On 11th Capt. T.S. Eves and 3 M.Os. arrived of "A" party
- 13th. Unit embarked on Hospital ship "Egypt". 14 of unit still absent.
- 16th On 16th arrived Alexandria. To Gabbari Camp where to re-equip.
- 25th Entrained less 1 and 50 for Suez. Arrived 26th.

 Camped near Indian Field Ambulances where drill etc.

 No cases taken in. No mention of the 1 and 50, but they were left behind owing to shortage of rolling stock, and probably came by a later train.

 Note. There is no detailed history of the evacuation of Cape Helles beyond that given.

NO. 17 STATIONARY HOSPITAL. M.E.F.

JANUARY 1916. Southern Zone.

January. From information given in No. 17 Stationary Hospital Gazette, sent from unit when stationed at Cumbala War Hospital, the unit left Cape Helles on 9th January 1915. Sailed via Mudros to Alexandria and on to Suez (Port Tewfik) where remained for 3 months. The following tables show the number of cases which passed through the Hospital during the period it worked at Cape Helles:-

Cape Helles, October 15th 1916 to January 8th, 1917: Officers, total admissions = 363. Subdivided into:-

(Chest 5 (Abdomen 5 (Upper Extrem. 12 (Lower Extrem. 21 (Multiple. 3 (Diarrhoea 30 (Jaundice 57 (Other diseases 191

Deaths - 8 (all from wounds, 3 of head).

Other ranks - total admissions = 6642. Subdivided into:

Head 371 Chest 108 Wounds. Abdomen 55 Upper Extrem. 327 Lower Extrem. 392 Multiple Wds. 52 567 Dysentery Medical. Diarrhoea 381 Jaundice 873 Other diseases 3919

Deaths - Of these 6642 admissions only 110 cases died (1.66%) and 105 of the deaths were due to wounds which left no hope of the mens' recovery. Of the 55 abdominal cases, the whole were of a more or less serious nature and required operative treatment. Twenty-one of these cases died. 45 deaths were due to head wounds. Only 5 cases died from medical causes, one of which was enterica and a second apoplexy.
