SECOND AUST ARMY TRAINING INSTRUCTION NO 23TESTS OF PHYSICAL TRAININGINSTRUCTIONS TO TESTING OFFICERS

1. GENERAL. Each Coy moving out will require inspection and checking at following stages -
- (a) Complete check of personnel and eqpt before moving out on first day
 - (b) at commencement and conclusion of each days march
 - (c) at selected intervening points
 - (d) complete inspection of personnel and eqpt at conclusion of exercise.

2. PERSONNEL
& EQPT:

- (a) The Coy parade state will be checked before movement and every man accounted for. ALL personnel of the coy will participate, excepting only those physically incapable of so doing. The percentage in relation to actual strength will be noted.
 - (b) Offrs and ORs will wear KWD (or shorts and shirt, but only if KWD NOT available,), boots, gaiters, (or anklets web) steel helmet and webbing eqpt.
 - (c) (i) The Coy will carry its normal arms and eqpt (excepting Boys rifles). Testing offrs will ensure that each man (including offrs) carries the following:
 - Rifle (and bayonet), SMG OR LMG
 - 100 rds SAA (or equivalent)
 - 2 grenades
 - 3 days rations
 - Mess tin, knife, fork and spoon,
 - Water bottle
 - Towel and personal hygiene gear
 - Ground sheet
 - Change of underwear
 - Spare sox
 - (ii) 12 magazines will be carried for each LMG and SMG.
- For safety reasons these will NOT be filled

(iii) The coy comd may at his discretion direct that each man will carry one blanket

- (d) Four SB's with two stretchers, and one Medical orderly from Bn HQ with small medical kit (minimum weight 4 lbs) will move with each coy.
- (e) Coy 108 set and sigs will move with Coy HQ

3. MOVEMENT

- (a) The testing offrs will NOT be required to "paint" a tactical picture nor will the coy comd be asked to move as if contact with an "enemy" is an immediate prospect.
- (b) However, the coy will move in dispersed formation and will be judged on the methods and formations which the coy comd and pl comds adopt for movement over this type of ground, under conditions which approximate to those of active service.
- (c) Tactical considerations will apply in choice of bivouac sites and security during halts.
- (d) Sections will be organised in their sub-groups, but NOT necessarily move in such formation.

4. CONDITION OF PERSONNEL

- (a) Since these are "tests of physical training", the physical condition and stamina of personnel will be most carefully checked at each stage of the exercise. The most careful and detailed inspection and questioning of individual men by testing offrs will be necessary.
- (b) The skill of the individual man in nursing his strength, caring for his body and particularly for his feet, adjusting his eqpt to the most comfortable posn, are points to be looked for.
- (c) The good judgment or otherwise of the coy (pl, sec)comd in moving over the ground with a view to saving unnecessary climbing etc., and the even distribution of loads, are also to be judged.

5. RATIONS AND WATER.

- (a) 3 days rations will be carried by each man, but the coy

comd may elect to carry additional rations for emergency. Individual or sub-group cooking will be used. Dixies will NOT be taken.

(b) Units will be judged strictly on water discipline. Sterilizing tablets will be carried if available.

6. CONDITION OF EQPT

Testing offrs will check care and maintenance of coy arms and eqpt, and condition at completion of the exercise.

7. REPORT ON TEST

Testing offrs will report in the form shown as Appx "A", in accordance with Second Aust Army Training Instruction No.22 para 5 (c).

- (A) ENEMY:- On 2-3 day an enemy convey was located 250 miles SE of LORD HOWE ISLAND, steering due WEST. By 1800 hrs of that day the convey has reached a point 100 miles SOUTH of LORD HOWE ISLAND still steering WEST.
- (B) OWN TROOPS:- Forces in the MINDANAO area were immediately mobilised and disposed as follows:-
18 Comp Bn area NORTH of SOUTH CHANNEL to excl PORT ST JAMES.
20 Comp Bn incl SOUTH CHANNEL to incl PORT ST JAMES.
28 Comp Bn mobile res. MINDANAO area.

During 2-2 day, enemy were detected by our aircraft and by 1000 hrs the convey had reached a point 400 miles EAST of NEWCASTLE. On 2-4 day the enemy continued to steam WEST, suffering heavy losses from our sustained air attacks, and by 1800 hrs on that day were 150 miles EAST of NEWCASTLE.

On early morning of 2 day the enemy were able to make a number of small landings from NEWCASTLE BEACH to MILE MILE BEACH, in bodies of approx 50 men, armed with rifles, I.L.G.s., I.L.G.s., mortars and Grenades. In most cases the enemy were able to penetrate inland and establish themselves, thus creating a static position between themselves and forward Bn's.

4. EXERCISE.

At 1800 hrs a telephone message was received from PATERSON to the effect that a body of approx 200 paratps had been dropped in vic sq 5665. C.O. 28 Comp Bn was ordered to move out immediately and destroy paratps, and issued the following order.
