- a. 9 Div Phase 2 to Op SANTA FE will continue but will NOT involve 1 ATF.
- b. 3/5 Cav minus Pl A Tp will revert to under comd 9 Div from 131600H.
- c. A Bty 2/35 Arty (US) reverts to in GS reinforcing 4 Fd Regt from 131600H.
- 2. Mission. 1 ATF is to return to NUI DAT commencing 16 Nov.

#### 3. Execution.

# a. General Outline.

(2) It will be necessary to deploy 108 Fd Bty and a Coy 2 RAR to XUYEN MOC YS6568 to cover the movement of the road convoy down Route 328 and along Route 23.

#### b. 2 RAR.

- (1) At 160800H move one coy by AMC to LION, to come under OPCON of A Sqn 3 Cav Regt and assume protection duties in that base. At approx 161530H this coy is to move to XUYEN MOC and assume command for local protection of the FSPB in that location. At approx 181130H the coy will return to NUI DAT by AMC.
- (2) Commencing 160800H be prepared to move by AMC to NUI DAT.

#### c. 7 RAR.

- (1) At 161000H mov to NUI DAT by AMC.
- (2) Leave one coy under OPCON of A Sqn 3 Cav Regt to assist in the movement of the road convoy from LION to NUI DAT.
- (3) Assume 1 ATF Standby coy duties from 161700H.







# INTELLIGENCE ESTIMATE VIET CONG RICE PROCUREMENT IN PHUOC TUY PROVINCE

## General

- 1. The rice harvest season in PHUOC TUY Province extends in the main from early December to early January. During this time it must be anticipated that the VC will attempt to procure part of the harvest to build up supplies and help cover the serious shortages that are known to exist in VC military units and base camps.
- 2. Operations KENMORE and SANTA FE have confirmed VC intentions to step up their procurement activities, and some forward deployment of the VC BA BLEN Forward Supply Council to carry out these activities has already been discovered and frustrated.
- 3. In order to forestall as much future VC procurement activity as possible a summary of the probable VC concept as applied to PHUOC TUY Province is attached. It is hoped that this overall picture will assist GVN and FWAF planning and co-ordination of rice denial operations throughout the province.

## Area Sub-Division (See Annex P)

- Information provided by all interested parties shows that there are four general areas to be considered. Area "A" is the area WEST of Route 2, Area "B" is NORTH and SOUTH of Route 327, Area "C" is between Route 2 and the SONG RAI and SOUTH of the SUOT LO O NHO, Area "D" is EAST of the SONG RAI around XUYEN MOC and Cape HO TRAM. These areas are discussed in further detail below:
  - a. Area A. The procurement areas are HOA LONG, the villages along Route 15 and the fields NORTH-WEST of HOA LONG. Recent captured documents show the area around the SONG CAU to be a rice target area in VC planning. Staging areas are NORTH of the NUI DINH hills and NUI THI VAI hills. VC patterns of movement in this area will be generally along the line of the CHAU PHA River then splitting NORTH of the hills to use avenues of approach to the WEST, SOUTH and SOUTH-EAST. To the NORTH of Area "A" the CU BI Rubber approach is probably best considered as a western extension of Area "B". Villages that should be considered for search operations, in the priority suggested, are:
    - (1) PHUOC HOA.
    - (2) HOA LONG.
    - (3) PHU MY.
    - (4) PHU HAI.
    - (5) LONG CAT.
    - (6) ONG TRINH.
    - (7) LONG HUONG.

Also the provision of additional check points on Route 15 WEST of BARIA may be necessary. /2.

- b. Area "B". This is obviously an important area in the VC supply system. It includes CU BI, a favoured VC approach from the WEST into NGAI GIAO/BINH GIA. The BAU CHINH forest (YS4980) is a staging area for VC traffic moving down from the TAM BO and YOUERT River trails. The BA BIEN Forward Supply Council has already established base camps in the jungle NORTH of Route 327 and many trail systems have been made. This area also commands the NORTH-EAST approach into MACV Base Area 301 which itself provides a forward assembly area for units attempting to infiltrate SOUTH into the population base or to make contact with liaison personnel in the farming area. Ambushes on tracks and trails in this area could continue to be lucrative. The villages of BINH GIA and NGAI GIAO should be considered as search areas.
- c. Area "C". An important rice-growing area which will require considerable search effort in villages and early warning of VC approach from the NORTH, NORTH-EAST and EAST through the LONG GREEN (YS5258). Effective screening in Areas B and D will do much to forestall VC encroachment into Area "C". Some foraging parties moving NORTH and EAST out of the LONG HAI Hills must also be expected. There are many well-used procurement areas in and around the Southern villages of PHUOC TUY and the following villages should be considered for searching, in the suggested priority:
  - (1) PHUOC LOI.
  - (2) HOI MY.
  - (3) AN NHUT.
  - (4) LONG DIEN (NORTH).
- (5) TAM PHUOC.
  - (6) LONG DIEN (SOUTH-EAST).
  - (7) DAT DO (SOUTH-EAST).
  - (8) PHUOC HAI.
  - (9) NUI NHON Village.
  - d. Area "D". Since most of the VC rice in this area has been killed with herbicide there remain two areas of interest XUYEN MOC village and the HO TRAM Cape area. It will be necessary to plan for early warning of VC approach to XUYEN MOC or around XUYEN MOC into Area "C". It is possible that having been pushed further out from the farming areas and, realizing the risk of attempting to penetrate across country, the VC may attempt to increase his use of seaborne resupply in the HO TRAM Cape area. Maximum surveillance and possible ambush sites should be considered for this area.

#### Enemy Forces.

The VC organisations responsible for the conduct of rice procurement are the Finance and Economy Section, Rear Services and the Forward Supply Council. Representatives or small parties from these organisations will be aided by village and district units and where possible elements of D445 Bn will be moved SOUTH and WEST to support the operations. In terms of the particular areas enemy forces most likely to be encountered are:

Area A - Village guerillas, CHAU DUC Distric Co (C41), and elements of Group 84. It is possible that some elements of 274 VC Regt could be discovered on foraging raids EAST of Route 15.

Area B - The Forward Supply Council must be expected to attempt to hold on to its camp and storage installations in this area. They could be supported by local guerillas, Group 84 and D445 Bn. Elements of 274 VC Regt could attempt to use the Western approach from the HAT DICH through CU BI.

Area C - This is a traditional area of operations for the LONG DAT District Co (C25) and D445 Bn. Village guerillas must also be expected to become more active around the villages and further attempts to breach the fence can be anticipated.

Area D - This area is likely to be used more as an approach and transit area between Area C and the HO'TRAM Cape. VC units that could be involved in supply operations in this area are local guerillas (PHUOC BUU guerilla unit), elements of Gp 84 (G57 unit), and representatives of BA BIEN Province Committee cells. It should be noted that countrywide studies of VC rice procurement have assessed the PHUOC TUY coastal area EAST of VUNG TAU to be a major rice corridor. On the ground this means that more frequent landings and transit of Area D may be attempted.

## VC Procedures

- 6. In GVN-controlled areas the VC sometimes prefer to use intermediaries to obtain their rice. One method is to have civilians purchase supplies in local markets in small amounts for what appears to be personal consumption. These people then carry the goods directly to the VC or to a pick-up point (LONG TAN area on the boundary of the Cattle/Farming line is a good example) from where the rice is transported in larger quantities to the VC staging areas and on to the base camps.
- Another method involves purchase in large quantities. Instead of giving a small amount of money to a number of people the VC give a large sum to one contact who procures the rice and delivers it to a designated location, or stores it in his house for collection on an as required basis.
- 8. Sometimes the VC will employ ruses to procure foosstuffs. In one case five VC entered a village, purchased food, and hired a Lambretta to transport the food. One of the VC was dressed in a police uniform, enabling them to pass through the checkpoint as they left town.
- 9. A large cross-section of reports indicates that VC rice collection parties usually enter a village between 2100 2300 hours. This fact could be useful when planning ambushes on approaches and times out and in for patrols.
- 10. According to local experts the VC will also attempt to collect paddy tax in kind directly from the farmers in the fields, especially where the husking is done in the field. Such collection parties would consist of Finance and Economy cadres with escort personnel from local VC units. Probable strength is section to half platoon size.

## COORDINATION OF 1 ARU/2 RAR AOS

Reference: A. 1 ATF OPS1884 dated 181000H Nov 67 (Op FORREST).
B. Map L8015 Sheet 6430-III (SE) VIETNAM 1:25000.

#### General

- 1. To minimise the problems of coordination and the risk of patrol clashes, it is necessary to restrict the AO allotted to 1 ARU for Op FORREST.
- 2. 1 ARU's task is primarily to:
  - a. Provide a continuous two platoon screen in its AO and to provide two platoon strength ambushes in the AO by night.
  - b. To secure the proposed base area for 3 RAR and C Son 1 Armd Regt against VC sabotage.
  - c. To protect engineer, survey and other parties operating in the new base area.
- d. To deny the eastern approach to HOA LONG to VC assassination groups.

#### Coordination

- 3. 1 ARU Revised AO Annex P.
  - 4. 2 RAR Perimeter. This remains the responsibility of 2 RAR Rear elements. In particular:
    - a. 2 RAR clearing patrols are not to operate in excess of 300 metres from the perimeter in the area SOUTH of the 67 Northing.
    - b. 2 RAR close TAOR patrols are to use routes NORTH of the 67 Northing when patrolling WEST of the SUOI DA BANG.
    - c. Separate instructions will be issued on 2 RAR Range operation.
  - 5. 7 RAR Perimeter. 7 RAR is responsible.
  - 6. 1 Fd Sqn Perimeter. 1 Fd Sqn is responsible but no clearing patrol is to operate further than 300 metres from the perimeter wire.
  - 7. 1 ARU Perimeter. 1 ARU remains responsible. In particular care should be taken to ensure that 1 ARU clearing patrols do not clash with 1 ARU platoons operating in the AO.

## 3 RAR Base Area

8. It is appreciated that many units and individuals will from time wish to operate in this area. It is essential that all units coordinate direct with OC 1 ARU daily on timings, strength of work parties, task and routes in and out of the area. This coordination is to be made by 1800 hrs on the day before the party is to enter the area.







PATROLLING

#### General

1. GS Instruction 1/67 dated 29 Jul 67 is cancelled.

## Patrol Areas

2. Patrol areas will be issued from time to time. The present 1 ATF base AO's will remain in operation until the end of December 1967 when new AO's will be issued to cater for the increase in the force.

#### Task Force Patrol Policy

- 3. Except for clearing and standing patrols, patrols within the 1 ATF base AO's will normally be of platoon strength. Authority to patrol in less than platoon strength will be given by HQ 1 ATF.
- 4. Patrols will operate within the range of 105mm field guns. If the 105mm field guns are not available at the HORSESHOE patrols are to remain within the range of the HORSESHOE 81mm mortars.
- 5. There will always be patrols in unit AO's.
- 6. When in base the battalions are to commit one company to patrolling. This can be a company as a whole or three separate platoon patrols. When the battalions are not in base the patrols will be provided by the base elements on a scale laid down by HQ 1 ATF. In this case it will be normal for 1 ARU. and the Defence Platoon HQ 1 ATF to take a larger part in the patrolling.
- 7. Patrol programmes will be so organised that maximum coverage of the AO is ensured.
- 8. It will be normal for the battalions to plan the patrol activities in their own AO's.
- 9. HQ 1 ATF will give early advice of additional patrols to be carried out.

#### Patrol Task Tables

- 10. Units patrolling are to deliver one copy of their unit task table by hand to the GSO2 Ops or GSO3 Ops and SD at the times nominated by HQ 1 ATF.
- 11. The proforma attached as Annex A is to be used and a route trace based on a 1:25,000 map is to be attached to the task table.
- 12. 1 SAS Sqn is to submit their task tables based on the verbal directions of the Commander, GSO2 Ops and GSO2 Int.
- 13. 1 ARU is to submit their task tables based on the 1 ARU training programme.
- 14. The 1 ATF patrol task table will be consolidated and distributed at least three days in advance of the first patrol timing.
- 15. The 1 ATF patrol task table will list all 1 ATF patrols including standing patrols for a particular period. No other patrols will be permitted except sub unit clearing patrols.

#### Clearing Patrols

- 16. Sub units will send out clearing patrols twice daily as follows:
  - a. All patrols will go out from the LEFT flank of the sub unit, travel CLOCKWISE and return through the RIGHT flank of the sub unit.
  - b. Patrols will depart at first light and 30 minutes (approximately) before first light. The evening patrol must be in by last light.
  - c. These clearing patrols will not be shown on the 1 ATF task table.

#### Patrol Equipment

- 17. a. Torches, air panels and smoke grenades will be carried.
  - b. All patrols are to have radio communications and be conversant with the company, battalion and 1 ATF command and air frequencies.

## Artillery Support

18. If the patrol does not have an FO or MFC, the patrol commander must be proficient in the use of target grid procedures.

#### LOCSTATS

- 19. a. The need for accurate and up to date LOCSTATS is most important.
  Units must pass LOCSTATS of all patrols at least hourly.
  - b. LOCSTATS of the platoons of a company patrol are required.
- c. The night locations of all patrols are to be submitted to 1 ATF CP by 1900 hrs.

#### Debriefings

- 20. a. All patrols are to be debriefed by the controlling unit.
  - b. With the exception of 1 SAS Sqn, patrol reports will only be submitted for those patrols having a contact. In this case the patrol commander is to bring the patrol report with him to the GSO2 Ops or GSO2 Int within 24 hours of the patrol returning to the base.




