#### GENERAL

- There has been an improvement in US/VN relations, and it now appears possible that the dispute will simmer down to minor dimensions. GVN appears still in firm control. Such rumblings as one hears give no evidence of being sufficiently organized to effect the stability of the government. The National Elections were completed with no trouble among the voters, and only the most ineffectual opposition from VC.
- 2. The intensity of VC-initiated operations continues to rise, and currently I rate the operational picture as less than satisfactory.
- 3. All advisory elements in the closing days of the month have been heavily engaged with the visit of the party of Secretary McNamara.

#### HEALTH

4. Captain Irvine has suffered a little gastro-intestinal trouble, common among new arrivals. Now recovered.

#### WELL BEING

- With the advent of the rains in the North the water problems of Phu Bai and Hiep Khanh have ended. However, measures are proceeding to prevent a recurrence next dry season. Currently, Phu Bai airfield is awash, with aircraft entry frequently impossible. This has had some effect on ration supply, but of minor significance.
- Earlier ration supply problems having their origin in multiple handling between Saigon and Hue (one of the birth-pangs of a new logistic system) have been removed by the institution of a special air delivery daily from Tan Son Mhut to Phu Bai, which most adequately caters for all local AATTV movement needs. On the occasions when aircraft have been unable to land at Phu Bai, road transport from Da Nang has met the need. At present the road is secure, and can be traversed without escort.
- 7. Communications at Hiep Khanh have been a problem, with water troubles frequently cutting out all electronic gear. This is receiving attention.
- Allowances. With another large pay raise for the US Forces in Vietnam the general need for recognition of the unsatisfactory position of AATTV members living in a US economic climate again comes to the fore. It will be appreciated that Australian personnel stationed in the US, and elsewhere in US controlled areas, receive allowances to help meet this situation. Here, in Vietnam, the US soldier receives additional allowances, and his Australian colleague is reduced (compare for example, the allowances of Australian personnel at Fort Bragg and Okinawa). This position continues most unsatisfactory.

CONFIDENTIAL

MORALE

- 9. At present, excellent. It may be anticipated that, after some months, the problems of monotony that were evident among the first team will appear with the second group.
- 10. Partly to meet this, and no less to give AATTV personnel an opportunity to exercise their techniques in the important and developing field of Village Defence, I request permission to modify the deployment of the team to permit further Australian participation in the CIDG (Civilian Irregular Defence Group) programme. It will be recalled that two members of the team stationed at Da Nang are engaged in this activity, and that, from time to time, a third member is detached to the CIDG base at Khe Sahn for the same type work.
- Il. The arrangement visualised is to reduce the Hiep Khanh and Phu Bai detachments (which are now running well within themselves, and which will, if necessary, be made good from US personnel) from ten to seven each, and Duc My from four to three, giving a seven man team for employment with the US Special Forces. Thus established, most personnel would be rotated through each of the three stations, giving approximately four months at each point. This would keep each man giving of his best throughout the year, give him a better overall knowledge of the country, and, I am confident, eliminate the problems arising from monotony.
- 12. I have discussed this proposal with the appropriate authorities here, and it receives their enthusiastic support. Approval of Australian authorities would enable me to launch it in time to be effective.
- 13. The general area considered for this activity is KON TUM-PLETKU, the value of Australian representation in which will need no explanation.

LANGUAGE

- I continue to be most impressed by the results of the incorporation of two linguists in the Team. I have reported earlier on the prestige lift following their arrival, both with the military element and the civilian populace. Both men are conducting classes for Vietnamese staff members of their establishments, and the results are outstanding. On the other side, I am no less impressed with the interest displayed by AATTV members in acquiring a working knowledge (crude, perhaps) of military Vietnamese.
- 15. The result of these two factors is that many classes can now be conducted without the necessary presence of an interpreter, a condition which pleases both the advisor and the Vietnamese instructor.

IMPACT OF NEW TEAMS

16. Exceeding my expectations, I find that the new team members have quickly gathered in and consolidated on the work of the initial group. Already it is possible to detect a fresh impetus in the work of all centres. The new teams are going forward from the fine ground work established in the first year.

CURRENT ACTIVITIES

Dong Da (Phu Bai). One battalion in training, one completed training, one due in. Recruit course, two replacements groups, NCO courses (CC1 and CC2). Student strength: 2200.

(2) CONFIDENTIAL

- Hiep Khanh
  Has just completed training of four CG companies. Awaits next intake, meanwhile is training a newly arrived Security cum Demonstation Company.
  Student Strength: 800.
- Completed training of one Ranger Battalion. Continuation of Jungle-Mountain-Swamp Course. Continuation training of two Special Task platoons. Continuation training of three recruit replacement companies. Student Strength: 1200.
- Captain Boileau has begun operations with the Special Forces and Combined Studies Division, where his current efforts are directed primarily towards Psy War measures with Montagnard tribesmen in support of the Villege Defence Programme.
- Captain Petersen, now well established as a member of the Da Nang group, is temporily working the Ban Me Thout area and similarly occupied.
- Extract from Dong Da report:

  "---- 2 Bn 5 Regt, which was the last battalion in training, is meeting with great success in operations in Quang Ngri province. In one action against a VC unit, this battalion is reported to have killed (counted dead) 68 VC, mainly by rifle and MG fire, for the loss of seven killed and several wounded.——"

  I observed that operation and can add that they went on subsequently to destroy the local VC regimental Headquarters. A very satisfactory result.

### INFORMATION REQUESTED 23. Status of proposal to attach

- Status of proposal to attach Australian personnel to US Rand D elements here.
- 24. Status of proposal that AATTV wear MACV insignia. I have advice through External Affairs channels on this matter, but can take no action until I hear from AHQ.

#### COMMENDATION

- A copy is appended of a letter from General Paul D. Harkins, COMUSMACV, to Comd, AATTV expressing his appreciation of AATTV's first year's work. This letter has been copied and sent to all past and present AATTV members. General Harkins has been assured of our continued dedication to the task on hand.
- I have had my attention drawn to the splendid work of WOl Perkins, WOII Williams (both recently departed this theatre) and Sgt Cochrane all of Hiep Khanh. This I have confirmed from my own observations. Each in his own alloted sphere respectively, General Subjects, Tactics, and Weapons, has made a most significant contribution to the successful development of this key installation.
- In a different field, I should record the outstanding performances of Captain Wade, of Duc My Ranger Training Centre, who has been in great measure responsible for the high operational effectiveness of the ARVN's Ranger units; and of Captain Healy, whose work with Special Forces and Combined Studies

Division at Da Nang made a material contribution to the effective launching of this entirely new type of military operation.
