Food monotonous, area security a little more tense; training satisfactory; incoming battalions in bad shape for officers. Instructed Major KENNEDY to establish liaison with local Province Chief and Sector Advisor, so that he doesn't get caught napping. To PHU BAI in C45, arriving 1815. Inspected night training. Inspected training. Senior Advisor I Corps (Col WOHNER) also present. Meanwhile took 10 temperature of AATTV/PEDERSON position. This installation has run down somewhat in the last few months - since the departure of NEWELL. Departure of Major DA COSTA, who has done a splendid job at PHU BAI. Advised of recommendation for Soldier's Medal for WO COLLINSON for heroism in saving a drowning VN soldier at KHAM DUC. Publication of orders for amalgamation of MACV/MAAG Big battle in CAMAU. Two VC battalions, and later a third, attacked district capital of KIEN LONG in CHOUNG THIEN province. Overran it, disembowelled District Chief, murdered his wife and infant son, plus several hundred inhabitants. GVN reaction weak. Conference with General TIMMES on future position of AATTV after re-organization. Not affected. Accepted general invitation from British Ambassador for AATTV personnel to attend Queen's Birthday reception. Signalled AHQ to extend Captain BOILEAU for one month, on account of the difficult operational position in QUANG NGAI. Arrival of Sgt HUSBAND.

Asked him to watch the US end of the current contretemps on awards and decorations for AATTV. Paymaster-in-chief despatched \$8000 without comment. Interesting to see if this continues. Lucky we didn't take his first attack lying down. Briefed Jl MACV (Capt TVEDT, USN) on Australian position on decorations and awards. Continued negotiations with J3 MACV for a HQ position for Major MURPHY. Secretary RUSK and General WHEELER visiting. Briefed Captain TEAGUE and WO STEWART. Rightest coup in LAOS because of government neglect of economic welfare of the people." This is double-talk for describing a disagreement between PHOUMI NOSOVAN and the coup leaders on the distribution of profits of the VIENTIANE casino. Now to see the reaction of SOUPHANAVONG and the Pathet Lao. Lt Col MCNAMARA to SINGAPORE for R&D briefing. Three AATTV members to the battalion at MALACCA for KAPYONG Day, via DANANG, UBON, BUTTERWORTH. British Embassy Reception for Queen's Birthday. LAOS still unsettled. Big powers trying to re-establish status quo, with surprising unanimity. NGO DINH CAN sentenced to death by a kangaroo court in SAIGON. Conference with CH MAAG, General TIMMES, on the shape of his new temporary appointment as advisor to Minister of Interior. Received CONARC signal on my visit to US. Now await approval from CANBERRA.

APRIL 1964..... MONT I AND "EAR Annex letter and Event or information Day of Place at 1 grid Hour enclosure number Month refer nce ANZAC Day. Good reception at Ambassador's residence, at which AATTV was well represented. WESTMORELAND announced to succeed HARKINS. Debriefed Capt PETERSEN of BAN ME THUOT on situation in DARLAC province. Autonomy is raising its head. Dai Viet making considerable progress among the middle seniority officers and officials. Briefed Ambassador with particular reference to Dai Viet activities. Signal from CANBERRA approving new method of incident reporting, and refusing permission for US Visit. Attended graduation exercises of Chinese High School - a worthy project. Discussed a revised strategy for the war with Ambassador LODGE. Accepted. Referred to WASHINGTON. General KHANH is sick - chronic stomach trouble, which presumably is nervous in origin. Understandably! You need both physical and mental robustness to last the distance in this business. To I Corps with NES (Deputy Chief of Mission, US Embassy). L 23. Weather good, visibility fair. First stop ASHAU. Warned off "in enemy hands". This was an exaggeration, apprently effected by Senior Advisor I Corps to get some action from GVN on clearing the VC from the neighborhood of the strip. (They hit WESTMORELAND's aircraft a few days earlier). On to KHE SAHN, where we saw the work of WO's ROONEY and DONKIN. Most impressive. They are re-capturing the original CIDG spirit, which has been sadly missing since the Strike Force have come to be manned by hooligans from the cities. To PHU BAI. Lt Col KERKER in hospital with kidney trouble. Station much improved since replacement of PEDERSEN. Almost back to its former standard. Hygiene not the best, however. Some cases of dysentery. NES had opportunity to see conditions of VN soldiers. Some fool had removed two battalions in training and committed them in DO XA fiasco. To DANANG. Briefed at I Corps. Overnight stay with Captain TEAGUE, BOILEAU and BURROWS. Briefing and facts were rather at variance, according to AATTV members who attended. Atmosphere of euphoria doesn't match the operational situation.

#### GENERAL.

1. The trends reported in March continue. Erosion of RVNAF manpower is seriour. A number of large and successful actions have been launched by the VC, with a corresponding number of large, and rather less successful actions by the GVN. I see no sign of the KHANH government having progressed towards gaining the support of the people.

#### REDEPLOYMENT OF HIEP KHANH GROUP.

- Action on this redeployment is now complete, on the lines indicated at para 4 of Report No. 20.
- 3. The work of AATTV members with these Special Forces detachments continues to gain favorable comment.

#### COMMENDATION.

- 4. I have been particularly impressed with the work of WO MC COURT who, while recovering from his recent pangi wound, and partly immobilized, has launched a programme of night ambush training for village defenders. Already this programme has altered the tactical picture in his area.
- I have had my attention drawn to the outstanding work of WO SWANSON and WO COOK, respectively of the DONG DA Weapons and Tactics Committees. This confirms my own observation. The recent successful operations by 2 Division owe much to the work of these two AATTV members.

#### HEALTH.

7. There has been a minor outbreak of amoebic dysentery at DONG DA among AATTV and MAAG personnel. All concerned have recovered and returned to duty. It is suggested that all AATTV personnel on RTA be examined thoroughly for residual effects of this and other troubles.

#### MORALE.

8. Excellent.

#### WELL-BEING

- Allowances. Several months have now elapsed since the Austarm inquiry into AATTV allowances scales was made. There has been no indication of relief. Meanwhile all Commissary prices have increased approximately 10 per cent.
- 10. Decorations and Awards. AHQ will have received my separate submission on this subject. This matter gives rise to discontent and criticism. It is important to the well-being of this Force that either a form of recognition of their operational service be effected or an appropriate reason provided why this should not be done.

#### VISIT TO UNITED STATES, COMD AATTV.

11. The to and fro signals on this matter were noted.

#### CURRENT ACTIVITIES.

Dong Da (Phu Bai)

2 Bn 6th Regt - Completed 4th week of 5 weeks training.

2 Bn 2nd Regt - Marched in.

CCl - Two companies completed 1st week of 9 weeks training.

Recruits - Two companies completed 1st week.

At the end of the month, 2/6 and 2/2 Bns by a unilateral decision on the part of ARVN were removed from training to take part in an operation in QUANG NGAI. This was most unfortunate, but not unusual.

#### 13. Special Forces, CIDG (Village Defense)

No Change.

CAM DUC will in future be spelt KHAM DUC.

Personnel based at KHE SANH and AN DIEM will find themselves detached from time to time, as the need arises, to other parts within the DANANG group, notably ASHAU, KHAM DUC, and TARAU.

As the CIDG programme attracts more Montagnard villages, the Special Forces "A" Teams will move further to the WEST.

#### 14. DUC MY

38 Ranger Bn completed its 6 weeks course.
23 Ranger Bn continues its 6 weeks course.
Basic Ranger Training continues.

JMS Course No. 13 completed.

#### 15. VUNG TAO

Special Cadre Course No. 1 completed. Special Cadre Course No. 2 commenced.

#### LOG OF INCIDENTS

Date	Location	Occurrence
23 Apr 64	AN DIEM	Our AN DIEM patrol, which Capt DE LA HUNTY is accompanying as training advisor, came under fire. One member suffered gunshot wounds to the chest.
24 Apr 64	ASHAU	A CV-2 aircraft carrying General WESTMORELAND was fired at when about to leave ASHAU. WO2 STOKES and WO2 ROUGHLEY, US personnel and Strike Force personnel were on the perimeter of the airstrip and were present at the limited fight which took place. Eight rounds struck the aircraft wounding some of the occupants. No casualties amongst the ground troops.
28 Apr 64	AN DIEM	Patrol made contact with VC. During this action Capt DE LA HUNTY received a facial wound from a round. The injury was slight and Capt DE LA HUNTY continued to perform his duties as training advisor.
29 Apr 64	AN DIEM	The same patrol engaged a VC sub-unit of approximately squad size. One US Special Forces member suffered a gunshot wound in the thigh and was evacuated for surgery.
