WELL BEING

1. The submission making suggestions for revision of the Scale of Allowances has been completed and is being forwarded under separate cover.

2. Briefly this indicates that the present scale of allowances requires a married man either to live under adverse social conditions, or to deprive his family in Australia of a portion of their income. It also indicates that, at the present scale, most married men will find themselves unable to make full use of the necessary recreational and leave facilities that have been provided.

HEALTH

3. No special comment.

4. W. O. Williams was briefly hospitalized with a stomach ulcer. He has returned to duty on a diet. This will need watching.

5. Appendix "A" lists status of sickness and minor casualties.

MORALE

6. Continues to be good. In most areas as the work load increases the morale rises. There has been a reduction in the strength of US personnel at two of the three major training establishments with which we are connected, leaving the Australian component with increased responsibility, and more opportunity to display special techniques appropriate to the operations.

GENERAL

7. Comments on Individuals

Much favorable comment on individuals and groups continues to come forward. In particular, during this month the work of Sgt Simpson, who has been temporarily detached to assist the Special Force Village Defense project at Ke Sen is noteworthy, as also is that of Lt Young, who has organized a new Intelligence/Operations office at his establishment in Danang, and that of Capt Tinkler, who, in the absence of the US Senior Adviser at Hiep Khanh, has been performing that officer's duties.

DETACHMENTS

8. The policy of making temporary detachments to broaden the experience of team members is proving workable and satisfactory. Useful liaison has been built with the senior US Officers of various arms (in particular, Artillery, Signals and Armour) who are ensuring that the maximum training value compatible with their basic tasks is afforded to members of corps other than Infantry.

LANGUAGE TRAINING.


9. I am advised that all US NCOs and Senior Officers entering MAAG are now to be given a three months language course in the United States prior to posting here. This policy will give rise to a need for corresponding action in Australia for AATTV replacement personnel. Course instructional material, which includes general cultural and military briefing aspects, is available in the United States.

ACCOMMODATION

10. The house to be provided for Comd AATTV is currently being negotiated. Splendid co-operation from the US military authorities produced this house. Furthermore, I should like to place on record my appreciation of the speed with which permission to negotiate was received from A. H. Q.

11. AATTV takes this opportunity of extending to the Chief of the General Staff, Members of the Military Board, and the Staff of A. H. Q. Christmas Greetings for 1962, and good wishes for the New Year 1963.
