

General

1. HMAS VAMPIRE and 6 RAR will contest a challenge match for the Wells Trophy on 4 Feb 73. The sports to be played are listed below. The sporting activities will be followed by a Bar-b-que and drinks.

 - 1. Boat Race (10 per side)

Points

- 3. A side will be allotted to 10 points for a win in any sport.
- 4. Tie. In the event of a match being tied teams will change ends and play 5 minutes each way. The first team to score wins. If a result has not been reached after this then the points are to be halved.

Rules

- 5. General. Rules will be as per Games and Sports in the Army and Potted Sports unless otherwise indicated in this instruction.
- 6. Substitutes. Up to but not more than two substitutes will be allowed in any sport at any time during a match.





"1. THE FOLLOWING PRESS STATEMENT BY THE DEPUTY PRIME MINISTER WAS MADE TODAY 22 DEC 72.

QUOTE:

THE MINISTER FOR DEFENCE, MR LANCE BARNARD, TODAY ANNOUNCED ACCEPTANCE BY THE GOVERNMENT OF THE RECOMMENDATIONS OF THE REPORT FROM THE JOINT SELECT COMMITTEE ON DFRB LEGISLATION (THE JESS COMMITTEE).

THIS MEANT THE INTRODUCTION OF A COMPREHENSIVE SCHEME OF RETIREMENT BENEFITS FOR SERVICEMEN BASED ON THE SPECIAL NEEDS OF MEMBERS OF THE ARMED FORCES.

MR BARNARD SAID IT WAS FELT THAT THE DEMANDS IMPOSED ON SERVICEMEN AND THE DISTINCTIVE NATURE OF THEIR WORK WARRANTED INCORPORATION OF THEIR RETIREMENT BENEFITS IN A SPECIAL SCHEME. THE GOVERNMENT WANTED TO INTRODUCE A SCHEME WHICH WOULD BE SIMPLE AND EASILY UNDERSTOOD BY ALL MEMBERS OF THE DEFENCE FORCES.

DEFECTS IN THE PREVIOUS COMPLEX SCHEMES HAD BEEN A CONSTANT

DEFECTS IN THE PREVIOUS COMPLEX SCHEMES HAD BEEN A CONSTANT SOURCE OF GRIEVANCE AND UNREST AMONG MEMBERS OF THE ARMED SERVICES.

MR BARNARD SAID THAT LEGISLATION TO IMPLEMENT THE NEW SCHEME WOULD BE INTRODUCED IN THE AUTUMN SESSION OF PARLIAMENT.
IN THE SAME SESSION THE GOVERNMENT WOULD LEGISLATE TO INTRODUCE RETIREMENT BENEFITS FOR MEMBERS OF THE PAPUA-NEW GUINEA DEFENCE FORCES.

DISADVANTAGED ON TRANSFER ON THE NEW SCHEME". MR BARNARD SAID THAT THE MODIFICATIONS TO RECOMMENDATIONS WHICH HAD BEEN ACCEPTED BY THE GOVERNMENT INCLUDED:

- MINISTERIAL RESPONSIBILITY FOR DFRB WILL BE TRANSFERRED TO THE MINISTER FOR DEFENCE AND THE POLICY FUNCTION TO THE DEPARTMENT OF DEFENCE, BUT DAY TO DAY ADMINISTRATION, INCLUDING THE PAYMENT OF BENEFITS, WILL REMAIN WITH THE DFRB OFFICE.
- THOUGH THE CONCEPT OF CONTRIBUTIONS OF 5.5 PER CENT OF PAY HAS BEEN ACCEPTED THERE WILL BE AN EXAMINATION OF DETRIMENT TO CERTAIN MEMBERS WHO PRESENTLY PAY SUBSTANTIALLY LESS.
- PENDING RECEIPT AND CONSIDERATION OF A REPORT BY PROFESSOR POLLARD, WHO HAD BEEN APPOINTED BY THE PREVIOUS GOVERNMENT TO INVESTIGATE VARIOUS METHODS OF UP-DATING PENSIONS, DFRB RETIRED PAY, INVALID PAY AND WIDOWS ANNUITIES WOULD BE ADJUSTED ANNUALLY ON THE BASIS OF VARIATIONS IN AVERAGE WEEKLY EARNINGS.

ANY INVALIDED MEMBER WHO HAS AN ACCRUED RETIRED PAY ENTITLEMENT IN EXCESS OF HIS INVALID PAY ENTITLEMENT WILL BE FAID HIS RETIRED PAY ENTITLEMENT.

3. Duties (General Summary)

a. RAP Sgt

- (1) Is responsible to the RMO for all documents and Q accounts etc held by the RAP.
- (2) Is responsible for the smooth operation of the RAP.
- (3) Is directly responsible for the health of BHQ.

b. Med Assts

- (1) Are responsible to the RMO for all documents held by the CAP.
- (2) Are directly responsible for the health of the coy to which they are allotted.

c. Batman

(1) Is to be available for general duties at the RAP.

d. All Members

- (1) Are to keep the RMO informed of their whereabouts. Unless otherwise indicated, it will be assumed that they will be in the RAP or CAP.
- (2) Are to observe Coy and Bn sports parades unless otherwise exempt by the RMO or Coy Comd. Permission to play extra unit sport must be obtained from the unit.
- (3) Are to report to the RMO's office at 1200 hrs every Friday.

4. Duties of the RAP Sgt

- a. He is allocated an office in the RAP which is to be kept in a neat and tidy state at all times.
- b. He is responsible for keeping documents and IHC's of BHQ up to date at all times, and for their security. (Refer para 5, sub paras g, h, i, j and k).

- c. He is responsible for onsuring an adequate supply of stationery etc (eg F Med 5's, 6's, pens etc) for the RAP's use.
- d. He is responsible for indenting for medical stores.
- e. He will keep, for the RMO, a register of referal and admissions with diagnosis.

f. Sick Parades

- (1) He will liaise with the RMO for appointments to be made for all members of BHQ, and others who cannot attend morning sick parades. The RMO will see only emergency cases once sick parade has finished, unless such appointments have been made.
- (2) He will coordinate timings for Coy sick parades being presented to the RMO.
- (3) He will attend and supervise sick parades from his office.
- g. He will control movements of vehicles allocated to the RAP and will be responsible to the RMO for them.
- h. He will ensure that the RMO is aware of all correspondence pertaining to him, and he will, with the aid of Coy Med Asst, keep the RMO informed of Coy activities.
- i. He will make fortnightly spot checks of RAP equipment.

5. Duties of Med Asst

a. He is allocated a CAP which he will keep in a neat and tidy state at all times. He will be administered by the Coy to which he is allocated.

b. Sick Parades

- (1) Unless otherwise specifically instructed by the RAP to the contrary, no member of any coy will report to the RAP direct, but will first consult his coy. Medical assistant, who will decide whether the member requires consultation or treatment at the RAP.
- (2) The coy med asst will screen each morning those of his allotted coy, who wish to consult the RMO at the RAP, and shall decide who will present for consultation.
- (3) Members requiring consultation at the RAP will be escorted by the med asst, who will present the members medical documents and participate in the running of the sick parade (dispensing, treating, clerking).
- (4) Prior to the sick parade the med asst will complete the following documentation:
 - (i) A46 for each patient.
 - (ii) Ensure a D11 form is completed (5 copies) where required, and forwarded to the RAP.
- (5) Timings for the morning daily sick parades for each coy will be forwarded to the coy med asst. Those presenting after sick parade hours will not be seen at the RAP, except in emergencies, but will report to the coy med asst.

- (6) After each sick parade, the coy med asst will record for his company, the following:
 - (i) Number attended for consultation by RMO.
 - (ii) Number of reviews (ie. second and subsequent visits).
 - (iii) Number ill from the following categories:
 - (a) Skin disease
 - (b) Ear, Nose, Throat disease
 - (c) Chest infection
 - (d) Bowel disease
 - (e) Joint, Muscle Bone injuries.
 - (iv) Number of treatments performed by the med asst for the day.

By the 5th day of each month, monthly totals for categories (i) - (iv) will be forwarded to the RAP.

c. D11 Register

- (1) This shall be kept by the coy med asst, and shall record:
 - (i) Date D11 completed by member.
 - (ii) Date forwarded to RAP.
 - (iii) Date received from RAP and forwarded to coy orderly room for typing.
 - (iv) Date typed D11 copies received from coy orderly room and forwarded to BHQ (Asst Adjt).

d. Treatments, Consultations After Sick Parade Hours

- (1) Where required, these will be carried out by the coy med asst either at the RAP (if this is necessary) or at the med asst's office, where minor drugs and first aid equipment will be kept.
- (2) Consultations by the RMO will not be undertaken after sick parade hours, except where the med asst deems the situation an emergency.

e. Nominal Rolls

(1) Each med asst will ensure that a daily accurate nominal roll is held by him for his coy.

f. FFI's

(1) To be performed as deemed necessary by the med asst, and followed by appropriate action where necessary.

g. Vaccination Parades

(1) Each coy med asst via liason with the RMO, will organize vaccination parades for his coy, at the appropriate intervals, and forward entered IHC's for signing to the RAP. Failure by any member to attend (without adequate reason) at the appointed times for vaccination, is to be reported along with details of Rank, No, Name to the RAP. Where any member is unable to attend for vaccination, the med asst will ensure that adequate alternative arrangements have been made.

h. IHC Register

- (1) The coy med asst will ensure that all IHC's for the coy are lodged with him, by checking those he possesses against:
 - (i) IHC Register (which will record incoming, outgoing IHC's along with reasons for each).
- and (ii) Daily nominal roll.

 Such a check will be performed at least weekly.
- (2) Where IHC's are withheld, the matter is to be reported promptly to the RAP.

i. Medical Documents Register

- (1) The coy med asst will record in the register the arrival and removal of documents, for any reason whatsoever, along with reasons for each occurrence eg. hospitalised, medical board specialist appointment, discharged, detached, "at RAP".
 - (2) The med asst will check at least weekly, whether any medical documents are missing, by referring to:
 - (i) Medical documents refister.
- and (ii) Daily nominal roll the absence of any medical documents is to be reported to the RAP.

j. Appointments Register

- (1) This will cater for:
 - (i) Hospital specialists appointments.
 - (ii) Special tests.
 - (iii) STC appointments.
- (2) The med asst will keep this register up to date by daily liason with the RAP, and will ensure that members report for these appointments as prescribed.

k. Filing of Documents

(1) The coy med asst will collect each day from the RAP the paperwork relevant to his coy, and file those applicable in the medical documents of the member eg. specialist reports, hospital discharge summaries, results of test, medical board results.

SUMMARY

The coy med asst will be responsible only for the medical aspects of his coy, in as far as this concerns him. The primary task is that of medical commitment, and no other will supervene this. Prior to the coy med asst committing himself to other tasks, he shall ensure that his primary task as med asst has been thoroughly attended to.

It is emphasised that information of a non statistical nature (ie. information classified as medical in confidence) is not to be divulged by NCO's to anyone whatsoever.

Security precautions will apply at all times - unattended documents, drugs will be locked and secured in a steel filing cabinet.

8. IMPROPER POSSESSION OR CARRYING OF ARMS AND AMMUNITION

- 1. Civil and Military Law imposes severe penalties in respect of unauthorised carriage or possession of arms, explosives, etc.

MINUTES OF CO'S CONFERENCE FRI 12 JAN 73

- 1. General. The Commanding Officer made a short opening address. The CO indicated that the unit had an excellent reputation and he expected this to be maintained in all fields throughout a probably more difficult second year. Maintenance of efficiency was to include operations/exercises, personnel management and care of stores and financial accounts. - 5. <u>Dacron Clothing.</u> The 2IC stated that current instructions on the wearing of this uniform would be clarified in the near future.
- 6. Promotion Exams. Maj Bishop, acting as Ops Offr stated that the status of publications has been issued. The IO was asked to ensure that publications were available with up to date amendments.
- 7. Assault Pioneer Course. A course is to be conducted by 28 Fd Sqn from 12 Feb 23 Mar 73. Although the course will be primarily for the benefit of the Assault Pioneer Platoon, companies may bid for vacancies to the Ops Offr. (The course will be run during the battalion competition).
- 8. Adventure Training. OC Spt Coy stated that two landrovers and one 3 ton vehicle were available for adventure training. The Commanding Officer stressed the need for this type of training.

.../9. Wessex

- 9. Wessex Familiarization. OC Spt Coy stated that the aircraft were in country but would be "tied up" through January. Companies should look at suitable dates in February.
- 10. Major Mansford stated that the system of amending training programmes would continue and companies are to ensure that Coy 2ICs or CSMs phone amendments to training programmes to the ops office each day.
- 11. The conference was briefed by the Adjt on the following aspects of CO's policy.

Allocation of Reinforcements

- 12. Soldiers would be broadly classified into two categories:
 - a. average to above average; and
 - b. below average.
- These classifications would be based on recruit training reports. The Adjt and the Chief Clerk would then allocate an equal number (where possible) of both categories to companies. The following factors would also be considered:
 - a. strengths of rifle companies would be kept equal where possible;
 - b. national servicemen would not be posted to Spt Coy if this could be avoided; and
 - c. coys may bid to the Chief Clerk for specialists such as draughtsmen, musicians etc. Bids for sportsmen would not be acceptable.

Promotion

- 14. <u>Lance-Corporals</u>. Coys were allocated those numbers shown on the Vu-Graph. Recommendations for promotion above the entitlement would only be considered in exceptional circumstances.
- Corporals. As a unit policy, only members who are qualified for Corporal in at least two out of the three subjects and have an education of AACE 3 or better would be considered for promotion to temporary corporal for a trial period of 3 months. If, after this period the member demonstrated the necessary qualities, the promotion would be made substantive by the submission of a further A26A. Members who did not have the above qualifications would only be considered as a special case.
- 16. Sergeant. For promotion to substantive sergeant, an A26A is required to reach CARO by the 1 Mar each year. All subjects for promotion and education of AACE 2 standard are required.
- 17. HDA. In addition to those factors outlined in MBI 90-14, all applications are to be checked against the coy roll book prior to submission and are to be endorsed by the coy comd or coy 2IC to this effect. Only in exceptional cases should HDA be submitted for more than one step in rank.

.../18. CO's

- 18. <u>CO's Conferences</u>. The CO's policy is that these would be held on an "on demand" basis. Coys will be advised of the details as conferences are required.
- 19. Manning. The Adjt discussed the manning chart with company commanders.
- Leave. Leave is to be taken during the two block leave periods per year. In special circumstances application may be made to take leave outside of this period for such reasons as marriage, opportunity to indulge to UK to see close relatives or where close relatives are visiting from Australia. Emergency leave would be granted along the lines of Annex D to the MBI and this would include requests to look after children regardless of whether or not members employ an amah.
- 21. Company commanders were briefed by the CO on the following points:
 - a. Battle Efficiency Tests. All ranks, except those members exempted by age (40 yrs and over) or medical restrictions are to actually complete Battle Efficiency Tests as per MBI 252-3 rather than simply have their name recorded in ROs as having done the tests.
 - b. Powers of Company Commander
 - (1) In the case of an NCO
 - (a) reprimand; or
 - (b) admonition.
 - (2) In the case of a private soldier
 - (a) a fine not exceeding Ten dollars;
 - (b) confinement to barracks not exceeding 7 days;
 - (c) extra guards or picket; or
 - (d) admonition.
 - (3) In addition to the above, the following CO's policy is to apply:
 - (a) all NCOs are to be remanded to the CO, unless the charge is of so trivial a nature that the coy comd thinks he should deal with it;
 - (b) all cases involving AWOL over 24 hrs are to be remanded to the CO (because of pay and allowances involved in a finding of guilty).
 - c. Sport. Training is to be carried out each Tue and Thu afternoon from 1500 hrs onwards. The sports officer is to promulgate an up to date list of training squads periodically. In cases where coys are away on exercise (with the exception of Butterworth), members are to return to camp on a Thu in time for training. (There were to be no exceptions to this and pl comds etc should be allowed back).

../22.

- 22. <u>Ceremonial</u>. The CO stated that the unit would concentrate on one major oeremonial parade per year on Long Tan Day, whilst the battalion birthday and other occasions would be of a less major nature.
- 23. A conference with the CO, Ops Offr and RSM would be held shortly concerning the issue of instructions on Friday morning officers and RSM/SNCOs (training the remainder of the unit).
- The CO stated that all officers and ORs were to be present for the O800 hrs sub-unit parade. The CO also stated that terms of address such as "boss" and "skipper" were not to be used within the unit.
- 25. Questions were then taken:
 - a. ID Cards. In reply to a question by OC B Coy, the Adjt said a reply was expected shortly on the loss of an ID card being a prevalent offence.
 - b. NS Extensions. In reply to a question by OC A Coy, the Adjt stated that policy on extensions of NS would be promulgated.
 - c. Reinforcements. OC D Coy was informed that the next draft of reinforcements was due on 16 Jan 73.
- 26. Final Point. The QM drew attention to FRO 10/73 and the requirement for companies to submit forms FEME 1.

- 1. Examination of unit Routine and Standing Orders received at HQ ANZUK Spt Gp has revealed that in a large number of cases, paragraphs designed to be read as orders have not been expressed as such but as statements of fact or intention.
- 2. If a serviceman is to be charged with breach of a written order, the prosecution case may well fail against him if the order is expressed as a statement.
- 3. When a written order is produced, it must as far as possible express an order in the active voice and as a complete sentence made up of three parts arranged in the following sequence:
 - a. The identity of the person responsible to do some act or refrain from doing some act.
 - b. The words "is to" or "are to".
 - c. The specific action that is required or prohibited.
- 4. Sentences such as "it is an offence to exceed the speed limit" and "the speed limit is 25 mph" are not orders but statements of fact.

 Attached as Annex A are examples of incorrectly and correctly drafted orders.
- 5. Units are to ensure that routine and standing orders comply with the contents of para 3 above. Where necessary, existing routine and standing orders may have to be redrafted and re-promulgated in an amended form.

- c. civilian attire is to be worn on all occasions (except as stated in sub-paras a. and b.) in accordance with sub-paras l. j and l. k. above.

5. Wearing of Shorts, Long Socks, Garter Tabs and Puttees

- a. Shorts are to be worn with the bottom of the shorts no higher than four fingers above the knee.
- b. When long socks are worn they must have a four-finger fold with the top of the fold no lower than four-fingers below the knee.

- c. Only 1 inch of garter tab is to be showing and,
- d. When wearing puttees there are to be three overlaps \(\frac{1}{4} \) inch wide, each overlap is to commence at the back of the heel and the final tie is to be in line with the outer ankle and all ends are to be tucked out of sight.
- 6. Badges of Rank. All chevrons are to be of the authorised AMF issue only.

7. Crash Helmets

All personnel including pillion passengers when riding motor cycles are to wear crash helmets. Helmets are to be of the authorised types either issued or local equivalent to the standard helmet. Helmets are to be correctly fastened at all times by both rider and passenger.

17. AMF IDENTITY CARDS (AAF A129)

Reference: A. MBI 212-5 dated 26 Oct 70.

General

1. Instructions concerning the preparation, issue, withdrawal, loss and replacement of AMF identity cards (AAF Al29) are contained in reference A. This order covers the implementation of those instructions within 6 RAR.

Carriage and Security of ID Cards

- 2. Unless directed otherwise by the CO, ID cards are to be carried at all times by all members of 6 RAR in Singapore/Malaysia.
- 3. Under NO circumstances are holders to allow their ID cards out of their possession, as temporary security for loans or similar services.
- 4. Identity cards are valuable documents and their possession by unauthorised persons represents a potential security risk. All ranks are directed to take special care to ensure safe custody of their cards at all times.
- 5. The loss of identity cards is declared a prevelant offence.

Issues

- 6. HQ ANZUK Spt Gp is the sole issuing authority for AMF identity cards.
- 7. The IO is responsible for ensuring that issues of ID cards are recorded in the "Miscellaneous issues" section of the holders AAB 83.
- Requests by the unit for issue of ID cards for individuals are to be made to HQ ANZUK Spt Gp, by the Int Sgt. Issues are made at Woodlands on the first and third Mondays of the month between 0900 and 1000 hours.

Action on Loss

9. When an ID card is lost/damaged by a member the loss/damage is to be reported immediately by the member to his sub-unit HQ, where replacement action by the Int Sgt is to be implemented vide reference A.

Withdrawal

- 10. Where it becomes necessary to withdraw ID cards the unit is to adjust the entries in AAB 83 and forward the ID cards so withdrawn to HQ ANZUK Spt Gp with covering letter.
- 11. Rank changes are effected on production of ID card at the issue centre.

18. IDENTITY DISCS

AMF identity discs are to be worn at all times when military or civilian clothes are worn. It is not necessary to wear ID discs at the swimming pool, for example.

19. LOSS OF MBIS/AROS

- 1. Incidents have occurred where MBIs/AROs have been removed from binders in the unit and used for members personal study. Members of 6 RAR are not to remove MBIs/AROs from binders unless for photostatting purposes and then only on signature.
- 2. Under no curcumstances are members of 6 RAR to remove MBI/ARO binders from the Battalion Area.

20. INSURANCE INDEMNITY OF HOUSEHOLD EFFECTS

Following the upgrading of insurance indemnity for household effects from A\$4000 to A\$8000, clarification has been sought from AHQ(C) as to how the extra four thousand may be allocated. The following is the text of a signal from AHQ(C) clarifying the situation:

"INSURANCE INDEMNITY OF DOLLARS EIGHT THOUSAND APPLIES TO REMOVALS IN AUSTRALIA ONLY. MAXIMUM INDEMNITY FOR GOODS TO OR FROM OVERSEAS STILL DOLLARS FOUR THOUSAND. INITIAL ELECTIONS CANNOT REPEAT CANNOT BE VARIED FOR GOODS TAKEN OVERSEAS. PRESENT POSITION IS UP TO MAXIMUM OF DOLLARS FOUR THOUSAND OVERSEAS AND DIFFERENCE UP TO TOTAL OF DOLLARS EIGHT THOUSAND IN STORE AUSTRALIA. FOR EXAMPLE FOUR THOUSAND OVERSEAS AND FOUR THOUSAND AUSTRALIA OR TWO THOUSAND OVERSEAS AND SIX THOUSAND AUSTRALIA. FOR MEMBERS CURRENTLY OVERSEAS ELECTION FOR GOODS TAKEN OVERSEAS CANNOT REPEAT CANNOT BE VARIED BUT AMOUNT OF INDEMNITY ON GOODS IN STORE IN AUSTRALIA MAY BE INCREASED TO COMBINED TOTAL OF MAXIMUM DOLLARS EIGHT THOUSAND IF REQUIRED. THIS IS TO BE DONE ON EXPIRATION OF PRIVATE INSURANCE SUBJECT TO DEPT OF SUPPLY BEING ADVISED THROUGH COMD HQ IN WHICH FURNITURE STORED".
