COMMANDERS DIARIES INSTRUCTIONS

AIM

1. The aim of a Commanders Diary is to provide data on which to base future improvements in Army training, equipment, organization and administration, and to furnish historians with a record of the activities of units and formations in operational and non-operational periods in peace and in war.

GENERAL

- 2. Entries are to be made daily on AF C 2118 (Adapted) each entry being initialled by the officer detailed to keep it.
- 3. Commanders Diaries will conform with the rules for drafting orders given in "Staff Duties (Australia)", Chapter 2, Section 12.

RESPONSIBILITY

During Non-operational Periods

4. A Commanders Diary is to be compiled by commanders of all formations.

During Operational Periods (1)

- 5. A Commanders Diary is to be compiled in duplicate by:
 - a. Commanders of all formations.
 - b. Each branch of the staff at formation headquarters commanded by a brigadier or above.
 - c. Heads of services not below the rank of lieutenant colonel.
 - d. Personal staffs and officers holding special appointments.
 - e. Unit commanders.
 - f. Commanders of a detachment of a unit when so ordered.

COMPILATION

- 6. Both original and duplicate copies are to consist of:
 - a. Cover (AF C 2119) (Adapted).
 - b. Index as printed on cover.
 - c. Narrative (AF C 2118) (Adapted).
 - d. Annexes as shown in the Index.
- 7. All details of the unit or formation (if a detachment is concerned, the name of the parent unit), period covered and enclosure numbers of the annexes are to be shown on the cover. If there has been a change of command since the last report, the date of assumption by the new commanding officer is to be included.
- 8. The annexes are to be assembled in the groups shown on the cover. If there are no enclosures for an annex NII will be entered on the cover. If additional annexes are convenient for a particular headquarters. arting at B.

ORDERS - ROAD CHECK POINTS

NORTH AND SOUTH

1. Duties.

- a. Search all civilians and civilian vehicles passing through the check point. The NORTH check point is to search southbound traffic and the SOUTH check point northbound traffic.
- b. Commence duty at each check points at 0645 and sismount at 1700 hrs.
- C. Each checkpoint is to have a broom, paintbrush, paint and camera. A number is to be painted on the ox carts and all occupants are to be photographed ensuring the number is visible.
- d. A register is to be maintained containing the following detail:
 - (1) Ox carts number.
 - (2) Owners name and address.
 - (3) Drivers and passengers names and addresses.
 - (4) Load carried.
 - (5) Time through the check point.
 - (6) Remarks to indicate direction NORTH or SOUTH.
- e. The register is to be retained by the unit responsible for the check point.
- f. The exposed films are to be passed to 1 ATF Div Int Unit on the day after exposure for processing. One copy of the photograph is to be returned to the unit responsible for the check point, and one copy is to be retained by Div Int Unit.
- g. Ensure that NO civilians move through 1 ATF Base Area without 1 ATF CP approval.
- h. Log all military vehicles passing through the check point except those in convoy. Units are to provide vehicle log sheets.
- i. No movement of civilians through the check points prior to 0800 hrs and after 1600 hrs.
- j. The NCO I/C of the check point is to be informed by 1 ATF CP of any ARVN, RF or PF soldiers who have received permission to move through 1 ATF area.
- k. If any movement of Vietnamese troops occurs which has not been previously approved, 1 ATF CP is to be contacted immediately as to what action is to be carried out.
- 1. If the NCO I/C of the check point considers any suspicious act is occuring he is to detain the persons or vehicle or both and inform 1 ATF CP to that effect. The Duty Officer in the CP is to direct Det 1 Div Int Unit to investigate.

.... m...

- m. Any suspicious persons will be taken to Div Int Unit and placed in the Provost PW compound.
- n. The NCO I/C is to ensure that all civilians and vehicles are thoroughly searched by the National Police. This is to include all effects carried and examination of vehicle from top to bottom.
- o. Hand over responsibility for the SOUTH Check Point to 1 Fd Regt RAA at 1700H.

2. Transport Group.

- a. In addition to providing an NCO and 8 soldiers the responsible unit for the SOUTH Check Point is to provide a driver for the Landrover and trailer.
- b. At 0730 hrs the Transport Group is to collect 4 National Policemen from District HQ HOA LONG and deliver 2 to each check point and return them to HOA LONG at 1600 hrs.
- c. Be used as required y NCO I/C of check point for meal reliefs.
- d. Return to unit lines when released by NCO I/C check point but not before 1700H.

3. Interpreter.

- a. During daylight hours 2 interpreters are available from 1 ATF. They are to report to the SOUTH check point no later than 0745 hrs.
- b. The unit manning the NORTH check point is to provide 2 interpreters from the unit.

4. Photography and Recording.

- a. Once an ox cart has been numbered and photographed it should not be necessary to photograph it again unless the number is non readable or any doubt exists at the check point. The NCO I/C of the Check Point will decide in this case if the ox cart is to be re-photographed.
- b. Recording of all names etc of occupants of the ox carts will be necessary for all ox carts irrespective of whether they have been photographed previously or not. A note placed in the remarks column is to indicate if the ox cart has been previously recorded.
- c. Numbering of photographs for receipt of this order will be as follows:

 - a. A Statutory Declaration is to be made by the member stating:-
 - (1) A brief explanation of the loss or damage.

- (2) In respect of each article lost:-
 - (a) Outline measures taken to recover the articles.
 - (b) Declare the value when new.
 - (c) Declare the value when lost.
 - (d) Attach vouchers and receipt if held, to support this declaration.
- (3) In respect of each article damaged:-
 - (a) Declare the cost of repair.
 - (b) Attach supporting evidence, eg. quote or receipt.
- b. Each claim submitted for consideration is to be accompanied by:-
 - (1) A full account of events leading up to the loss or damage, together with any report by an Investigating Officer etc.
 - (2) An outline of the members duties and any special assignment at the time of the occurrence.
 - (3) Statutory Declaration as in a. above, supported, if possible, by statements by other members.
 - (4) A certificate, by the CO, that the articles were necessary for use within the theatre either for actual performance of duty or for the well being and morals of the member.
 - (5) A certificate, by the CO, that the articles have been replaced by the member.
- 2. Compensation is not payable:
 - a. In excess of the value as determined at the time of loss or damage.
 - b. In respect of any article that can be rendered serviceable.
 - c. In respect of money or articles which a member is NOT required to replace for the proper performance of his duty, or for his well being or morale.
 - d. In respect of any article NOT replaced by the member.
- 3. The cost of repair of an article to render it serviceable, may also be claimed.
- 4. It is stressed that the greater amount of the above detail that is included, the better the chance of a favourable decision being given bb AHQ.

POSTAL

226. CONDITIONS FOR CONCESSION

All mail MUST bear senders return address on the back of the envelope. It is also advisable to print the words "Forces Mail" in the top left hand corner of the front of the envelope.

227. CUSTOMS

The Australian Government permits \$50 (Aust) worth of goods duty free in any one calender year. The following imports are restricted to the amounts indicated:-

Cigarettes, 2,000 per year.

Tobacco, 5 lbs per year.

Cigars, 200 per year.

228. CONTRABAND AND PROHIBITED IMPORTS

Weapons, double edge knives, flick knives, wood carvings, unless lacquered, dirty clothing, drugs and narcotics of any nature, any species of plant life are prohibited imports.

233. REGISTRATION OF ARTICLES

- 1. If any article requires registering an extra 23c MPC is required.
- 2. All parcels must be neatly wrapped and tied with some type of strong cord and addressed in large letters, accompanied by a Customs declaration stuck to the outside of the article, and senders return address on the back.

234. MAIL TIMINGS

Outgoing letter mail closes at 1430 hours daily. Incoming letter mail is ready for collection at approximately 1900 hours daily.

235. PARCEL POST - (AIRMAIL)

A maximum weight of 1 lb will be accepted for Airmail parcel post. All others by surface mail (weekly RAAF Courier) but delays are caused due to Medevac priority over parcel post mail. Approximate transit time for parcel post is 2 to 8 weeks.

236. TELEGRAMS - EFM CODE

Maximum of 3 codes per telegram, only available to Australia and New Zealand. The cost of 3 codes is 36c US.

237. OVERSEAS LETTER POSTAGE RATES

Rates of postage to some overssas countries are listed as follows:-

2. Prices to other countries are obtainable at the Unit Post Office.

238. USE OF 1:25,000 PICTO MAP SUPPLEMENT

Use of 1:25,000 Picto Map Supplement.

Addressees are cautioned that the 1:25,000 scale pictomap is a supplement to the standard 1:50,000 scale map. It contains certain inherent distortions which result from the photographic process by which it is printed and should not repeat not be used in situations which require exact coordinate locations. Eg. Adjustment of supporting fire and reporting locations.

239. USE OF AAF D11 IN VIETNAM

- 1. The form AAF D11 is designed to record illness and injury to a soldier and to establish whether the member:
 - a. Has a claim under the CEC Act; or
 - b. Has suffered an injury which results in downgrading in classification which may vary his rights under DFRBF Acts.

In addition the form serves as a "Case Diary for the Investigation necessary to establish a. or b. above.

- A soldier serving in VIETNAM is in an area which because it is a "Special Services Area" attracts cover under the relevent Repatriation Acts. There is only two occasions where an investigation is necessary into injury or illness in these circumstances, they are:
- a. When the injury or illness is the result of wilful misconduct on the part of the soldier concerned, eg. a self inflicted wound; or

b./

- b. Where the illness or injury is not due to enemy action and occurs during a temporary absence from the special service area (such as during a leave trip to an adjacent country, e.g. a vehicle accident).
- In such cases the purpose of the investigation is to establish whether the soldier has committed an offence or whether his conduct was in fact wilful misconduct where he may forfeit normal benefits under:
 - a. The Repatriation Scheme, or
 - b. The Commonwealth Employees Compensation Act, and in either case
 - c. The DFRBF Scheme.
- The AAF D11 is only a means of establishing the cause of the illness or injury occurring in other than "Special Service Areas". Where the injury or illness occurs in a "Special Services Area" the recording of the occurence in the soldier's Field medical Card is sufficient proof and records in its own right. What is the greatest importance is that soldiers report to the RAP and that a record is made in the member's medical history.
- It is not intended that battle casualties be included within the scope of MBI 129-6.
- A one hundred percent check of AFs Med 4 and 5 is to be carried out and new ones raised if necessary.

240. PSYOPS LEAFLETS AND BROADCASTS

PSYOPS leaflets and broadcasts directed against the VC in our area of operations regarding VC surrender procedure. VC are to remove their shirts and to sling weapons over their shoulders with the muzzle pointing to the ground, then to surrender to the nearest security force elements with hands raised above their heads.

241. SUBMISSION OF OPERATIONAL REPORTS

- 1. The following reports are to be submitted typewritten on a skin.
 - a. Sub Unit Operational Analysis.
 - b. After Action Reports.
 - c. Installation reports.

242. 7RAR ALARM S TREN TESTS

The 7 RAR Alarm Siren is to be tested weekly at 1200 hrs on Fridays by the RP.

243. TRANSPORT BOOKINGS

Transport bookings should, if possible, be made 24 hours in advance. This enables planning of the coming days requirement and ensures maximum effective use of available Unit Transport.

244. PAYBOOKS

No member is to carry his paybook on operations. For the members benefit it is advised that the following procedure be adopted:-

- a. If the member requires pay on the following payday his paybook is to be submitted to the Coy Pay Clerk, with a pencil entry showing the amount of pay required.
- b. If the member does not require pay he retains his paybook.

- 1. Subtended is a letter which has been circulated to wives of servicemen serving in Vietnam by the Australian International Travel Centre.
- There has been considerable interest shown by members in the possibility of making a trip to either Singapore or Hong Kong while their husbandsare on leave. However, the difficulty of coinciding soldiers leave with group concessions travel would seem an unsurmountable one.

In a desire to help wives, QANTAS have had close discussion with the Australian International Travel Centre, who have subsequently collated two proposed itinieries for wives of AOSA who in this way can travel individually and whenever their husbands can get his leave.

SINGAPORE - 10 day tour includes Air fares, 10 days accommodation at Hotel Singapore - (Bed and Breakfast only) transfers to and from Airport, porterage, gratuities and several tours of city - \$507.

HONG KONG - 10 day tour includes Air fares, 10 days accommodation at Hotel Mandarin - (Bed, breakfast, lunch and dinner throughout tour) transfers to and from Airport porterage, gratuities and several trips of area - \$695.

NOTE - Cost of such tours must be, by law, 10% more than tourist class return air fare - i.e. approx \$461 Singapore and \$631 Hong Kong.
