





ENEMY FORCES OF AINSLIE

- of XA BANG (YS4583). It is regarded by the VC as their territory. It is shown as such on their maps and field sketches. Its main value to the VC is as an area where the bulk of the procurement of supplies for 5 VC Div units is conducted. As a logistics key point SLOPE 30 is a centre of a network of roads, tracks and trails for the receipt and despatch of all classes of supply.
- Province to the NORTH. Medical supplies, cloth, wire, telephone cables and other items are carried up from SAIGON and the markets from the SOUTH. Food, weapons and ammunition move from the RUNG SAT across the trails NORTH EAST into SLOPE 30. Well defined and heavily used trails lead out of SLOPE 30 to 5 VC Div and VC BARIA Province base areas throughout PHUOC TUY. All main forces, local and at least some of the district VC forces in PHUOC TUY depend heavily on SLOPE 30 for resupply. Its denial to the VC would cause a serious upset to their resupply organisation and cause them to establish a major alternative system.
- The establishment of a new ARVN outpostat XA BANG brought an immediate reaction from the VC. The prospect of GVN prescree encroaching into such an important and traditional VC area of control is unacceptable to them.
- Since the first unsuccessful assault on the new post (20 Jul 67) it has been subjected to spasmodic mortar attacks, none of which have caused any segious damage. The VC have also moved machine guns close to the road and engaged aircraft in the areas in an attempt to inhihit resupply and maint enance of the post. Continued VC presence in and around the area must be anticipated and opposition to any clearing actions should be expected.
- 5. Some well known VC staging areas and camp sites around the area are:
 - a. BAU CHINH forest (a VC name for the area to the SOUTH EAST; centre of mass YS495805).
 - b. Plantation (YS4982).
 - c. Jungle at the foot of NUI SAO Hills, centre of Mass YS490850.
 - d. Jungle around CU BI (YS4282) on the WEST.
- 6. It is in these areas that the VC units have used forward lay up positions and from which harassing action would be most likely to develop.
- The Enemy forces of all types may be encountered in the area elements of 274 VC Regt from the HAT DICH, 275 VC Regt and D445 EAST from the TAM BO or NUI SAO Hills, CHAU DUC Coy (C41) SOUTH WEST from CU BI and local guerillas. If surprised in the area the VC would most likely seek to break contact to gain time to assess our intentions. The longer 1 ATF units remain in the area the more they must guard against possible battalion-size attacks as happened to 3/11 ACR at YS447825 on 19 Jun 67.





ENEMY FORCES

- the SONG RAI and BINH CHAU (YS 7867), has been reported over a long period, by various sources, as an important VC supply area. It includes Cape HO TRAM (YS 6758), a name always linked with two others (Slope 30 and BAO BINH) to summarize the three major centres of VC resupply in 5 VC Div area of operations. For nearly a year HO TRAM and the beaches EAST and WEST of it have been used by the VC for seaborne resupply. The full scale of this over-the-beach effort has never been clearly determined and no ground operations have every been conducted into the area to ascertain the nature and extent of VC installations.
- 2. Indications of current VC activity in the area come from air and ground recce of base camps, results of airstrikes, track activity both inland and on the beach and reports from ralliers and refugees. (Annex P shows what is known about the area already and where air strikes have been put on known or suspected VC base camps. It will be seen that) the two main areas of known VC activity are EAST of the NUI KHO hills (YS 6562) and up to 2000 metres in from the eastern beach. The first area is suspected to be a possible alternate depot area for the former SONG RAI caches, the latter is the most likely area in which storage, liaison and/or transhipment camps would be located.
- Enemy troops most likely to be encountered are local guerillas and members of VC production cells. There have been agent reports of larger enemy groups in the area (up to 250 strong) but these reports are unconfirmed. Main force units have infrequently in the past come to the area on porterage and escort duties. There is a VC unit responsible for co-ordinating infiltration of materiel and supplies from North Vietnam. It is known as Unit 1500 has an estimated strength of 400 and is organized into transport and specialist platoons (naval recce, protection, stores, medical, production, liaison). It is possible that elements of this unit could be encountered if any VC resupply operations are imminent and it is thought a small recce element of the unit is permanently stationed in this Subordinate units of Group 84 must be expected in the area. Even without the sea infiltration aspect the VC foster small production schemes of various kinds throughout the area e.g. the HO CHI MINH sandal-maker killed by a patrol at YS 712653 on 20 Jul 67. There is also the possibility that forward troops may encounter people in such isolated production cells who would be genuinely interested in rallying or seeking refuge from the VC.
- 4. Although the manority of known sightings are generally confined to two areas there may be other installations of significance as yet undiscovered. Withe the removal of Slope 30 from the VC logistic system it becomes even more important to confirm the present status and future potential of the Cape HO TRAM region as a base area for the VC.

 Three Year High School Certificate.

(f) Tasmania

i. Secondary Schools Certificate or ii. Area/Modern Schools Certificate.

(g) Commonwealth

i. Army First Class Certificate or ii. Army First Class Certificate (Technical).

(2) Qualification in a similar range of subjects at an examination or examinations other than those above may be accepted providing they are assessed by the Selection Board as being equivalent to or higher than the above examinations.

Notes: (a) Candidates are advised that it is necessary to obtain a pass in

English and three other subjects at the Services General Certificate of Education (SGCE) (or its equivalent) before becoming eligible for promotion from the rank of Second Lieutenant to that of Lieutenant.

- (b) Candidates who are in doubt as to the acceptability of a craft subject should consult the Deputy Assistant Director of Army Education in the Command concerned, through the Command Headquarters.
- (3) Special Entry Applicants must possess the following qualifications:-
 - (a) University graduates or technical college diplomates a degree or recognised diploma.
 - (b) University undergraduates must have successfully completed one or two years of any degree course.
 - (c) Partially qualified technical college students as approved by the Adjutant-General.
 - (d) Former RMC cadets certified by the Commandant RMC as having:
 - i. Successfully completed the first two years of the higher level course in Arts or Applied Science or Engineering or ii. reached an academic level equivalent to that of university undergraduate who has successfully completed one year of a degree course (MBI 166-2).

431. CURRENCY

- 1. Recently a number of members were apprehended and found to be in possession of American currency (Green).
- 2. On each occasion the member stated that he was unaware that it was illegal to be in possession of Australian or American currency.
- 3. Attention is drawn to 7 RAR RO Part 1 108/67 for strict compliance.

432. ACQUISITION, CONVERSION AND USE OF CURRENCY

- 1. The acquisition of United States dollars (Green)/ Australian currency is forbidden except at Australian Force Vietnam Cash Offices.
- 2. The conversion of United States dollars, Australian currency and Military Payment Certificates (MPC) into any other currency is forbidden except at exchange

offices authorised by Commander Australian Force Vietnam, or the Ambassador of the United States of America or Military Assistance Command Vietnam or the Government of Vietnam.

- 3. The use of US dollars/Aust currency/MPC in any financial transaction except with United States and Australian facilities is forbidden.
- 4. Failure to observe the provisions of these orders by members of the Australian Force Vietnam in Vietnam is to be treated as a serious offence (AFV RO 2/67).

433. ANNUAL QUALIFICATIONS

The personnel listed at Annex A have qualified at BE, TsOET, Range Prac, Voice Procedure, First Aid and Map Reading.

434. NOTIFIABLE INJURIES

Reference A. 7 RAR Admin Instruction No. 3 (SVN) Part 1 B. MBI 38-1

- 1. Companies are held responsible for notifying Bn HQ of any member who may be subject to NOTICAS action. Wherever possible this notification should be in writing with a precedence of Immediate. A guide to notifiable injuries can be found in Reference B above. If any doubt exists as to whether a NOTICAS signal is to be instituted, the matter is to be referred to Bn HQ.
- 2. The RAP is responsible for notifying Bn HQ whenever a casualty is admitted to the RAP who could be subject to NOTICAS action.

435. LEAVE - PERSONNEL ARRIVING IN THEATRE

No officer or soldier is to be granted leave outside 1 ATF base area during the first three weeks following his arrival in South Vietnam (1 ATF RO Part 1 No. 194).

436. REMITTANCES OF CASH AND POSTAL ORDERS TO AUSTRALIA

- 1. Members wishing to remit sums of \$100 or more to a person in Australia are to obtain the written approval of the Commanding Officer.
- 2. Paymasters and their staff are not to accept application for remittances of \$100 Aust or more to a person in Australia without sighting the approval of the Commanding Officer.
- 3. Members wishing to purchase postal orders to the amount of \$100 Aust or more in any one transaction are to obtain the written approval of their Commanding Officer.
- 4. Members of Postal Units are not to supply postal orders to the amount of \$100 Aust or more to the members of AFV without first sighting the written approval of the Commanding Officer (1 ATF RO Part 1 No. 195).

437 OVERSEAS LIVING-IN ALLOWANCE (VIETNAM)

- 1. The Overseas Living-in Allowance (Vietnam) is payable to members serving in AFV.
- 2. The rate of Overseas Living-in Allowance is:
 - a. Officers \$Al.70 daily
 - b. Other Ranks \$Al.55 daily
- 3. Credit for the allowance is made to the members paybook by means of a Paybook Variation Advice (PVA) issued by Army Pay Accounts Centre. It is found, however, that there is usually a delay at Army Head-quarters of approximately two months in receipt of PVAs from date of the members arrival in theatre. This means that members are prevented from drawing against credits created by the living-in allowance until receipt of the PVA.
- 4. To overcome this, provision has been made for a member who has been caused financial hardship by non-receipt of Vietnam allowance to make application to draw through his paybook an additional fortnightly amount equal to his entitlement of Vietnam allowance and taxation deduction appearing in his paybook.
- Payments under this authority are not to be made until the member has been in South Vietnam for 14 Days (1 ATF RO Part 1 No. 189).

438. IMPORTATION OF GOODS THROUGH U.S. POSTAL FACILITIES

- 1. Instances have been reported where members of the Australian Forces have imported goods from the United States, using a United States Army PO address.
- 2. There is no authority for Australian persons to use such an address and this practice is to cease forthwith.
- 3. In future, any goods addressed to Australians, using United States Army PO addresses, will be returned to the consignor. (1 ATF RO Part 1 No. 190).

Due to the built up nature of the area in which the search was conducted artillery fire was unlikely to be used. As a result 106 Bty (dismounted) was employed as a search company. This gave the battery some experience in operating as infantry.

b. AUST Aviation (Army)

One OH13 was placed in support of 7 RAR for the operation. The aircraft was used for the following tasks:-

- 8. The search area was the western portion of the village of DAT DO and consisted of houses and huts, cultivated areas and patches of secondary growth. Visibility varied from unlimited to 5-10 metres in the scrub patches.
- 9. Weather initially was hot and clear but heavy rain fell late in the afternoon. This slowed down the fly out of the battalion because of restricted visibility.

Mission

.10. 7 RAR was to search the west half of DAT DO en 24 Aug 67.

Concept of Operations

Annet C

General Outline

- a. 7 RAR AOMto be divided into seven (7) areas of operations each designed to be searched by a company or equivalent on the same day, ~ Movement to the AO to be by air.
- b. The direction of search was to be conducted from the outside to the centre and was to start at 0730 hrs simultaneously, if possible.
 - c. No cordon was to be used and extraction was to take place later in the day.

d. Search of the village

(1) This was to be searched in detail to include all houses inside and out, surrounds and open fields. Every square metre was to be prodded.

- (2) Suspect persons to be escorted to Battalion Headquarters.
- (3) Route 23 to be kept clear of troops to allow free movement of traffic.
- (4) Every householder to be given a leaflet explaining the reason for the search. The leaflets requested co operation and included an apology for any inconvenience caused.
- (5) All houses to be suitably marked with chalk paint or tape.
- (6) Suspicious mounds of earth and fresh diggings to be prodded then dug out.
- (7) All wells to be checked.
- (8) Every soldier searching to be covered by a cover man.
- (9) In particular the following to be looked for:-
 - (a) Excessive amounts of rice.
 - (b) Tunnels and hides.
 - (c) Explosives.
 - (d) Arms and ammunition.
 - (e) Medical supplies.
 - (f) Posters and propaganda.
 - (g) Caches of any description.
 - (h) Quantities of clear plastic sheeting as used in the manufacture of gas masks.

Execution

Movement to the AO was carried out smoothly and efficiently as planned. D Coy was moved to its AO by APC. This company had been previously located in the area of LONG DIEN with C Coy who remained LOB during op BURNSIDE. Route 52 provided an excellent boundary between the battalion and 2 RAR operating to the east.

Interpreters

The number of interpreters available for op BURNSIDE had to fulfil the needs of two battalions. Consequently search companies were allotted only two - one less than during an earlier search of HOA LONG. The shortage of interpreters was alleviated to a degree by the preparation and issue to each householder of a leaflet in VIETNAMESE. This explained the reason for the search, requested the co operation of the householder and regretted any inconvenience caused. It is recommended that future searches should always include the distribution of a similar leaflet.

Attitude of Villagers

14. Generally, the people were quite friendly once their initial shyness had been overcome. Some company commanders had the impression that the presence of our troops and subsequent search was almost expected. This could possibly be borne out by the fact that in one instance a householder informed friendly troops that her husband had left the village three days ago - when he had heard that the Australians were to conduct a search in DAT DO!

-4-

Method of Search

- The seven areas of search were sub divided by companies either into three platoon AOs or four or more smaller areas of search. The numerous existing tracks enabled boundaries to be fairly easily located at the beginning of the day. Although only one air photograph was available before the operation sufficient time existed to enable each company commander to study it. It is recommended that a stock of air photographs of all built up areas be prepared and held in reserve. During future searches of a similar nature they could be of great assistance.
- 16. To search a house and its surrounds thoroughly, a whole section is considered necessary. Floors, walls and roofs must all be examined meticulously, furniture and piles of fire wood must be shifted and subsequently placed back in position before troops leave. The whole process is a time consuming one but one which the majority of soldiers enjoy doing. While each man is carrying out a particular part of a search it is necessary for another soldier to act as his cover man. Prodding of the ground was done by means of steel rods, sharpened at one end. A knob at the opposite end provides a good handle for the user. Rods come from boxes of artillery ammunition and are in the order of three feet in length. They are considered to be superior to machettes or bayonets for earth prodding.

Results of Search

- 17. The village of DAT DO was found to contain a total amount of unmilted rice in the order of 480 short tons. Little of a suspicious nature other than the rice was located. It is thought that the villagers may have had some prior warning of the search but this is unconfirmed. It could possibly account for the fact that only rice was located.
- 18. It is worthy of note that not as much rice was located in individual houses as had been found in HOA LONG. The majority of houses in DAT DO contained only small quantities perhaps in the order of a few hundred pounds. A minority of houses however contained very large quantities as the Summary in Annex B indicates.

Recording of Finds

- As a result of experience gained during the search of HOA LONG on 18 Aug 67 a pro forma was produced and used throughout the battalion to accurately record all excessive finds. Periodically search companies passed relevant information to Battalion Headquarters in accordance with the sequence of the proforma. Battalion Headquarters was thus able to quickly and efficiently collate the information on the master sheets. An example of the proforma is attached at Annex B as the Summary of finds.
- As a result of lessons learnt from the search of HOA LONG the following formula was used to calculate rice found at DAT DO:-

a. Polished Rice

- (1) One cu ft weighs 55 lbs.
- (2) One short ton (2000 lbs) measures approx 36 cu ft.

b. Unpolished Rice

- (1) One cu ft weighs 35 lbs.
- (2) One short ton measures 57 cu ft approx.

Op BURNSIDE was the second operation of its kind conducted by the battalion in the space of one week. Much valuable experience has been gained at all levels as a result. The battalion was air lifted to NUI DAT from DAT DO airstrip at YS 476599 by last light on 24 Aug 67 as planned.

Commanders Analysis and Recommendation

Recording of information at battalion level was much inproved on this operation as a result of experience gained on operation MOSMAN.

SEARCH OF DAT DO

- The area of search will cover DAT DO. This village has been subject to recent VC terrorism and harassment and has not previously been searched by units of 1 ATF. Some local cordon and search operations have been carried out by ARVN units. These may have caused local VC cadre and sympathizers to feel secure now to infiltrate more personnel and warlike stores in preparation for anti-election activities.
- DAT DO is the rice marketing centre of PHUOC TUY. It is a town of some 7000 people guarded by the HORSEHOE on the NORTH and the fence on the EAST. There have been some small scale patrol clashes between ARVN and VC units in and around DAT DO. Local sources believe that the VC are attempting to build up supplies of grenades, explosives and small arms inside the village prior to the elections. It is essential to clean out thoroughly all caches, not only to safeguard the town during elections but also to assist in protection of check points, the HORSEHOE and traffic to and from it.
- Enemy forces likely to be encountered are members of local village guerillas, the LONG DAT District Coy (C25) or even members of D445 Bn. In view of current VC activities the most likely threat to our troops is from small VC hit-and-run groups. This could include sniping, booby-traps and CD mines.

OPERATION BURNSIDE 24 AUG 67

Introduction

- 1. Operation BURNSIDE entailed a search of the village of DAT DO. 7 RAR searched that sector West of Routes 44 and 52.
- 2. DAT DO had been subjected to recurrent VC Terrorism and harassment and although it had not been searched previously by units of 1 ATF, some local cordon and search operations had been carried out by ARVN units. These may have caused local VC cadre and sympathizers to feel secure to infiltrate more personnel and warlike stores in preparation for anti-election activity.
- DAT DO is the rice marketing centre of PHUOC TUY. It is a town of some 7,000 people guarded by the HORSESHOE in the NORTH and the fence on the EAST. There have been some small scale patrol clashes between ARVN and VC units in and around DAT DO. Local sources believed that the VC were attempting to build up supplies of grenades, explosives and small arms inside the village prior to the elections. It was essential to clean out thoroughly any such caches; not only to safeguard the town during elections but also to assist in protection of check-points, the HORSESHOE and Traffic to and from it.
- 4. Enemy forces thought likely to be encountered were members of local village guerillas, the LONG DAT District company (C25) or even members of D445 Battalion. In view of the recent VC activity the most likely threat to our own troops was from small VC hit-and-run groups. This could include, sniping, booby-traps and command detonated mines.

Results of Search

There were no significant cache's located by 7 RAR during the search. With few exceptions the majority of material found belonged to ARVN soldiers. Excessive quantities of rice were recorded and this amounted to 479 short tons. The names of the owners of houses and locations where excess rice was located have been recorded and forwarded to 1 Div/1 ATF. A summary is also contained at Appendic 1.

Conclusion

There appeared to be no apparent buil-up of VC supplies or cache's in the area of DAT DO and in the main the civil population appeared friendly and offered assistance to the searchers.



Duration

2. 26 Aug 67.

Location

8 miles SE of NUI DAT YS4367 bordering on the coast and SOUTH CHINA SEA. Centre of area YS 5153.

Supporting Forces

6. a. 106 Btv RAA. This battery was employed as a search company. It was the third time that the direct supporting Artillery Battery had been given an infantry role.

b. Had artillery support been required it could have been provided from the HORSHOE feature YS 4962 where 108 Bty was located.

Two Combat Engineer Teams

7. These were held at Battalion Headquarters and were available on an "as required" basis. The teams were equipped with mine detectors.

Interpreters

8. These worked with search companies to explain to villagers what was happening and to check indentification papers. Two were allotted to each search company.

National Police

9. National Police accompanied and assisted the search troops in carrying out their primary mission of searching houses and surrounds. They were particularly useful in dealing with suspect "Draft Dodgers" and during examination of identification papers.

Intelligence

10. Increased guerilla activity rendered it necessary to search PHUOC HAI before the National elections on 3 Sep 67. See Annex A.

Terrain

- The search area included the west half of PHUOC HAI which consisted of a thickly populated area with a high density of dwellings. The area to the NW contained huts and patches of cultivated area. The south was bounded by the beach and SOUTH CHINA SEA.
- 12. The weather was hot and clear. Some thick cloud developed later in the day but no rain fell.

Mission

7 RAR was to search the west half of PHUOC HAI YS 5153 on 26 Aug 67.

Concept of Operations (Annex C)

- Operation ULMARRA was a 1 ATF operation involving 2 RAR and 7 RAR. The search was to be conducted on the one day without a cordon being used. 2 RAR was given the east half and the west half was allotted to 7 RAR.
- 7 RAR AO was divided into seven company search areas each suitable for a one day search. The battalion was to fly in by air mobile coy to carry out the task and be extracted by the same means later in the day.
- 16. Direction of search was to be from the outside twards the sea.

Execution

The operation was carried out as planned at the AO but the late arrival of the air mobile company caused the start to be delayed nearly two hours.

- 18. Little of significance was located and no food or rice could be described as excessive. Several suspects however were located and apprehended for questioning. These appeared to be "Draft Dodgers". Becuase the search started later than originally planned it is possible that illegal items could have been removed from the village. It was significant that a great many fishing boats remained in the water, far out to sea, while the search was in progress. These factors could account for the fact that little of significance was formed.
- The people of PHUOC HAI did not appear to be a friendly as the 19. inhabitants of HOA LONG or DAT DO, however they did nothing to hinder our troops with the search. In comparison with previous searches AOs were smaller and since large amounts of food were not located most companies found they had more time available to concentrate on a more thorough search of the houses.
- The Ply out back to NUI DAT was carried out as planned, later 20. in the day.

Commanding Analysis and Recomendation

21. Op ULMARRA was the third operation of its type conducted by the battalion in the space of eight days. It proved to be a useful and interesting experience.

- 1. The area of search will cover PHUOC HAI. The village is subject to some VC terrorism and harassment and has not been searched by units of 1 ATF in the past.
- PHUOC HAI is a wealthy fishing village of some 8000 people. The fishermen although they cannot put to sea until 0400 hrs, sometimes depart as early as 0300 hrs depending on the tides. There are bewtween 400-500 fishing boats in PHUOC HAI, other fishermen from further afield come to use on the sand. Old VC trenches and pits will be found on the Eastern and Western sides of the village. The seaward approach to PHUOC HAI make it searching is carried out
- 3. Enemy forces likely to be encountered are members of local guerillas and the Long Dat District Coy (C25)

OPERATION ULMARRA 26 AUG 67

Introduction

- 1. Operation ULMARRA entailed a search of the village of PHUOC HAI. 7 RAR searched the west sector of the village.
- The fishermen although they cannot legally put to sea until 0400 hours, sometimes depart as early as 0300 hours depending on the tides. There are between 400-500 fishing loats in PHUOC HAI. Other fishermen from further afield come to use the rich fishing ground and it is possible at times to count up to 1,000 boats on the sand. Old VC trenches and pits are located on the Eastern and Western sides of the village. The seaward approach to PHUOC HAI kes it a useful point of entry for VC supplies and it is essential that detailed searching be carried out.
- 3. Enemy forces thought likely to be encountered were members of local village guerillas and the Long Dat District Company (C25) or even members of D445 Battalion.

Results of Search

There were no significant finds by 7 RAR during the search and none of the persons apprenended and questioned were subsequently detained as VC suspects. The names of the owners of houses where suspicious material was located was recorded and passed to 1 DIV INT/1 ATF.

Conclusion

There appeared to be no apparent build-up of VC supplies or caches in the area searched by 7 RAR. In the main the civilian population were not as friendly as the inhabitants of HOA LONG and DAT DO had been found to be.
