

# PART 1 G MATTERS

# Present Location

1. No change of location has occurred during the reporting period. Det 1 Topo Svy Tp is located in the HQ 1 ATF area at GR YS 433666.

#### Enemy Contacts

2. Det 1 Topo Svy Tp has had no enemy contacts luring the reporting period either whilst engaged on survey operations or at its bast camp location.

#### Tasks

- 3. The following tasks undertaken, were completed during the reporting period.
  - a. HOA LONG SPECIAL 1:5000 (GR YS 420645).

    Area covered 20 x 1000 metre grid squares in original plot.

- 7 x 1000 metre grid squares in offset printed map.

The task was carried out in the manner described in OP Report No 2 Para 4b with the following variations.

- (1) Only one connexion could be made to the 3rd order point NUI DAT (AAS OO1). The connexion was made to a photo identified point on the northern side of the village (AAS OO2). Lack of intervisibility to any other point in the village prevented a further direct connexion being effected, and the time factor prevented a chain theodolite connexion being carried out from (AAS OO2) Consequently the point AAS OO2 served to provide position only, the plot being reliant on the 1:4000 French Colonial Cadastral plan for scale and azimuth. Scaled map points provided a further check.
- (2) A thorough ground annotation was carried out employing two survey parties each of two surveyors, with protection provided from one of three sources viz, HOA LONG COMMANDO CO (2 days) HOA LONG PROVINCIAL FORCL (2 days) 6 RAR (1 day). The size of the protection party varied with the known friendliness of the locality, from a minimum of 3 per party to an infantry section. The village of HOA LONG conservatively averages 1-2 VC incidents each 24 hours.
- (3) Because of the obvious continuing demand for

with Lt Col A.L. Benton M & I Div Engr Sec USARV to have the sheet offset printed in three colours by 569 Engr Co at NHA TRANG. This was accordingly carried out on Thu 28 Jul 66. Colour separation was effected by drafting element of Det 1 Topo Svy Tp. The colours chosen were black, green and blue.

The sheet has been well received by 1 ATF and local-provincial civil and military authorities.

b. Defoliation st. ip map - 1:5000 HOA LONG to NUI DAT (GR YS 430665)

A very detailed map extending 500 metres either sile of Provincial Route 2 between the northern limits of HOA LOAG Village and the 1 ATF Base Area was prepared. The strip map showed details of all cultivations, in extent and type. Field annotation was carried out after the base plot, with the air of interpreture and protection from the HOA LONG COMMANDO CO. The purpose of the strip map is to provide a basis for possible compensation subsequent to defoliation taking place.

- c. LONG TAN Photo plot 1:5000 (GR YS 485557)

  Area covered 9 x 1000 metro grid squares.

  Following OP Report No 2 LONG TAN photoplet was recompiled with new photography for OF HOBART (6 RAR).
- d. BINH BA South enlargement 1:5000 (GR YS 445732)

  Area covered 5 x 1000 metro gril

  squares.

This was a simple enlargement from the BINH BA 1:10000 photoplot, of the Duc Mi hamlet (OF Report No 2 para 3d. The enlargement was prepared for OP SYDNEY 2 (5RAR) which was a cordon and search operation.

- e. Sundry Traces and Plans These in the main were:
  - (1) Edition 2 of Location Plan of NUI DAT 1 ATF Base Area.
  - (2) Detailed schematic plan of HQ 1 ATF area for wide distribution.
  - (3) Covers for Book 1 and Book 2 of 1 ATF SOPs.
  - (4) Diagram of HQ 1 ATF (MAIN) as annox for SOPs Part 2.
  - (5) Various alterations to artillery strike zone plan (OP Report No 2 para 3g (2)) with amendments to TAOR boundaries.
  - (6) Annexes showing intelligence info mation to operation orders for the forthcoming operations.
  - (7) Hand colouring of 1:25000 enlargement series for briefing information tent.
  - (8) Diagrams relating to courts of enquiry.
- f. Improvements to accommodation area (Sprs & Cpls) and work area: Substantial hard standing and 2/15 x 16 tents with covered messing area between was exected in Sprs and Cpls accommodation area. Minor improvements

/were

were carried out in the work area. Permanent overhead cover was provided on all protection pits.

4. The following tasks are currently in hand:

- a. Datailed "cantonement survey" of the 1 ATF base area NUI DAT. This project has been modified during the reporting period to meet an immediate requirement. The following phases have been completed.
  - (1) 4th order traverse around periphery of grid square 6643 with connexion to NUI DAT (AAS 001).
  - (2) Stadia traversing for horizontal detail and height in the HQ l ATF Area. (height still to be computed).
  - (3) Internal traverses with offset measurements to permanent structures and tent positions within HQ 1 ATF Area.

The following tasks are in hand, and comparision with OP Report No 2 will indicate the modifications contained there in.

(4) Stadia traverse to extend control ever road system in remaining 1 ATF Base Area, picking up drainage, bunkers, defensive wire and all forms of access.

Det 1 Topo Svy Tp will provide by 20 Aug 66 a completed plan of 1 ATF Base Area showing the detail listed in (4) above, together with a ditailed plan showing that listed in sub paras 2 and 3. A final phase will provide 2 motre interval and contours over the entire base area.

b. Photoplot of BINH GIA village - 1:5000 (GR YS 495775)

Area to be covered - 12 x 1000 motro grad

It was incorrectly reported in OP Report No 2 that this plot was at a scale of 1:10000. All detail plotting has been completed and master compilation is about to be commenced. This task has not been of a high priority. It is intended that a field check annotation will be carried out, and at a later stage colour separated frawings produced for printing, either 'offset' by the 569 Engr Co at NHA TRANG or by the Silk Screen Printing Press; should this arrive.

c. Photo plot/map enlargement of NUI NUA islan - 1:10000 (GR YS 280560) with subsidiaryenlargement of XA LONG SON village at 1:5000.

Area to be covered - 48 x 1000 metre gri squares. Commencing with a map enlargement from the std 1:50000 series, a ditional detail will be added from 9" x 18" photography, about to be flown. This task will meet the requirement for an anticipated 1 ATF operation.

d. Map enlargement/photo plot of NUT TINH HILL system
- 1:25000 (GR YS 3406.0)

Area to be covered - 210 x 1000 metre grid squares.
This plot is basically a trace from the existing 1:25000 photo enlargement, with additional detail from 1:25000 photography and the pictomap series. The aim is to produce a sheet for dyelining which will be less cluttered by contours than the existing enlargements and including

more detail in the form of creeks, tracks, clearings and timber densities. The enlargement is required for a forthcoming operation by 6 RAR.

c. Landing zone plot of area of operations.
Original plot at 1:25000. LZs to be shown symbolically on an overprint of the 1:50000 series preferabley L7014 if available.

The plotted information is being keyed to a tabulation showing nature of LZ, obstacles, size and capacity in terms of HUI and CHINOOK helicopters. The latter information will be supplied by RAAF after visual reconnaisance of the selected LZs. These are between 900 and 1200 LZs to be tabulated and marked. The interselection has been done from a stu y of the pictomaps together with all the available photography.

- f. VUNG TAU overprint (OP Report No 2 para 3 f.). This task has been temperarily shelved, pending a new edition of the VUNG TAU 1:12500 sheet.
- g. Annexes to "Combat Operations After Action Report Operation ENOGGERA.

  This task consisted of preparing dyeline copies of the LONG PHOUC 1:5000 photoplot showing the following information:
  - (1) Annox A Area of operations including sector
  - (2) Annex B Intelligence (held at time of commencement).
  - (3) Annex C VC installations, eaches and equipment found as a mosula on the operation.

This will be the normal follow up requirement of all operations and the report has a wide distribution to senior HQs both in VIETWAM and AUSTRALIA.

- 5. The following tasks are scheduled to commence during the month of August.
  - a. BINH BA photoplot celour separation and printing (Refer OP Report No 2 para 3 d and para 3 d of this report It has not been decided whether this shoul be at a scale of 1:10000 covering the area described in OF Report No 2 or at 1:5000, simply covering the area of the 3 hamlets, BINH BA, DUC MI and DUC TRUNG. This village is to be subjected to an intensive civil aid-pacification programme. A ground check will be carried out prior to colour separation.
  - b. PHOUC TUY Province Agricultural Map Scale 1:50000 To be produced as:
    - (1) An overprint of the L7014 series with mono-chrone background for tactical purposes.
    - (2) A line drawing with schematic detail and Vietnamese nomenclature for school classroom use as a civil affairs programme.
  - c. Other civil affairs projects.
    These are to some extent speculative at this stage and could be modified at will.

- (1) Assistance with training aids of the chartmap variety for the HOA LONG school.
- (2) Provision of framed copies of the HOA LONG SPECIAL and other similar projections for Province Officials "by courtesy of the Vietnamese Government".
- Dyelines: During the reporting period 1230 dyelines have been produced.

# Dot Establishment

- 7. Silk Screen Printing Press: In reply to an AHQ Sig of 4 Aug 66, OC Get 1 Topo Svy Tp suggested the following.
  - a. A maximum of three members of 1 ATF Svy Tp be be exchanged for 3 Litho technicians.
  - b. A further three or four personnel from 1 ATF SVY TP be trained "in theatre" to supplement the technicians during periods when the equipment was operational

# Map Supply and Distribution

Pictomaps 1:25000: Depot holdings in country have improved and Jet 1 Topo Svy Tp has been able to get 500 of each sheet covering the Area of Operations. It is estimated that, until the "in country" bulk holding policy is reviewed, the Det will be able to meet only 25% of the normal demand. The series is very popular at all levels, although in recent weeks some of its limitations are being realised.

# 1701 Series 1:50000

- 9. The demand for this series has been offset to some extent by the pictomap 1:25000 series. The series is not popular with infantry mainly due to the limitations of the scale. Distribution of the L7014 series has been effected North of. Latitude 12° NORTH Distribution of that area south of Latitude 12° NORTH is expected in late August.
- 10. Annex B provides a summary of map distribution since the arrival of map stocks into the theatre.
- 11. Task Force policy on the provision of air photos, mosaics maps and enlargements in 1 ATF is stated in an instruction dated 8 Aug 66. This instruction is included as Annex C.
- Map Stock Register: Because the maximum holding of any map sheet is limited due to overall bulk of the total holdings in the map store, it is necessary to maintain a fairly rigid system of control. This is effected in the form of a map index register which comprises the following:
  - a. Map indexes overprinted on 1:1250000 series prepared by directorate of Mil Svy (AHQ Det 0612).
  - b. 1st overlay of tracing paper on each index sheet showing in pencil the number of copies held of each sheet.
  - c. 2nd overlay of tracing paper on each index sheet showing in pencil the bin or box number and envelope

number, applicable to each sheet.

13. The register described above is made current weekly by adjusting for map movements in and out.

# PROVISION OF AIR PHOTOS, MOSA CS, MAPS DULARGEMENTS, AND USE OF CONTACT IN 1 ATF

- 1. The aim of this instruction is to clarify Task Force policy on the provision of:
  - a. Air photographs.
  - b. Photo mosaics.
  - c. Maps.
  - d. Enlargements and photo plots.
  - e. Contact/Mipofolie plastic protecting film.

#### Air Photographs

- Air photographs are obtained primarily for photo intelligence. However a limited distribution is proposed for operational planning purposes and unit intelligence uses, to supplement the existing mapping. The intended distribution for air photographs is shown in Annex A.
- Air photographs will normally be at a scale of 1:5000. This may be varied to suit the photo-intelligence requirement, or the requirement of a particular unit. The number of prints obtained may also have to be varied to allow printing priorities to be maintained.
- 4. A request for air photographs shoul be submitted 10 days before the date on which delivery is required. The actual date of Belivery is dependent upon the priority allocated to the task and cloud conditions prevailing during the flying perior.
  - Priorities are subject to review by higher HQ. Those in use are:
    - a. 1-X (Immediate) Restricted to Majo: Field Commanders only.
    - b. Priority 1 To exploit major targets of opport-unity.
    - c. Priority 2 In support of operations beginning within 48 hours of the requested time over target.
    - d. Priority 3 In support of operational planning and surveillance of activities capable of posing a future threat.
    - e. Priority 4 In support of routine planning; terrain studies; map supplements; surveillance of units or activities capable of limited interference with the mission; basic coler.

6. The Photo Intelligence section of Det 1 Div Int Unit is responsible for collating photo requests and placing orders on the US supply source. Normally 6 complete sets of prints will be obtained in order to effect the required scale of issue. For an SAS operation, 3 sets will be ordered, usually at a scale larger than 1:5000.

#### Photo Mosaics

- A large distribution of photo mosaics cannot be effected in 1 ATF for any operation. The 1:25000 pictomap is basically a photomap with an intensified image and marked up cultural detail. As a supplement to the standard 1:50000 map series, the pictomap is intended to satisfy all normal photomap requirements.
- A limited distribution of photo mosaics prepared from intelligence photography is intended (Annex A). The scale of those photo mosaics will normally be 1:5000, but may be varied to suit photo intelligence requirements or the needs of a particular operation.

#### Maps

ŧ.

9. The scaling of 1:25000 pictomaps and standard 1:50000 maps for all 1 ATF units is shown on Annex A. Every effort will be made to meet the stated scaling, however "in country". bulk stocks of pictomaps are limited, and the distribution rate for these may have to be scaled down. It is therefore essential that pictomaps are used judiciously, and wasteage kept to a minimum. Cutting of pictomaps should be done carefully, and the offcuts retained. Units are urged to cover, whenever possible, pictomaps back and front with "Contact" or other similar plastic films.

# Map Enlargements - Photoplots

- 10. Det 1 Topo Svy Tp has the capability to produce map enlargements and photoplots. A photoplot is a map plotted directly from air photographs, using scaled map points for position and scale. The scale at which photoplots will normally be produced is as follows:
  - a. Areas including a village or hamlet 1:5000 .
  - b. Areas not including a village or hamlet 1:10000.
- ll. The distribution of map enlargements and photoplots will normally be the same as that for maps. This may be limited by the amount of dyeline paper available for reproduction.

# Use of Contact/Mipofolie Plastic Films

- 12. Contact/Mipofolie should be used in the following instances:
  - a. To cover both si es of all pictomaps issued.
  - b. To cover the detail side of 1:50000 maps subjected to arduous use.

- c. To cover both sides of yeline copied map enlargements and photoplots.
- 13. Pictomaps are in short supply, and must therefore be made to last as long as possible. Covered on both sides, it should be possible to get 3 6 months life out of each map sheet.
- 14. Conversely, the supply of standard 1:50000 maps is plentiful. Contact should therefore only be used on 1:50000 maps when these are going to be subjected to arduous use over a protracted period, without the opportunity for re-supply.
- 15. Oyeline paper is soft and absorbent. It is therefore very vulnerable to the ravages of normal useago. Whenever possible, dyeline copies should be covered with Contact/Mipofolie on both sides.
- 16. Distribution of Contact/Mipofolie to all 1 ATF units will be controlled and effected by Jet 1 Topo Svy Tp. It is intended that, when an adequate supply of material becomes available, sufficient quantities in roll form will be issued to units to cover their scaled holdings of pictomaps, in accordance with Annex A, to give complete coverage of the TAOR. Dyeline copies for a particular operation will be supplied with adequate Contact to cover both sides of each sheet.
