COMMANDERS DIARIES INSTRUCTIONS

AIM

1. The aim of a Commanders Diary is to provide data on which to base future improvements in Army training, equipment, organization and administration, and to furnish historians with a record of the activities of units and formations in operational and non-operational periods in peace and in war.

GENERAL

- 2. Entries are to be made daily on AF C 2118 (Adapted) each entry being initialled by the officer detailed to keep it.
- Commanders Diaries will conform with the rules for drafting orders given in "Staff Duties (Australia)", Chapter 2, Section 12.

RESPONSIBILITY

During Non-operational Periods

4. A Commanders Diary is to be compiled by commanders of all formations.

During Operational Periods (1)

- 5. A Commanders Diary is to be compiled in duplicate by:
 - a. Commanders of all formations.
 - b. Each branch of the staff at formation headquarters commanded by a brigadier or above.
 - c. Heads of services not below the rank of lieutenant colonel.
 - d. Personal staffs and officers holding special appointments.
 - e. Unit commanders.
 - f. Commanders of a detachment of a unit when so ordered.

COMPILATION

- 6. Both original and duplicate copies are to consist of:
 - a. Cover (AF C 2119) (Adapted).
 - b. Index as printed on cover.
 - c. Narrative (AF C 2118) (Adapted).
 - d. Annexes as shown in the Index.
- 7. All details of the unit or formation (if a detachment is concerned, the name of the parent unit), period covered and enclosure numbers of the annexes are to be shown on the cover. If there has been a change of command since the last report, the date of assumption by the new commanding officer is to be included.
- 8. The annexes are to be assembled in the groups shown on the cover. If there are no enclosures for an annex NIL will be entered on the cover. If additional annexes are convenient for a particular headquarters. the relevant papers should be grouped as annexes starting at B.
- 9. Documents concerned with future planning for operations form Annex "Z", "TOP SECRET Supplementary Diary" of the formation originating the document. It is to be prepared and disposed of as shown in Paragraph 16.

CONTENTS

- 10. The diary is to contain:
 - a. Changes in command, (giving place names as well as map references), establishment, equipment and organization.
 - b. Information received, decisions made and orders given.
 - c. Where applicable, a short summary of the day's fighting, including company movements.
 - d. Opinions and recommendations of the commander with regard to equipment, tactics, organization and morale.
 - e. Progress of defensive works.
 - f. Weapon state.
 - g. Weather and ground conditions, if of potential importance.
 - h. Major causes and number of casualties to officers, men and equipment.
 - i. A note of all prisoners and enemy equipment captured.
 - j. A statement showing how the unit was employed in the time not accounted for. The type of training, etc, should be specified.
- 11. In order to ensure accuracy and completeness and to save work as much information as possible is to be included in annexes consisting of copies of documents issued and received, routine returns, etc. All annexes are to be referred to in the column provided and the time of receipt or despatch is to be given.
- 12. The narrative is to supplement and connect the annexes, but need not give a precis of any of them.

DISPOSAL

- 13. Original Commander's Diary. This is to be forwarded monthly, unless otherwise ordered, by the seventh day of the succeeding month direct to AHQ.
- 14. Duplicate Commander's Diary. This must be clearly marked as a duplicate. It is to be sent separately from the original to AHQ one month after the original has been despatched but not before the former has been acknowledged.
- 15. When overseas, both copies of diaries are to be sent through the Army Records organization in the overseas theatre but at different times.

16. TOP SECRET Supplementary Diaries.

- a. The documents referred to in Paragraph 9 together with a list of them made out on AF C 2118 (Adapted) must be placed in separate cover (AF C 2119) (Adapted). All details must be filled in and the cover clearly marked in red: "ANNEX Z OFFICER ONLY". It may be convenient to group the papers by appendices.
- b. Supplementary diaries must be forwarded under the normal rules for TOP SECRET correspondence, to AHQ. The inner envelope must be plainly marked:

1. LETTER OF COMMENDATION FROM GENERAL ABRAMS



GENERAL

Introduction

1. As part of Operation Interfuse, 4 RAR is to return to Townsville from South Vietnam during the period Nov/Dec 71. The battalion is to be re-established in the 500 Area Lavarack Barracks.

Aim

The aim of this instruction is to state the arrangements and procedures to be made for the reception and dispersal on leave of 4 RAR. It is to be noted that whenever the unit title, 4 RAR, appears throughout this instruction, members of 104 Fd Bty and any other members returning on HMAS Sydney are included.

PRELIMINARY ARRANGEMENTS

Fostering Unit

3. 1 RAR is to foster 4 RAR. The responsibilities envisaged are rationing and quartering for 4 RAR Advance Party and limited manpower assistance, to the Advance Party, for the reception of the Main Body.

Advance Party

4. This group returned by Defence Charter to Townsville on 18 Nov 71. The composition of the 4 RAR Advance Party is shown at Annex A.

- 5. An Australian Component will not be raised for 4 RAR. All correspondence for 4 RAR (Townsville) is to be addressed to 'Advance Party 4 RAR' until the main body arrives.
- 6. On RTA, the Advance Party will go on leave until 29 Nov 71, when they will return to Townsville to assist in the reception of 4 RAR Main Body. OC Advance Party, Maj Stevenson will be available throughout at Extension 7138.

Main Body

- 7. The 4 RAR Main Body, less D Coy, will RTA ON HMAS Sydney in mid Dec 71. The actual date is still classified but is available on a 'need to know' basis from HQ 3 TF/NQ Area. For the purpose of this instruction that date will be referred to as 'D' day.
- 8. Although 4 RAR Main Body will disembark in Townsville to march through the city, the personnel strength remaining in Townsville for leave and on movement will be 120. The remainder will return to the ship for disembarkation at Sydney.

Rear Party

9. The arrival date of the Rear Party (D Coy) is to be advised.

On-Board Briefing

- 10. To ensure a smooth disembarkation/reception, a good march past and a speedy dispersement, an on-board briefing will be necessary.
- 11. WO2 Clarke, Det 10 MC Gp is to board HMAS Sydney off Darwin to give this important brief and to finalize all onward movement arrangements for those personnel disembarking at Townsville. Tickets are not to be issued on board HMAS Sydney.

HF Communications

12. A HF listening watch is to be kept from 2200 hours D-1 in case communications are required ship to shore before the HMAS Sydney anchors.

103 Sig Sqn is to provide this service. Further details are to be advised.

Weather Report

- The SC (Mov) is to send an unclassified priority weather report signal (prepared by the DCA Meteorological Section) to reach HMAS Sydney by 1500 hours D-1. This signal is to contain the following information for the period 0500 1500 hours on D Day:
 - a. wind speed/direction and increasing/decreasing

during the forecast period;

- b. the height and direction of swell;
- c. the height of sea in feet; and
- d. any other pertinent information, eg, cyclones, rain/cloud expected, etc.

Publicity

- The Public Relations Officer (PRO) HQ 3 TF/NQ Area, is to arrange publicity to cover the reception and march. On topics involving the Minister for Defence, who is to review the march, PRO is to act in accordance with AHQ GS Instr No 32. Limited helicopter time is available to PRO and/or photographer to cover the disembarkation, reception, etc. See Annex B for appropriate timings.
- 15. 4 RAR families are to be briefed on reception timings and other arrangements by 4 RAR Advance Party.

Customs Clearance

16. HM Customs representatives will board the HMAS Sydney at Darwin. They will check and clear all cabin luggage and luxury items in hold stowage. These items are to be made available, if possible, to the troops as part of the dispersal procedures.

Quarantine

17. These procedures will be completed aboard HMAS Sydney together with Customs clearances prior to arrival at Townsville. It is anticipated any personnel quarantine required will be at Townsville or Sydney depending on NOK address.

Pay

- 18. Cash payments are to be made on board in accordance with HQ AFV instructions. Remittances of undrawn pay are to be prepared by 4 RAR pay staff before arrival Townsville. These will be passed to Cash Office (Townsville) staff, before disembarkation, for processing to CPM N Comd. This procedure will ensure cheques, bank credits, etc, will be processed with minimum delay.
- 19. A HQ 3 TF/NQ Area cash office representative is to board HMAS Sydney on arrival off Townsville (See Annex B for timings). His task is to collect all remittances and despatch them to CPM N Comd.

Handover of Barracks (500 Area)

20. The Advance Party 4 RAR is to take over BHQ, Q Store and compound

during the period 30 Nov - 17 Dec 71. If Townsville Sub Area is still occupying the Q Store complex at this time then part only will be handed over. The remainder of the Q complex is to be released as vacated.

- 21. The remaining barracks, (messes, accommodation and associated stores) are to be handed over to 4 RAR late Jan early Feb 72. This handover inspection is to be by mutual arrangement between 4 RAR/Townsville Sub Area. Annex C outlines the HQ 3 TF/NQ Area requirements in relation to the handover.
- 22. 1 RAR is to provide accommodation for 4 RAR elements, as required, until such times as accommodation has been taken over by 4 RAR. A guide to the likely requirement is:
 - a. 25 Nov 17 Dec 71 two offrs, two sgts, 50 R and F, and
 - b. 17 Jan 31 Jan 72 three offrs, four sgts, 60 R and F.

Catering

23. 1 RAR is to foster 4 RAR elements for messing in accordance with HQ 3 TF/NQ Area Admin Instr 28/71, until approximately 4 Feb 72.

Stores/Equipment

- 4 RAR will return to Australia with all equipment and stores that are serviceable. Their present Part One Account Number will also accompany the battalion home.
- 25. Unit stores and equipment will be offloaded in Townsville. Some will be offloaded from HMAS Sydney, on D Day, but the majority will arrive on HMAS Jeparit on 28 Dec 71. The details for the Jeparit unloading will be advised separately.
- Personal accompanied baggage, weapons carried by members and luxury items in Connexes are to be discharged at Townsville. A total of eight connexes will be offloaded.

Transport Loan

27. DADOS 3 TF/NQ Area is to arrange the loan of one ¾ ton landrover and two 2½ ton CLs for 4 RAR Advance Party use. The loan dates are from 29 Nov 71 to 4 Feb 71. OC 4 RAR Advance Party is to liaise with DADOS for the receipt and documentation of this transport.

- 28. It is essential to define and clarify certain areas to be used during the reception of 4 RAR and referred to throughout this instruction. These areas are: (See diagram at Annex D)
 - a. Disembarkation Point. This is the area at which troops disembark from the ship's LCMs at Townsville. This disembarkation point is the Townsville Public Boat Ramp (PBR).
 - in which the disembarking troops are received, and later dispersed on leave. It contains the disembarkation point and the control organization for the reception. It is out of bounds to the public or relatives. It is the asphalt parking area around the PBR.
 - c. Reception Area. This is the place at which disembarked troops may re-unite with their relatives and friends and where refreshments are served. It is located at the eastern end of ANZAC Park adjacent to the Transit Area.

Co-ordination and Control

- 29. The co-ordination for the reception is the overall responsibility of HQ 3 TF/NQ Area. Capt 0. Martinson, SCQ (Mov) is appointed co-ordinating officer. The control of the operation changes for various stages. The stages and control envisaged are:
 - a. embarkation into LCMs HMAS Sydney;
 - b. disembarkation at the PBR Det 10 MC Gp;
 - c. reception and march past 4 RAR Advance Party;
 - d. movement by bus back to transit area Det 10 MC Gp;
 - e. return of all weapons 4 RAR advance party;
 - f. return of transients to HMAS Sydney Det 10 MC Gp; and
 - g. on movement for leave Det 10 MC Gp.

General Movement Aspects

The overall movement co-ordination is designed to ensure a rapid turn-around of HMAS Sydney, to reduce time spent in waiting and to allow

for a quick dispersal for onward movement after the march through Townsville. To achieve this, control must be exercised. The various stages of movement are:

- a. movement of troops from HMAS Sydney to the disembarkation point/transit area;
 - b. reception of baggage in the transit area;
 - c. refreshment and welcome by friends and relatives at the reception area, Anzac Park;
 - d. the march through Townsville;
 - e. the return of all marching members back to the transit area in buses;
 - f. hand in of weapons belonging to 4 RAR personnel only;
 - g. return of transients to HMAS Sydney;
 - h. hand out of tickets and onward movement arrangements; and
 - i. collection of personal baggage.

Disembarkation

- or NW off Magnetic Island, depending on the intensity and direction of the prevailing weather conditions. The disembarkation is to commence early am (detailed timings to be advised) using LCMs off HMAS Sydney. 4 RAR will disembark from the LCMs at the disembarkation point. The LCMs will remain in this area during the march through Townsville. The troop disembarkation should be completed by 1000 hours. An outline fair weather programme is shown in Annex E.
- Foul Weather. This is defined by the Navy as being too rough to lower the landing craft. If the weather 'deteriorates' the disembarkation plan will change. The main changes anticipated are:
 - a. A civilian passenger ferry (Hayles) will be used to transport the troops to shore. One ferry is available and is to make two trips.
 - b. The disembarkation point will be the RAAF crash boat wharf or the dredge wharf.
 - c. Unless severely adverse weather conditions prevail, the march through Townsville is to go on.
 - d. Those members returning to HMAS Sydney for southern ports will be returned to HMAS Sydney by passenger ferry.

RESTRICTED

/33. In the event

- In the event of extremely foul weather the march will be cancelled. This decision will be made by the AA and QMG HQ 3 TF/NQ Area upon receipt of an 'unable to disembark' signal from HMAS Sydney. HMAS Sydney is requested to confirm the landing of troops by priority signal, to Army Mov Townsville upon receipt of the weather report signal.
- If the HMAS Sydney cannot land all troops, those for Townsville will be landed by civilian ferry. Det 10 MC Gp is responsible for arranging the ferry and an alternate disembarkation point, ie, RAAF crash boat wharf.

Helicopter Support

35. G Branch is to task a Sioux helicopter for ship/shore liaison duties on D Day. An outline of tasks anticipated is shown at Annex B. The helicopter is required at the Transit Area by 0600 hours D Day. 1 RAR is to mark an LZ in the northern corner of the asphalt at the Transit Area.

Visits to HMAS Sydney

76. Visits to HMAS Sydney are to be limited. Annex B shows those visits currently scheduled. Requests for visits not scheduled should be made to the co-ordinating officer.

Communications

- Radio communications are required at the Transit Area and on board HMAS Sydney. These are required by 0600 hours on D Day.
- A telephone extension (PMG) is required at the Transit Area in the mobile movement control office. This extension is to be in and tested by D-1.
- 39. 103 Sig Sqn is responsible for the above communications. This includes the security, control and manning of the radio link and telephone at all times. Liaison with Det 10 MC Gp will be necessary to establish the siting of these communications. The ship and shore radio operators are to report to Det 10 MC Gp at the Transit Area by 0545 hours D Day. (See Annex B for flight details for operator to board HMAS Sydney).

Security

- Area and Reception Area are as follows:
 - a. 4 RAR Advance Party is required to provide a security picquet to guard any installation, vehicles, etc, positioned in the above areas on D-1. This duty involves an all night roving picquet which is to dismount at 0600 hours D Day. Detailed timings are to be advised.

RESTRICTED

/b. 1 RAR

- 8 -

- b. 1 RAR is to provide a working party of eight personnel to report to Det 10 MC Gp at 0900 hours D Day. These soldiers will be required for marshalling tasks, assist provost personnel and general duties throughout the day.
- c. Det N Comd Pro Coy is responsible for traffic control into and within the transit area under the direction of Det 10 MC Gp. It is also responsible for crowd control at the Reception Area, to seal off the Transit Area and the clearance of unauthorized persons, etc, from both areas. A roving patrol of two personnel is required overnight on D-1 until 0500 hours D Day.

Establishment of Transit/Reception Areas

41. 4 RAR Advance Party assisted by Det 10 MC Gp is responsible for the detailed preparation and layout of the Transit and Reception Areas. Those locations have been reserved for use on D Day by liaison with the Townsville Harbour Board and City Council respectively. The layout of the transit/reception areas is to include:

a. Transit Area.

- (1) positioning and marking of baggage trucks;
- (2) signposting and sealing off where necessary;
- (3) provost control points;
- (4) positioning of the mobile movement control office from which details for On-movement (ticket issues) can be made;
- (5) telephone connection and radio communications;
- (6) weapon hand in points for 4 RAR personnel; and
- (7) bus parking area in relation to weapon hand in points, movement office and LCMs to ensure a smooth flow for dispersal procedures.

b. Reception Area.

- (1) overhead cover and shade,
- (2) refreshment and catering area,
- (3) signposting where necessary, and
- (4) position of rubbish bins.

March Through Townsville

- 42. Fair Weather. The fair weather programme includes a march through the city of Townsville. Transiting troops will march to bolster those 4 RAR members disembarking Townsville. A detailed instruction relating to the march is to be issued separately by HQ 3 TF/NQ Area. The outline timings are:
 - a. 1100 hours 4 RAR group assembles;
 - b. 1126 hours 4 RAR group march off;
 - c. 1140 hours completion of march; and
 - d. 1145 hours return to Transit Area.

Medical

- A first aid post is to be established within the Reception Area. This post is to be manned by 0800 hours D Day. Its basic task is to provide minor medical assistance to soldiers and relatives during the day. 1 RAR is responsible to ensure that this requirement is met.
- In addition to the normal duty ambulance, SOMS HQ 3 TF/NQ Area is to arrange an ambulance to be on standby at the PBR from 0630 hours D Day. This vehicle will be called forward if required, for medical evacuations on disembarkation.

Provost Control

- Det N Comd Pro Coy is to provide sufficient personnel to meet the requirements stated in sub-paragraph 40.c. The number of personnel required for duty on D Day is four.
- Provost control throughout D Day at the transit area is considered essential to ensure the success of the reception of 4 RAR. The transit area is a working area into which members of the public and relatives/friends of returning soldiers are not to be permitted entrance under any circumstances. The transit area is to be 'sealed off' by 0630 hours on D Day.

Catering at Reception

47. (Sub-paragraph 41.b. refers). Although 4 RAR Advance Party is responsible for the detailed reception arrangements, the catering will be organized by HQ 3 TF/NQ Area. The Catering Advisor, HQ 3 TF/NQ Area, is responsible for this aspect of the reception. The catering should be based on light refreshments/snacks for 500-600 personnel. 4 RAR Advance Party is to liaise direct with ASCO Area Manager for the positioning of a cool drink service within the reception area.

RESTRICTED

48. A reception luncheon will be held in the Mount Stuart Officers' Mess at 1230 hours for official guests, 4 RAR and 104 Fd Bty officers and their wives, mess members and other invited guests. Separate details will be issued later. An LCM/tender will leave the PBR at 1420 hours to return those transitting officers to HMAS Sydney.

Baggage

- Those members disembarking for Townsville, or onward movement from Townsville (120 personnel) are to carry their weapons and baggage with them. At this disembarkation point trucks will be waiting onto which the baggage is to be placed for security.
- 49. 4 RAR Advance Party is to arrange with DADST for four trucks to be stationed at the disembarkation point by 0800 hours D Day. These vehicles are to be clearly marked:
 - a. B Coy,
 - b. C Coy,
 - c. Sp Coy, and
 - d. Admin Coy.

In addition to these, a further two trucks are required, on completion of the march, to carry personal luggage, etc, for those members proceeding directly on leave ex Townsville. One vehicle is to be marked 'BRISBANE' and the other 'COUNTRY AREAS'.

50. Members with baggage are to place it into one of the former four vehicles according to their company. The baggage is to be collected after the march and placed into one of the latter two trucks or retained as required.

Transport

- A bus is to be made available to transport the families of 4 RAR to the reception area and later to the saluting base for the march past. The bus is to be used on a repayment basis paid by 4 RAR funds. 4 RAR Advance Party is to issue detailed instructions to the families including timings, routes, etc.
- DADST is responsible for the provision of transport as requested by 4 RAR Advance Party. The task is to move 4 RAR back to the transit area after the march and as follows:
 - a. to move 35 personnel to the airport for Brisbane; (timings to be advised);

b. to move 13 personnel either to the airport, railway station, Lavarack Barracks or a combination of all depending on connecting travel arrangements for Queensland country areas; and

It is anticipated that the 72 personnel remaining in Townsville will be picked up by relatives or dependants.

DISPERSAL OF 4 RAR

Leave

- 53. Leave details are as follows:
 - a. Advance Party. This group will travel on leave on RTA until 25 Nov 71. They are then recalled until the reception of the Main Body is completed. They will then proceed on leave again until 24 Jan 72. Additional free travel where applicable is authorized for this second period of leave after recall.
 - b. Main Body. Approximately 120 personnel will disembark Townsville and proceed on leave until 1 Feb 72. This 120 personnel comprisees:
 - (1) 72 NOK Townsville,
 - (2) 35 NOK Brisbane, and
 - (3) 13 NOK North of Rockhampton (excluding Townsville).
- Normal means of travel is authorized from Townsville to NOK address. Payment for other than normal means is to be completed prior to disembarkation.
- Applications for free/assisted travel are to be processed before departure from SVN. Once approvals are in hand and detailed movement arrangements, etc, can be completed by movements staff on board HMAS Sydney.

Action in Transit Area

- All vehicles returning from the march will be directed by provosts to move into parking areas in the Transit Area (see paragraph 41) where all members are to debus. The following controlled dispersal procedure is then to occur:
 - a. all 4 RAR members are to hand in their personal weapons;
 - b. those personnel returning to HMAS Sydney (274) are to embark into waiting LCMs and depart Townsville;

/c. personnel

a 12 an

- c. personnel remaining (120) are to be processed for leave with the issue of tickets and travel details;
- d. personal baggage may be collected;
- e. members with NOK in Townsville may rejoin their families;
- f. on-travelling members are to board vehicles for their destination, ie, airport; and
- g. anyone requiring an overnight stay prior to on movement is to be transported to Lavarack Barracks and fostered by 1 RAR.
- The complete withdrawal of weapons, before dispersal, is of prime importance. 4 RAR Advance Party is solely responsible for this aspect of the procedures. 4 RAR Advance Party is to advise HQ 3 TF/NQ Area the detailed procedure to be used, for the withdrawal of weapons, as soon as practicable.

Leave Transportation

There are no scheduled public transport agencies that leave Townsville southbound after 1500 hours. Unless all arrangements have been made in SVN, charter arrangements will have to be made to avoid an overnight stay in Townsville for those troops heading south.

Co-ordination Conference

59. A co-ordinating conference to discuss final details is to be held in the conference room Bldg 124 late November/early December. Timings and date are to be advised one week prior by signal.




