

Two check points are manned in the TASK FORCE area by this section, having two Pro NCOs on each. We are assisted by two NATIONAL POLICE and a VIETNAMESE interpreter on each point. Hours of operation are:-

Check point 1. 0700 to 1900 hrs daily
Check point 2. 0800 to 1615 hrs daily
Thesecheck points during the month of Aug 66 searched approx 200
vehicles and 1,500 to 2,000 VIETNAMESE persons daily prior to
allowing them to pass through the 1 ATF area. It has been estimated
by 1 ATF CIVIL AFFAIRS that this section conveyed approx 2,000
VIETNAMESE people weekly in unit transport through the 1 ATF area

Check Point 1 recorded for the month of Aug 66 that 938 vehicles travelled to VUNG TAU, 872 vehicles travelled to BARIA and 136 vehicles travelled to HOA LONG.

4. Only limited patrolling of BARIA was carried out due to the increase in comittments within the TASK FORCE area.
