He was fair, bright about 5'8", well built and a grocer prior to enlistment.

He was taken bad with pneumonia on the 31/2/19 and was bad eight days. The last three days he was unconscious and died at 2.45 a.m. on the 7/3/19. He was a pal of mine and always lived with me. He left Australia with me on the S. S. "Persic." 22nd A.A.S.C. I made arrangements for his burial, which was at Sous le Bois civilian Cemetery. There were three greaths also a nice cross placed on his grave. He was buried with full military honors. Having a team of six black horses and a pill box. I have a photograph of the funeral also one of the grave. A French family have promised to always look after the grave. He died at the 5th C.C.S.
