

"Hounded Mesopotamia"

Concerning the death of the above named Officer. I am now able to send you the following cable message, dated January 7th, which we have received this morning, from Mesopotamia.

"Lieut Cannell, R.A.F. was shot down on October 29th while attacking holtile infantry. He died of wounds on October 31st, without regaining consciousness, and was buried in the Battlefield Cemetery at Surgat".
