"I have to coknowledge receipt of your letter dated 13th instant, and to state you will, ere now, have been advised through the Hilitary Commandant, Victoria Barracks, Sydney, of the regrettable news that your son, No. 700a, Private A.S. Haddon, lat Ansac Camel Battalion, has been posted as "missing". The following is a copy of a cable message received from abroad.

"let Camel Corps advise evidence in this case
"very contradictory. Board suggest that inquiries
"should be made from the Officer Commanding Dressing
"Station; Charing Cross that date. Haddon not yet
"reported by any Dressing Station but seen in Cacolet
"preceeding towards Dressing Station according to one
"witness. Will advise as further information come to
"hand."

A further cable message regarding this case was despatched on the 19th instant. You will be promptly communicated with as soon as later information is to hand."

CANEL CORPS. (Late let Battalion.)

HAPPOH. 4.S. Private

KILLED 19.4.17.

I knew Haddon. He was in No. 2 Company with me, and was in the Machine Gun Coy. He was short, young, but hair going grey, although he was only 23/24 years old. I was transferred to No. 11 Company three days before he was killed, but I was told 2/3 days after he was killed that he had been killed on 19.4.17, at the furthest point they reached on that day at Gasa. They had just captured a redoubt. I went across to see the Company after the Eattle, and I heard about his death. I think Private Barry told me about him. They were in the same section. Earry got the D.C.M. for his work that day. We retired back 2 miles that night.

From what I was told, I felt sure Hadden was killed outright.

CAMEL CORPS. Late let Rattalion.

"5111ed 19/4/17"

Informent described Haddon as about 5 feet 8 or 9 inches

high, medium build, dark complexion aged about 20/25.

Informant states that they both belonged to 2nd Company Imperial Camel Corps Machine Sun Section. On 19/4/17 the Comapny was in action near Gaza Palestine fighting the Turks for a place called Esmson's Ridge. Informant had men Haddon that morning and they went into action together but got separated. He was however, told by one of Haddon's mates (who so far as he could remember was a stretcher bearer) that he had seen Haddon coming back wounded although he did not appear to be seriously hurt. After that no one seems to have seen him although enquiries for him were made on the spot as well as in the various hospitals in Egypt.

Informant added that Haddon was a good lad always ready

to do what he was told and in high favour with his mates.
