In the attack on Oct.4 at West Cak Ridge I was with him all the time till past the 1st objective, and here we got beyond our owon barrage. I heard Major Brown of B Co. cell Lt.Power back behind the barrage and I saw him start back and almost immediately a shell burst just where he was - he was enveloped in smoke and dust and that was the last I saw of him. When I went on to the 2nd Objective he was not there. I was only 10 yards from him when the shell burst - jt was beyond him and fragments of it caught my helmet. Of course we ducked at once and immediately after came the order to advance, and I had not time to see if his remeins were there. I feel personally convinced the shell must have killed him.

He was killed outright by a shell at Passchendaele Ridge on 4/10/17 and I saw his body afterwards, and am certain he was killed outright This was as we were advancing and happened early in the morning of 4/10/17. Lieutenant Hawke M.W. since killed was near Mr. Power at the time.

Power was a 1st Lieutenant and came from Queensland his name was Noel .. He was in the stunt at Broodeseinde Ridge on 4/10/17. In the attack a shell was seen to explode quite close to him, and no further trace was ever seen of him. . court of enquiry was held and these facts were brought out. He was (before the enquiry) marked as missing, but the Regiment is satisfied that he was killed outright and this was the finding of the Court of Enquiry. He was in B Company.

Power's name was woel, he was in B Co. of the 4th Battalion and the only officer of that many in the 4th Btn. at the time he was willed. He met a brother or cousin in France just before some into Broodeceinde and this relation was slightly wounded on the y/10/17. In the attack on Broodeseinde on the 4/10/17 we had to halt for an hour at the first objective; during this duit, officers of the Connany were called together and given further instructions - Power was one of them, and I remember speaking to him there. We officers then sent back to our platcons, Tower left for his which was about 100 yards off. A few minutes later word came through from his Platoon - No. 5 that he was missing. I then took charge of his platoon with my own. We searched that ground for about 2 hours the next day, but no trace was found of him. Later on a Court of Enquiry was held and verdict given that Power had been silled in action. It was afterwards established that he did not reach his platoon after the conference of prov officers. To reach his platoon he would have to move dlightly away, and na not towards the German line. The shelling was very heavy and he must have been killed instantly by shell fire. It was quite impossible for him to have been taken prisoner. The conference of officers was held about 7 a.m. so there was no chance of his having lost his may in the dark.

Informant states that on the 4/10/17, the Battalion was in action at Polygon Wood. They hopped over in the middle of the day. About two hours afterwards, informant saw the Lieutenant who had been evidently killed instantly not long after the hop-over, as he was found just over the line. Informant recognised him by some personal belongings on him, which however, he did not remove, as at the time they were advancing further forward. He never saw the Lieutenant again.

Informant added that Lieutanant Power was in charge of the Machine gun to which he (Informant) belonged, and prior to the hop-over, he had seen him alive at the jumping off ground. He was a well liked officer.

Informant states that they both belonged to B.Company, the Lieutenant being in charge of No.5, Platoon.

On 4.10.17 the Battelion was in action near Polygon Wood. They hopped over at 5.30 a.m. About 2½ hours afterwards when they had gone on about 2 miles, and had got their first objective, they were resting along side Celtic Farm, between the first and second objectives. The Lieutenant was engaged in examining a Map when a shell burst quite close to him and killed him instantly. Informant was about 20 yards away, and saw the whole occurrence.

According to Informant the Lieutenant was an Officer very much liked by his men.
