"He was a member of my platoon, and on the afternoon of the 29th Harch he was observing when a shell burst on the paramet of the trench and killed him instantly; a piece of shell passing through his head. I always admired him for the cheery way he had of doing things, and by his cheeriness he inspired others who were likely to become a bit depressed, during the din and roar of battle. He was buried just outside Hebuterne, and a cross was erected over his grave."

"Killed, 29.3.18."

He was killed outright in one of our bombing raids at Hebbiaton (? spelling) at about the end of Marth/18 and was buried the next day about 20 yds. behind the front line which was about half a mile in front of the village. There were about a doz. graves altogether and he was buried with Lt. Hall of A. Co. 14th Batt. A. I. F. who was killed in the same raid. (The latters name is now cancelled A. G. C.)

Capt. Roland, padre of 14th Batt. A. I. F. conducted the service. The Germans had not yet got close. Tidid not see them killed but was present at the funeral. I did not know Revill personally. He belonged to a Co.
