Regers, D. Coy., 48th Eattn. Informant states that yor son was killed at Fosieres on August 6th during a counter attack. He was close by informant and was shot through the head and killed instantly. He says that your son was known as fom and says that he had a "crook" foot and walked lane through his foot having been smashed some time previously. Is this description correct?

We are so very sorry to have to cond you this report and we hope that the knowledge that his death was instantaneous, and therefore painless, will help to confort you in your loss.
