I know he is Prisoner of War. His name is Claud, and he came over with 21st Rfts. He was a friend of ours. We left him well with the working party at Marquion.

Note Witness was clear and quite reliable in his information. In all cases Pte. Stewart was able to supply the rank, number or initial of the missing man. He gave most of the information from memory as he feared to raise suspicion by attempting to compile a complete list from his fellow captives. Naturally he only knew a small percentage of them, but his memory seemed excellent and he was most anxious to supply all possible particulars. I understand a full report of Pte. Stewart's and L/Cpl. Parsons' experiences has been sent to Australia by Lieut. Col. Murdoch.
