



HMAS ASSAIL - REPORT OF PROCEEDINGS - JANUARY 1978

Sir,

- 1. I have the honour to report the proceedings of HMAS ASSAIL, under my command for the month of January 1978. Time zones in this report are as indicated.
- 2. At the beginning of January ASSAIL was berthed at the Patrol Boat Landing in Darwin undergoing an AMP. This remained the situation until 1000(IK) Tuesday 10 January when the ship departed on a 15 day patrol along the North West coast. HMAS ARDENT sailed at the same time which enabled both ships to conduct some 00W manoeuvres before beginning their respective patrols.
- ASSAIL proceeded across the Joseph Bonaparte Gulf to the fishing ground near Browse Islet where six pairs of Taiwanese trawlers were sighted. None was boarded, however, because of the difficult conditions created by Cyclone Trudy which was building up to the north.
- 4. During the morning of Thursday 12 January ASSAIL anchored near Cape Leveque Lighthouse so that the headkeeper could be approached regarding becoming a coastwatcher. The ship departed in the afternoon and proceeded to Broome. ASSAIL berthed at 1000(H) Friday 13 January to embark fuel and allow the ship's company an overnight stop.
- The patrol was continued the next day when ASSAIL departed Broome and proceeded towards Port Hedland. Two pairs of Taiwanese trawlers (MAO HUNG 11/12 and YUAN YU 11/12) were boarded that afternoon. On Sunday 15 January another two pairs (KING HAI HWA 1/2 and HUNG CHOU 1/2) were boarded in a fishing ground to the north east of Bedout Island. The ship anchored near Bedout Island that night in order to watch the trawlers but none came near the island.
- ASSAIL berthed in Port Hedland at 1000(H) Monday 16 January to replenish with fuel and departed the following day at the same time. During the patrol between Port Hedland and the Monte Bello Islands only one pair of trawlers was sighted (YU TAI 1/2) and these were boarded on Tuesday evening. ASSAIL anchored in the Monte Bello Islands during the early hours of Wednesday 18 January before proceeding to Point Murat that night.

/7. The ship

- The ship berthed at the Point Murat Jetty at 1000(H) Thursday 19 January and remained there until the next day when the return leg of the patrol was commenced. ASSAIL then headed towards Broome where fuel was replenished on Sunday 22 January. The passage to Darwin was made via the fishing ground near Browse Islet where two pairs of trawlers (CHUNG FANG 1/2 and MON HO 31/32) were boarded on Monday afternoon. The ship arrived in Darwin at 0900(IK) Wednesday 25 January.
- 8. During the period 25-31 January ASSAIL patrolled the Beagle Gulf as part of Operation Seawatch. The patrol was uneventful except for the poor weather conditions which caused the ship to anchor on several occasions. ASSAIL berthed in Darwin at 0930(IK) Tuesday 31 January to commence an Assisted Maintenance Period.

Marine and Weapons Electrical Engineering

9. During January no major problems were encountered with any of the machinery or electrical equipment.

General

10. The health, welfare and conduct of the ship's company was very good during the month.

HMAS ASSAIL - REPORT OF PROCEEDINGS - FEBRUARY 1978

Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of February 1978. The time zone throughout this report is IK $(-9\frac{1}{2})$.
- 2. At the beginning of February ASSAIL was berthed in Darwin undergoing a two week AMP. The ship departed harbour at 0800 Monday 13 February in company with HMA Ships ARDENT, ADROIT and AWARE to participate in your sea inspection, Sir, of ADROIT. On completion of the exercise ASSAIL proceeded to patrol line Alfa in the Beagle Gulf where the ship was programmed to patrol until 2 March.
- The first week of the patrol (13-20 February) was largely uneventful. The routine consisted of patrolling each night and anchoring by day so that maintenance could be carried out. Much work on the upperdeck was completed during that week owing to the abnormally good weather. The ship's newly joined Stage 4 officer under training also received a good deal of shiphandling and pilotage training in that period.
- 4. At 0530 Monday 20 February ASSAIL rendezvoused with HMAS ARDENT near the patrol line. Officer of the Watch manoeuvres were conducted by the Midshipman until 0900 whereupon ASSAIL proceeded to anchor off Charles Point and ARDENT entered Darwin harbour.
- The ship departed the anchorage during the afternoon to return to the patrol line but at 1905 a minor fire occurred in the wiring system on the starboard engine.

 ASSAIL drifted in the calm sea whilst the damaged wiring was removed and a temporary system installed and at 2240 the ship was once again steaming on the starboard engine.

 ASSAIL anchored off Charles Point several hours later and berthed in Darwin at 0900 Tuesday 21 February to enable repairs to be carried out. The ship remained in Darwin for the remainder of the month.

/Marine and Weapons

Marine and Weapons Electrical Engineering

- 6. The most serious defect experienced during February was the damaged wiring on the starboard engine (HMAS ASSAIL URDEF 17/80 and TM 145 L34/80 refer). This defect was rectified on Tuesday 28 February but the ship did not complete the remainder of the patrol because the replacement for a defective overspeed switch on the starboard generator was not available. The rest of the ship's machinery and electrical equipment performed well.
- 7. An INC inspection of the 40/60 Mk 7 Bofor was carried out between 6-9 February.

General

8. The health, welfare and conduct of the ship's company was good during the month. A lecture on security and the dangers of alcohol abuse was presented to the ship's company during February.

HMAS ASSAIL - REPORT OF PROCEEDINGS - MARCH 1978

Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of March 1978. The time zones used in this report are India Kilo $(-9\frac{1}{2})$ until Monday 27 March then Kilo (-10) for the remainder of the month.
- At the beginning of March ASSAIL was berthed in Darwin undergoing an AMP. The period up to 19 March was largely uneventful except that on Monday 13 March you, Sir, conducted an informal walkround of the ship. At 1000 Sunday 19 March ASSAIL departed Darwin and commenced a 26 day patrol of the Arnhem Land coast and the Gulf of Carpentaria.
- After leaving harbour ASSAIL proceeded to the area west of Charles Point in order to locate the ketch OSTARA. The ketch had reported to Marine Operations, Canberra that it was lost and very low on fuel. ASSAIL, with the assistance of an S2G, found the OSTARA at 1230 whereupon she was given 15 gallons of dieseline and a position. The OSTARA then proceeded into Darwin and ASSAIL headed for a practise area where all weapons were successfully fired at rocket flares.
- The first leg of the patrol consisted of a passage along the Declared Fishing Zone to Gove via the western side of Bathurst Island. Only three Taiwanese drift netters were found in the area and these were all boarded. ASSAIL berthed in Gove at 0930 Wednesday 22 March to replenish with fuel and have an oversight stop. The following morning you, Sir, visited the ship for a short period whilst on your tour of Gove.
- Upon departing Gove ASSAIL proceeded south to the Sir Edward Pellew Group of islands where the ship anchored during the afternoon of Friday 24 March. ASSAIL weighed anchor the next morning and conducted a patrol along the DFZ towards Mornington Island. Three Taiwanese drift netters were located in the area but they were all operating well outside the limit. ASSAIL anchored in the Bountiful Islands at 1100 Sunday 26 March.
- The ship departed the Bountiful Islands at 0400 the next day and commenced a patrol towards Weipa. Many contacts were investigated along the coastline but all proved to be Australian prawn trawlers. ASSAIL berthed at

/Evans Landing

Evans Landing in Weipa on Tuesday 28 March to take on fuel before proceeding to Thursday Island. The ship arrived at Thursday Island at 1000 Wednesday 29 March and remained in harbour until 1530 the next day.

7. On Friday 31 March ASSAIL conducted another firing of all weapons against a sleeve target towed by an Omni Aviation Aztec. At the end of March the ship was patrolling the DFZ between Weipa and Thursday Island.

Marine and Weapons Electrical Engineering

8. All machinery and electrical equipment operated very well during March and only minor defects were encountered.

General

9. The health, welfare and conduct of the ship's company was good during the month.

HMAS ASSAIL - REPORT OF PROCEEDINGS - APRIL 1978

Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of April 1978. The time zones used in this report are Kilo (-10) until Monday 10 April then India Kilo $(-9\frac{1}{2})$ for the remainder of the month.
- 2. On Saturday 1 April ASSAIL was patrolling the DFZ between Weipa and Thursday Island. Two pairs of Taiwanese trawlers were boarded that afternoon after which the ship proceeded to anchor near Duyfken Point. ASSAIL weighed anchor at 1310 the next day in order to patrol the area west of Weipa until midnight when the ship returned to the same anchorage.
- 3. At 0500 Monday 3 April ASSAIL proceeded to rendezvous with HMAS BAYONET near the entrance to Weipa. After conducting a variety of 00W manoeuvres and several heaving line transfers both ships entered harbour to fuel and stay overnight.
- ASSAIL departed Weipa at 1100 Tuesday 4 April and commenced patrolling the DFZ towards Mornington Island. On Wednesday afternoon ASSAIL was directed by HMAS CAIRNS to proceed to Thursday Island and await the development of Cyclone Hal which was forming near Groote Eylandt. Despite the rough conditions experienced in the two day passage, no serious damage was caused. The ship berthed on HMAS BAYONET at 1030 Friday 7 April.
- 5. The effects of Cyclone Hal had almost disappeared by 1200 Monday 10 April when ASSAIL departed Thursday Island in company with BAYONET. Officer of the watch manoeuvres were conducted for a short period before ASSAIL detached and proceeded to Gove for fuel.
- Upon departing Gove at 1730 Tuesday 11 April the ship commenced a patrol of the Arnhem Land coast towards Darwin. Soon after rounding Cape Wessel at midnight 11/12 April, two contacts were gained which were approximately 15 miles from the coast. Whilst proceeding to investigate, a net was found which extended between 9.6 12 miles from the Cape. As it was not certain which FFV owned the offending net, both were boarded and questioned. Once the SHIN NAN KAI 2 claimed the net the other FFV was allowed to go. The former vessel was then apprehended and, after recovering her net, was escorted to Darwin where both ships arrived at 0830 Friday 14 April.

/7. ASSAIL remained

- ASSAIL remained in Darwin until 28 April during which time an AMP was conducted. The only event of note in this period was that eleven members of the ship's company participated in the Anzac Day march and memorial service in Alice Springs at the invitation of the local sub-branch of the Returned Servicemen's League. This invitation is extended each year and it appeared that both the RSL members and the ship's company enjoyed the reunion very much.
- 8. At 1000 Friday 28 April ASSAIL departed Darwin and commenced an FFV patrol along the Arnhem Land coast. No such vessels were located over the next two days and at 1320 Sunday 30 April the ship anchored near Truant Island and stayed there for the rest of the day.

Marine and Weapons Electrical Engineering

9. No major defects were encountered during the month and all machinery and electrical equipment functioned well.

General

10. The health, welfare and conduct of the ship's company was very good during the month.

HMAS ASSAIL - REPORT OF PROCEEDINGS - MAY 1978

Sir.

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of May 1978. The time zone used throughout this report is India Kilo $(-9\frac{1}{2})$.
- 2. At the beginning of Monday 1 May ASSAIL was anchored at Truant Island, having departed Darwin two days previously on an FFV patrol along the Arnhem Land coast. The ship weighed anchor that morning and proceeded to Gove for fuel, arriving at 1130.
- ASSAIL departed Gove at 1330 Tuesday 2 May and commenced patrolling the DFZ towards Groote Eylandt. No FFV's were encountered before the ship anchored near Chasm Island at 0345 3 May to avoid the rough conditions created by a freshening south easterly wind. ASSAIL weighed anchor at 0800 the following day and returned to Gove where fuel was embarked during the forenoon of Friday 5 May.
- 4. After departing Gove the ship commenced the return leg of the patrol to Darwin. Again no FFV activity was sighted and the only incident of note was that on Saturday 6 May ASSAIL searched in vain around the Goulburn Islands for the source of mysterious lights which had been observed from ashore during the previous three nights. The ship arrived in Darwin at 1400 Sunday to take on fuel and stay overnight before patrolling the Beagle Gulf.
- The first two days of the patrol consisted of anchoring during the daylight hours and patrolling by night. On Wednesday 10 May ASSAIL boarded the Taiwanese drift netter TA SHUN 1 and soon afterwards was directed to the Garden Point Mission on Melville Island where two small vessels of Indo Chinese origin were held by the local police. These vessels (KIM THANH and CONG THANH) were under escort to Darwin by early evening. After a passage made difficult by rough seas, the 42 refugees arrived in harbour at 1400 on Thursday where the Immigration Department assumed custody of them.
- ASSAIL returned to the patrol area the following day but no ICOV's were detected until the forenoon of Sunday 14 May when the CON DAO 3 (121 refugees) was found drifting by an S2G Tracker of VS816 Det Dar. This vessel was towed by ASSAIL to an anchorage near Cape Fourcroy where water was

/provided for

provided for the refugees and the diesel engine. Repairs were also carried out on the propeller shaft which had uncoupled and jammed the rudder. By 2130, ASSAIL and CON DAO 3 were proceeding towards Darwin where both vessels arrived early Monday morning.

- 7. At 0830 Tuesday 16 May ASSAIL resumed the Beagle Gulf patrol. The next three days were uneventful except that on Thursday afternoon a combined firing of all weapons was conducted in a firing area near the patrol line. ASSAIL berthed in Darwin at 1130 Friday 19 May to commence a maintenance period which occupied the remainder of the month.
- Buring the period 21-23 May several members of the ship's company, including myself, gave evidence in the trial of the SHIN NAN KAI 2 which ASSAIL had apprehended on 12 April for fishing within the DFZ near Cape Wessel. Despite the defence provided by a Queen's Counsel from Melbourne the magistrate found the Taiwanese were guilty and as punishment the trawler and catch were confiscated and the master was fined \$1,000.

Marine and Weapons Electrical Engineering

9. The majority of engineering and electrical equipment functioned satisfactorily during the month. The exceptions were the General Service Pump motor and one of the RM 916A radar transceivers but these defects have been rectified.

General

- 10. The health, welfare and conduct of the ship's company was good during the month. Morale was also good. A lecture on security and the dangers of alcohol abuse was presented to the ship's company in mid May.
- ll. In the latter part of May eight senior and junior sailors were posted to the ship. Initially it appeared that such a large change in the ship's company, particularly in the technical branch, would have a detrimental effect upon the ship but by the end of the month few problems had arisen and all had settled in quickly.

HMAS ASSAIL - REPORT OF PROCEEDINGS JUNE, 1978.

Sir,

- 1. I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of June, 1978. The time zones used in this report are as indicated.
- 2. At the beginning of June, ASSAIL was alongside the PBL completing a two week AMP. The ship departed harbour at 1530IK Thursday 1st and commenced an eleven day patrol of the Beagle Gulf. The pattern of this period consisted of patrolling by night and anchoring during the day whilst a S2G Tracker conducted the daily reconnaissance flight. Approximately every four days the ship fuelled in Darwin and stayed overnight to allow the ship's company to go ashore.
- Round the Islands yacht race from ASSAIL. After disembarking the official guests, the ship returned to the Beagle Gulf only to be directed to a stranded pleasure boat by an S2G Tracker. The boat was towed into Darwin during the afternoon after which ASSAIL again proceeded to the patrol area. The ship berthed on Sunday afternoon to refuel before commencing an FFV patrol along the North West coast.
- ASSAIL departed harbour at 1000IK Monday 12th to rendezvous with HMAS ARDENT near Charles Point. Seamanship evolutions, 00W manoeuvres and weapons firings were conducted until late that afternoon when ASSAIL detached and proceeded west. The patrol to Port Hedland was uneventful and no FFVs were sighted. After an overnight stop in Port Hedland, the ship proceeded to Broome at 1000H Sunday 18th. ASSAIL departed Broome at 1000H Tuesday 20th in order to rendezvous with HMAS LABUAN and return two personnel who had been taking delivery of spare parts in the town.

During the afternoon of Wednesday 21st, ASSAIL was proceeding towards Troughton Passage on one engine when a defective rectifier in the battery charger caused the engine to stop. Neither engine could be started because of the low power available in the battery banks but after 45 minutes, both were running when the charger was used to boost the batteries dueing the starting process. ASSAIL then continued the passage to Darwin via North Peron Island where some peculiar structures made of 44 gallon drums were investigated. No satisfactory explanation could be reached as to why these structures existed but they were old and there was no evidence of recent human activity. The ship berthed in Darwin at 2240IK Thursday 22nd and remained alongside for the remainder of June undergoing maintenance.

Marine and Weapons, Electrical Engineering

Despite the number of defects, the majority of mechanical and electrical equipment worked well during the month. The most serious defect encountered during the month was with the 24 volt battery charger (URDEF 20/80) but that was repaired on Friday 30th. A defective SOLAS III survival radio (URDEF 19/80) was replaced during the AMP leaving no outstanding URDEFs at the end of the month. Two INDEFs on the AN/DRC F1 radio transceiver and one RM916 radar transceiver had not been rectified by 30 June as the necessary replacement items had not been received.

General

7. The health, welfare and conduct of the ship's company was very good during the month. Morale was also very good. The new element of the ship's company who joined in late May have settled in well and appear to be enjoying the patrol boat way of life.

Sir

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of July 1978. The time zones used throughout this report are as indicated.
- At the beginning of the month ASSAIL was alongside in Darwin undergoing an assisted maintenance period as well as preparing for Project Jindalee trials.
- ASSAIL departed Darwin at 1000(IK) Thursday 6th to rendezvous with HMAS ARDENT and conduct a variety of exercises before proceeding west towards Derby where the Jindalee trials took place. The ship berthed at Derby at 1400(H) Sunday 9th to embark equipment and assist in preparing the wooden prawn trawler KATHERINE LEE which was also participating in the trials. During the evening ASSAIL moved to deeper water and commenced the fitting and calibration of equipment. This carried over to Monday afternoon when Mr Robert Garret of the Defence Research Establishment came onboard.
- At 0001(H) Tuesday 11th ASSAIL departed King Sound and proceeded to the trials area about 50 miles north west of Cape Leveque. The KATHERINE LEE also headed for the trials area but, because of the strong tidal streams experienced at Sunday Strait and her slow speed, was not available until the following day. On Thursday evening ASSAIL returned to King Sound to replenish fuel from HMAS LABUAN whilst the prawn trawler proceeded to anchor at Cape Leveque. During the morning of Friday 14th the equipment fitted in KATHERINE LEE was removed thus completing her part in the trials. ASSAIL then spent the remainder of the day in the trials area.
- The ship berthed at Derby at 0600(H) Saturday 15th to disembark equipment and refuel for the return passage to Darwin. ASSAIL anchored near Cascade Bay at midday to await instructions on whether or not to escort LABUAN to Darwin because of an unserviceable main engine. By 1900(H) ASSAIL was advised to return to base as LABUAN would be repaired in Derby. After an uneventful passage the ship berthed at the Patrol Boat Landing at 1300(IK) Monday 17th.
- 6. During the following week ASSAIL was engaged in preparations for Intermediate Docking at the RAN Slipway.

Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of August, 1978. The time used throughout this report is $IK(-9\frac{1}{2})$.
- At the beginning of the month, ASSAIL was on the slip at the RAN Slipway undergoing an Intermediate Docking period. This remained the situation until Friday 4 when ASSAIL was unslipped and moved to the PBL to complete the I.D. work.
- The ship departed Darwin at 0900 Monday 14 to commence a twelve day patrol period of the Beagle Gulf. The first day was occupied with gun functioning trials of the new 40/60 Bofor mounting received during the I.D. as well as exercising with HMAS ARDENT. After disembarking the trials team in Darwin that evening, ASSAIL returned to the patrol area.
- The period until Sunday 20 was uneventful except for an overnight stop in Darwin on Thursday 17. - I have the honour to report the proceedings of HMAS ASSAIL under my command for the period 1 22 September 1978. The time zone used throughout this report is India Kilo $(-9\frac{1}{2})$.
- 2. At the beginning of the period ASSAIL was berthed at the Patrol Boat Landing in Darwin completing the final preparations required for Annual Inspection and Squadex. The departmental inspections were conducted over Monday 4th and Tuesday 5th and on the following day you, Sir, carried out a harbour inspection and divisions. With the harbour phase of the inspection completed, ASSAIL sailed with the remainder of the Third Patrol Boat Squadron at 0345 Thursday 7th to conduct the Squadex in accordance with COMAUSMINPABFOR EXOPORD 13/78. Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of October 1978. The time zone used is H(-8) unless otherwise indicated.
- At the beginning of the month ASSAIL was berthed starboard side to No. 3 wharf, Geraldton Harbour. HMAS MORESBY berthed starboard side to No. 2 berth at 0900. I and my Executive Officer attended a cocktail party hosted by MORESBY at 1830 and on Monday 2nd at 1100 MORESBY's Commanding Officer and I attended pre-lunch drinks at the Council Chambers with His Worship the Mayor, Mr Lyle Harris.
- At 0845 on Thursday 5th ASSAIL cast off and proceeded to the survey area with MCRESBY where survey operations were carried out until Saturday 14th with ASSAIL refuelling in Geraldton Harbour as necessary. Because of the limitations of weather and equipment on the ship it was decided to install a Hi-Fix receiver in ASSAIL in order that she could act independently of MORESBY. The installation was carried out on Saturday 14th with ASSAIL remaining alongside MORESBY until 0745 on Sunday 15th. The ship carried out independent sounding operations and completed the allocated area in the Zeewyk Channel at 1516 on Thursday the 19th and proceeded to Geraldton, berthing starboard side to No. 3 wharf at 1914. The speed of the survey operations was restricted to 13.5 knots because of the starboard engine gearbox losing oil pressure on Monday 16th.
- At 0926 on Saturday 21st ASSAIL cast off and proceeded to the survey area and began sounding at 1232 in the Middle Channel area in the Houtman Albrolhos Islands. The survey operations were completed at 0539 on Monday 23rd and ASSAIL secured starboard side to MORESBY, at anchor, at 0745. The Hi-Fix receiver and Atlas Deso-10 echo sounder were then returned to MORESBY and the ship cast off at 0900 and proceeded to Geraldton, berthing starboard side to No. 1 berth at 1325.
- ASSAIL cast off at 1859 on Tuesday 24th and proceeded to Exmouth, berthing starboard side to Point Murat jetty at 1001 on Thursday 26th. After refuelling, the ship sailed for Broome at 1300. ASSAIL secured starboard side to the inner Broome wharf at 0815 on Saturday 28th, refuelled and proceeded to Darwin at 1100.

/8. Clocks were

Clocks were advanced $l\frac{1}{2}$ hours at 2315 on Sunday 29th to 0045 IK $(-9\frac{1}{2})$. On the evening of Monday 30th ASSAIL altered course towards North Peron Island to investigate a yacht sighting. At 0314 $(-9\frac{1}{2})$ on Tuesday 31st two Taiwanese trawlers were identified as the FU YUAN CT6-0288 and the FU YUH CT6-0287. After boarding the FU YUAN, the catch was found to consist of only a few sharks. The position from the closest point of land was 316 Cape Scott 19.3 miles. The boarding of the trawler provided valuable experience for ASSAIL's crew as they had not previously carried out a boarding of a fishing trawler. The ship then proceeded to Darwin without further sightings, berthing starboard side to HMAS ADROIT at 1316 $(-9\frac{1}{2})$ in Darwin Harbour where she remained until the end of the month.

Marine and Electrical Engineering

- There were a number of major and minor defects which affected the ship's operation during the month. Air was being drawn into the port main engine water cooling system on Saturday the 7th. This was temporarily repaired by ship's staff. (INDEF 18/80 refers). On Monday 16th the starboard main engine gearbox oil pressure fell below minimum operating pressure. This is still outstanding (URDEF 30/80 refers). The ship's steering arrangement appears to be drawing air or other impurities into the system which caused excessive effort to be put into steering the ship. (INDEF 20/80 refers). The ship's winch is suspect but should be repaired by ship's staff during the November AMP.
- 8. URDEF 28/80 was raised on the 10th for a fractured oil line on the 40/60 Bofor; this has been repaired by ship's staff. On the 10th the transceiver for the ship's radar was found to be out of order. The spare transceiver was fitted and found to be operating with only 50% efficiency and very shortly after became unserviceable. (URDEF 29/80 refers). The URDEF was rectified when the ship's staff repaired one transceiver and INDEF 19/80 was then raised on the remaining defective transceiver.

General

9. The health, welfare and conduct of the ship's company was very good during the month. Morale has remained very high.

HMAS ASSAIL - REPORT OF PROCEEDINGS - NOVEMBER, 1978

Sir,

- 1. I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of November, 1978. The time zone used is H(-8) unless otherwise indicated.
- At the beginning of the month, ASSAIL was berthed starboard side to HMAS ADROIT at the Patrol Boat Landing (PBL), Darwin, carrying out an Assisted Maintenance Period (AMP). At $0940(-9\frac{1}{2})$ on Thursday 2, the ship cast off and proceeded to the outer Darwin Harbour area to test the steering motor and starboard engine gearbox. On completion of the trials, ASSAIL berthed port side to the PBL at $1112(-9\frac{1}{2})$.
- On Thursday 16, ASSAIL held a family day which proved very popular with the eighteen family and friends who attended. The ship cast off at $1000(-9\frac{1}{2})$, proceeded to Darwin outer harbour and carried out 00W manoeuvres and manoverboard exercises and came to anchor for lunch. After lunch, the ship weighed and returned to the PBL at $1411(-9\frac{1}{2})$, disembarked all of the passengers and cast off and berthed port side to No. 1 Stokes Hill Wharf.
- The Assisted Maintenance Period (AMP) was completed on Friday 17 and ASSAIL cast off at $0902(-9\frac{1}{2})$, tested the steering gear in the quarantine area of the harbour and on completion, berthed port side to the No. 1 Stokes Hill Wharf at $1018(-9\frac{1}{2})$. At $1500(-9\frac{1}{2})$ on Saturday 18, the ship cast off and proceeded to Derby. Clocks were retarded $1\frac{1}{2}$ hours at $2045(-9\frac{1}{2})$ on Sunday 19 to time zone H(-0800).
- on Monday 20, refuelled and embarked the equipment for the Jindalee radar trials. The ship then cast off at 1710 and anchored near North Mary Island at 1722. ASSAIL weighed at 0703 on Tuesday 21 and carried out calibration trials on the Jindalee equipment, then berthed starboard side to the Derby Wharf at 1551. The Trials Officer, Alex Papij, from the Defence Research Establishment at Salisbury, was then embarked and the ship cast off at 1710 and proceeded to the trials area near Brue Reef.

/2 6. Jindalee trials

6. Jindalee trials were then carried out until Thursday 30, with ASSAIL steaming on specific tracks and variable speeds during the working day. The ship anchored near Cape Leveque on completion of each days work and refuelled in Derby as required. At 1257 Thursday 30, ASSAIL berthed port side to the Derby Wharf, refuelled and off loaded the Jindalee equipment. The Trials Officer also disembarked and the ship cast off at 1755 and proceeded to Exmouth.

Marine and Electrical Engineering

- 7. URDEF 30/80 to the starboard main engine gearbox was repaired by ship's staff when faulty '0' rings were replaced. The hydraulic steering was finally repaired on Friday 17 by Base Staff (INDEF 20/80). The flukes and tripping arm on the anchor were badly bent when anchoring near Cape Leveque, a new anchor for the ship is at HMAS STIRLING (INDEF 24/80). The ship's winch was repaired bfter obtaining a new clutch assembly from Stores.
- The galley range isolating switch and associated wiring burnt out and were temporarily repaired, Stores have been received and expect to repair the items in HMAS STIRLING (INDEF 23/80). Two air conditioning unit motors burnt out and were replaced by Naval Stores, INDEF 22/80 was raised on the transceiver for the 916 radar and a new one was received through Naval Stores.
- The health, welfare and conduct of the Ship's Company was very good during the month. Morale was very high.

HMAS ASSAIL - REPORT OF PROCEEDINGS - DECEMBER 1978

Sir,

- I have the honour to report the proceedings of HMAS ASSAIL under my command for the month of December 1978. The time zone used is H(-8) unless otherwise indicated.
- 2. At the beginning of the month ASSAIL was on passage from Derby to Exmouth. At 1602 on Saturday 2nd the ship berthed starboard side to the Point Murat wharf, Exmouth, and refuelled.
- The intention was to remain alongside overnight but the weather deteriorated and, after some damage occurred to the ship's side, my Executive Officer took the ship to sea at 0001 on Sunday 2nd (HMAS ASSAIL DDW 040630Z DEC 78 refers). At 0015 the ship came to anchor in 60 feet of water with 5 shackles on deck 5.5. cables 045 from the Point Murat wharf. The anchor began to drag and ASSAIL weighed at 0234 and steamed the remainder of the night. The ship berthed starboard side to the Point Murat wharf at 0855 and, after embarking the remainder of the crew, cast off at 0910 and proceeded to HMAS STIRLING.
- 4. On the passage south the weather gradually increased to force 7 and at 0546 on Monday 4th the anchor was discovered missing. There was minor flooding in all compartments except the after mess and the Executive Officer's cabin. At 0310 on Tuesday 5th water was found to be dripping over the switchboard. The switchboard was isolated and the ship reversed course so that a thorough investigation of the upper deck could be carried out. It was then found that the Bosun's store was completely full of water up to deck level and was seeping back through the ship. The store was pumped dry and the ship continued south to HMAS STIRLING, berthing port side to the patrol boat wharf at 1854. It was then found that the hatch cover to the Bosun's store was not sealing properly due to the rubber being too hard and brittle.
- 5. At 1052 on Wednesday 6th ASSAIL moved berth to the Escort Wharf to enable repairs to be carried out to water damaged equipment. The ship remained alongside until Tuesday 12th conducting an AMP and INO inspection on the 40/60 mounting. The base engineering staff at STIRLING assisted the ship to a great degree and displayed enthusiasm and a high standard of professionalism.

/6. ASSAIL fuelled

- ASSAIL fuelled at 1520 and cast off at 1715. At 0155 on Thursday 14th two Taiwanese trawlers were sighted transitting 12.5 miles from the coast near Cape Ronsard (HMAS ASSAIL KBG 140223Z DEC 78 refers).
- 7. ASSAIL berthed starboard side to the Point Murat wharf at 1554 on Thursday 14th, refuelled and proceeded to Broome at 1805. The ship berthed starboard side to the Broome wharf at 0759 on Saturday 16th, refuelled and proceeded to Darwin at 1107. Clocks were advanced $1\frac{1}{2}$ hours at 2315 to time zone India Kilo $(-9\frac{1}{2})$.
- 8. The ship berthed port side to HMAS ARDENT at the Patrol Boat Landing at 1057 ($-9\frac{1}{2}$) on Monday 18th. At 0946 ($-9\frac{1}{2}$) on Tuesday 19th ASSAIL cast off and proceeded to the Beagle Gulf area. During the afternoon of Thursday 21st the port rudder gland began taking in an excessive amount of water and the ship returned to Darwin (HMAS ASSAIL DDW 210525Z DEC 78 refers) berthing port side to HMAS ADROIT at the Patrol Boat Landing. ASSAIL remained alongside for the remainder of the month.

Marine and Electrical Engineering

- 9. The major and minor defects were mainly caused by the bad weather and resultant flooding. The ship's side scuttle (URDEF 31/80) and the galley isolating switch (INDEF 23/80) were both repaired by STIRLING. The ship's windlass and associated electrical equipment had to be repaired because of the ingress of salt water. The oil line to the fresh water pump on the starboard main engine was replaced (URDEF 34/80) and the leaking port rudder gland was repaired by Darwin base staff (URDEF 35/80).
- 10. The defects still outstanding are the rectifier for the 40/60 Bofor which is awaiting stores action (URDEF 33/80) and the switch for the 10 inch signal lantern, also awaiting stores action (INDEF 25/80).

General

- ll. Lectures on security and the dangers of alcohol were given to the ship's company prior to the Christmas break.
- 12. The health, welfare and conduct of the ship's company was good during the month. Morale has remained high.
