

EAST AUSTRALIA AREA: REPORT OF PROCEEDINGS FOR QUARTER ENDED 31ST MARCH, 1974

1. I have the honour to submit the Report of Proceedings for the East Australia Area, for the quarter ended 31st March, 1974.

Changes in Organisation and Administration

- Captain R.G. Craft, RAN, relinquished his appointment as Captain of the Port and Commanding Officer, HMAS KUTTABUL on 22nd March, 1974. Commander J.C.E. Lloyd, RN, Master Attendant, was appointed Captain of the Port and Commander H.C. Davies, RN, Commanding Officer, HMAS KUTTABUL from that date.
- Mr. J.E.W. Pross (SMSO) was provisionally promoted on 24th January, 1974, as Assistant Secretary, Recreation Division, Department of Tourism and Recreation. He is currently on furlough pending finalisation of appeals, and as a result of this provisional appointment Mr. G.H. Osborne (SGSO) was transferred to the office of SMSO on 11th February, 1974, and Mr. A. Anderson is acting as SGSO.

Inspections & Walkrounds

No formal Inspections were conducted during the quarter, but I familiarised myself with visits to WRANS Quarters, Bondi; Degaussing Range; REVY, Pyrmont; Naval Store Leichhardt; RANAD, Kingswood; HMAS WATSON and various city office accommodation.

Australia Day. A guard of two officers, one petty officer and eighteen sailors from HMAS PENGUIN was paraded for Australia Day celebrations on the 26th January, at Martin Plaza. The Guest of Honour was the Honourable E.A. Willis, B.A., M.L.A., Minister for Education.

7. Details of movements and utilisation of ships and other craft operated by FOCEA are shown in Annex C.

Captain of the Port

- 8. Berthing. HMAS STALWART started refit on 1st February, reducing the number of berths available at Garden Island by four, until her completion in late May. While the paying off of HMAS SYDNEY released some wharfage, there has been no decrease in berthing requirements, possibly due, in part, to fuel economy measures in the Fleet. During recent weekends there have been 11 DDG/Escorts requiring berths, and 10 berths available. The berthing situation will be more congested when HMAS MELBOURNE returns on 3rd April. To improve the berthing situation a recommendation will be made shortly, as a result of the feasibility study into the relocation of the Floating Dock.
- 9. Support Craft. The major requirement in this field is still for replacement of the seven oil fuel lighters (0.F.L.) and two Motor Water Lighters. The OFL's in particular are becoming increasingly difficult to maintain, as those involved in fuelling are 33 years old, while those used for sullage are aged 54. The MWL's have been in service for 25 years, and had estimated disposal dates of 1974 and 1975. The replacement lighters proposed in other papers to carry both fuel and water and be selfpropelled is strongly supported.
- 10. Financial. Messrs. Fenwicks Pty. Ltd. raised their tughire charges by 50% on 1st September, 1973, with the effect that the cost of a large ship cold move has increased from about \$350.00 to \$500.00. Tug hire is Captain of the Port's major expenditure at an annual figure of about \$35,000. Dumpmaster unserviceability and difficulty in obtaining spare parts has necessitated hiring and recently was required for a ten day period at \$220 a day. The provision of a third Dumpmaster (contained in M & P proposals) will ease the situation when it arrives.

Office Accommodation

11. Westfield Towers, 100 William Street, Sydney. 23,220 sq. ft. of office space has been leased and occupied in Westfield Towers, for the following branches:-

In addition, an area of approximately 3357 sq. ft. has been reserved on Level 10, Westfield Towers, to accommodate the Defence Regional Office, with a proposal to provide a VIP/Ministerial Suite with "en suite". Lease is for a period of 3 years with a 3 year option.

12. Re-allocation of space in Garden Island

- a. Building 69. Space vacated by AFO was taken up by Navy News, Area PRO, Area Security, Area Organisation and the Credit Union.
- Records to GIC Woolloomooloo, Room 72 was reallocated to Naval Police.
- c. Buildings 32 and 37. GMGID was provided with 4500 sq. ft. in Building 32 and 500 sq. ft. in Building 37, for re-allocation.
- d. Building 34. Approximately half of this building was re-allocated to FOCAF. Remainder is still occupied by Pay Office.
- Naval Headquarters. The area vacated by Navy News and PRO is to be re-allocated to CSO(A). The area formerly occupied by PMG Telephonists at NHQ is now vacant and being made ready for use by WPO and staff.
- MAGNAVOX House. SOAP has moved from the old Preservation Plant Building, Forbes Street, into ground floor of Magnavox House, Dowling Street, Woolloomooloo. Preservation Plant Building will be occupied by Navy Display Unit, and the Area Transport Pool will be set up in the Sun Garage, Dowling Street, Woolloomooloo.

15. GOSI Return Store Inspectors (3). An area of approximately 300 sq. ft. has been made available on 1st Floor, Northern end, Building 64, Garden Island, to accommodate the Return Store Inspectors to free the Signal Tower for use by FOCAF. GOSI staff are expected to move into this space shortly.

16. DCA Building, Waverton. Plans to use space vacated in the DCA Building complex at Waverton have lapsed.

Acquisition

17. Information has been received from Navy Office that Treasury and Defence approval has been obtained to the proposal to acquire the Qantas Technical College, Rothschild Avenue, Rosebery, for an amount of \$425,000. Vacant possession will not be available before February 1975. The site was acquired for use by GMGID for use for Apprentice Training.

Area Telephone Exchange

18. The new area telephone exchange of 2000 lines was cut over on 10th February, 1974. Whilst there were teething troubles involved in the cutover, the new facilities now provided and the increase in the number of extensions available are an improvement on the old facilities. Telephone user education is vital to this operation, and when extension users are fully trained to make use of these facilities, an even better service is envisaged.

Radio Control in Vehicles

Radio control units were installed in ten NHQ vehicles on 28th January, 1974, resulting in improved use of vehicles. It is anticipated further increased vehicle utilisation will come when the Transport Pool form in the Sun Garage and more vehicles become available for pool use.

Representation at Public Meeting - The Fitzroy Committee

At the request of the Civic Reform Group Captain J.A. Gledhill, DSC, RAN (CSO(FP)), and Mr. D. Goode (SEO) attended a "Talk In" at the Aquatic Club on 26th March, 1974, with the Fitzroy Committee. Comment by these two officers was confined to measures taken by the RAN and the Department and to meet the requirements of the local community.

WRANS Quarters, Bondi

Though alterations to the Bondi Wrans Quarters are progressing slowly, an additional 13 Wrans have been posted for accommodation there, 6 of whom are living out. This makes a total of 26 borne for accommodation at Bondi, 19 of whom are living in.

Senior Officers Quarterly Luncheon

The quarterly luncheon was held on 29th March, 1974, at RAN House, Sydney. Mr. Hyslop and I attended as official guests at the invitation of the Area Secretary.

Major Works

- 23. HMAS HARMAN. The new Administration Block is expected to be completed by June, 1974. The new emergency power plant for the Transmitting Station has been connected up but some structural work is not complete.
- 24. HMAS NIRIMBA. The new entrance road and Apprentices' Car Park have been completed. The Senior and Junior Sailors' Accommodation Block is expected to be completed by mid-May and a new Apprentices' Block should complete in mid-April, 1974.
- 25. HMAS WATSON. Plans have been drawn of alterations to the TAS School and lower B Accommodation Block, to accommodate the N.D. School. Estimates of cost are being prepared and subject to funds being available, it is anticipated that tenders could be called in about six months.
- Housing. Twenty Two new Married Quarters are now being occupied at Kogarah, comprising 16 villas and 6 town houses. This modern housing development which we were lucky to obtain is proving extremely popular. The provision of floor covering, raised in other papers, needs to be resolved to complete this morale raising project.

Supply Division

- Storing of HMAS VENDETTA. HMAS VENDETTA berthed at REVY, Pyrmont on 12th February, 1974, and embarked approximately 42½ tons of stores comprising provisions, clothing, mess gear, canteen articles and fresh water. Rear Admiral D.C. Wells, CBE, The Flag Officer Commanding, HM Australian Fleet, visited REVY to view the storing. In recent times ships are making more use of this method of embarking stores.
- Review of Supply Accounts Processing. During the fortnight ended 22nd February, 1974, a team comprising Messrs. G. Farmer (Finance, Canberra), F. Hardaker (Supply Division, Sydney), Mr. Hayes (D.O.R.E., Canberra) and E. Bateman (Methods, Sydney) conducted a review related to the processing of Supply Accounts in the East Australia Area. A copy of the Committee's Report has been received. Some of the recommendations have already been implemented and others are still being considered.

- 29. Conversion of Stock Accounts to EDP. During the quarter, conversion of stock accounts to EDP at the Air Store Depot was progressed and to date approximately 44,000 items of Air Stores have been converted.
- Onthetoff Committee. The Committee, comprising Captain K. Vonthetoff, RAN and Messrs. L.M. Scully (DVGS) and B. White (Department of Defence), visited Sydney on 6th March and held discussions with the Chief Superintendent of Supply in connection with its investigation into the establishment of a Supply Support Command.

Public Relations

- The upward swing in activity by Area Public Relations which began in 1973 continued in the first quarter of 1974, a period when, due to service leave committments, it would normally be expected that events for coverage would be below normal. The staff level continues to be below strength with only two Journalists instead of the establishment strength of four. On March 22nd the cine-cameraman, Mr. P. Green, left on transfer to the Department of Media, leaving Area Public Relations without a qualified cine-cameraman.
- Accommodation. The move from Naval Headquarters Building to Building 69 in early February resolved many, if not all the major problems which had frustrated Public Relations operations from an accommodation viewpoint.
- 33. Assignments. Details of Public Relations assignments are enumerated in Annex F.
- During the quarter Area Public Relations distributed on a wide basis:
 - a. 30 New Releases (16 same quarter of last year).
 - b. 8 News and Magazine TV films (9 same quarter last year).
 - c. 300 Still pictures (no comparative figure).
 - d. 10 Telex conference calls (nil same quarter 1973)
- Media useage of material, especially by radio personalities, television stations and newspaper columnists has been more than satisfactory.

- The number of assignments during the three months continued at a high rate for this time of the year and were quite varied. Media reaction to most of the assignments was excellent and highlights the good relations Navy has enjoyed for some time with the media in general. Their coverage of some assignments has been disappointing but this has been tied to other news events at home and abroad which have edged out Navy material. Major assignments include:
 - a. The visit to Newcastle for the Australia Day weekend by HMAS HOBART. Area Public Relations and Ship's Public Relations visited. The result was excellent coverage with NBN Channel 3 and the Newcastle Herald travelling to Newcastle on the ship, a direct broadcast by Radio 2KO from the ship and generous newspaper coverage.
 - b. Public Relation Course for Public Relation Officers from Ships and Establishments in early January.

 Area Public Relation Officer organised venue, arranged for guest lecturers, visits to media etc.
 - Officer Commanding East Australia Area, Flag Officer Commanding HM Australian Fleet coped with demands from ABC TV for a "Four Corners" special on the RAN. Requests from ABC TV for filming of special programmes on HMAS SYDNEY were also handled by Area Public Relations and Fleet Public Relations.
 - d. Exercise "Southern Cross" coverage was carried out by Area Public Relations and arrangements made for media representatives to be aboard Australian Ships in the exercise. Excellent assistance came from Fleet Public Relations Office, Ship's Public Relations Officers and NAS NOWRA.

Col. L.B. Swifte, Army Public Relations Sydney who is Commanding Officer of the Defence Department Public Relations group.

EAST AUSTRALIA AREA: REPORT OF PROCEEDINGS FOR QUARTER ENDED 30 JUNE 1974


1. I have the honour to submit the Report of Proceedings for the East Australia Area, for the Quarter ended 30th June, 1974.

Inspections and Walkrounds

- I inspected HMAS CRESWELL on the 4th April and HMAS WATSON on the 30th April. On the 20th May I walked around HMAS HARMAN.
- In May, at the request of the Naval Officer Commanding Queensland, some of my staff officers went to Brisbane and assisted with HMAS MORETON's departmental inspection. From next year however, it is anticipated that the Naval Officer Commanding Queensland will be in a position to carry out inspections using his own resources exclusively.

Ceremonial

- 4. On 24th April I attended the RSL Children's ANZAC Eve Commemoration in Hyde Park. This proved a novel occasion, as it was the first ceremony I had attended since the inception of the new National Anthem.
- Dawn next day found me at the Cenotaph in Martin Plaza for the ANZAC Dawn Service. In the afternoon, at the conclusion of the ANZAC Day March, I attended the ANZAC Day Commemoration Service in Hyde Park, at which His Excellency the Governor of N.S.W. was present.
- RAN participation in this years ANZAC Day March was limited to the East Australia Area Band and to the services of two Naval Officers who assisted in providing commentary for TV channels Ten 10 and ATN 7, whilst at various ANZAC Services that day, some eighteen officers were present as guest speakers.

- On 27th April, I was guest of honour at a ceremony at Kernell to mark the 204th Anniversary of Captain Cook's Landing. For this occasion, HMAS WATSON paraded a forty-eight man guard and the Fleet provided its Band. Both were a credit to the Service and made me very proud.
- At the Battle of the Coral Sea Commemoration, which was staged at the Cenotaph in Martin Plaza on 6th May, HMAS PENGUIN paraded a thirty-six man gaurd. I was present on this occasion also, and afterwards at a luncheon to launch "Australia/America Friendship Week". This years guest of honour was Admiral B. Clarey, USN (Retired).

Operational Control

9. I assumed Operational Control of HMA Ships on the Australian Station during the following periods:

090800K - 102100K APR 74 161200K - 201200K APR 74 031200K - 200800K JUN 74

Operations

- I had the pleasure and privilege of being the Director of Exercise Kangaroo One, a large multi-nation tactical training exercise which was staged in the Coral Sea, off the east coast of Australia and ashore in the Shoalwater Bay area, in Queensland. The exercise was conducted between 3rd and 17th June, with personnel, ships and aircraft of Australian, British, New Zealand and USN/USMC forces taking part.
- 11. Command and control of maritime operations was exercised through a Maritime Headquarters located in Fleet Headquarters, Sydney, while a Joint Forces HQ in Rockhampton co-ordinated and controlled the land battle and amphibious landing and re-embarkation phases, which were a highlight of the exercise.
- 12. From the Australian viewpoint, Kangaroo One was an unqualified success, achieving a great deal in training and in cementing the relations between the participating forces, some of which have already indicated a willingness to support continuing exercises of this nature. I personally hope that Kangaroo One is the forerunner of more such worthwhile ventures.

Captain of the Port

- 13. Details of visits of foreign vessels are shown in Annex E.
- All such visiting ships were berthed at Garden Island, except RFA TIDESPRING, who was at a buoy. RFA DERWENDALE was berthed alongside at Fitting Out Wharf for a total of 12 days, and at No. 1 Explosives buoy for a week. Drawing 39 feet on arrival, and displacing approximately 85,000 tons, she is thought to have been one of the largest vessels to berth at Garden Island.

HMAS STALWART returned to the EMS mooring on 24th May. A strong southerly gale on 25th/26th May caused the head buoy to drag about 30 feet. The mooring has subsequently been relaid, and its holding power increased. Execution of this work, however, delayed HMAS STALWART's reberthing in late June by one week. The restored availability of three extra berths, and the many associated services has greatly eased berthing congestion.

Works and Property

- 16. Storm Damage 25th/26th May. Freak storms on the night of 25th/26th May, caused by the most extraordinary weather conditions for some thirty years, wreaked havoc on several littoral Naval installations in Sydney and in Jervis Bay.
- Work Boat AWB 2009, containing about \$5000 worth of diving stores; damage to three other boats and to the wharf and workshops on the waterfront; and extensive erosion of the sea wall ballast along the entire waterfront. Repair work was commenced almost immediately and is progressing.
- At Bradley's Dolphins during the same night, wind lifted and carried away a large portion of decking of Dolphin A, severely damaging it. It has been estimated repairs to the dolphin will cost \$15,000 and complete replacement in the order of \$40,000.
- 19. In HMAS WATERHEN, the sea slightly eroded that part of the embankment where there is no sea wall. An estimate for repairs is being sought.
- HMAS CRESWELL reported further erosion of the breakwater and its access bridge, as a result of the storms. A requisition for \$1500 has been issued to cover temporary repair work and a further one for \$500 to engage a diver to survey underwater deterioration. The item for repair of the breakwater in the Major Repair and Maintenance Programme 1974/75 has been brought forward for early action and it is hoped restoration work can begin shortly.
- 21. Chowder Bay Oil Fuel Installation. A storm on 1st May extensively damaged seven of the eight fender piles on the main berthing dolphins at Chowder Bay and as a result the fuelling berth is out of action until probably late this year.
- Wardroom Galley, HMAS KUTTABUL. Refurbishment of this galley is nearing completion despite lengthy delays due to unforeseen sewerage work, material shortages and industrial trouble, generally. For the best part of a year, the wardroom cooks have been carrying on their work in the relatively austere confines of a mobile galley caravan which is all but parked on Wylde Street.

Senior Officers' Quarterly Luncheon

The luncheon was held on Friday 28th June 1974. Rear Admiral D.C. Wells, Flag Officer Commanding HM AUSTRALIAN FLEET, and Monsignor Lyons, Senior Chaplain (RC), Command Chaplain, attended.

OFFICE ACCOMMODATION

- Westfield Towers, 100 William Street, Sydney. The area of 3,357 sq. ft. of office space reserved on Level 10 is still vacant. This will accommodate the Defence Regional Office pending the setting up of the organisation. The VIP Suite has been used on a number of occasions by various Departmental senior officers and VIPs as working space.
- Naval Headquarters. WPO and staff moved into the old telephone exchange area. The typing pool has been transferred from the old Court Martial Room to WPO general office. The Organisation Section moved from Building No. 69, Garden Island, to WPO office, NHQ.
- Superintendent, Aircraft Maintenance and Repair. Because of demolitions in the near future SAMR will be required to move from Kembla Building, Margaret Street, Sydney, by 31 August, 1974. Planning for the move is well advanced, however, due to various lead times and material shortages, there is some doubt as to whether the 31st August deadline can be met. Mid or end September, 1974, is a more realistic date for the SAMR move to 1 & 2 floors of 100 Walker Street, North Sydney.
- No. 1 Oxford Street, Sydney. No decision has been made on the proposal put forward to use all or part of this building to accommodate the tri-service sections of Defence Regional Office.
- Remington Centre, Liverpool Street, Sydney. This is another building which is being considered to house the Defence Regional Office staff. No firm decisions have been taken on the leasing of space in this building. A number of plans for the building are currently receiving consideration by Department of Defence.
- Skandia House, Sir John Young Crescent, Woolloomooloo. A brief is being prepared in respect of the usage of this building.
- Defence Reorganisation. Progress is being made in this matter. However, there will be no major breakthrough until the various sections can be drawn together in a common building, thus allowing firstly co-location and secondly integration of the common cells. Much will depend upon obtaining one of the number of buildings being considered for this purpose.

- Moolloomooloo Re-development Proposal. A number of proposals relating to the re-development of the Woolloomooloo Basin have been put forward recently. Basically the whole of the Basin will be turned over to provide houses for low and middle income earners. All the Commonwealth owned areas and Navy occupied buildings in the area will be lost and will be taken over to provide the space required to implement these schemes. Navy Office has been advised of these plans and their implications.
- Main Signal Office. The alterations to the MSO area, which were recommended by the Command Work Study Team have been completed by Dockyard. The new layout has proved successful and enables messages to be processed more efficiently and rapidly. The closure of Garden Island Main Signal Office for a trial period of 3 months took place as scheduled on Saturday 25th May. During the first month there have been no insoluble problems resulting from the transfer of GMGID, CSS SYDNEY and C of P message traffic to the Command Comcentre.
- Supply Division. HMAS STUART berthed alongside at REVY on 21st May, and accepted approximately 30 tons of stores in under three hours. They included provisions, mess gear, clothing, medical supplies, furniture and canteen stores.
- Due to lack of berthing space at Garden Island, HMAS SWAN was berthed at REVY from 27th May to 31st May.
- Public Relations. The quarter ended 30th June, 1974 has been one of the busiest for some time with media and general inquiries as well as assignments for Area PR staff increasing in line with the upward swing which began last year. The number of major assignments, during the quarter which are numerated in Annex F, was exceptional and included the 25th Anniversary Air Day at NAS NOWRA, visits by RN and USN ships and the multi-nation exercise Kangaroo One. Media co-operation with Navy continued at the same high level. In susage of Navy PR material the newspapers were disappointing but radio and television were excellent.
- During the quarter, Area Public Relations distributed on a wide basis
 - a. 36 News Releases (30 previous quarter, 40 same quarter last year).
 - b. 4 News and Magazine TV films (11 same quarter last year).
 - c. 313 Still Pictures (224 same quarter last year).
 - d. 25 Telex Calls (no comparative figure) all to multiple addresses.

East Australia Area Band. The East Australia Area Band has continued to be kept busy with both Naval and Public Relations commitments encompassing the city, suburbs and establishments within the command. Letters of appreciation from various organisations prove that the Band is a most valuable Naval public relations asset.

PUBLIC RELATIONS ASSIGNMENTS

The number of assignments during the quarter have been exceptionally high and have included major assignments organised in close association with ships and establishments. Media cooperation and response has been, in the main extremely good. Radio has been excellent in using PR material resulting from a concerted bid by Area PR to encourage radio news services and personalities to use Navy material. Likewise Television has been good, but the Sydney newspapers have been somewhat disappointing related no doubt to the shortage of space caused by the newsprint shortage and the strong competition from other news sources, particularly the political field. Major assignments include -

- a. FAA 25th Anniversary Air Day. Area PR was heavily involved and a close link was forged with NAS NOWRA to ensure maximum publicity and public attendance. Preplanning visits were made to Nowra, an Area PR team spent four days at NOWRA obtaining stories and pictures which were released State-wide, Area PR escorted representatives of all media to the establishment before Air Day to film and take pictures of rehearsals, special material supplied to the Sydney Morning Herald which published a Fleet Air Arm supplement and media were escorted to Air Day.
- b. For the first time the Navy supplied commentators to Television for the ANZAC Day March telecast. Area PR made the arrangements, obtained material for the commentators and briefed them. The commentators were used on TEN Channel 10 and ATN Channel 7.
- c. Two incidents involving helicopters from NAS NOWRA, both on the eve of Air Day, were handled by Area PR in liaison with NAS NOWRA and CAVO. Information was quickly supplied to media on request and the adverse publicity for RAN Aviation which could have easily developed was averted. Likewise when a Sky-hawk crashed off Nowra in May, Area PR working with NAS NOWRA, CAVO and DPR was able to deal with media publishing facts and not conjecture.
- d. Visit by HMAS TORRNES to Newcastle. Area PR continued its policy of visiting Newcastle before the vist and talking with all news media, inviting some to travel on the ship. The invitation was accepted by the Newcastle Morning Herald and Radio 2NX who made direct broadcasts from the ship on the passage to Newcastle. Media responded well to the pre-visit and coverage during the ship's stay was generous.

Exercise Kangaroo One. Area PR had limited participation e. in the planning stages which was carried out by Lt. Col. L.B. Swifte, Army Public Relations in Sydney, who was appointed Commanding Officer of the Defence Department Public Relations Group for the Exercise. Journalist and a Camerman were supplied from Sydney Office and joined HMAS MELBOURNE for the duration of the exercise. A Journalist from DPRs office was attached to Sydney office for the duration of Kangaroo One to issue purely Navy material from the cell at sea or from the MHQ established at Fleet HQ. The Journalist at sea sent daily news reports by signal. These were received in Sydney office and daily releases made to major media sources from Sydney be Telex with information received from MHQ. A picture release of pictures supplied by RAAF Amberley was made by Sydney Office.

Contact was maintained with the CIB ROCKHAMPTON to assist co-ordination of PR releases. A copy of all information released to the media ex Sydney was sent by Telex to Rockhampton. Sydney Office supplied information to columnists - material which came from the sea cell, and worked with Navy News to ensure a comprehensive cover. Media response was very poor. Newspapers in the main ignored the exercise after the departure of the exercise fleet until their own representatives were taken north to the Exercise area. Radio, however, used most of the material supplied. From a Navy point of view media coverage of its involvement and participation was far from satisfactory. A separate report is being made.

- ABC Radio Shipboard Broadcast. On the eve of Kangaroo One the ABC broadcast their breakfast session from the bridge of HMAS MELBOURNE. This broadcast was arranged by AREA PR with excellent assistance from the ship's PRO and Fleet PRO. This was the first time the ABC had ventured outside the studio for such a programme for many years.
- Rescue by HMAS SWAN. Area PR dealt with all media inquiries concerning the rescue of three yachtsmen during shocking weather conditions off the coast. Messages sent by the ship enabled AREA PRO to answer all inquiries. Media were escorted to the ship when it returned late at night and media were able to interview the yacht survivors. Later Area PR arranged for a boating magazine to interview SWAN's CO, Officers and swimmers and excellent coverage was obtained.
- h. Visits by RN and USN Ships. Area PR played host to an RN PR team and provided the Journalist and photographer with working accommodation in the Area PR office, as well as other assistance. Similarly Area PR provided office accommodation for USN and USMC PR personnel during their

stay in Sydney. Every assistance possible was given to the visitors. The system worked well and enabled all inquiries of a PR nature to be channelled into this office and there was someone who could answer them. Opportunity was taken to talks with our opposite numbers and learnt from them. Equally, they noted they had learned from us.

EAST AUSTRALIA AREA - REPORT OF PROCEEDINGS FOR QUARTER ENDED 30TH SEPTEMBER 1974

1. have the honour to submit the report of proceedings for the East Australia Area for the quarter ended 30th September, 1974.

Inspections and Walkrounds

- Between the 22nd 24th July, I inspected HMAS MELVILLE and HMAS COONAWARRA on behalf of the Naval Board. As I have reported previously, I was impressed with the high standard of appearance of these two establishments and with the spirit and enthusiasm of our personnel there.
- 3. On 2ni September, I informally walked around HMAS ALBATROSS.

Ceremonial

- The Annual Legacy Church Parade was held in the Dockyard Chapel, Tarden Island, on Sunday, 1st September. I was invited to Ettend and to inspect the Junior Legatees at a parade prior to the Church Service. A smart twenty-six man guard made up of Naval Reserve Cadets from TS PARRAMATTA and TS WARREGO was also paraded, and the EAA Band provided hymnal music at the Service.
- The following Thursday, the 5th September, I was privileged to be the Juest of Honour at the Annual Legacy Day Celebrations which were staged in Martin Plaza. On this occasion a twenty-six man guard was paraded by HMAS WATSON, the East Australia Area Band was again in attendance and I delivered the annual address.
- 6. On Sunday 8th September, the New South Wales Naval Reserve Cadets held their Arnual Church Parade in Garden Island Dockyard. There was an extremely good turn-up of boys this year; some coming from quite far afield. I was invited to inspect the Divisions and to read a lesson at the Service. TS PARRAMATTA and TS WARREGO paraded a twenty-six man guard again and the RANR Band provided the music for both the Parade and the Service.

My Story

Operational Control

7. I assumed Operational Control of HMA Ships on the Australian Station for the following periods:

311000K Jul 74 - 111000K Aug 74 100800K Sep 74 - 160800K Sep 74 270600K Sep 74 - 050330K Oct 74

Operations

- During the SHOALHAVEN RIVER flood in August, 1974, numerous requests for assistance were made to RAN Air Station NOWRA by the NOWRA branch of the N.S.W. State Emergency Service (S.E.S.), State Police and private citizens. Personnel evacuation, medevac, searches, fodder drops and flood survey (perations were conducted during the period 28th 30th August utilizing both helicopter and road vehicles.
- Over the period 44.50 helicopter hours were flown, 10 vehicles drove 510 miles, 352 people were evacuated by truck and helicopter, 2 night helicopter medevacs were carried out, 4 youths were rescued from a remote area, 52 naval personnel assisted the SES, and milk, oats and hay were delivered by helicopter. Co-ordination between RANAS NOWRA and SES was facilitated by the use of a Naval Liaison Officer in the local SES leadquarters; this proved most satisfactory. Other operational aspects of the quarter have been covered in Annex C.

Captain of the Port

- 10. Industrial disputes during August and September seriously interrupted the port service available to the Fleet. The strike by Painters and Dockers from 7th 12th August was closely followed by that of the Merchant Service Guild from 13th August to 13th September. The latter involved support craft Masters and Engineers, thus prohibiting the use of tugs and preventing the provision of fuel, ammunition, stores and water by lighter. A ban was also placed on the use of contract tugs.
- 11. HMAS MELBOURNE's docking, due on 7th August was the major casualty but al. ships suffered some measure of disruption in their activities. It has taken several weeks to catch up on the effects of this strike.
- 12. On Navy Office instructions, Bronzewing was withdrawn from the service on 16th August and her crew were re-employed within the Master Attendant's Section. Notice of this intention was given to her crew and Union officials beforehand. Her withdrawal from service became an issue in the foregoing industrial dispute and the Merchant Service Guild have made representations to the Minister. Pending an outcome of these representations and upon the advice of the Industrial Office, Department of Defence (Navy) progress towards her disposal has been deferred.

- 13. The ability to fuel ships has been further limited by the discovery of salt water in the Fitting Out Wharf and West Dock Wall section of the Woollcomooloo O.F.I. pipeline. Two ships reported contamination up to 2% and as a result fuellings from this pipeline ceased from 10th September. It has, however, been possible to carry out one major fuelling since then. The contents of the suspect section, about 200 tons, were discharged into a fuel lighter and then HMAS MELBOURNE was fuelled immediately followed by HMAS SUPPLY, the fuel pressure in the line keeping out any water during this time. Lack of lighter space prohibits using this procedure very often. To date, the Department of Housing and Construction have had no success in tracing the source of contamination. A pressure test is planned to take place in the next two weeks to try to locate it.
- 14. Captain N.E. Lee, R.A.N., assumed the duties of Captain of the Port on 30th September.
- 15. Details of visiting ships during the quarter are shown in Annex G.

Works and Property

- As a result of the underwater survey of the breakwater at HMAS CRESWELL, the ADHC has requested an additional \$50,000 in order to satisfactorily repair the eroded sections of the breakwater, and its access bridge.
- 17. At HMAS HARMAN, the new Administration building is nearing completion and following the installation of telephones, it is anticipated the building can be occupied shortly.
- 18. Alterations and additions to the Wardroom Mess, HMAS KUTTABUL are progressing satisfactorily. The galley has been completed and food service in the Wardroom is back to normal.
- 19. At HMAS NIRIMBA, construction of the new Ship's Company accommodation is almost finished and it is expected that the buildings will be handed over in early October, some two years later than the original estimated date for completion. The two Apprentices blocks being constructed are nearing completion also and should be ready for taking over in mid-October.
- Repairs have been effected to the storm ravaged areas of HMAS PENGUIN.

Accommodation

AUSTRALIAN WAR MEMORIAL

21. On 26th August, 1974, oral advice was received from Navy Office that Department of Services and Property had completed negotiations for the leasing of five floors of the Remington Centre, to accommodate anticipated components of

the Defence Regional Office. Senior Executive Officer, Mr. D. Goode, has been made project officer for planning and movement of components of Navy, Army and Air into this building. The Supply Division Work Study Section has been co-opted to assist.

- On 1st September, 1974, Aircraft Maintenance and Repair Branch moved from the Kembla Building, Margaret Street, Sydney, to new accommodation at 100 Walker Street, North Sydney.
- On 4th September, 1974, I visited Navy Office with the Area Secretary, and held discussions with Special Deputy Mr. F. Green, and subsequently PHASD Mr. B. White and staff and the Secretary, Department of Services and Property, Mr. M. Timbs and staff, on a proposal for leasing of the Skandia building, Woolloomooloo. This proposition was not acceptable, and a further proposition that a substantial portion of the Remington Building be leased for Defence purposes was to be given consideration.
- On 26th September, 1974, oral advice was received from Defence Facilities Branch, that Ministerial support had been given to a proposal for the Department of Services and Property to negotiate for the lease of the total high rise component of the Remington Building (14 floors) with an option of two of the low rise floors.
- 25. Of course this Command for many years has strongly advocated for its functions to be concentrated in one Government owned administrative building. The Woolloomooloo Project and more recently, the No. 1 Oxford Street proposal offered the ideal pasis for almalgamation. The leasing of Remington Centre falls short of the ideal. Four lower rise floors already accommodate commercial interests. Furthermore, proposed early rental commencement dates for Remington Centre are scarcely adequate for effective longer term planning. Finally there is a forced acceptance of an additional 30,000 square feet of space in North Sydney thus maintaining fragmentation of administrative responsibilities and pròlonging any final merger of Command branches and civilian establishments.
- On 26th September, the removal to the Bondi WRANS Quarters of WRANS employed on the south side of the harbour was completed. Some work in the Quarters remains to be done; in the galley, and drying and box rooms, but none that would prevent occupancy of the Quarters.

Supply Division

A meeting between representatives of the Defence Movements Working Party and the Assistant Director, Papua New Guinea Office, was held at 'Jenner' on Friday

27th September, 1974. The purpose of the meeting was to determine procedures to be adopted for supply of stores by Army, Navy and Air in respect of the arrangement relating to the Supply Support of the Papua New Guinea Defence Force by the Department of Defence from 1st December, 1974.

- Storehouse staff at Garden Island (excluding Weapons Equipment) held a stop work meeting on 23rd July 1974 and excepting Fuellers, resumed duty on 9th August, 1974. The Fuellers returned to work on 13th August, 1974 and again ceased duty at noon on 15th August, 1974, resuming work on 2nd September, 1974. During the periods the Fuellers were absent, black bans were also imposed by 'Storeman and Packers' employed by private fuel companies. The main cause of the dispute dealing with a disability allowance has been heard by the Government Arbitrator. However, his decision has not yet been handed down. Industrial trouble still continues at the 'Shell Oil Co.', particularly affecting the supplies of Aviation Fuel.
- 29. Storemen employed as Crane/Forklift Drivers at Newington struck from 26th July to 5th August, 1974.
- 30. Transport Drivers attended stop work meetings in connection with a wage increase claim and were subsequently absent from duty as follows:
 - a. On 1st August, 1974.
 - b. From 7th 9th August, 1974.
 - c. On 23rd August, 1974.

The increase has since been granted.

- A stcp work meeting of members of the Foremen's Association occurred from 11.30 a.m. to C.O.B. on 26th September, 1974. Supply Division business, however, was not affected for the short period involved.
- 32. Owing to an abnormal tide during the week-end of 20th 21st July, minor flooding of a Storehouse occurred at Rydalmere. There was no damage to stores.
- 33. The collapse of the stores wharf at Garden Island has necessitated the re-arrangement of Supply Division services by utilising as an interim measure, another wharf on the Island. Current indications are that a considerable time will lapse before the wharf is back in service.
- 34. Work commenced on 9th September, 1974, on construction of three new Explosive Storehouses in the Evans/Canberra Roads area at Kingswood.
- 35. The new office accommodation building (N66) at Kingswood was occupied as from 23rd September, 1974.

- 36. Transfer of Avionics from S.L.S.O. to S.N.A.S.O. commenced at the start of September and to date, 1,700 items of an estimated total of 3,700 items have been transferred.
- 37. Conversion of stock accounts to E.D.P. at the Air Store Depot was completed in the quarter and a total of approximately 84,000 Air Store items are now on NAV STOCK.
- 38. Conversion of stock accounts to E.D.P. at the Weapons Equipment Depot is now in progress and during the quarter approximately 7,500 items were converted.

Public Relations

- 39. The three months under review has been one of the busiest recorded. Assignments and output in terms of New Releases and pictures exceeded previous quarters. Requests for assistance and information from the media reached a new high as did telephone and mail requests and inquiries from the general public. The demand for project material from school students, teachers and reference libraries was exceptional and the trend of requesting overall defence type material was maintained.
- Media co-operation with Navy PR remains at the highly favourable level indicated in the previous report. As mentioned in the previous report useage of Navy PR material by the metropolitan dailies is somewhat disappointing while radio and television are excellent with radio taking prime place and using just about all material supplied.
- 41. Internal PR is at a high level with ship's and establishment PROs maintaining close contact, due, in the main to the favourable location of Area PR.
- During the quarter Area Public Relations distributed on a wide basis:
 - a. 54 News Releases (36 in previous quarter).
 - b. 2 TV News clips (4 last quarter) (films taken during visits by Films Officers, DPRs Office because of vacancy in Sydney Office).
 - c. 367 still pictures (313 last quarter). (Does not include file pictures to media and special orders from Navy Office).
 - d. 40 telex calls to multiple media addresses (25 last quarter).
- 43. Public Relations assignments covered during the quarter are detailed in Annex F.

East Australia Area Band

The East Australia Area Band has continued to be kept busy with both Naval and Public Relation commitments encompassing city and suburban areas.

45. Details are contained in Annex G.

General

- A Residential Management Course was held at Glenavon Lodge, Vaucluse, from 23rd to 27th September. I was among the Guest speakers, and presented a paper on Australian Naval Defence. Mr. R. Hyslop, Assistant Secretary, Naval Personnel, also spoke on Government and Naval administration.
- 47. The lease of Beecroft Peninsula from the State Government was temporarily extended to 30th October, 1974, following discussions between Australian Government and State Government authorities. At these discussions it is reported that the Australian and N.S.W. Governments reached a measure of agreement on the proposed transfer of Australian Government land, including land at HMAS WATSON, to the State of N.S.W. for the establishment of a Harbour National Park.
- A Committee of Enquiry into the administration of the RAN Torpedo Maintenance Establishment has been established and began its investigations on 30th September, 1974.

OPERATIONS

The Ships and other craft operated by FOCEA were employed during the period as follows:

HMAS ARCHER

HMAS ARCHER commenced refit 8th July, 1974 prior to being handed over to Indonesia as the KRI SILIMAN.

HWAS ADROIT

HMAS ADROIT became the Sydney Port Division training patrol boat having been transferred from Brisbane on 4th July, 1974, subsequently undertaking week-end training sailing from HMAS WATERHEN on 17th - 18th August, 1st September and 7th and 8th September with a Reserve crew. Indonesian P.C.T. Courses were undertaken on three occasions during this period.

TRV 801

This vessel has been in Dockyard hands undergoing a refit and replacement of port propeller and shaft during the past three months.

TRV 802

TRV 802 was loaned to NOIC/JB whilst TRV 801 underwent Refit and Penairs in Sydney. During this point TRV 802 has been engaged in support of operations for Turana trials, torpedo recovery for submarine firings and RAAF air drops, Range clearance duties, assistance in work-up for HMAS AWARE, SAR duties for night flying operations from NAS NOWRA, and on one occasion for Scattering Ashes at sea.

TRV 803

This vessel has been employed in a strenuous and varied programme during the period, commencing in July with four days Navigational Training support for HMAS WATSON, followed by torpedo recovery for HMAS ODIN, a joint Staff Service College Harbour Cruise, acting as a target for HMAS VAMPIRE and a further six days at the end of the month for torpedo recovery for submarine firings.

During August, 1974, a total of seven days were spent operating for HMAS WATSON for Navigational training, three days for Torpedo recoveries and working with HMAS OXLEY and one occasion scattering Ashes.

In September, 1974, three days were spent for Navigation Training Courses, eight days for torpedo recoveries, three days engaged in RANRL trials in Sydney Harbour, assisting in HMAS OTWAY work-up programme, and acting as a target for HMAS VENDETTA.

AIR SPRITE

AIR SPRITE developed a defect in her port engine and was subsequently escorted to Sydney where she was berthed at HMAS WATERHEN to await the result of an investigation into the serviceability of a replacement engine (NOICB DAW 080621Z August 1974 refers). Prior to this, she undertook trials for TURANA, and flare experiments, range clearance and SAR duties for night flying activities of NAS NOWRA.

PUBLIC RELATIONS ASSIGNMENTS

Major assignments covered during the quarter included:

- Floods on the N.S.W. South Coast which heavily involved Navy from NAS NOWRA. With co-operation of NAS NOWRA PRO a steady stream of information was supplied to media concerning the flood situation and Navy's primary role. DPR Navy and DPR Defence were kept fully informed. Material supplied to the media received wide useage.
- b. Industrial disputes at Garden Island which had a crippling effect on the Fleet attracted heavy media attention and a high inquiry level to Area PR following a story on TCN9s "Federal File" programme. In consultation with SEA, Master Attendant, Navy Office, DPR Navy and Defence, media inquiries were answered. Media co-operated well sticking with the factual situation supplied in response to their questions.
- c. The visit to Newcastle by HMAS OXLEY and HMAS VENDETTA received excellent media coverage following a continuation of Area PR policy of a Journalist visiting Newcastle before the visit, making a news release and talking with all news media on their requirements.
- d. Organising of the Sydney section of the PR course conducted by DPR Navy. This included an address to students by FOCEA and visits to media. The course is paying dividends with students, now PROs, supplying information in a steady flow.
- e. The final training cruise by HMAS ANZAC and its return to Sydney was covered by Area PR. Media response was excellent with TCN Channel 9 pre-shooting an onboard sequence before the ship left and running it together with new film on the day the ship returned. This film included an interview with FOCAF and was shown in all major capital cities.
- The ABC TV programme "Target" aimed at a teenage audience sought Area PR assistance in producing a series of films on navy including one on Naval Exercises, Garden Island Dockyard and HMAS MORESBY and the Hydrographic service. These were all successfully completed and most have been shown on the programme throughout Australia.

The circumnavigation of Australia by the patrol boat, HMAS BOMBARD was the subject of a News Release sent Australia wide. It has received extensive useage. Area PR also assisted the ship in preparing complete Press Packs for the voyage as it did for HMAS ARROW on its departure for Darwin and for other ships.

h. An all State cover of HMAS VENDETTA's return from ANZUK service was provided with the co-operation of Perth Office PRO and particularly the ship's PRO. This included a news release covering a race between a land party and the ship and a ship to shore telephone call involving the ship's PRO and Radio 2UE breakfast show announcer.

i. Other assignments included the loss of the bow door by HMAS BUNA and the escort mission by HMAS PARRAMATTA, the Woolloomcolco Bay incident involving the liner Australia and HMAS MELBOURNE, the Bathtub Derby participation by HMAS BRISBANE, the Adelaide and Melbourne visits by HMAS TORRENS which received wide coverage, Navy participation in the City to Surf race, assistance in the filming of a new national anthem featuring the EAA and Fleet Bands, presentation of gifts to a handicapped childrens' home by HMAS VENDETTA, Direct liaison with Australian Information Service in Los Angeles concerning HMAS PERTH and the supply of PR material to the ship

EAST AUSTRALIA AREA - REPORT OF PROCEEDINGS FOR QUARTER ENDED 31 DECEMBER, 1974

1. I have the honour to submit the report of proceedings for the East Australia Area for the quarter ended the 31st December, 1974.

Inspections and Walkrounds

I inspected HMAS WATERHEN on the 31st October, HMAS LEEUWIN, on behalf of the Naval Board, on the 4th, 5th and 6th November and HMAS NIRIMBA on the 13th November, 1974. Despite the economic and manpower stringencies, these establishments continue to be maintained at a high standard and morale is good.

Ceremonial

- During "Navy Week", open days were held at HMAS's ALBATROSS, WATSON, PLATYPUS and NIRIMBA. Allwere well patronised. On Sunday the 13th October, a United Church Service was held in the G.I. Chapel. The E.A.A. Band provided music for the Service and I was invited to read the Affirmation of Duty.
- At the Remembrance Day ceremony at the Cenotaph, Martin Plaza, the Navy paraded a detachment from HMAS WATSON, comprising thirty-six sailors and one officer, and the E.A.A. Band.

Operational Control

5. I assumed Operational Control of HMA Ships on the Australian Station for the following periods:

Captain of the Port

- 7. USS REASONER visited Sydney from the 21st to 25th November. Her Commanding Officer, Commander T.E. Fleming, U.S.N. paid me a call on the 21st.
- 8. Woolloomooloo, Chowder Bay and Garden Island fuelling installations have continued out of operation during the quarter. The progress of repairs is included under the heading of Works and Property.
- 9. HMAS ANZAC was accepted into the Captain of Port's custody, to await disposal, on the 21st November, 1974.

Works and Property

- 10. The three ships company accommodation blocks and two apprentices accommodation blocks in HMAS NIRIMBA were completed during the quarter and are now occupied.
- 11. At HMAS WATSON, six temporary buildings have now been removed and a further two sold. Approval has been received to dispose of another five, and for which tenders will be called shortly.
- 12. The possible source of contamination in the OFI line from Woolloomooloo was traced to a fracture in the line in the vicinity of Nos. 5 and 6 berths Woolloomooloo. It was repaired at a cost of \$10,000, and is yet to be tested. Repair was costly owing to the location of the fractures, which was below the high water line, and the necessity to remove extensive sections of protective concrete from around it. It is not know whether the repair has overcome the original problem of salt water in the line but time will tell.
- 13. Work on the Chowder Bay fuelling berth is scheduled to start on the 20th January and completion is forecast for mid-May 1975.
- Repair work and testing of the G.I. Dieso tank has recently been completed. The first delivery of fuel is expected in early January.

Accommodation

- 15. Staff at the Kingswood Armament Depot and Missile Maintenance Establishment moved into newly constructed office accommodation during October, 1974.
- The exchange of accommodation between RANTAU and GOSI was carried out on 23/24 November, 1974.
- 17. Formal approval was given on 4 December, 1974, for the lease of floors 15-28 of the Remington Centre for Lafonce occupation.

Supply Division

- 18. Navstok conversion of the Weapons Equipment Depot, Sydney, completed on 18th November, 1974.
- The Navstok conversion of the Torpedo Depot commenced on 18th November, 1974. A total of 7,961 stock accounts were transferred to EDP on completion of conversion on 24th December, 1974.
- 20. During the latter part of November, arrangements were made for the successful recovery and transportation from Rockhampton airport to Sydney of crashed Wessex aircraft N7-222.
- 21. Processing of claims for fresh/frozen provision accounts, previously carried out by Area Finance Branch, was transferred back to the Victualling Branch during November.
- 22. The crew of the QANTAS aircraft carrying the Prime Minister overseas on 6th December, 1974, were issued with cold weather clothing prior to departure.

Industrial Relations

- 23. Industrial unrest occurred during October and November over the issue of contract cleaning at Garden Island. This matter was resolved following a meeting of Union representatives with the Minister on 8th November, 1974.
- 24. Two industrial disputes occurred during the quarter involving Painters and Dockers (Rigger) in the Master Attendant's Section.
- The first one arose from complaints about the standard of their amenities and the lack of dining space. These were genuine grievances. However the refusal of management to meet excessive claims for additional washing time, demanded because of the lack of space, led to a five day stoppage. Repainting of the two amenities rooms has been completed, and efforts are continuing to provide the required dining space.
- 26. The second one arose following the discharge of a Painter and Docker (Rigger) delegate in the Master Attendant's Section on 1 November. The dispute was referred to the Public Service Arbitrator and a subsequent enquiry conducted by Deputy Public Service Aribtrator Watson resulted in the delegate being reinstated subject to his apology to the foreman involved in the incident.
- 27. Mr. G.W. Bennett, Superintending Electrical Store Officer of the Supply Division has been appointed as a member of the Committee of Enquiry into Industrial Relations in Naval Dockyards.

Operation "Navy Help Darwin"

28. This was undoubtedly the biggest peacetime logistic exercise undertaken by the Navy and involved all elements of the East Australia Area Command. The operation began on

Christmas Day as soon as first detailed information was received of the disaster, and continued unabated over the Christmas/New Year period. The response to recall was excellent with NHQ manned as were all other support elements of the Command. The activities included the activation of all major stores complexes, the provision of transport, the establishment of refugee centres in three Sydney establishments — KUTTABUL, WATSON and PENGUIN. Reception centres were established at Sydney Airport and HMAS KUTTABUL which processed civilian refugees as well as Naval personnel and their families evacuated from Darwin. A more detailed report of the complete operation will be forwarded separately.

Public Relations

- 29. The period under review was undoubtedly the busiest Navy PR in Sydney has recorded, far exceeding the previous quarter which, at that time, was the busiest recorded. It did not slacken throughout the period and reached a dramatic climax with the effect of Cyclone Tracy and the decision to send a Naval Task Force.
- Requests for assistance and information from all sections of the media, and the general public, reached a new all-time high. The demands for project material, Navy and general Defence, from school children, teachers, libraries and members of the general public and organisations continued at a high level and came from all Australian States. These high demands have placed and continue to place heavy pressures on Area Public Relations.
- 31. Media co-operation with Navy PR continued at a highly favourable level with Radio Stations giving excellent support and coverage to Navy news releases and events. Local newspaper coverage was disappointing but useage of material by suburban, country and interstate papers was very good.
- 32. During the Quarter Area Public Relations issued on a wide basis:
 - a. 70 News Releases (54 in previous quarter) making total for 1974 of 188, an all time high.
 - b. 7 News Film Releases for TV (2 last quarter) achieved by using cine-cameraman on casual basis).
 - c. 820 still pictures (367 last quarter).
 - d. 52 Telex releases, stories and information to multiple addressees (40 last quarter).
- 33. Public Relations assignments covered during the quarter are detailed in Annex E.

General

- Approval has been given by the N.S.W. Lands 34. Department for the continued use of Beecroft Range from 31st October, 1974, for a further period.
- 35. Departmental officers attended an exploratory conference with the State Planning Authority on 12th November, 1974, to discuss the Sydney Harbour Waterside Zoning Plan, the plan to develop the Woolwich site and the future of RAN Armament Depot, Newington.
- 36. A Residential Management Course was held at Glenavon Lodge Vaucluse, from 1st December to 6th December. Guest Speakers included Rear-Admiral Dovers and Mr. F. Green, Special Deputy Navy Office.
- The Senior Officers Quarterly Luncheon was held 37. on Friday, 29th November, 1974. Rear-Admiral Dovers and Mr. F. Green accepted invitations to attend the luncheon.

OPERATIONS

During the quarter, ships and other craft under the control of FOCEA were employed as follows:

HMAS ADROIT

At the commencement of the quarter, the ship was prepared for a bi-annual refit at Vicker's Cockatoo Dockyard, entering dockyard hands on 8th October. Preliminary sea trials were undertaken on 11th December, and the refit completed on 19th December, the ship remaining alongside at HMAS WATERHEN to the end of the quarter.

TRV801

At the beginning of the quarter TRV801 was in dockyard hands at Garden Island undergoing repairs. Acceptance trials were completed on 2nd December and the ship returned to Jervis Bay for deployment on the 6th December.

TRV802

This TRV was deployed to Jervis Bay, replacing TRV801 who was in Sydney undergoing repair and docking. During October, operating from Jervis Bay, the ship spent 13 days at sea employed for target laying, range clearance trials, torpedo recovery duties, and Cadet Seamanship ship handling training. In November, a further 13 days were spent at sea including the escorting of the AWL to Sydney for refit.

In the early part of December TRV802 was returned to HMAS WATERHEN on 11th December, with an RANR crew on board. She was the flagship of the Pittwater Regatta on 21st December in Broken Bay.

TRV803

During October, this WATERHEN based TRV spent 16 days at sea for Torpedo Recovery duties, Navigational training, various trials programmes, and the occasional VIP harbour tour.

November Navigational training for HMAS WATSON, was undertaken on three occasions and a SAR Distex undertaken in Botany Bay in conjunction with the Water Police and the Airport Authority.

December, eight days were spent undertaking Torpedo Recovery duties, Navigational training, and as standby starting boat for the Sydney/Hobart Yacht race.

TDY SEAL and TDY PORPOISE were deployed to Port Stephens as support to the diving training task from 1st October until 19th October. SEAL then undergoing a period in the Dockyard until 25th November, subsequently undertaking day running missions for the Diving School, spending the latter part of December alongside at HMAS WATERHEN.

PUBLIC RELATIONS ASSIGNMENTS

The number of assignments during the quarter reached an all-time high reaching a climax with Operation Navy Help Darwin which came at a time when Navy PR is engaged in pop-up stories and assignments. Again it was not possible to cover all assignments because of the staff limitations and the list of job priorities was maintained. Again the cine-field suffered because the position had not been filled, but this has now been rectified with film being supplied to TV stations daily ex Darwin through Area P.R. The assignments have been many and varied and major assignments include:-

- Operation Navy Help Darwin. Area PRO maintained a. contact with media from approximately 1.30 p.m. 25th December, 1974. Extensive use of the messages recalling ship's companies was made by radio and T.V. One T.V. station offered its news studio for a Senior Navy Officer to personally announce the recalls and any other information but the offer could not be taken up because of planning for the Task Force Departure. Area PRO maintained constant contact with Fleet HQ and DASO and all sections of the media. Area P.R. staff worked throughout the holiday period escorting media on Garden Island, giving voice reports to radio stations, arranging radio and T.V. interviews with Senior Fleet Officers, issuing Telex news releases etc. A P.R. team of 1 Journalist and a cine-cameraman was despatched to Darwin by RAAF aircraft on 29th December, 1974 to arrive ahead of the Fleet and to provide P.R. support to NOCNA and FOCAF. The team is remaining in Darwin as long as the support is required. Media coverage for Navy so far has been excellent and promises to be even better.
- b. Fiji Trip by HMAS VENDETTA: A Journalist from Sydney Office and a photographer from Navy Office travelled in HMAS VENDETTA on the Fiji trip 2nd/17th October, 1974. P.R. material was airexpressed to Sydney and was later distributed throughout Australia with very good useage. Material for Navy News was also supplied.
- c. Navy Week 74 was held in the Sydney Area with four establishments and one ship open to the public during the weekend 12th/13th October, 1974. Stories and pictures were issued to media and with the very limited funds available advertisements

were inserted in the major metropolitan dailies. Media co-operation left a lot to be desired and attendances were very disappointing.

- d. During October stories and pictures were released following a visit to HMAS CRESWELL and HMAS ALBATROSS. Visits by ships to Victoria, Tasmania and New Zealand were previewed and news release material issued. Sydney office made arrangements for two representatives of "The Mercury" in Hobart to travel from Devonport to Hobart in HMAS HOBART. Good media coverage resulted.
- e. In November the aircraft carrier HMAS MELBOURNE was open for public inspection over two consecutive weekends. Area P.R. issued News Releases, wrote newspaper advertisements, arranged radio interviews with the C.O. and other officers to promote the Open Days. Despite competition from beach weather and other sporting attractions MELBOURNE attracted 10,000 visitors and a very good media coverage.
- f. Also in November good media coverage was received for three separate mercy flights from HMAS ALBATROSS taking injured or ill people to Sydney and South Coast Hospitals. Later good media coverage was given to two separate cases in which civilian divers suffering serious decompression sickness were treated at the School of Underwater Medicine at HMAS PENGUIN. Other events publicised included the return of HMAS STUART from ANZUK, the towing of HMAS ANZAC into the reserve fleet; the crash of a Wessex helicopter off Jervis Bay, Exercise Warm Waters. Two separate industrial disputes at Garden Island were covered and media calls dealt with.
- g. A T.V. film clip and pictures on the decommissioning of HMAS TARANGAU and the recommissioning of the PNG Defence Force patrol boat base Lombrum was issued by Sydney office on receipt from DPR who was on the scene.
- h. In December, in association with Army P.R. Sydney, Navy P.R. escorted a "This Day Tonight" team to South Head for coverage of a story on the demolition of Defence Department buildings. It was part of a general story on the hand back of land.
- h. Navy P.R. previewed the opening of a Naval Aviation Museum at NAS NOWRA then arranged air transport and escorted News Media including television to the actual ceremony. Pictures and stories were issued to the media throughout Australia.

- j. Also in December Navy P.R. issued preview T.V. film, stories and pictures then escorted Sydney media, including the Australian Womens Weekly, to HMAS CRESWELL for the promotion parade. Coverage of the parade was issued to media throughout Australia receiving widespread useage. A Telex news release was made to Sydney media on the day of the parade and was used by most radio stations.
- k. The following day Navy P.R. escorted media and covered the apprentices passing out parade at HMAS NIRIMBA. Pictures and stories were issued to media together with a same day Telex release for use by radio stations.
- 1. Advance publicity was undertaken for HMAS PLATYPUS and the annual memorial service at the K13 memorial at Carlingford attended by 300 officers and sailors from Platypus and all submarines. The ceremony received extensive coverage on T.V. and in newspapers, especially suburban papers.
- m. Pictorial coverage was organised for the departure of four submarines from Sydney Harbour. A picture taken by Area PR's photographer was despatched same day to all Australian capitals and was used in every major city.
- n. Visits by HMAS NIRIMBA apprentices to Old Sydney Town near Gosford and to Inverell to recover old steam engines were covered by news releases which received a good run on all media. A P.R. team visited Old Sydney Town to cover the apprentices. Pictures were sent to all capitals and received a good run.
- O. Other assignments/coverages in December included Newcastle and Sydney media concern over the use of an area near Broughton Island, staff went to sea in HMAS MELBOURNE and HMAS ONSLOW to escort media or gather PR material, arrangements were made for the ABC to film segments for Station Identifications on board a submarine, pictures arranged for an OTC promotional film, film cover of a Christmas Party for the Children of HMAS SWAN's ships company and despatch to the ship, Presentation of a \$3000 cheque to the Far West Home by Naval Wines Association and Navy participation in the Murray River Canoe marathon.
