MSL 706 General Harbour duties. Operating satisfactorily.

Assisting in all OFL movements. Otherwise general harbour duties including routine trips to Govt. Station Lorengau. Operating satisfactorily.

MOTOR BOATS. Motor bost "Maringo" under went extensive refit during quarter. Main engine, which had to be removed to workshops for major repairs, was ready for reinstallation at end of March. Workboat 409 performed satisfactorily during quarter and was employed on general harbour duties including routine trips to Govt. Station Lorengau.

VISITS OF IMPORTANT PERSONS TO H.M.A.S. TARANGAU.

6th MARCH The World Chief Guide, Lady Baden-Powell visited Manus and luched with NOIC in HMAS TARANGAU on the day of arrival. The District Commissioner, Mr. E.G. Hicks was also present. Lady Baden-Powell then proceeded to Lorengau where a reception in her honour was held in the evening. On return to TARANGAU next day her ladyship again lunched with NOIC and took departure for Rabaul by air in the afternoon.

17th MARCH The Australian Minister for External Affairs, the Rt. Hon. R.G. CASEY arrived Manus by air from Hollandia. The Minister was taken on a tour of inspection of HMAS TARANGAU during which he inspected the Papua-New Guinea Division on parade. The Minister remained overnight at NOIC residence and departed by air for Madang on 18th March.

27th MARCH The General Officer Commanding, Northern Command, Major General T.J. DALY CBE, DSO visited P.I.R. Nutt Point officially and was the guest of NOIC at the residence "TARANGAU" overnight.

HOUSING

During the three months ending 31st March, 9 of the 11 projected conversions were completed. These consisted of 8 former Chiefs and Petty Officers buildings (single accommodation) plus the former combined post office and class room building. Two buildings of the former category now remain to be completed by the end of April. Refrigerators, stoves and sinks were received in H.M.A.S. WOOMERA.

CONSTRUCTION 9.

Consequent on disbandment of the Naval Works Unit as mentioned in the previous report no new construction was progressed with the exception of three new dormitories to cope with the expansion of the P.N.G. Division. This work was carried out by a combined party of Shipwright, PNG and Compound labour under the direction of the Shipwright Officer. It is intended to contruct one additional dormitory in the Native labour compound using the same labour. All materials for such work are available locally. Beyond the "conversion" type of work as mentioned under "Housing" above no other construction can be contemplated in "Tarangau" at the present time.

TRANSPORT 10.

Considerable difficulty has been experienced in the maintenance of Motor transport due to the lack of personnel. Transportation commitments are heavy, considering the fact that there are over 700 people to be logistically supported by the Navy on Lombrum. In addition there are continuous transport commitments between Lombrum and Momote Airfield and the Oil Fuel Installation at Papitalai. Experience has shown that the present garage force of 1 POM(E) and native assistants cannot effectively cope with the rate of unserviceabil which averages about 20 per cent of the vechicles held. The problem will become more acute during the next quarter when it will become necessary to declare a number of vehicles for disposal in accordance with Navy Office direction. This matter will be the subject of a separate report in due course. Page 4

-11. GENERAL ELECTRICAL

No. 1 Alternator has been installed and is operating satisfactorily. Unfortunately No. 3 Diesel became unserviceable and is at
Garden Island for repair. However, the power situation is in limits.
The lights and batteries have been removed from the Ndillo light, No1
and No.9 light bouys have been removed from the harbour. Ten dongas,
formerly the Chiefs and Petty Officers living quarters have been
wired and converted to temporary residences. One other donga,
formerly the post office and school room has been similarly converted.
The police Bois married quarters has been wired for light and power.
VENNER time switches have been installed in hot water systems to
relieve the load, these being set for off peak periods. Three new
dongas have been erected and fitted out and wired for PNG Division.

12. RADIO.

The IJ 8922 Transmitter has been giving trouble. The internal wiring of this transmitter has deteriorated badly due to climatic conditions, and is due for replacement. Some concernwas felt when without a Radio maintenance rating for one month during the change of drafts.

13. TELEPHONES

Telephones are still a constant source of annoyance and use many man hours. It is still not known whether a new system is to be installed in TARANGAU. (NEA 63/14 dated 12 February, 1958.) refers.

14. CINEMA

Correspondence is still being carried on regarding the fitting of two new 35mm machines and equipment or the fitting of 16mm machines and equipment. (NEA 44/17 dated 1st April, 1958 refers.)

15. POWER HOUSE

The generator for the Mirrlees Diesel driven generator was received after repair and is now in operation. This engine will be due for its 2,000 hours refit approx 1st May,1958. No 2 Generator underwent its normal 2,000 hours refit completing on 17th January,1958. No. 4 Generator underwent its normal 2,000 hours refit during the week ending 14th March,1958. Minor stoppages only have been experiencede mostly due to heavy overleads. No word of No. 3 Diesel which was returned to Sydney for repair has yet been received.

16. SHORE REEEERS

These are now working most satisfactorily as the P.N.G. Watchkeepers are now more familiar with their work. Unfortunately with their very rapid indoctrination to the work fluctuating temperatures caused the loss of a quanity of frozen produce. Constant supervision is still necessary.

17. A.D. 301 FLOATING DOCK was used once during this period to raise the "WOOMERA" three feet. Considerable difficulty was met with on the mechanical side, due to a shortage of E.R.A.'s. The former has now been rectified.

18. WATER RETICULATION

No major repairs to the mains were carried out during this period. Hot and Cold water fittings were installed in the new Temporary residences, and a hot water system in the main ablutions block.

19. MEDICAL

The health of the Ship's Company and residents remains satisfactory. No Malaria occured among European or P.N.G. personnel. Three wives of service personnel were confined in N.H.M.I. during the quarter. SA(S) Peter John GLAZIER, R50780, suffering from a gunshot wound to the Rt. arm, was evacuated by air to Balmoral Naval Hospital for convalescence. Lieutenant Commander Eric Douglas WILLDER, RAN suffering from severe Hepatitis was also evacuted to Balmoral Naval Hospital.Page 5

.... The present hospital routine in the first quarter since the "run down" appears to be working satisfactorily.

20. SPORTS

During the quarter ended 31st March, 1958, sport played in H.M.A.S. TARANGAU has mainly been of a social nature incorporating the families of residents, and "living in" members of the Ship's Company. Tennis has been the most popular game and some Badminton

has also been played.

The granting of permission for ladies to use the swimming pool has greatly increased the use of the pool, and it is now proving to be one of the most popular amenities in the Depot. Three cricket matches have been played with the RAAF and good use has been made of the two sports ovals and the Basketball court by visiting American destroyer divisions. During the quarter, ratings of the PN.G. Division have been learning to play Basketball and it is hoped that in the future this game can be added to their other sporting activities and matches arranged with the P.I.R.

21. SUPPLY OF PROVISIONS, VICTUALLING STORES.

During February advice was received from the suppliers in Goroka New Guinea, that they were unable, in the future, to continue the supply of fresh vegetables to this establishment. In spite of many promises that no difficulty would be experienced it is noteworthy that this firm has not once completly filled our order since November, 1957 when the supply commenced.

It has been decided in the interest of continuity and ensure wholesome supplies of vegetables to demand quick frozen varieties from the R.E.V. Yard. Negotiations for the supply of small quantities

of salad vegetables from WAU, New Guinea are in progress.

22. NAVAL STORES

A considerable quantity os surplus naval stores and equipment was returned to Naval Yard, Sydney in H.M.A.S. Ships WOOMERA and KIMBLA. Action will be taken to further reduce holdings as opportunity for free freight occurs.

23. CONDUCT.

The conduct of the Ship's Company is satisfactory and morale is high.

24. COMPLEMENT

The reduced complement generally appears to be capable of keeping pace with current commitments. However a severe strain has been placed on the following Departments:-

- (a) ENGINEERING Particularly with heavy fuelling programm e and maintenance of small craft and motor transport and power house.
- (b) SUPPLY AND SECRETARIAL The addition to service residents (total now 49) has considerably increased the work of the Victualling staff who are obliged to work long hours in order to keep accounts up to date. The typing problem will deteriorate further with the despatch of another writer without relief. Approvalto employ civilian typists from local residents is awaited. (My letter NEA 2/3 dated 25 March, 1958, refers.)

MOTOR BOATS.

Motor Boat "Maringo" - main engine was re-installed first week in April, after extensive overhaul in Tarangau Workshops. Deckhouse was removed and repaired. Boat operated during quarter on routine trips and recreational trips. Condition satisfactory. Work boat 409 was taken in hand for extensive refit of hull and upper works when Maringo returned to service. Condition of engine satisfactory.

OFL 1207 Employed in all refuelling operations. Condition satisfactory.

7. VISITS OF IMPORTANT PERSONS TO "TARANGAU".

4th JUNE. The Air Officer Commanding Home Command, Air Vice
Marshal Candy C.B.E. paid informal visit to "Tarangau"
during his inspection of the R.A.A.F. Station, Momote.

22nd.JUNE. HOUSING.

The eleven projected conversions from the former Chiefs and P.Os. quarters and the former Post Office were completed in April, and all are occupied by ratings and their dependents. The total number of families now accommodated in Tarangau is fifty.

One new Native Compound Dormitory is under construction by Base Staff. During the quarter there has been some re-construction in the form of a complete renovation of the Native Labour Compound Office, also a renewal of the concrete swamp crossing near the Water pumping station. Work was commenced in June on the reconstruction of the Papitalai Bridge at the eastern boundary of the OFI.

TRANSPORT.

The maintenance of motor transport is a continuing difficulty. The general situation remains similar to that reported in the previous quarter. It is intended to report separately on this matter when final declaration of vehicles for disposal is made.

Certain repairs are still being carried out to vehicles from P.I.R. (at Nutt Point). Despite the Armys promise there is still no sign of a Diesel Mechanic to assist in such work (NOL No. 3391/121/11 (03299) dated 1 April,58 refers).

M.V. DAROA. The winches, windless and associated electric motors were shipped to Rabaul in M.V. "Bulolo". The main Engine blocks and cranckease etc. have now been stripped and are now awaiting shipment in "Bulolo" E. T.A. 4th July,1958. It is estimated that all remaining equipment will be shipped in the next vessel to Rabaul. M.V. "Kakoda" called and collected many DAROA engine parts for use as spares on her present protracted voyage on charter to C. S.I.R.O.

POWER HOUSE. A start has been made on the erection of No.5 B & M

Diesel Engine. This is a spare time job and is liable
to be protracted.

No.1 Mirrlees has completed its 2,000 hourly refit and is now back on load.

No.2 B. & M. Diesel has completed its 1,000 hourly refit and No.4 will shortly be due for its 1,000 hourly refit.

All engines are running satisfactorily but we have little for emergency. During the refit of engines any shut down would seriously inconvenience all residents and require the imposition of serious power restrictions. The repair of the Belliss and Morcom Diesel damaged before Christmas and despatched to Garden Island for repairs appears to be progressing particularly slowly and its return is urgently requested.

14. WATER RETICULATION.

A number of minor holes have appeared in the water pipe line but all have been satisfactorily repaired without the necessity of shutting off supplies.

15. REFRIGERATION.

The main reefers continue to work most satisfactorily.
The pre-fabricated 300 cub.ft. cold room has now been erected in the ORIC Store and is working satisfactorily.
This has now enabled the moving of the Butcher's shop from its unsatisfactory position at Tarangau Reefers to a more suitable and convenient position in the ORIC Store.

16. MEDICAL.

The general health of the Ship's Company and residents remains satisfactory. No Malaria occurred among European or P.N.G. personnel. There were three confinements in N.H.M.I. during the quarter. Two appendicectomies were carried out over the period. One was a R.A.A.F. dependent - Mrs. Daveson, and the other was S.R. Dale MURPHY, U.S.N. 3199791 of the U.S.S. Everett E. Larsen, D.D. R. 830. CM(E) Alan William HILL, R-35017 was evacuated to Balmoral Naval Hospital suffering from severe Psycho-Neurosis. The purity of the water supply is at present in the process of being examined both bacteriologically and chemically. Endemic skin infections have been more prominent and troublesome during the later part of this quarter. This is expected to be controlled in due course. Co-operation has been given to the Administration Medical Officer at Lorengau. A start has been made at repainting those parts of the hospital where the paintwork had deteriorated badly. Arrangements have been made to acquire some medigal and surgical stores from the R.A.A.F. Momote on their

17. ELECTRICAL, GENERAL.

No.3 Alternator Bellis & Morcom Deisel has not yet been repaired by Garden Island. The time taken to do urgent jobs seems excessive. The Power House has only had three serviceable Alternators for some considerable time. As one Diesel is generally in the process of overhaul no stand-by Alternator is available.

A larger Hot Water System was installed in the Wardroom living quarters.

A larger battery charging generator was installed in the Battery Shop.

Maintenance equipment ordered on the local quarterly maintenance schedule appears to be slow in coming forward.

Julians.

The Cinema is operating reasonably satisfactory.

A decision is swaited regarding the installation of new equipment (NOL No.3474/61/5 (12153) dated 29 May,58 refers.)

TELEPHONES. The system is operating but deterioration has considerably limited its efficiency, and continuous maintenance is required. Early installation of an automatic exchange, tropical type hand sets and new aerial cable outlined in NOL No.3169/2/357 (13394) dated 13th June,1958, is awaited.

A.D. 301. During this period dock was lowered and raised three times to take A.W.B. 409, pontoon cubes, M.R.L. 252, and to facilitate refuelling.

Regular supplies of quick frozen vegetables of good variety have been available for family victualling during the quarter. Meat is now being received prepacked in cello. Both of these inovations are proving very satisfactory; are much much appreciated by the resident families and have made a considerable difference in the efficient conduct of the victualling store.

In addition to items listed above, various minor tasks were carried out on attached craft, buildings and residences. To combat the rapid deterioration of buildings and equipment the small Shipwright Department (Shipwrights and Plumbers) has been hard pressed and the appropriation of additional Shipwrights, when available, to help alleviate this situation is sorely needed.

TRANSPORT.

The maintenance of motor transport continues to present some difficulties. The general situation remains similar to that reported in the previous quarter. A separate report of the requirements and final declaration of vehicles for disposal has been forwarded. (My letter N.E.A. 101/23 of 17 September, 1958.) Certain repairs and servicing are still being carried out to vehicles from P.I.R. (Nutt Point).

Assistance was provided to right and tow out from Harbour foreshores to P.I.R. Base their 3 ton truck which had run off the road and capsized on the night of Wednesday 16 July.

The installation of the Hydraulic Hoist has been completed and this unit is now working very satisfactorily. Small concrete platforms have been constructed to provide a suitable flat base for the Wheel Alignment Unit. These two additions will improve the efficiency of the garage.

Numerous leaks have been found and repaired in the main water line from Water Point. This is original American Combat piping and is nearing the end of its useful life. A hole in the timber sheathing adjacent to the dam spillway was found. This caused a washaway of the adjacent earth and serious water loss, but was speedily repaired.

The corroded water cooled muffler in MSL 706 collapsed on the vessels trip to Rabaul and fumes and cooling water were discharged into the engine room. Pending receipt of a new unit from Machinery and Spares Depot a satisfactory substitute has been fabricated by Ship's Staff.

M.V. "TARA".

The Army Vessel "TARA" received fuel and water on 15 September. Assistance was also provided with certain repairs to their refrigerating machinery.

R.A.A.F. SURPLUS STORES.

An Aerated Water Machine purchased by the Canteen
Fund, H.M.A.S. Tarangau, has already been dismantled
and brought to H.M.A.S. "TARANGAU". This will
shortly be erected adjacent to the Bakehouse.
The Baker's Oven is a large and heavy item. It is
proposed to dismantle part of this and an endeavour
will then be made to lift the remainder for transport
to "TARANGAU". The smaller components have already
been received. The Rock Crushing Unit and small
Willy's engine at the quarry, formerly belonging
to R.A.A.F., has been taken over and repaired to
enable crushing to be resumed.

REFRIGERATION.

With the withdrawal of R.A.A.F. one only Cold Room
is now required for use. Two only compressors are
now required to maintain temperatures.

17. ELECTRICAL - GENERAL.

Only one serious fault developed over the period
1 July, 1958 to 30 September, 1958. A Generator
broke down between phases. The Generator was
stripped down, risings unsoldered, bars lifted and
repair satisfactorily completed.

On Thursday 4th December work commenced laying new water pipe line from Water Point to Check Point with materials available in H.M.A.S. Tarangau, which had been supplied previously for this task. This project has become an urgent commitment due to the rapid deterioration of pipe line in use. Anticipate completion at approximately the end of January, 1959. In addition to items listed above various minor tasks were carried out on attached craft, buildings and residences. To combat the rapid deterioration of buildings and equipment the small Shipwright Department has been hard pressed. However, the assistance of the Mobile Works Unit for approximately six weeks greatly assisted the Ship's Staff to overcome this backlog of defects, but the appropriation of additional personnel to this Department is still sorely needed. 11. MOTOR TRANSPORT. The native labour potential is being used to great advantage assisting with running repairs and general maintenance in this section. However, constant supervision is necessary at all times and it is an extremely difficult task coping with a never ending stream of work caused by bad roads and adverse tropical conditions. The establishment of vehicles for H.M.A.S. Tarangau has now been received and a survey and list of vehicles for disposal is being prepared. POWER HOUSE. 12. All diesel generators have been taken in hand for periodical refits as hours became due. During the 1,000 hour overhaul of the "Mirrless" diesel a water leak was detected in number five cylinder. The liner was removed, found to be holed and a spare was fitted. Power lines were brought down by severe storms during the quarter causing No.1 Generator to race when load was released. No damage was detected and power was restored to normal after repairs had been effected to the lines. The job of rebuilding No.3 and No.5 Bellis & Morcom diesel generators is still being progressed as manpower can be spared. Extra work has been caused by the cylinder block being exposed to weather during passage from Sydney. HEAVY EQUIPMENT. 13. The Caterpillar type 955 Traxcavator which arrived per M.V. "Malaita" 12th December has been assembled and tested satisfactorily but this machine will not be of any great value until one of the Caterpillar Bulldozers can be made serviceable by Hastings Deering Ltd., Lae. The Caterpillar D8 Bulldozer belonging to R.A.A.F. was eventually shipped to Sydney per M.V. Malekula on 15thDecember. 14. WATER RETICULATION: The old "combat piping" rising main from Water Point still continues to be a source of annoyance; numerous leaks have been detected and repaired during the quarter. Trouble has also been experienced with the main filter isolating valves becoming detached from the spindles through excessive wear; temporary repairs have been made pending receipt of spares. All the old sand and gravel has been removed from the filters and new media inserted with a resultant cleaner water condition. AUSTRALIAN WAR MEMORIAL

The following projects were completed:-

The pipe line to one filter became choked by two pieces of timber preventing sufficient flow to the filters. The 12" pipe was disconnected and the timber removed. A strainer has now been fitted to prevent a repetition of this. The timber supports for the open trough have been replaced by concrete blocks and when time permits it is intended to concrete all around the trough, as it has practically reached the end of its effective life. The Chlorinator and associated equipment has now been lifted into position and is being connected by piping to the water system. More details is required before the flow meter can be connected up and the building housing the Chlorinator requires extra stiffening when labour can be made available. Arrangements have been welded to the existing piping for connecting the new 9" Rising Main the laying of which is well under way insofar as 265 lengths (each 12°) have been placed end to end ready for connecting from Water Point to Check Point. Repairs to the 6" and 4" mains within the Depot area continue to multiply and it is considered that a complete renewal of these mains will be required in the near future. REFRIGERATION & AIR CONDITIONING. 15. Three main shore refrigeration compressors were refitted by members of the Mobile Maintenance Force and the plant is running satisfactorily. Water sprayers in cooling towers were also removed and renewed. In addition the hospital air conditioning plant was refitted by this Force. but requires further adjustment. A 100 cub.ft. "Coldstream" Refrigerator Unit ex R.A.A.F. Momote has been installed in the Chief and Petty Officer's Mess and a "Werner Scotsman" Ice making Machine also ex R.A.A.F. is ready for installation, but a few small spares are required before this machine can be made serviceable. The aerated water machine mentioned in the last report has been installed and works satisfactorily. It is also expected that the quality of "lolly-water" will improve as the "brew-master" gains experience. 16. SMALL CRAFT: Two new Exhaust Silencers have been installed in M.R.L. 252. Assistance on repair of auxiliary machinery was rendered by the Mobile Maintenance Force and the refrigeration plant is still in the process of being refitted by the Ship's Staff. MAJOR MINOR.

There were five successful confinements in the Hospital during this quarter, four being wives of Naval personnel, one a civilian. During 1958 the wives of seventeen Naval personnel had successful confinements in Naval Hospital, Manus Island. In addition there were three emergency abnormal confinements in native women.

Staphyloccocal infections which have been prevalent during the past six months, have diminished considerably, since inoculations with Staphyloccocal Vaccine have been introduced. Malaria control has been 100% effective due to the elimination of the reservoir of infection. All personnel, native and european are now taking suppresives. Larvae control has been in abeyance during the past three months as the vehicle used to fill the drip drums throughout Lombrum has been unserviceable. The "Swingfog" has been used less than normally due to weather conditions; wind and rain preclude its effective use. Expert opinion received by Doctor Peters, Malariaologist to the New Guinea Administration suggested that Gammexane used in the "Swingfog" apparatus is useless as a residual spray for use in dwelling houses. It has only a "knockdown" effect.

The main autoclave in the Operating Theatre has been unserviceable from time to time, but is working at 50% efficiency. A new suitable autoclave has been demanded.

The air conditioning in the Operating Theatre is still not functioning satisfactorily. Further work on this plant is pending. The sterile water supply in the Operating Theatre which is badly contaminated with rust is now in the process of re-organisation.

The conduct and morale of personnel continues to remain very good and the amenities are satisfactory. The Ship's Company wet canteen has been modernized and painted out in a variety of pastel colours and renamed "Junior Rates Club". Club Sporting facilities have also been provided. The Ship's Company have been encouraged to attend social functions at Nutt Point and Momote and to partake in more sporting activities.

With the advent of the Northwest season, with its unsettled weather and heavy rain, the opportunities of playing outdoor sports have been very limited during this quarter.
