The following report of proceedings for the

month of November, 1945, for H.M.A.S. "NYANIE".

Nov 1st - 3rd. Morotai harbour

Nov. 4th - At 1020 "NYANIE" proceeded to RAO arriving at 1200, and departed at 1600 to arrive Morotai at 1745.

Nov. 5th - 9th. Secured alongside "ANACONDA" making requisite trips for stores and water.

Nov. 10th. - 1005 proceeded to position 280° Tg Gila 1.6 miles and sunk mine by gun fire. 1140 secured alongside "ANACONDA".

Nov. 11th - 14th Morotai harbour.

Nov. 15th - Vessel carried out unsuccessful search for floating mines in vicinity of Morotai Straits and southern approaches. This operation entailed being under way from 0730 - 1850.

Nov. 16th - 18th Morotai harbour - diving gear embarked.

Nov. 19th - Embarked Engineer Lieutenant Commander Chambers and party and proceeded at 0800, to Kau Bay arriving at 1230. Inspection was made of three sunken Japanese ships with a view to salvage. "NYANIE" departed for Morotai at 1110/20th to arrive at 1435, when party and diving gear were disembarked.

Nov. 21st - 23rd Morotai Harbour.

Nov 24th - Proceeded to PANGEO with stores for U.S. Range Force departing Morotai 0730 and arriving Pangeo at 1545.

Nov 25th - Departed Pangeo 0930 and arrived Morotai 1450.

Nov 26th - 2320 proceeded to provide navigational escort to the "KANTO MARU".

Nov 27th - 0030 contacted H.M.A.S. "BOWEN" with "ESTUA MARU" and returned to harbour in company with same. Vessel proceeded again at 0310 and sighted "KANTO MARU" at 0415 which was escorted to harbour, anchoring at 0840.

Nov. 28th - 30th Harbour. Sub Lieutenant J. Lewis, R.A.N.R. relinquished command to Sub-Lieutenant F.J. Digwood, R.A.N.R.

General -

Health and morale of the crew remains satisfactory.
On November 26th hull and underwater fittings were inspected by diver. The cutlass rubber bearings are wearing and one blade in the starboard screw is out of alighnment, but the Base Engineer Officer is of the opinion that the vessel can safely make the anticipated trip to Lae for paying off.



Remarks by S.O. (E).

As the Army Authorities have requested this vessel be taken over by them on the 1st of December with the permission of the Naval Board and port of delivery LAE, the vessel should be docked on arrival, as a dock is available.

An examination of the starboard propetler and cutlass bearings was made by a qualified diver, who reperted 1 blade bent starboard propeller and cutlass bearings worn down considerably.

The question of Bray Diesel spares as reported in paragraph 16 is a serious one. The Gray Diesel spares and 3 Gray Diesel engines were confiscated from S.R.D. store by Army Authorities without permission from S.R.D. or NOIC Moluccas.

At the time mentioned in paragraph 16, no Gray Diesel spares were held though repeated efforts were made to obtain the confiscated spares or other spares held from the Army Authorities.

H.M.A.S. "NYANIE" is in immediate need of slipping. The copper paint has worn off in many places below the waterline, and much sea growth has collected. Vibration from the starboard shaft is experienced and renewal of all three cutlass bearings is required.

16. MECHANICAL.

On the 17th October, the fresh water pump on the starboard engine broke down, and could not be repaired by ship's staff. This was reported to the Squadron Engineer Officer on "NYANIE's" arrival back in Morotai. He stated he had no spare parts. Ship's staff of "NYANIE" were fortunate in securing the required spare part from scrapped landing barges on the beach, and repairing the starboard engine.

GENERAL REMARKS.

(A) Mechanical - No major defects have occured to date, slight leaks in the cooling system of exhaust pipes of all three engines was repaired and reinforced by N.M.A.S. "PLATTPUS". Gutless bearings are showing signs of wear, but this is to be expected, "NYANIE" having steamed 5,170 miles. "NYANIE" is in dire need of docking. She was launched in early May, and the copper bottoming composition is fast wearing off. Toredo shells have been found along both garboard and chine strakes.

The "Amplight" auxiliary charging set has been giving a great deal of trouble. The motor is unreliable and the generator temperamental. The set is a Briggs & Stratton type built in Australia under license.





 "BIRCHGROVE PARK" (S.O.). "ANACONDA". "KRAIT" and "THREE CHEERS" en route to Ambon to participate in "OPERATION OCCUPATION AMBON".
- The vessel was extremely crowded and felt sluggish in a seaway. Seventeen men were living on a mess deck designed for eight, and the ship's officers had no accommodation whatsoever, their wardroom being full of general cargo. Fortunately excellent weather was enjoyed.
- 16. 23rd September 1045 secured on H.M.A.S. "ROCKHAMPTON" at the main jetty Amboina. Japanese working party proceeded with unloading.

Distance run 469 miles. Steaming time 67 hours 15 minutes.

Fuel consumed 330 gallons.

- 17. 24th to 27th September Lying in Ambon.
- 28th September 0700 slipped and proceeded out of harbour to put boarding officer aboard H.M.A.S. "WESTRALIA".
 0915 Re-secured on H.M.A.S. "GLENELG" at main jetty.
 1010 Slipped and proceeded with a landing party and Japanese Naval Lieutenant onboard, with instructions to inspect gun positions on the South coast of Ambon.
 1200 Landed party in Hilau Cove.
 1300 Shore party returned, set course for Ambon.
 1600 Secured on H.M.A.S. "GLENELG".
- 19. 29th and 30th Sentember Lying in Ambon.

GENERAL REMARKS.

(A) Mechanical - No major defects have occured to date, slight leaks in the cooling system of exhaust pipes of all three engines was repaired and reinforced by N.M.A.S. "PLATYPUS". Outless bearings are showing signs of wear, but this is to be expected. "NYANIE" having steamed 5,170 miles. "NYANIE" is in dire need of docking. She was launched in early May, and the copper bottoming composition is fast wearing off. Toredo shells have been found along both garboard and chine strakes.

The "Amplight" auxiliary charging set has been giving a great deal of trouble. The motor is unreliable and the generator temperamental. The set is a Briggs & Stratton type built in Australia under license.

(B) General. - The morale of the ship's company is high, and whilst several members of the crew are keen to be demobilised, all hands realise that it will take considerable time, and as a ship's company are very keen to be at sea doing a useful job during this period of waiting.

Great disappointment was felt by both officers and crew in the manner by which "NYANIE" was completely described by S.R.D. on the close of hostilities.
