Nominees are requested to consult the Electing the Management Committee Bylaw and the Constitution for further information on the process, both of which can be obtained from the Operations Manager or from the ACA website (campdraft.com.au). Nominees may submit a curriculum vitae and a statement of professional concerns in accordance with the Bylaw and this must be received within 10 business days after the close of nominations. In accordance with the Constitution, it is advised that the Association has Public Liability Insurance to the value of \$20,000,000.00.

If a ballot is required for any of the above Executive Positions or Zone Management Committee Members as stated in "The Table" above, a ballot will be held and ballot papers will be posted to all adult financial members before 7 September 2021. All ballot papers must be returned to the nominated address by 5 October 2021 so that the result of the ballot can be declared at the Annual General Meeting.

Only honorary, life and financial Adult Members as at the 31 December 2020 are entitled to vote.
